THE FOLLOWING TEL WAS SENT TO BUREAU, LITTLE ROCK AND OKLAHOMA CITY ON FOUR SIX SIXTYEIGHT

ON APRIL SIX, INSTANT, AN ANONYMOUS MALE TELEPHONICALLY ADVISED THAT ON APRIL THREE, LAST HE CASUALLY MET A MAN IN THE OKLAHOMA CITY GREYHOUND BUS TERMINAL WHO IDENTIFIED HIMSELF AS CLIFFORD SCOTT FROM FT. SMITH, ARK. DURING THEIR CONVERSATION SCOTT MENTIONED THAT HE HAD BEEN IN A HOSPITAL AND INCLUDED MENTION OF NORMAN, OKLA., ALTHOUGH THE CALLER DID NOT SPECIFICALLY RECALL THAT HE SAID THIS WAS THE LOCATION OF THE HOSPITAL THAT HE HAD BEEN IN; THAT SCOTT ALSO CLAIMED TO BE A GI; TO BE AN EXPERT ON GUNS AND THAT SCOTT EXPRESSED HATRED OF NEGROES. SCOTT WAS DESCRIBED AS A WHITE MALE, ABOUT THIRTYFIVE YEARS OLD, FIVE FOOT ELEVEN, ONE SEVENTYFIVE TO ONE EIGHTY LBS., TATTOO OF SOME KIND ON RIGHT FOREARM. NO OTHER DESCRIPTIVE INFORMATION.

THE CALLER SAID HE WAS ADVISING THE FBI BECAUSE HE BELIEVES THERE IS A MENTAL HOSPITAL IN NORMAN, OKLA. MR. LEONARD BARKSDELL, ENGINEER, SOUTHERN PACIFIC RR OBSERVED SKETCH OF ASSASSIN ON FRANK MCGEE, TV NEWS REPORT. STATED THE LIKNESS FOR PERSON OBSERVED AT VALENTINE, TEXAS, CAFE, THIS MORNING APPEARED TO BE IDENTICAL WITH UNSUB ASSASSIN SKETCH.

BARKSDELL REPORTED HAVING BREAKFAST AT VALENTINE, TEX, APPROX. EIGHT FORTYFIVE AM CST, THIS DATE, WHEN OBSERVED THIS PARTY ALSO EATING. STATED HE HAD SHORT CONVERSATION WITH PERSON WHO MENTIONED HE HAD DRIVEN FROM WEST VIRGINIA AND WAS ENROUTE TO FORT HUACHUCA, ARIZONA AND HAD TO BE THERE BY NIGHT OF APRIL SIX AND WAS GOING TO VISIT FRIEND AT EL PASO ENROUTE.

BARKSDELL DESCRIBED PERSON OBSERVED AS WHITE MALE, ABOUT FORTY FIVE YEARS, FIVE FEET TEN INCHES, TWO HUNDRED TO TWO ONE ZERO LBS, STOCKY BUILD, RECEDING HAIR, WEARING LIGHT BLUE SUIT, WHITE SHIRT, NO TIE.
