OGLESBY WAS INTERVIEWED APRIL TWENTY SIX, SIXTY EIGHT, AT WEST MEMPHIS AND GAVE HIS NAME AS BILL JAY OGLESBY AND DENIED ANY KNOWLEDGE OF INSTANT CASE. HE RECALLED THAT ON APRIL FOUR, SIXTY EIGHT, HE SPENT A PART OF THE DAY WITH RUTH WICHARD BUT COULD NOT RECALL EXACT HOURS, OTHER THAN HE TOOK HER TO THE AIRPORT TO CATCH A NINE FORTY P.M. PLANE. WAS EMPLOYED BY KROD-TV STATION, EL PASO, TEXAS, FOR A PERIOD OF THREE YEARS PRIOR TO HIS CURRENT EMPLOYMENT AT WREC-TV FOR FOUR YEARS. HE STATED RAY WAS A HYPOCHONDRIAC, CONTINUALLY TOOK PILLS AND AMPHETAMINES. HE AGAIN STATED RAY WANTED TO AVOID AMERICAN COLONIES AND STAY OFF THE BATEN PATH IN MEXICO.
