UNDER DEVELOPMENT AS PCI SINCE INITIAL INTERVIEW THIS CASE. IS SEVENTY YEARS OLD, ON VERGE OF SENILITY, EXTREMELY RAMBLING IN CONVERSATIONS, AND AGENTS EXPERIENCE DIFFICULTY KEEPING INTERVIEWS ON PERTINENT TRACK, AS WELL AS SEPARATING FACT FROM CONJECTURE. JERRY RAY HAS DESCRIBED HIM AS KOOK, AND OTHER SOURCES REGARD HIMAS CRAZY OLD MAN WHO TALKS TOO MUCH.

ON INTERVIEW TODAY GAWRON STATED WITHIN DAY OR TWO FOLLOWING RELEASE ON BOND, JUNE TWENTY THIRD TWENTY FOURTH SIXTY SEVEN, HE READ IN CHICAGO TRIBUNE OF BANK ROBBERY OF FIFTY THOUSAND DOLLARS IN SOUTHERN STATE, AND RECALLED BANK HAD BEEN CASED BY SUBJECT AND SELF ON TWO FRIDAYS, BIG PAY ROLL DAYS, FIFTY EIGHT FIFTY NINE, BUT NOT ROBBED DUE TO GAWRON LEG INJURY.

WEEK OR SO LATER THEY SAID SUBJECT IN OMAHA, DOING WELL, HE BELIEVED AS SALESMAN. WEEK OR SO LATER THEY SAID SUBJECT IN LOS ANGELES. CLAIMED NO DISCUSSION AS TO HOW THEY KNEW, OR INFO AS TO DIRECT OR INDIRECT CONTACT.

SIX WEEKS AGO WAS VISITED BY SAME MAN WHO INDICATED SUBJECT AND ONE OR MORE OTHERS WERE ACCOMPLICES IN BANK ROBBERY.

GAWRON DECLINED TO GIVE LOCATION OF BANK OR IDENTITY OF MAN AT THIS TIME, SAYING WANTED TO SEE MAN AGAIN AND IDENT ALL ACCOMPLICES, AND BE SURE HIMSELF IN THE CLEAR. PROMISED ADDITIONAL

DETAILS IN FEW DAYS. INTERESTED IN BANK ROBBERY REWARD. WAS PRESSED FOR DETAILS ON PROBABILITY OF IMMEDIATE REWARD BUT DECLINED.
