**PURPOSE(S):** To update status of the investigative efforts of the Attorney General's Office.

DETAILS: On March 17, 1994, contact with MARK K. GLANKLER, Criminal Investigative Division, Shelby County Attorney General's Office, revealed that his investigation has not yet located FRANK HOLT, the alleged "shooter" of Dr. MARTIN LUTHER KING, JR., for interview. Additionally, GLANKLER advised that social security information concerning FRANK HOLT has not, to this point, proved beneficial in determining his whereabouts.

GLANKLER also advised that the more than 20 witnesses present at Jim's Bar and Grill on the date of the shooting had been accounted for, either by way of interview or by virtue of the fact that they are deceased; of those interviewed, none have identified FRANK HOLT as the shooter.

GLANKLER explained that the Shelby County Attorney General's Office is attempting to wind down their investigation by doing a background investigation on LLOYD JOWERS, to determine his bonafides. GLANKLER closed by stating that the date for the 44-1980-126

### MESSAGE TO THE MEDIA



The media should not give any-type of consideration to a St.Louis summit on crime, until they read THE DIARY OF JOHN LARRY RAY---AMERICA'S # 1 POLITICAL PRISONER.

THE DIARY OF JOHN LARRY RAY points out how the u.s. congress (house select committee on assassinations), the u.s. department of justice, and the federal bureau of investigation spent a quarter of a century, and untold numbers of taxpayers dollars, trying to get information as to where did JAMES EARL RAY accumulated a large sum of money, after he escaped from the Missouri sate penitentiary, and prior to the assassination of MARTIN LUTHER KING.

- \* They accused JOHN LARRY RAY of giving false testimony in front of the u.s. congress, and tried to extend his sentence to 23 years (perjury).
- \* They accused JOHN LARRY RAY of burglary, but dismissed the charge when it came out that the FBI and St. Louis circuit attorney GEORGE PEACH was carrying out a conspiracy.
- \* They tried to extend JOHN LARRY RAY sentence by prosecuting him on a bank robbery in Springfied, Illinois, but the jury wouldn't buy it.

- \* They tried to extend JOHN LARRY RAY, sentence by accusing him of saulting a u.s. marshal, the chage was dismissed, after it came out that it was the marshals who were doing The assaultings.
- \* They accused JOHN LARRY RAY of having a couple of hunting shells in his home, and tried to extend his sentence to an additional 15 years without parole or good time.
- \* They tried to extend JOHN LARRY RAY sentence to an additional 25 years under the SPECIAL DANGEROUS OFFENDERS ACT, but judge BEATTY wouldn't buy it after the man upstairs came into the picture.
- \* They tried toput JOHN LARRY RAY in the ILLINOIS CRIMINAL' INSANE ASYLUM, but an Adams county sanity jury wouldn't buy it--they accused JOHN LARRY RAY of shooting civil rights LEADER vernon jordan, THUS HE WAS NUTS.
- \*They ordered JOHN LARRY RAY to served 4 additional years claiming that he lite a newspaper while in solitary confinement, and put it out with his foot---they called it an act of arson.
- \* They put JOHN LARRY RAY in several hospitals taking brain-waive tests due to beatings while under the custody of the u.s. department of justice---including the St. Johns hospital in Springfield, Illinois, and the Incarnate Wprd hospital in St. Louis, Missouri.
- \* They held JOHN LARRY RAY in solitary confinement in more than a quarter of the nation's states---from maryland to CALIFORNIA.
- \*They mademany deals and many money offers, and freedom offers.

THE DIARY OF JOHN LARRY points out that the federal bureau of investigation was on the right track, when they were investigating organized figures, among others, and the u.s. congress was on the wrong track when they were investigating bank robberies in the death of MARTIN LUTHER LUTHER KING. However, JOHN LARRY RAY derailed both of these groups, with UNTRUE TESTIMONY and UNTRUE STATEMEMTS -- and for a good reason.

#### FEDERAL BUREAU OF INVESTIGATION

ELLIOTT was advised of the official identity of Special Agent (SA) Federal Bureau of Investigation (FBI), and of the fact that he was being interviewed regarding any information he may have pertaining to the assassination of Reverend MARTIN LUTHER KING, Jr. since he indicated in his letter dated January 15, 1994 to DAN WADE, Assignment Editor, KOB Television, Broadcast Plaza, Albuquerque, New Mexico that he did have pertinent information regarding the assassination of Reverend KING. ELLIOTT was advised that this interview was being conducted at the request of the Oklahoma City Division of the FBI after ELLIOTT sent a copy of his foregoing letter to DAN WADE to the Oklahoma City Division of the FBI by cover letter dated January 20, 1994.

The interview with ELLIOTT commenced in the presence of SHANNON McREYNOLDS, PNM Classification Officer and Case Manager for Housing Unit 2A in the North Facility, the maximum security unit at PNM. McREYNOLDS was present for security reasons and ELLIOTT, who was acquainted with McREYNOLDS, agreed to his presence during the interview. ELLIOTT furnished the following information regarding the assassination of Reverend KING.

During the summer of 1993, ELLIOTT, while incarcerated at OSP, was housed in a cell next to another inmate named TOM LESTER PUGH, who was also serving time for murder. During their incarceration next to one another, the television program known as Home Box Office (HBO) featured a program about JAMES EARL RAY and the killing of MARTIN LUTHER KING, Jr. which prompted PUGH to talk to ELLIOTT. ELLIOTT thought that PUGH became sociable with him because PUGH, whom he claimed is homosexual, thought that he and ELLIOTT would later share a cell together. This did not happen, however.

In PUGH's conversations with ELLIOTT, PUGH told him that in either October or November, 1967 he (PUGH) and PAT EARLY or URLEY (phonetic spelling) robbed some businessmen at a poker game which was taking place at a cabin in the Memphis, Tennessee area. The local newspaper said that the robbery occurred at a fish fry but PUGH said it was at a poker game. During the robbery a Rolex watch was stolen from one of the victims. PUGH claimed to have later been interviewed about this robbery by the FBI while in custody in Dallas, Texas.

PUGH told ELLIOTT that during February 1968 he and EARLY went to a gun shop on the west side of the river in Memphis, Tennessee where they purchased a .30 caliber rifle and a 30.06 caliber rifle. According to PUGH, the purpose for purchasing these weapons was to use them to assassinate MARTIN LUTHER KING, Jr. when he visited Memphis, Tennessee later that year. PUGH was to plan the assassination and to act as the driver while EARLY was hired as the sharpshooter because of his previous training and shooting experience.

PUGH told him that the persons who contracted PUGH and EARLY to kill KING were unnamed members of the Retail Merchants Association of Memphis, Tennessee. Their reason for wanting KING killed was that local Afro-Americans in Memphis, Tennessee were boycotting local businesses of white merchants due to the civil rights movement in which KING was an instrumental figure.

The person who actually hired PUGH and EARLY to perform the assassination on behalf of the Retail Merchants Association was the business manager for the popular entertainer named JERRY LEE LEWIS. PUGH did not give the name of this individual but said he was the father of LEWIS' 13 year old cousin whom LEWIS married. PUGH was already acquainted with LEWIS' business manager since PUGH had previously committed unnamed crimes for this person.

PUGH told ELLIOTT that after this person hired PUGH and EARLY for the assassination and after they then purchased the two foregoing rifles, PUGH and EARLY thought about their assignment for a few days. PUGH realized that the assassination of KING would be a highly publicized event and that the FBI would be persistent in investigating the case so he told LEWIS' business manager that he and EARLY had changed their minds and would not be carrying out their assignment to assassinate KING.

ELLIOTT said that as he was being furnished this information by PUGH, ELLIOTT asked PUGH where he was when KING was assassinated and PUGH got angry and told ELLIOTT that he would not say anything which would implicate him in this matter. PUGH did not say whether he (PUGH) was in Memphis, Tennessee at the time that Reverend KING was assassinated. ELLIOTT felt that PUGH was being truthful when furnishing the foregoing information to ELLIOTT about the assassination of Reverend KING.



For the information of the Bureau, Memphis and Oklahoma City, U.S. Probation Officer GUNTHER HASELBAUER, Santa Fe, New Mexico, contacted the U.S. Bureau of Prisons at the request of SA Albuquerque Division, on 3/18/94 and determined that there are currently three federal prisoners named PATRICK EARLY but none are located in federal facilities in the State of Arizona at this time.

JAMES EARL RAY has at least two known brothers. One is JOHN LARRY RAY, DOB SSAN FBI #368725A, who is the subject of a case entitled, "JOHN LARRY RAY; FARMERS BANK OF LIBERTY, LIBERTY, ILLINOIS, 5/30/80, BANK ROBBERY, OO: SPRINGFIELD, 91A-SI-8398."

The other brother is JERRY WILLIAM RAY, description unknown, living in Northbrook, Illinois as of 1980.

# Bill for school prayer goes to Miss. governor

By Sarah C. Campbell The Commercial Appeal Jackson, Miss,, Bureau

JACKSON, Miss. — The Senate sent Gov. Kirk Fordice a bill Wednesday that would let public school students offer organized prayers during elective and mandatory school events.

Opponents argued the bill vio-lates the U.S. Constitution's prohibition on state establishment of religion.

I suggest to you that a student-initiated prayer - and that's what we're talking about under this bill — is not an establishment of religion and does not violate the (Constitution), Sen. Roger Wicker (R-Tupelo) told his colleagues.

Under the bill, the prayers could not endorse a specific religion nor be aimed at converting

The bill also would give school administrators the authority to permit voluntary prayer by stu-dents and others. The two-page bill does not say how school officlais could determine whether a prayer to be offered meets the oill's requirements.

Fordice had not seen the bill Wednesday, said his spokesman John Arledge. Fordice has supported efforts to allow organized prayer in public schools.

Sen. Dick Hall (R-Jackson), who voted for the bill, urged senators to remove language in It that permits prayer at events that all students must attend.

"I think you're going to put the school districts in position where a state law is telling them one thing and their (legal) advisers are telling them another," Hall said.

"If enacted, students would be required to attend a daily religious service that is contrary to their beliefs," said Sen. Alice Harden (D-Jackson), who op-

# New claims about King's killer tied to selling story

The prospect of a large amount of money may have motivated recent claims of a conspiracy in the 1968 assassination of Dr. Martin Luther King Jr., a witness has told criminal investiga-

A sum of \$300,000 in anticipated royalties for book and movie productions possibly played a role in the claims that former Memphis businessman Loyd Jowers had a hand in killing King, witness Betty Spates said in a recent statement to the Tennessee Bureau of Investigation.

Jowers gained attention last December when he told a na-tional television audience that he was paid by another Memphis businessman to hire a gunman to kill King. In 1968, Jowers owned a restaurant called Jim's Grill near the Lorraine Motel

where King was shot.
Spates, who frequented Jim's Grill, told the TBI that Jowers recently said he was involved in the killing "because of the money" to be gained from royalties.

In her Jan. 25 sworn statement obtained Wednesday by The Commercial Appeal — Spates also denied earlier statements that she saw Jowers with a rifle hurrying into the back of the restaurant moments after the assassination at 6:01 p.m. on April 4. 1968.



Spates told the TBI she saw Jowers with a rifle about noon that day, but she denied making key statements that have fueled the conspiracy tale.

At one point in the statement, Spates said: "Loyd Jowers and his attorney, Lewis Garrison, said I blew \$300,000 in royalties we could have split. They said I should have told the story that I saw Loyd and a black man in the back of Jim's Grill and saw the black man they said was Frank Holt hand a rifle to Loyd Jowers."

Jowers told the ABC television news program PrimeTime Live in December that he received money to hire a man to shoot King. The supposed gunman, later identified as Holt, a transient now living in Florida, told The Tennessean in Nashville he was not involved in the assassination.

Reached Wednesday, Garrison denied any involvement in possible book or movie deals and said he never offered any money to Spates. Garrison also noted that Spates has changed her story several times

ry several times.
"She just looks like she's not too credible," Garrison said.

Spates declined comment Wednesday.

Spates was first questioned by authorities about the King assassination on Feb. 12, 1969. In a statement on that date, Spates said she had no knowledge about King's shooting.

In a signed affidavit given this month to attorneys seeking a new trial for King's convicted assassin, James Earl Ray, Spates



Loyd Jowers in 1963 told a different story.

Spates said in the March 8 affidavit that she saw Jowers moments after the shooting coming through the back of the restaurant "white as a

in 1963 ghost" and carrying a rifle. "His hair was all messed up and he had obviously been on his knees on the damp ground because the knees of his trousers were wet and muddy," she said.

That account has been the substance behind the new conspiracy claims that have fueled efforts to get a new trial for Ray. Ray's London attorney, William Pepper, said Wednesday he's suspicious of the TBI statement.

spicious of the TBI statement.
"I've known Betty for six years. Since she's started talking about this, she's always told me the same thing," Pepper said. Pepper suggested that others — possibly Jowers — may have gotten to Spates to change her story.

In her TBI statement, Spates said Memphis private detective Kenneth Herman once gave her more than \$500 for her story. Herman denied that.

The TBI has assisted Dist. Atty. Gen. John Pierotti since he reopened the case after Jowers's television interview.

Despite the changes in her story, Spates's TBI statement added to the mystery about what happened the day of the assassination with her contention she saw Jowers with a rifle about six hours before the shooting.

DETAILS: On 7/21/94, contact with MARK K. GLANKLER, Criminal Investigative Division, Shelby County Attorney General's Office, revealed there are no new leads in their investigation, other than what they are doing in response to the attempts of Ray's defense attorneys to test fire the rifle that was allegedly used to kill Dr. MARTIN LUTHER KING, Jr. The Commercial Appeal has run several articles concerning the attempts by Ray's attorneys to secure approval to test fire the weapon. However, on 6/16/94, the Tennessee Court of Criminal Appeals halted, at least temporarily, the test firing of the weapon.

Also, on 5/25/94, the Tennessee State Parole Board rejected JAMES EARL RAY's request for parole from the sentence he is serving in the 1968 slaying of DR. MARTIN LUTHER KING, JR. According to the <u>Commercial Appeal</u>, RAY's insistence he did not kill KING, combined with the similar cavalier attitude toward seven escape attempts in his criminal history, appeared to weigh heavily with the panel. RAY's next parole hearing will be in July 1999.

In another article in the <u>Commercial Appeal</u>, a defense attorney for RAY said on Thursday, 6/16/94, that he may call on U.S. Attorney General JANET RENO, to investigate the 1968 assassination of Dr. MARTIN LUTHER KING, JR., in Memphis, in an effort to expose what he called a 26 year cover up.



As you know there have been various people involved in attempting to resurrect the investigation into the murder of Dr. Martin Luther King, Jr. In my opinion their reason for doing this is strictly commercial. I further feel that they would stop at nothing to make it appear that the Federal Bureau of Investigation, this office and Lord knows who else has conspired for all these years to cover up the real truth and continue to make James Earl Ray the scapegoat.

Because of their activities I have called upon you in the past for assistance, as you know. In addition to that one of my Investigators, Mark Glankler, and Tennessee Bureau of Investigation Special Agent, John Simmons, have been monitoring these peoples' activities.

They have recently become aware of attempts a British television producer and local private investigator are making to name a Raul Ramos Coelho as a conspirator in the murder of Dr. Martin Luther King, Jr. Mr. Coelho is a naturalized immigrant from Portugal, coming into the United States originally in the early 1960's. The television producer recently met with investigators of my office, stating he believed he had located the "Raoul" James Earl Ray has long stated was involved in this murder. The producer has latent fingerprints in his possession allegedly of Mr. Coelho. He has requested that we have these latent fingerprints compared to all unidentified latent prints recovered during the original murder investigation.

Since this meeting with the television producer, I have been provided the latent fingerprints allegedly belonging to Mr. Coelho, without the television producers' knowledge. We have had photographs taken of these prints which are of sufficient quality to be used for comparison purposes.

My investigators have obtained two (2) cards of KNOWN INKED fingerprints from Mr. Coelho without the television producers knowledge.

It is my opinion these known fingerprints we are providing and the latent fingerprints need to be compared to known fingerprints of Raul R. Coelho as well as any unidentified latent prints recovered in the original murder investigation. This will allow my office to discredit the theory that Mr. Coelho was involved in this murder should his name be released publicly.

I am respectfully requesting the following of the FBI:

- 1) Determine if known inked impressions of Raul Coelho's fingerprints exist in FBI civilian files.
- 2) Determine if photos of all latent prints recovered during the initial investigation of this murder exist in FBI files.
- 3) Compare known inked fingerprints of Mr. Coelho (obtained by my investigators) to all unidentified latent lifts recovered during the initial investigation of this murder, as well as to any known inked impressions, if they exist, in FBI files.
- 4) Compare known prints of Mr. Coelho, if they exist in FBI files, to the photographs of latent prints we are providing with this request.
- 5) Compare known prints of Mr. Coelho, if they exist in FBI files, to all unknown latent prints recovered during the initial investigation of this murder.
- 6) Compare the latent prints we are providing to all unknown latent prints recovered during the initial investigation of this murder.



**REQUEST(S):** The FBI Latent Fingerprint Section is requested to make certain comparisons with the enclosed fingerprints to certain latent fingerprints the Bureau may have pertaining to the case in their possession.

DETAILS: For the information of the Bureau, for the past year, the Shelby County District Attorney General's (SCDAG) Office has been conducting investigation into the shooting death of MARTIN LUTHER KING, JR. in light of certain information that surfaced concerning the possibility that JAMES EARL RAY was not the person who killed Dr. KING. The Memphis Division of the FBI has maintained close liaison with the AG Office to insure that Memphis is aware of any developments. Most recently, SCDAG JOHN PIEROTTI's office has requested FBI Laboratory assistance in their investigation.

Specifically, SCDAG JOHN PIEROTTI has recently become aware of attempts a British television producer and local private investigator are making to name a RAUL RAMOS COELHO as a conspirator in the murder of Dr. MARTIN LUTHER KING, JR. COELHO

is a naturalized immigrant from Portugal, coming into the U. S. originally in the early 1960's. The television producer recently met with investigators of the SCDAG's office, stating he believed that he had located the "RAUL" whom JAMES EARL RAY has long stated was involved in the murder. The producer has latent fingerprints allegedly of COELHO. Since meeting with the television producer, PIEROTTI has been provided the latent fingerprints allegedly belonging to COELHO, without the television producer's knowledge. He has had photographs taken of these prints which the DAG's office believes are of sufficient quality to be used for comparison purposes. In addition, SCDAG PIEROTTI's investigators have obtained two cards of known inked fingerprints from COELHO without the television producer's knowledge.

SCDAG JOHN PIEROTTI is respectfully requesting the following of the FBI Latent Fingerprint Section:

- 1. Determine if known inked impressions of RAUL COELHO's fingerprints exist in FBI civilian files.
- 2. Determine if photos of all latent prints recovered during the initial investigation of MARTIN LUTHER KING, JR.'s murder exist in FBI files.
- 3. Compare known inked fingerprints of COELHO obtained by PIEROTTI's investigators to all unidentified latent lifts recovered during the initial investigation of Dr. KING's murder, as well as to any known inked impressions, if they exist, in FBI files.
- 4. Compare known prints of COELHO, if they exist in FBI files, to the photographs of latent prints provided by SCDAG PIEROTTI's office.
- 5. Compare known prints of COELHO, if they exist in FBI files, to all unknown latent prints recovered during the initial investigation of Dr. KING's murder.
- 6. Compare the photographs of latent prints provided by SCDAG's office to all unknown latent prints recovered during the initial investigation of Dr. KING's murder.
- 7. The SCDAG's office also requests the FBI Latent Fingerprint Section to make any other comparisons that are deemed appropriate.

## Jowers vanishes, but his theory of King plot haunts legal system

He and his wife split up. Now, he can't be found.

A year after former Memphis businessman Loyd Jowers gained national attention by claiming he plotted with others in 1968 to assassinate Dr. Martin Luther King Jr. his life has been forever altered.

Yet, while the Jowers conspiracy theory has fallen from the media spotlight, it has not gone away.

A lawsuit in Shelby County Circuit Court continues to spawn hundreds of pages of testimony regarding the supposed conspiracy.

And attorneys claim they've located "Raoul," the shadowy figure named by convicted assassin James Earl Ray, who claims he was set up.

claims he was set up.

Now if they could just get someone to believe them.

"It's no hoax, as sure as I'm talking to you right now," said Jowers's lawyer, Memphis attorney Lewis Garrison, who said his client has gone so deep into hiding, he doesn't where he is. "But convincing someone is something else."

Among the chief critics is Dist. Atty. Gen. John Pierotti, who reluctantly opened an investigation last year into Jowers's claims.

"Oh, yeah?" a wry Pierotti asked Monday, when told of the Raoul development. Pierotti said his investigators have interviewed scores of witnesses while checking into Jowers's claims, and he doesn't have much faith in the new lead.

We've looked into every thing filey ve come ap with and found nothing to substantiate

Jowers, 68, created a stir in December 1993 when he told reporter Sam Donaldson on the ABC news program PrimeTime Live that he was paid "a large amount of money" by another Memphis businessman to have King shot.

Media attention in the ensuing weeks forced Pierotti to reopen the case that had been officially closed when Ray pleaded guilty in 1969

Until making his claim on national television, Jowers had been a footnote among the many books, films and investigative files exploring the assassination of King, who was shot in Memphis on April 4, 1968, on the balcony of the Lorraine Motel.

In 1968, Jowers owned Jim's Grill, a restaurant at 418 \$. Main below the boarding house from which Ray is believed to have fired the fatal shot Interviewed by police three days after the assassination, Jowers, then 41, said he heard a loud noise "like something that fell in the kitchen."

When he came out with his new story, reporters swarmed to rural Martin, Tenn., where Jowers had been living since 1991. The attention forced Jowers to move again, his attorney said, and now he's not even sure where his client is.

"He and his wife separated," Garrison said. "She just said. I can't live like this anymore."

But Garrison is not completely out of touch. He's defending Jowers in a \$46 million lawsuit brought by Ray last August.

The suit claims a man named

"Raon!" had Ray bring a rifle to Memphis supposedly to show to prospective gun buyers. The gun was not used to kill King, the suit says, but only to implicate Ray, whose fingerprints were on

In the Donaldson interview, Jowers said Ray was present when King was shot, but wasn't a knowing member of the conspiracy.

Garrison said plaintiff and defense attorneys have interviewed several witnesses under oath in deposition hearings, recording 500 to 700 pages of testimony, Ray's London attorney, William Pepper, declined to re-

lease the testimony transcripts.
One witness, a Texas woman,
"led us to Racul," Gerrison said.
He would provide few details,
but claimed investigators have a
photo of Racul, who's living in a
Northern state.

"He and his brother are from Brazil," Garrison added. "Their trade was gunrunning."

Pepper declined to discuss details, but spoke with equal enthusiasm.

"We're increasingly putting flesh on the bones," he said. "It's scandalous that the attorney general has not done a serious investigation of this."

As for Pierotti, he said he believes mysterious Raoul is a fictional, composite character created by Ray from several people who helped him avoid arrest for several months following the assassination:

But, Pierotti said, he'll be hap py to check it out.

"Just as long as they keep coming up with stuff, we'll look intg it," he said.

On 2/10/93, WARREN YOUNG, Shelby County District Attorney's Office, 201 Poplar, provided the following information:

During the recent filming of the HBO mock trial of JAMES EARL RAY, Shelby County District Attorney's Investigator JIM SMITH provided "testimony" that in 1968 he was employed as an officer with the Memphis Police Department. About the time of Dr. KING's assassination, he was assigned to pick up a Federal Agent named SMITH testified that Agent was sent to Memphis for the purpose of teaching illegal intelligence gathering methods to the Memphis Police Department. SMITH further testified that at the time Dr. KING was killed, there was a van containing Federal Agents outside the motel, and these Agents were conducting an illegal wiretap of Dr. KING's motel room.

YOUNG advised that he and District Attorney General PIEROTTI learned of SMITH's testimony yesterday following a visit from former USA W. HICKMAN EWING, who portrayed the prosecutor in this HBO film. General PIEROTTI was unaware that SMITH had been involved in the making of this movie, and did not know that he had testified. YOUNG stated he felt the FBI should be made aware of this matter given the allegations made concerning illegal wiretapping by Federal Agents. YOUNG was also concerned inasmuch as SMITH is currently assisting the Memphis Division with a pending IGB investigation, and might have access to FBI files regarding the JAMES EARL RAY case. YOUNG stated that SMITH has been very evasive concerning his exact involvement in this IGB case, and both YOUNG and PIEROTTI are concerned about how he is spending his working hours inasmuch as he apparently testified during normal working hours while indicating he was working with the FBI on this IGB matter. YOUNG indicated he anticipates an internal investigation will be initiated based upon the above information.
