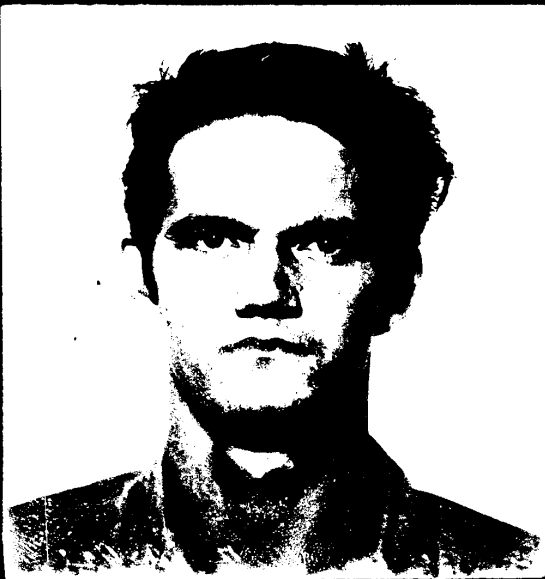

I did turn one photograph over as I thought I recognized this to be a local Memphis kid. I did not however recognize him as the person to whom I sold the Kinostillars.

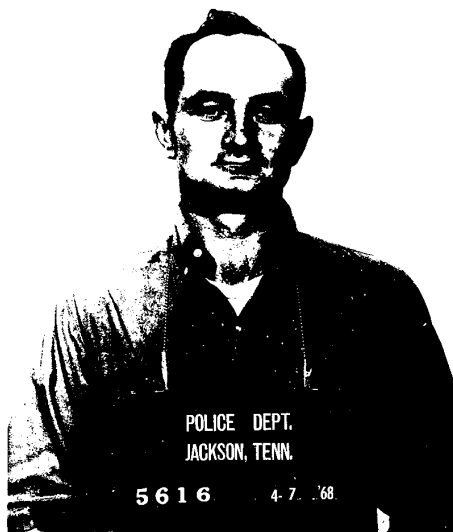
