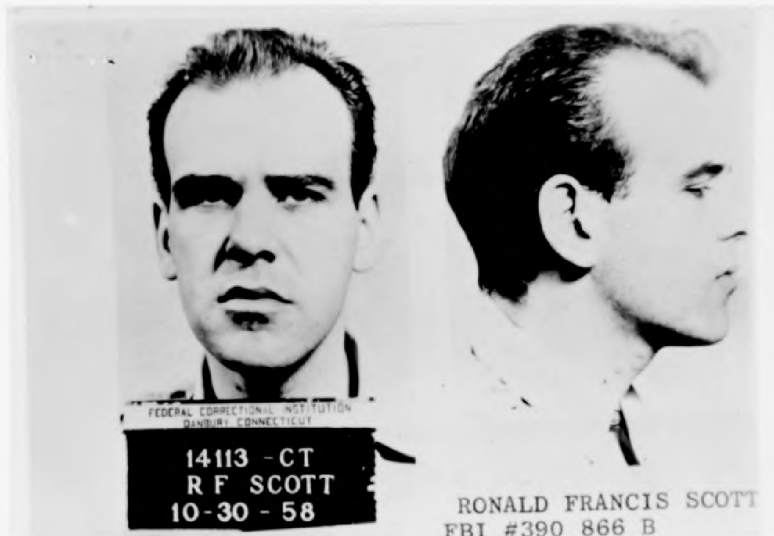

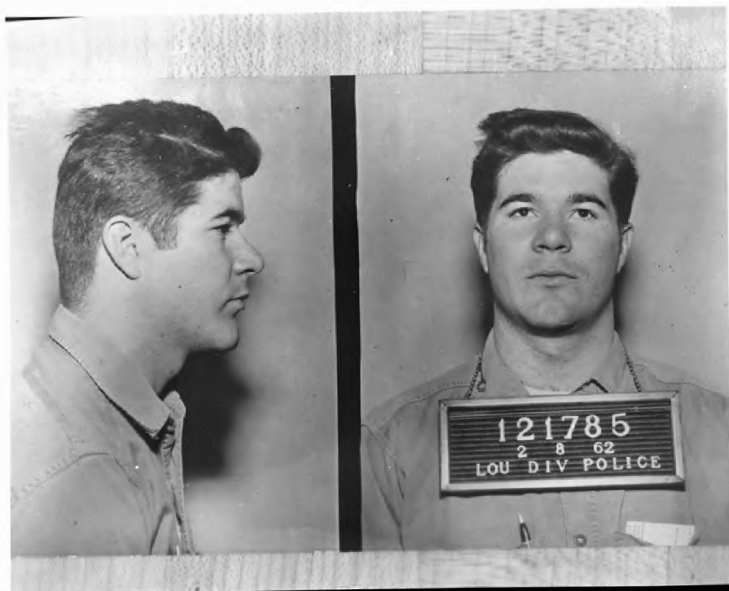

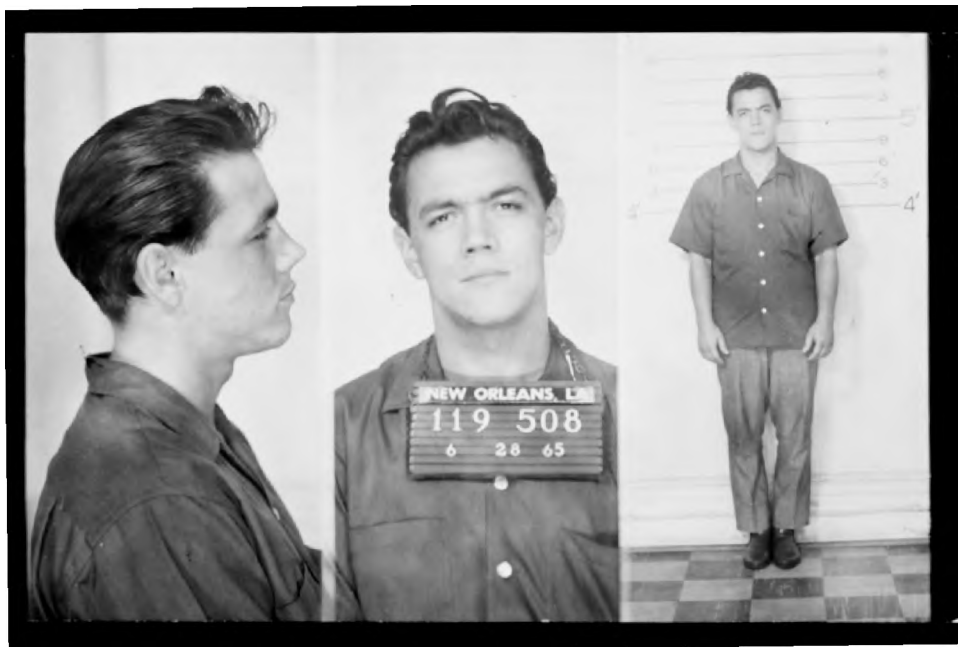

I have been concerned ever since I saw this man. I have believed him to be related to the crime and was quite surprised when the word was published that he was a dark suit.

Perhaps he did at the time of the assassination, but I saw a full face with sallow complexion. Wearing a cap with a plastic type top and work pants, reddish brown turn over shoes and I would say he is about 160 lbs maybe a few less, Height 5ft 10 or 8. I wrote all of this down the next morning after the murder.

I told my girl friend he
was probably going to
the Merchant Business
and I was surprised to
see this account in
the paper. This man
was walking north on
Coburn Creek Parkway
near Catharine St at about
7:15 A M. the day after
the murder. I definitely
saw this man.

He was teaching Wilding at the Johnson City Vocational school part time and working at Tenn. Eastman in Kingsport, Tenn. His name is "Curtis Neely", About 30, slightly dark complexioned, receding reddish hair near 6 ft. in height. He told her he was a Counter-agent for the "Communists", and she later reported this to the local F.B.I. She stated to me she recognized this profile drawing at once, but did not wish to become involved. He is a teacher in the Vocational education system of practical Nursing.

I worked for 34 years at the Post Office Dept. in Johnson City, Tenn., and am presently in the process of disability retirement.
