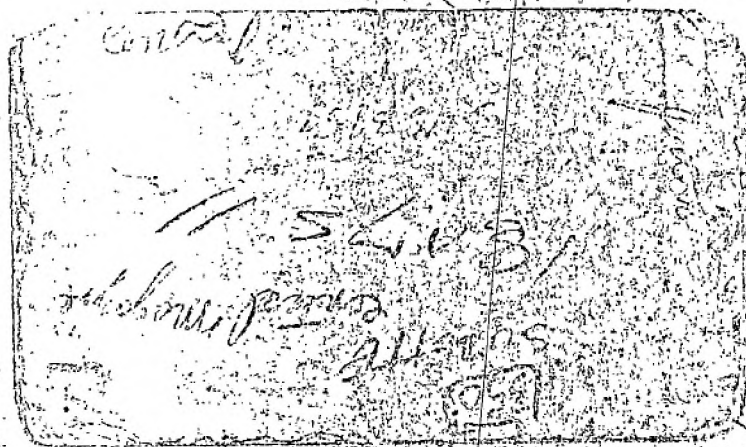

Dear Sir:

At approx. 11:00 PM 7-8-68 the undersigned made his relief at the County Jail to guard Charles Q. Stevens. After making the relief, Stevens stated that he would like to go downtown and drink a beer. Upon checking a cruiser out, we went to 325 S. Main, the Green Beetle, where Stevens drank two beers and while he was drinking his second beer, it was brought to my attention by the manager, that Jerry Ray, the brother to James Earl Ray was sitting at the bar. At this time I walked behind the bar and approached Mr. Ray and asked him if he would like to have another beer. At this time we started a conversation and he stated that he was James Earl Ray's brother and asked me if I thought that he was guilty and if they would ever bring him back to Memphis. I stated I did not know if he was guilty and I thought they would bring him back. He further stated that he and an older brother got into town earlier this afternoon and was attempting to find an office they could rent so they could set up a committee to get funds for the defense of his brother. He further stated that they were going to hire another lawyer from St. Louis, name unknown. Ray stated he and his older brother were staying at the Linden Lodge Motel, Room 210.

Upon further talking to Ray he stated that he had served approx. 8 yrs. in Mo. State Penn. for armed robbery and after getting out he was advised to change his name to Jerry [redacted]. Subject further stated the reason for changing his name was that he would be killed if people found out that he was a brother to James Earl Ray. Ray did not know that I was a policeman and I served him four beers. Upon contacting Chief Crumby, he stated if he was drunk to have a car pick him up after he left the place. Upon leaving, Cor 2, Ptlm. Bedford and Ptlm. Medford arrested Ray for Drunk. He was transported to HQ and given an intoximeter test which read .17. Upon checking at the Linden Lodge I found Mr. Ray was registered under Jerry N. John Ray, 1862 (st. unknown), St. Louis, Mo. A photostatic copy of his registration card at the Linden Lodge was made and also copies of all his personal papers in his billfold were made.

Charlie Stevens was taken back to the County Jail before Ray left the Beetle by two detectives.

DATE: July 9, 1968

At 8:00 A.M. this date we were notified by Chief Henry Lux that Jerry William Ray, WM, 32, 1902 Cherokee St., St. Louis, Missouri, had been arrested at 1:15 A.M. this date at Main and Vance on a charge of public drunkenness. We were further advised that he is a brother of James Earl Ray, alleged assassin of Dr. Martin Luther King, and that he was registered in the Linden Lodge, Room 210, with another brother, John Larry Ray, WM, 34.

At 9:00 A.M. this date Jerry Ray appeared in Div. II, City Court, before the Honorable Judge Bernie Weinman on the above listed charge. At that time Judge Weinman dismissed the charge against him. When this case was called, a white male in the court room was observed to appear interested in the case and after the case was dismissed, Lt. Holcomb identified himself to this white male and asked his name. He advised that he was John Ray, Jerry's brother. He was invited to Chief Inspector Wallace's office to be interviewed by Lt. Arkin and Lt. Holcomb and he readily agreed.

After reporting to this office, John was advised of the right to remain silent and was advised that he was not under arrest and could leave at any time during this interview or decline to answer any questions asked him. With this understanding, John readily agreed to cooperate with us and gave the following information:

He advised us that he and Jerry had arrived in Memphis at 6:00 P.M., July 8, 1968, and had checked into the Linden Lodge, Room 210, and had paid the rent for that night only. He said that they had come in his car, which is a 1963 Chrysler New Yorker, four door, white in color, bearing Mo. Lic. AE2-558, and the left rear bumper has a bumper sticker with the writing Ekeet Ray Mueller. Mr. Ray said that they had been talking to a newspaper reporter who is affiliated with the Chicago Daily News, by the name of Jerry Lipson. Mr. Lipson had advised he and Jerry that they could possibly come to Memphis or Birmingham and set up an office for the purpose of obtaining funds for an attorney to represent James Earl Ray. This reporter told him that he would handle all the publicity pertaining to this fund raising and John stated they were just looking Memphis over and might ~~rent~~ rent a room or an office while they were here. He further advised that he was either going to Birmingham or was going to call to see if James Earl's attorney is back from London yet.

The following personal history was obtained from John as to his family and background:

He is a white male, approximately 6 feet tall, 190 lbs., with black straight hair combed straight back with a part, receding hairline, ruddy complected. On his inside lower right arm are tattooed the initials J.R. and a blue tattoo is on top of the right lower arm. He advised that he was born [redacted] in Alton, Illinois, and is presently living at 1902 Cherokee St., St. Louis, Missouri, and is the owner of the Grapevine Tavern at 1982 Arsenal, St. Louis, Missouri. He also advised us that there were nine children in the family, but that two of them are deceased along with his mother. He advised his father's name is Gerald Ellis Ray, @Jerry, 68, of Rt. 17, Hannibal, Missouri. He advised that James Earl is the oldest child in the family; that he is next oldest and Jerry is next under him.

The following are the rest of the brothers and sisters:

Melba Marie [REDACTED], 29, Quincy, Illinois, address unknown, who is a mental case and draws a mental disability check from the government.

Carol Ann Pepper, 26 or 27, of 2025 Bellevue, Maplewood, Missouri, a suburb of St. Louis. She is the wife of Albert Pepper, a plumber.

Susan Jane (last name unknown), 21, married, and residing in Chicago, Illinois. John advised the FBI knows her whereabouts, but will not tell him.

We then interviewed Jerry at the same place in the presence of John and advised him that his drunk charge had been dismissed in court and advised of his constitutional rights as to questions and was advised that he could leave if he wanted to or answer our questions if he wanted to. Jerry appears to be an alcoholic and could never could give us a legitimate reason for being in Memphis except he thought James Earl may come back to Memphis early and wanted to see him if he did. He further advised that he was leaving here and going to Knoxville, Tennessee, and then he changed that to Whitesburg, Tennessee, to visit his six year old son by a prior marriage, Michael Eugene Ray, who is staying with his ex-wife's parents. Her name is Carol Dean (last name unknown), 27, and lives in Morristown, Tennessee.

Jerry advised that he is unemployed and at large, but is presently staying with John. He advised he has a 1960 model DeSoto, white/light green, bearing Illinois license, that he left at John's house in St. Louis.

Jerry also is approximately 6 feet, 190 lbs., with black receding hair, combed back straight. He is ruddy complected and rough in appearance. Jerry advised he was born in Quincy, Illinois, [REDACTED], and he has the initials J.R. tattooed on top of his lower left arm and a blue tattoo on top of his right lower arm.

Investigation of his personal property disclosed his Army classification card, Social Security card, and Illinois driver's license bearing the name Jerry William [REDACTED]. He stated the reason for this was that he had no birth certificate and in 1943 he registered for the draft under this name, but could give no reason for doing this. He further advised he had a Post Office rental box in Wheeling, Illinois.

When Jerry was arrested last night, all his personal papers were photostated and during this interview he was asked about each one of them. All pertinent information was noted on the copies and the copies are to become a part of this file.

John and Jerry have checked out of the Linden Lodge and they were asked to call this office when they found another place to stay and to keep in contact with us during their stay in Memphis. They stated they would do this.

NOTE: John Larry Ray has a bad speech impediment and appears to be tongue tied.

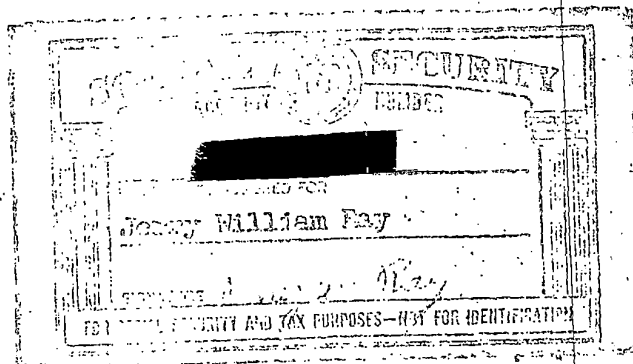

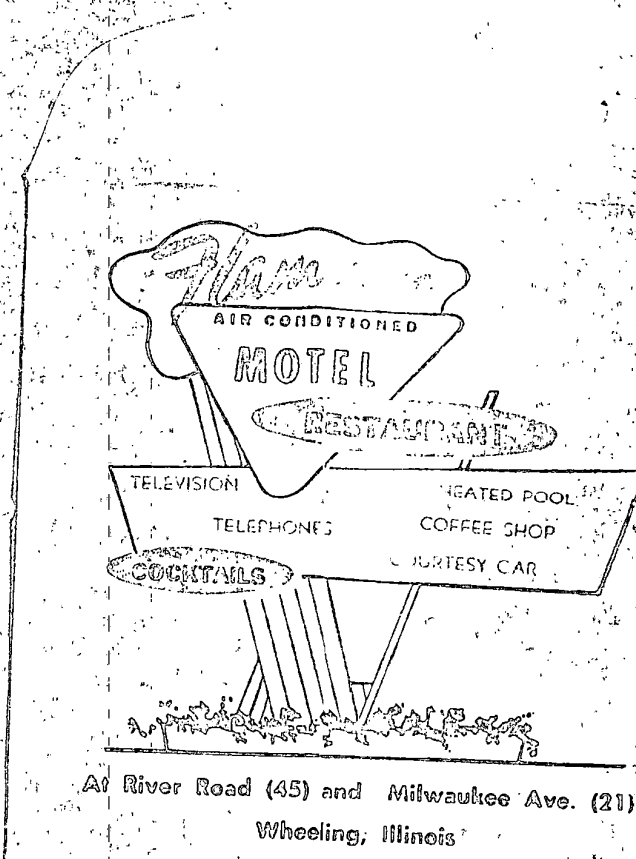
