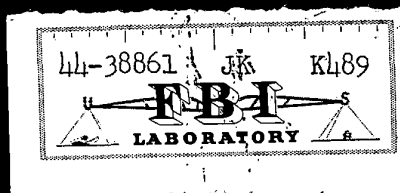
Dear Judge;
