On 5/6/68, the manager of the Aurora-Midway Branch of the People's National Bank of Washington, telephonically advised that it had come to his attention that a check had been issued to a Mrs. EARL RAY by a Mrs. ROGER L. MILLER of 19724 80th West, Edmonds, Washington.

The manager reported this check had been cashed at the Liberty Supermarket, Memphis, Tennessee, and under the endorsement appeared the numbers "743-9797" which he thought might be a telephone number.

SA JOHN E. CONNOR checked the records of the Seattle Credit Bureau and the Edmonds Police Department and found both to be negative concerning Mrs. ROGER L. MILLER also known as KATHERYN MILLER, 19274 80th West, Edmonds, Washington.

SA CONNOR determined that the records of the Credit Bureau of Snohomish County, Everett, show that the MILLERS have been listed since January, 1965, coming to the Edmonds area from Seattle. Mr. MILLER was listed as a driver for Darigold Farms. His wife, KATHERYN MILLER, and Mr. MILLER had previously been employed by Muffler City in Seattle having lived in the Seattle area since at least 1958. The credit record was satisfactory.

While in Garfield's Barber Shop, Sanford, Florida, an unknown white male, possibly identical with subject JAMES EARL RAY, was also in the barber shop. This individual claimed to be a taxi driver for the Yellow Cab Company of Sanford, Florida.

Mr. FLEMING believed this individual closely resembled the photograph and description of RAY as appearing in the local press.

A next door neighbor of the MILLERS, one Mrs. JAMES FARMER, 19730 80th Place West, Edmonds, advised that Mr. and Mrs. MILLER and their teenage daughter live next door; that both Mr. and Mrs. MILLER work in Seattle; and that one is a native of the Seattle area and the other a native of the Memphis, Tennessee area and still has relatives in that area.

On the evening of 5/6/68, Mr. and Mrs. ROGER L. MILLER, 19724 80th West, Edmonds, Washington, advised that Mrs. MILLER comes from Memphis, Tennessee, originally and that her sister, MELVA, has been married to EARL RAY for approximately the past 11 years and that they presently reside at 2680 Frisco Street in Memphis, Tennessee, with their two children.

The MILLERS advised that RAY is approximately 38 years of age, a white male, 5'6" in height; 140 pounds in weight; and has coal black hair. They said he has lived in the Memphis area all his life to the best of their knowledge and that he has been employed in iron work and in a battery shop there. They said he was previously in the military service and has never been in prison to their knowledge. The MILLERS said that EARL and his wife have lived in Memphis ever since they were married and his mother still lives next door. The MILLERS said that EARL's father died approximately one year ago and that he has sisters and brothers in the same area.

Mrs. MILLER stated that as soon as she and her husband read in the newspaper the identity of the suspect in the KING killing, they thought of the name of Mrs. MILLER'S brother-in-law; and having known of his whereabouts and activities of the past 11 years and knowing what he looked like, realized that this was only a similarity in names. The MILLERS concluded that to their knowledge, Mrs. MILLER'S brother-in-law's relatives are all in the Memphis area and they were in no way connected with or related to the person charged in the KING killing.

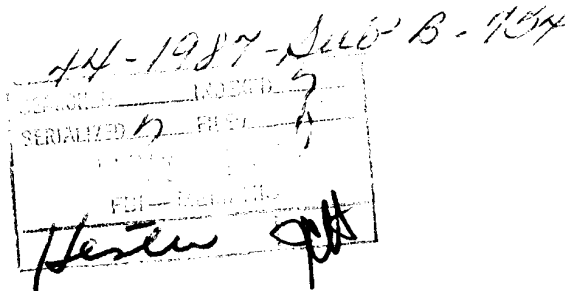

Re: LATENT FINGERPRINT EXAMINATIONS  
BY LOCAL POLICE DEPARTMENTS

All of the law enforcement agencies in the San Francisco territory were contacted and requested to conduct a comparison of unidentified latent prints in their files with the fingerprints of JAMES EARL RAY.

All of these agencies, except those listed on page 2, advised their departments do not maintain a separate file of unidentified latent prints. They advised their usual procedure is to file the unidentified latent prints in the appropriate case file without duplication in a centralized file. These departments advised that new unidentified latent prints developed in current cases would be checked against RAY's prints; however, the unidentified latent prints now filed in the case file are not subject to ready examination and the requested examination and comparison of all old latent prints with RAY's would be beyond the capability of their departments.

The below listed law enforcement agencies who maintain a latent fingerprint section, on the date indicated, advised no latent print identifiable with RAY was located or that their review was continuing and the San Francisco Office would be notified if an "ident" was made.

Enclosed for the FBI Lab is one registration card of the Woodland Motor Court in name RICHARD B. MC GINNIS.

Local Thomasville, Georgia tourist court operator HARRY G. WICK initially contacted Thomasville Resident Agency 4/15/68, and advised a suspicious white male checked into his tourist court, the Woodland Motor Court, Thomasville, on 4/5/68 about 1:00 A.M. and departed following morning. White male driving 1966 white Ford Mustang bearing 1967 or 1968 Texas license PBG-848. White male described as about 32 years of age; 5'8", 160 pounds; muscular build and broad shoulders; sandy-colored hair. Subject's personal belongings only consisted of shaving kit and he left the following morning wearing the same clothes worn at time of entry. During registration this individual was very nervous and in attempting to reach assigned cabin, drove over sidewalk of motor court. Registrant did not appear to have been drinking, however.

WICK was subsequently shown Wanted Flyer of JAMES EARL RAY. WICK advised photo closely resembles suspicious person but is certain registrant had light-colored, sandy hair and that this was his natural-colored hair inasmuch as approximately one day's growth of beard was the same color.

Re Milwaukee airtel to the Director dated 5/13/68.

Referenced airtel requested investigation of Chicago and Memphis based upon the theft of credit cards from MARSHALL I. GOLDMAN, Aurora, Illinois, who was assaulted by three white males at Madison, Wisconsin, on 2/27/68, in view of a possible tie in this case because of phone calls made to and originating from Memphis, Tennessee, around 4/4/68.

Review of the airtel places the assailants in Madison, Wisconsin, on 2/27/68, in Chicago, Illinois, on 3/8 and 3/11/68 and 4/3/68. In addition, phone calls were made from Booneville, Mississippi, and Baldwin, Mississippi, on 3/29 and 3/31/68. In view of the fact that the subject was known to be in Los Angeles at the St. Francis Hotel from 1/23 to 3/17/68 and that he purchased the murder in Birmingham, Alabama, on 2/28-30/68 plus the fact that a call was made from Chicago, Illinois, on 4/3/68, it was known that the subject was registered in the hotel in Memphis, Tennessee, it appears to this office that the assailants of GOLDMAN and/or the individuals who stole his credit cards could not logically be identified as the subject and the requested investigation will not be conducted. SACB.

Since we have no reason to believe, in the first place, that the subject ever had a wife, Seattle should not conduct an extensive investigation or waste a large amount of manpower in identifying **BESS RAY**.

No investigation is requested of Anchorage until such time as Seattle further identifies **BESS RAY**.
