FOR INFORMATION OF MEM PHIS, THE TAMPA TEL RELATIVE TO THOROMAN INDICATED THAT ONE EDGAR HARRY HUBER (PROTECT IDENTITY) OF ORLANDO, FLA., HAD SEEN AN ARTIST'S CONCEPTION OF KING'S SLAYER. HUBER INDICATED THE LEFT PROFILE OF THIS CONCEPTION RESEMBLED THOMAS THOROMAN, BUT THE RIGHT PROFILE HAD NO RESEMBLANCE. Miss SHERRY WINSLETT advised she resides at 10146 Hartford Court, Schiller Park, Illinois, telephone 678-4773. She advised she is employed as an airline stewardess for Delta Airlines. On April 5, 1968, she was a stewardess on Delta Flight 649, which originates at Atlanta and then goes to Augusta and to Savannah. During the flight from Atlanta to Augusta, luncheon is served on the plane and she and one of the stewardesses have to serve all the passengers on the plane in 35 minutes. The flight from Augusta to Savannah takes less than 30 minutes. She does not recall any individuals on this flight and specifically does not recall any individual described as a white male, age 28, to 32, weight 160 pounds, pale skin, hooked nose, hair thin on sides, thin on top, wearing a black half turtle-neck jersey shirt and black trench coat. Miss WINSLETT stated that there was another stewardess on this flight the name of whom she cannot recall who was stationed in Atlanta.

She stated that should she recall any information regarding the above individual, she would notify the FBI in Chicago.

BILLY D. MC GRIFF, 1342 Plantation Road, Jackson, Mississippi, was interviewed by MICHAEL BARON and WILLIAM E. DOYLE, who identified themselves as Special Agents of the FBI. He was interviewed at the Travel Lodge Motel, Baton Rouge, Louisiana.

MC GRIFF was told of his rights as they appeared on an Interrogation; Advice of Rights form, and he stated he understood his rights and that it would not be necessary for him to sign.

Mr. MC GRIFF advised he could furnish no information regarding the slaying of the Reverend MARTIN LUTHER KING and that he was not in anyway involved in the slaying.

He stated that on April 5, 1968, he was at the headquarters of the L. E. Myers Company, Sardis, Mississippi, with a group of men, including his supervisor, EARL FORTENBERRY. He advised that the group was talking about the slaying of Reverend KING and at that time he mentioned that he was in the Memphis, Tennessee area at the time of the slaying. He advised that he did not know exactly the comments that were made regarding the slaying of Reverend KING, but that he definitely was not involved nor could he furnish any information regarding the slaying of the Reverend KING.

Mr. MC GRIFF stated that on April 4, 1968, he was employed by the L. E. Myers Company, a contractor for the Mississippi Power and Light Company, Sardis, Mississippi. The job was rained out for that day and he and VAN SULLIVAN, Mize, Mississippi, a co-employee, took a ride to Memphis, Tennessee, as there was nothing else to do. He advised they made one stop in Memphis, at a Walgreens Drug Store to purchase some sunglasses. He advised that he was quite sure that they had returned back to the State of Mississippi at the time of the slaying as they heard news of the slaying on the car radio.

MC GRIFF stated that he definitely was not in Birmingham, Alabama, during March 29-30, 1968. He advised that he had been employed continuously since December 15, 1967.
