ADVISED AFTER VIEWING PHOTOGRAPH OF RAY THAT HE WAS NOT IDENTICAL WITH PERSON TO WHOM SHE RENTED APARTMENT. SCHWARZAUER STATED THAT IN OCTOBER, SIXTYSEVEN, SHE RENTED A TWO-ROOM APARTMENT AT SIX ZERO SIX CHURCH STREET, COLUMBIA, MISSISSIPPI, TO A YOUNG MAN WHO GAVE HIS NAME AS EARL WILLIAM RAY. THIS INDIVIDUAL ADVISED HER THAT HE WAS GETTING MARRIED AND WOULD BRING HIS WIFE TO LIVE IN THE APARTMENT WITH HIM. EARL WILLIAM RAY WAS A YOUNG MAN. SCHWARZAUER RELATED RAY ONLY OCCUPIED THE APARTMENT FOR ONE NIGHT AND THEN LEFT. SHE STATED RAY WAS UNKNOWN TO HER AND THAT SHE HAS NOT SEEN HIM SINCE OCTOBER, SIXTY SEVEN, WHEN HE RENTED THE APARTMENT. SCHWARZAUER STATED THAT UPON SEEING PHOTOGRAPH OF JAMES EARL RAY ON T. V. IN PRESENCE OF HER SISTER AND HER MAID, GUSSIE MINGO, SHE JOKINGLY REMARKED THAT THIS MUST BE THE INDIVIDUAL TO WHOM SHE RENTED HER APARTMENT. SCHWARZAUER STATED THAT THE INDIVIDUAL WHO RENTED HER APARTMENT BEARS NO RESEMBLANCE TO JAMES EARL RAY AND IS NOT SAME PERSON. SHE STATED THAT SINCE APARTMENT WAS VACATED BY EARL WILLIAM RAY, SHE HAS HAD IT COMPLETELY REDECORATED THROUGHOUT.

VINCENT BURNELL, FOREMAN, ROTO PRINT COMPANY, HAS ADVISED MEDIZER HAS SSN [REDACTED]

[REDACTED], WAS SHOP WORKER. MEDIZER FREQUENTLY BRAGGED TO COWORKERS ABOUT HIS NAZI PARTY ACTIVITIES AND DISPLAYED LITERATURE AND OTHER NAZI ITEMS. ON MARCH TWENTY, SIXTY EIGHT MEDIZER ADVISED HE WAS QUITTING JOB TO WORK FOR NAZIS IN ARGENTINA, REPORTEDLY ON "FORCED PASSPORT." HE INDICATED HE FIRST WOULD VISIT FRIENDS IN DALLAS.

MEDIZER ALSO DURING EMPLOYMENT MADE VAGUE THREATS AGAINST MARTIN LUTHER KING AND THAT HE WOULD "TAKE CARE OF HIM."

SUBSEQUENTLY MEDIZER PICKED UP PAYCHECK ON MARCH TWENTY NINE, SIXTY EIGHT, STATED HIS PRESENT PLANS INCLUDED A VISIT TO ST. LOUIS, MISSOURI, THEN TRIP TO WASHINGTON, D.C. AREA WHERE HE WOULD DISCUSS HIS PLANS WITH MAJOR KOEHL /MATT KOEHL OF NSWPP/ AT ARLINGTON AND DO WHAT EVER "THE MAJOR" WANTED HIM TO DO.

Re Chicago teletypes to Bureau dated 4/25 and 5/2/68, Dallas teletype to Bureau dated 4/26/68, and Springfield teletype to Chicago and Dallas dated 5/2/68.

A summary of investigation conducted at Dallas is set out as follows:

On 5/6/68, JOHN C. MEDIKER was located at his place of employment, the Texas Enneplate Company, 1900 S. Ervay Street, Dallas. Records of that company as furnished by Mrs. MARGARET ROSE, Personnel Department, reflected that MEDIKER had been employed by that company as a printer since 4/18/68, with his residence shown as 5505 East R.L. Thornton Expressway, Dallas. Personnel records of the above company also reflected that MEDIKER sustained an injury while on duty on 4/22/68, and at that time he gave the above address.

On 5/6/68, MEDIKER was interviewed at the Texas Enneplate Company and stated that he left Chicago, Illinois, on 3/31/68, by way of Greyhound Bus, directly to Dallas, Texas, with an approximate 2-hour layover at St. Louis, Missouri, on the same date. He stated that he arrived Dallas early on the morning of 4/1/68, and immediately contacted a friend of his

by the name of EDDIE CHAMFIELD, who lives at 3506 East N. L. Thornton Freeway. MEDIKER stated that before leaving Chicago he lived at 4801 Belmont and worked for the Metz-Print Company. He stated that while in Chicago he was a member of the American Nazi Party (ANP) and plans to continue his membership with the ANP by paying his dues to the ANP headquarters in Arlington, Virginia. MEDIKER further stated that he does not plan to contact any of the ANP members in Dallas, Texas, since he is becoming inactive in the ANP inasmuch as he is getting married shortly to a Dallas girl by the name of CHARLENE HARRIS, who works at the Coca Cola Bottling Company, Dallas, Texas.

MEDIKER then stated that on 4/1/68, he obtained a construction job through his friend, EDDIE CHAMFIELD, with the Leroy Roberts Construction Company, 4031 Mission Street, Dallas, Texas. He stated that he worked continuously at this construction company with EDDIE CHAMFIELD until approximately 4/12/68, at which time he left that company because he did not like construction work. MEDIKER stated that he then began working for the Texas Nameplate Company on 4/18/68, and has been so employed to the present date.

MEDIKER then stated that in regard to the murder of MARTIN LUTHER KING, JR., he does not recall ever making any threats against the life of KING, however, since he is a member of the ANP, he does not agree at all with the policies followed by KING or his successors. He stated, however, that as a member of the ANP he does not believe in violence and the present policy of the ANP is against physical violence.

MEDIKER is described as white male; born [redacted], at Chicago, Illinois; 5'10"; 145 pounds, Selective Service No. [redacted] (Classified as 1-A with the Denton, Illinois Selective Service Board); blue eyes, blond hair.

MEDIKER stated that since he is getting married in the near future, he plans to stay in the Dallas area and purchase a home and become inactive in the ANP.

He further stated that Mr. LEROY ROBERTS or his foreman, BILL DAVIDSON, could vouch for his whereabouts from 4/1 to 12/68.

On 5/8/68, Mr. BILL DAVIDSON, Foreman with the Leroy Roberts Construction Company (supra), advised SA JAMES V. ANDERTON that his payroll records reflect that JOHN C. MEDIKER was employed

by that company as a fork lift operator (assistant) from 4/1/68 through 4/12/68. Mr. DAVIDSON stated that in addition to his pay roll records he recalls MEDIKER working during that period with his friend, EDDIE CHAFFIELD.

SCHNEIDER'S WIFE INTERVIEWED AND CONFIRMED HE DRINKS TO EXCESS. SHE RECALLED SCHNEIDER'S TELEPHONE CALL TO POLICE ONE NIGHT WHEN HE WAS DRUNK. SHE HAS NO REASON TO BELIEVE THAT IF HE MADE THREAT, THAT HE EVER INTENDED TO CARRY IT THROUGH.

NEIGHBORHOOD INVESTIGATION INDICATED SCHNEIDER AND FAMILY HAVE EXCELLENT REPUTATION IN COMMUNITY. NO ARREST RECORD OF SCHNEIDER CHICAGO.

HEGELSON stated that the Bureau wants all pertinent background developed on BILLINGS and an interview of him conducted as soon as possible with results to the Bureau, Memphis, and other interested offices. If interviewed in the past he must be reinterviewed concerning the above allegation and full details obtained about that statement by him. Investigation must be started on 4/25/68 and given immediate attention plus expeditious handling.

On 4/25/68, Baltimore telephonically contacted the Little Rock Office and was advised that BILLINGS had been sentenced in USDC, Little Rock, 11/21/67, on a guilty plea to 5 years on one charge and 5 years on 3 other charges to run concurrent. He was transferred on 11/29/67 to the U. S. Penitentiary at Leavenworth.

For information of Kansas City, in connection with the allegation made by BILLINGS, Charlotte by teletype to Bureau, 3/30/65, advised that the Chief Deputy and Secretary of the Sheriff's Office, Sanford, N. C., had no knowledge of any incident near Sanford about 3/4/65 wherein an officer was disarmed by a man with a machine gun or other weapon. Both stated they were sure they would have heard of such an incident in that area.

Savannah by teletype to the Bureau, 3/30/65, furnished the following:

"BUSTER" LEWIS may be identical with DAVID DELANE/LEWIS, aka Buster, ITSMV, Bufile 26-237966, FBI #263964C. LEWIS, 4/14/59, in USDC, EDVA, sentenced one year and one day custody USAG to run concurrently with four years sentence he was serving in Federal Reformatory, Petersburg, Va. On 8/5/58, he had been sentenced in USDC, Columbia, S. C., on two counts for violation Section 2312, Title 18, U. S. Code, and received sentence of four years each to run concurrently. No current information in Savannah files concerning him.

JERRY BARBER may be identical to JERRY DON BARBEE, aka JERRY BARBER, FBI #885195B, who is the subject of Savannah file "JERRY DON BARBEE, aka - Fugitive. UPAP - GL," OO: SAVANNAH, Bufile 88-32105, Philadelphia file 88-4908. BARBEE was arrested lower Marion, Pa., and released on \$500 bond, 12/3/64. His present whereabouts are unknown. Philadelphia has photo of BARBEE which was sent by Savannah 12/30/64.

Savannah indices negative on IRVING BARBER and JUNE TAYLOR. It is noted that there is a lounge bar on Lady Street, Columbia, S. C.

## FEDERAL BUREAU OF INVESTIGATION

MELVIN LEMONS, Secretary to the Director, Medical Center for Federal Prisoners, Springfield, Missouri, advised CARLOS LEE BILLINGS, FBI # 368794A, is at the Medical Center for psychiatric treatment with the long-term goal of an eventual return to the U. S. Penitentiary at Leavenworth, Kansas.

He stated on April 2, 1968, the Medical Center directed a letter to the U. S. Probation Office at Little Rock, Arkansas, stating that although BILLINGS now appears to be competent, several months ago he was too psychiatrically disturbed to participate in any court here. A plan is to examine him again in a month to determine whether or not he is competent to participate in legal proceedings.

LEMONS stated that while BILLINGS was at the Medical Center on a previous occasion a psychiatric report prepared April 17, 1967, by Dr. ANDREW P. GUSCHWAN, M.D., Staff Psychiatrist, contained the following diagnosis:

"Schizophrenic Reaction, chronic undifferentiated type, sociopathic personality disturbance, anti-social type, migraine headaches, with possible brain damage."

CARLOS LEE BILLINGS, inmate, Medical Center for Federal Prisoners, Springfield, Missouri, was advised of the identity of JAMES A. MITCHELL as a Special Agent of the Federal Bureau of Investigation. He was told the purpose of the interview concerned a report he had made sometime ago to the FBI that he had been offered \$50,000. to kill MARTIN LUTHER KING by two individuals identified only as JAMES and EDDIE. This took place in Columbia, South Carolina, in about March, 1965. He was furnished a warning and waiver form, which he read and executed. He then furnished the following oral information:

In early 1965, in Columbia, South Carolina, he met a soldier stationed at Fort Jackson, South Carolina, who was to be discharged within a few days. His name was JIM or GLENN BARBER, but he is not sure of the first name or the spelling of the last name. He had just returned from Panama, and he believes he held the rank of Corporal. BARBER had marijuana and pep pills in his possession and was a very convincing talker. BARBER had met a female in Columbia named JOHNNIE BLACKWELL. She worked as a waitress at a lounge he believes was called the "Downtown," located near Chubby's Steak House in Columbia. She was from a little town twenty miles south of Columbia, name unknown. BLACKWELL roomed with a girl named JUNE TAYLOR, somewhere on Bull Street in Columbia. Both girls were prostitutes, and BILLINGS lived part of the time with TAYLOR. TAYLOR worked at a night club there called the "Red Rooster."

BLACKWELL had met two men known as JAMES and EDDIE and had filled a prostitution date with JAMES for \$50. The initial meeting took place in some club, name unknown, located near Chubby's Steak House, possibly the "Downtown." BLACKWELL told JIM she had to leave because she had a date with a soldier from Fort Jackson, South Carolina, named BARBER. JAMES asked her to ask BARBER if he could get ahold of any weapons, whereupon she told him BARBER had a machine gun.

JAMES expressed an interest in buying it from BARBER and told her to pass this on to him, which she agreed to do. The prostitution date was filled in a motel in town, name unknown.

The following night, at the V.F.W., he, JAMES, EDDY and BARBER met. TAYLOR and BLACKWELL were present, as well as two other girls who worked at the "Red Rooster," but this was their night off. He does not recall their names. This was the first time he had met JAMES and EDDY. The men went outside and BARBER gave them each a stick of marijuana which he had brought back from Panama. They all sat in JAMES's white 1964-65 Lincoln Continental and smoked marijuana. The Lincoln had a Tennessee license plate *Sm 1 fine* beginning with the number 2, which designates Memphis. JAMES was always smoking big cigars and wore a large diamond ring. He understood JAMES has money in Mississippi and Tennessee. He owns land in Clarksdale, Mississippi, has a big car lot in Memphis and a night club. In the old days he was a bootlegger. JAMES despises the Negro race and, particularly, any with Communist leanings.

While in the car, JAMES told BARBER he understood he had a .50-caliber machine gun and BARBER said he did. JAMES asked if he wanted to sell it and he said, "Yes." Either JAMES or EDDIE asked where the machine gun was and how long it would take to get it. BARBER said three days because it was in Westwego, Louisiana, in care of a friend who ran a night club, The Canal Bank Inn. He never heard this man's name. JAMES or EDDIE asked BARBER if he had any ammunition for it, and he said he had a whole belt. One of the men then offered him a thousand dollars for the machine gun.

They all met again the next night at the largest drive-in restaurant in Columbia, name unrecalled. JAMES or EDDIE asked him if he had ever used the machine gun before, and he said he used one while in military service. It was agreed that BILLINGS would take BARBER to Westwego, Louisiana, which is on the west bank of New Orleans, to get the machine gun. They were to meet JAMES and EDDIE on a certain unrecalled date in Columbia and collect \$1,000. for the machine gun. The meet was to be at some unrecalled motel. BILLINGS stated he has trouble remembering things that happened this long ago.

He drove BARBER to get the machine gun at the Canal Bank Inn, and BARBER contacted some man outside of his presence who reportedly told him the weapon had not arrived. He and BARBER stayed in an apartment house at the rear of the Canal Bank Inn for two days waiting for the weapon to arrive, but it never did. He became irritated with BARBER and then felt BARBER never had such a weapon. BILLINGS returned alone to Columbia, South Carolina, and he understood BARBER was going to his home in Fort Myers, Florida. BARBER's parents reportedly lived in and operated a trailer park at Fort Myers. BILLINGS stated that at the time all this was going on he had and was driving a 1959 Chevrolet convertible, maroon in color, bearing a Maryland Temporary Tag. He bought the car under his true name from Luby's Chevrolet in Baltimore, Maryland.

Upon his return to Columbia he met with JAMES and EDDIE and informed them he did not get the weapon. He was told the plan was for him and BARBER to kill MARTIN LUTHER KING for \$50,000. \$5,000. was to be in advance, with the remaining \$45,000. to be paid to them in Greenville, South Carolina. JAMES said KING had to be "wiped out" because J. EDGAR HOOVER had reported KING to be a confirmed Communist and the most notorious liar of our day. The killing was to take place along a scheduled march from Selma, Alabama, to Montgomery, Alabama. The machine gun was to be placed in the back of a paneled truck and driven to a spot on the Selma-to-Montgomery route. When the front line of marchers, including Dr. KING, approached the spot, the rear doors of the truck would be opened and the marchers machine-gunned. The truck was to come from some other state and purchased legally in the name of a deceased person. They would then drive the paneled truck away from the line of march to a country road where a passenger car would be parked. The truck would be abandoned and then they would travel into Montgomery, Alabama, by a devious back-roads route. They would then travel to Greenville, South Carolina, where they would meet JAMES and EDDIE. JAMES would tell them how to get to Sydney, Australia, via Mexico, on a freighter.

JAMES has a friend who formerly lived in Mississippi but now has a sheep ranch in Broken Bow, Australia. This man would help set them up in a bar or some other type of legitimate business.

When he told JAMES and EDDIE that BARBER could not produce the machine gun, they said the plan had been dropped because MARTIN LUTHER KING announced he was not going to participate in the march.

He described JAMES as white male American, age 40; 5 feet, 10 inches; 210 pounds; blue eyes; brown hair, graying on the sides. JAMES lives on a farm eight miles from Memphis, in Mississippi.

EDDIE described as white male American; 6 feet, 1 inch; 180 pounds; brown hair; age 38, good dresser, residence Memphis, Tennessee.

BARBER described white male American, 22; 5 feet, 8 inches; 170 pounds; black hair; husky build, and good looking. He believes BARBER a psychiatric case and believes this was the reason he was discharged from the military.

He has seen JAMES and EDDIE since the above incident; however, he is not going to say more unless the Government dismisses an Interstate Transportation of Stolen Motor Vehicle charge against him. He has two detainers against him, and one is a State detainer. The federal detainer is from U. S. District Court, Montgomery, Alabama, and this detainer prevents him from making parole. He is eligible for parole on his current 5-year sentence in September 1968. He might get a parole to a State detainer, but parole would not be favorably acted upon with a federal detainer on file. If this detainer were removed he would furnish the full names of JAMES and EDDIE and where they could be located, in addition to subsequent contacts he has had with these men. He was told that no promises of any kind could be made in this regard.

A photograph of JAMES EARLY RAY, FBI # 306443A, taken at the Missouri Department of Corrections, Jefferson City, Missouri, on March 17, 1960, was shown to BILLINGS. and he stated that he does not know this individual either by name or photograph.

BILLINGS admitted he was at the Medical Center for psychiatric treatment. He has a writ in federal court under the provisions of Title 18, Section 2255, U. S. Code,

trying to get his original Interstate Transportation of Stolen Motor Vehicle conviction set aside on the grounds he was incompetent at the time. He was at the U. S. Penitentiary at Leavenworth, Kansas, but was recently transferred to the Medical Center because he has been seeing a red man with a green coat and alligator shoes. This red man is responsible for all his troubles. He is not visible to him now, but he does see him when he is alone, but not since he arrived here in February 1968.
