ROBERTSON BRINKER, SIX ONE ROSLYN, GROSSE POINTE SHORES, MICH. ADVISED HE HOLDS A T&T CREDIT CARD NUMBER [REDACTED]

[REDACTED] WHICH IS MADE OUT TO ROBERTSON BRINKER. THE RIDDELL CATERING COMPANY DOES NOT HAVE A PHONE AND THERE IS NO CREDIT CARD IN THE NAME OF THAT COMPANY OR IN THE NAME OF RIDDELL.

ROBERTSON BRINKER SAID NEITHER HE NOR ANYONE ELSE HAS USED HIS TELEPHONE CREDIT CARD FOR ANY PHONE CALLS FROM MEMPHIS. HE IS NOT ACQUAINTED WITH FRANK OR ROBERT BRICKLEY AND HE COULD NOT EXPLAIN HOW THE INFORMANT COULD BE FAMILIAR WITH HIS POSSESSING A TELEPHONE CREDIT CARD OR WITH HIS CONNECTION TO THE RIDDELL CATERING

H.V. BRINKER, ROBERTSON'S FATHER, ADVISED THAT WHILE HE WAS IN BOCA RATON, FLORIDA FROM MARCH ONE THROUGH APRIL ONE LAST, HE TRADED AT A SUNOCO SERVICE STATION AT THE CORNER OF U.S. ONE AND PALM AIRE, BOCA RATON, FLORIDA. HE WAS IMPRESSED WITH THE EFFICIENCY OF A YOUNG WHITE MALE AT THE STATION. THE YOUNG MAN TOLD HIM HE HAD A BROTHER IN CLEVELAND IN THE TAILORING BUSINESS AND THAT HE WOULD LIKE TO MOVE BACK TO THE MIDWEST TO BE NEAR HIS BROTHER. MR BRINKER TOLD THE YOUNG MAN HE RAN A CATERING SERVICE FOR U.S. RUBBER IN DETROIT AND SHOULD HE EVER WANT A JOB TO CALL HIM OR HIS SON ROBERT. HE GAVE THE YOUNG MAN ONE OF HIS BUSINESS CARDS WHICH READS, "RIDDELL FACTORY CATERING COMPANY, INDUSTRIAL CATERERS". HE COULD NOT REMEMBER IF HE WROTE ROBERT'S NAME ON THE CARD FOR THE BOY BUT WAS SURE HE TOLD HIM ROBERT'S NAME AND THAT THEY CATERED FOR U.S. RUBBER.

THE PRECEEDING WAS THE ONLY EXPLANATION EITHER BRINK COULD OFFER FOR THE INFORMANT KNOWING ABOUT A TELEPHONE CREDIT CARD IN THE NAME "ROBERT BRINKLEY" AND BRINKLEY'S CONNECTION WITH RIDDELL CATERING. BOTH EMPHATICALLY DENIED HAVING EVER LOST THEIR CREDIT CARDS OR LETTING ANOTHER PERSON USE THEM.

MIAMI ATTEMPT TO LOCATE SUNOCO STATION DESCRIBED AND ASCERTAIN IF THE YOUNG MAN MENTIONED BY H.V. BRINKER COULD BE "BOB" LNU OR IF THE BUSINESS CARD COULD HAVE BEEN PASSED ON BY THAT PERSON TO "BOB".

Enclosed herewith for the Identification Division, Latent Fingerprint Section, is one Greyhound Bus ticket, No. 3 00082229 42, covering passage from Knoxville to Los Angeles via Memphis and El Paso.

Enclosed for the Bureau, Kansas City and other offices is one rough map drawn by City Editor WILLIAM THOMAS of the "Los Angeles Times" based on information furnished to him by their informant, known as "BOB" (LNU), which supposedly depicts the location of the house in Kansas City where JAMES EARL RAY allegedly stayed overnight. This appeared as Item 5, Page 1, of Mr. THOMAS's notes, as set forth in referenced Los Angeles teletype. The reference is as follows:

"5. In Kansas City, RAY stayed overnight at a home. It is a small, gray, shingled, one-bedroom house about three miles from central Kansas City. (We have rough location.)"

The Identification Division, Latent Fingerprint Section, is requested to examine the bus ticket in question for any

AND HIS WIFE, JEAN HOLLAND. WALTER JAMES HOLLAND AND WIFE MOVED JANUARY, SIXTYEIGHT, FROM JEROME STREET; NOW RESIDING UNKNOWN ADDRESS NEAR CHATTANOOGA, TENN. HOLLAND SELF-EMPLOYED WITH BOBBY WALLACE DOING INDIVIDUAL HOUSE ROOFING UNKNOWN LOCATION NORTH ALABAMA.
