The following investigation was conducted by SA WELDON L. KENNEDY at Marathon, Florida, on May 18, 1968.

DAVID DAY, Deputy, Monroe County Sheriff's Office Sub-station, Monroe County, Florida, advised that RONALD K. PIERCE, age approximately 45 years old, is an indigent lobster fisherman who is married and has five children and to supplement his fishing income he works part time as an automobile mechanic.

DAY further advised that PIERCE is a long time resident of Marathon, Florida, who seldom, if ever, leaves the Florida Keys. As far as DAY knows, PIERCE does not hold a pilot's license, has no interests in flying, and does not own a plane. PIERCE has had no affiliation in Cuba.

The following investigation was conducted by SA PATRICK A. PHILBIN on May 18, 1968, in Belle Glade, Florida.

Chief of Police CHARLES GOODLETT (NA),
Belle Glade Police Department, advised that he has known
WILLIAM L. PIERCE for about 35 years. He said that
PIERCE used to own PIERCE's Quaters which was a
sort of "flop house" for migrant farm workers. However,
he advised PIERCE lost the business about six months
ago for non-payment of taxes.

Chief GOODIETT further advised that PIERCE used to have an interest in cattle, farm land and a "Ramey" machine he invented that wove hemp into cloth. He continued by saying the PIERCE had made a lot of money years ago but had lost it by making bad investments over the years.

Chief GOODLETT stated he was very well acquainted with BILL PIERCE and he is not a racist or a bigot.

Chief GOODLETT advised PIERCE is presently working for the True-Flow Welding Company and lives in Pahokee, Florida.

The records of the True-Flow Welding Company showed that WILLIAM PIERCE was at work on April 4, 5 and 6, 1968.

The following investigation was conducted by SA ROBERT W. WISEMAN at Boca Raton, Florida, relative to identifying the unknown individual at the Texaco station located at U.S. #1 and Palm Aire Street, in Boca Raton who was the recipient of a business card from Mr. H. D. BRINKER.

Physical inspection of the Boca Raton area developed that there is no Palm Aire Street, however there is a Sunoco station located at the intersection of Highway #1 and Royal Palm Road, which appears to be the logical location of instant service station.

Mr. BERNARD IRELAND, Jr., co-owner of instant service station advised that beginning March 7, 1968, and for a period of three weeks he employed one DALE WHITMAN, whom he described as in his early twenties, very personable and an excellent public relations man with customers. WHITMAN was dissatisfied with his employment and was interested in bettering himself and left voluntarily to secure employment elsewhere with an unknown uniform company in Fort Lauderdale, Florida.

Subsequent investigations identified DALE WHITMAN's mother as Mrs. GORDON YOST, who resides in a trailer lot #35, Tropic Gardens Trailer Park, S. Federal Highway, Delray Beach, Florida, which is just north of the Boca Raton City limits. Mrs. YOST interviewed on May 21, 1968, stated that her son DALE WHITMAN is an only child of a previous marriage and his father is deceased. She stated that during approximately the middle of February, 1968, her son phoned her from Chicago, Illinois, stating that his wife had left him and that divorce action by her had been instituted. As a result he came here to this area and resided with her and her second husband up until May 7, 1968. She stated that he was very dissatisfied with the employment apportunities here in South Florida, and had worked for a while at the Sunoco station in Boca Raton, left there and worked for an unknown uniform company in Fort Lauderdale, as a truck driver and on the afternoon of May 7, 1968, came home saying that he was going up north to seek better employment, and that he would contact her at some later

date when he got settled and left. She advised that she has had no contact with him since and has no idea of his current whereabouts but is of the opinion that he would not go back to Chicago because of his unhappy situation and divorce action. Mrs. YOST continued saying that prior to coming to Florida, she and her son DALE resided for many years in the Warren, Ohio area and that she has two brothers in Warren, Ohio, now who her son might contact. She stated that one brother or uncle of DAIE WHITMAN is BYRD JAY LANE, who resides at 1594 Kuszmaul Avenue in Warren, Ohio, and that the other brother ROBERT LANE also is in Warren, Ohio, address unknown, but his address will be known to BYRD. added further that she has another brother named NOAH LANE who resides at an unknown address in Columbus, Ohio, and his address also will be known to BYRD. BYRD JAY LANE and ROBERT LANE are both employed by General Motors Corporation in Warren, Ohio. The employment of NOAH LANE in Columbus, Ohio is not known to her.

Mrs. YOST continued saying that her son DALE took most of his personal effects with him upon departure including any correspondence, notes and similar items. stated that after he departed she did find some notes with telephone numbers on them and business cards which she threw away in the trash without reading and had no knowledge of their contents believing that they were of no value to her son or he would not have left them. Mrs. YOST is unfamiliar with the name of H. D. BRINKER or H. ROBERTSON BRINKER or the Riddle Factory Catering Company of Detroit, Michigan. She does not recall her son mentioning anything about this, but added that she does know that he was interested in bettering himself and was making every effort possible while in this area to get better employment than the two that he did have. Mrs. YOST did divulge in the conversation that her son DALE WHITMAN at age 18 had enlisted in the U.S. Navy and shortly thereafter while being stationed in Bainbridge, Maryland, was involved with the Federal Government concerning a car theft for which he had a two year probationary sentence. She explained this is the reason why she was initially reluctant to discuss her son's whereabouts or possible whereabouts with the interviewing agent.

DAVID LARSEN and JOHN D. KENDALL who identified themselves as reporters from the "Los Angeles Times" newspaper to SAs DAVID N. JELLISON and JOHN F. HANION, Jr., appeared at the Mismi Office of the FBI at 6:50 PM, May 17, 1968. They stated that their editor was in contact with the Los Angeles Office of the FBI as were "Los Angeles Times" reporters in several other cities in the United States.

They stated in effect that a source who they declined to identify had sold the "Los Angeles Times" some information regarding the assassination of Dr. MARTIN LUTHER KING, Jr. They further stated that a man named WILLIAM PIERCE of Belle Glade, Florida, might be involved in the assassination as was a HEN THOMPSON of South Florida.

Specifically they stated that WILLIAM PIERCE flew JAMES EARL RAY in a private plane from St. Louis, Missouri to Belle Glade, Florida, on April 5, 1968, and EEN THOMPSON then took RAY out to sea in a boat on April 11, 1968.

They stated that their own investigation had determined that there was a WILLIAM LINCOIN PIERCE residing in Miami and a WILLIAM L. PIERCE residing in Belle Glade, Florida. They stated further that they had determined there was a BEN THOMPSON who owned three boats and who was associated with East Coast Fisheries, Miami, Florida.

At the conclusion of the interview, KENDALL and LARSEN stated that they desired to be furnished with up-to-the-minute information from the FBI Office in Miami. They were informed by SA JELLISON that no promises could be made in that regard at which time LARSEN stated "Should we be frozen out of any up-to-the-minute information, we will crucily you."

Mr. BENJAMIN LARNARD THOMPSON, JR., 12801 East Randall Park Drive, after being informed of the identity of the interviewing Agents, voluntarily furnished the following information:

In March, 1967, he commenced working for Aerodex, Miami. Prior to that time, he earned his living through commercial fixhing off the Florida Keys.

For a number of years he worked for East Coast Fisheries, Miami. In this regard, he would operate boats mortgaged through PETER SCHWARTZ who was one of the owners of East Coast Fisheries. Four or five years ago, he operated a 38 foot fishing boat named the "Virginia Lee" on which SCHWARTZ held the mortgage. He returned this boat to SCHWARTZ about a year later and switched the mortgage to a 48 foot fishing boat named the "Miss Gayle," on which SCHWARTZ also held the mortgage. Approximately two and one-half or three years ago, he and SCHWARTZ had financial differences, and he left the employment of East Coast Fisheries.

Following this incident, he went in partnerships with LOUIS LOBER, Miami, and purchased a 28 foot fishing vessel, which had no name. He and LOBER fished commercially until on or about August 1, 1966, at which time he sold his equity in this boat to LOBER and got out of the fishing business entirely.

Most of his fishing was accomplished from Bakers Haulover (Miami) in the north to Elliott Key in the south. His fishing interests were in lobsters.

Approximately four years ago, he was arrested by the British Government for fishing For lobsters in Bahamian waters. He had been carrying on this activity for approximately ten weeks before he was caught. British authorities kept him in jail overnight and the following day he was fined \$27 and allowed to leave Nassau with his boat with the promise of not fishing in Bahamian waters again. He recalls

that there was quite a bit of newspaper publicity for a period of five days during this incident.

With regard to his former partner, LOUIS LOBER, he spoke with LOBER about four months ago. At that time LOBER still had the boat and was fishing. He noted the reason he sold his interest in the boat to LOBER, as mentioned above, was the fact he could not make a living any longer in fishing. LOBER, whom he described as being around 37 years old, recently had an operation on his throat for the removal of a growth from his "voice box." As far as he knows, LOBER has never been arrested and in fact, both he and LOBER went to school together in Miami and he considers LOBER to be af good character and reputation.

With regard to his personal whereabouts during the period from April 3 - 12, 1968, since January, 1968, he has worked at Aerodex, Miami, on a shift in which he leaves home around 2:15 p.m. and returns around 12:30 a.m. On April 3, 4, and 5, 1968, he was working at Aerodex on the above mentioned shift. On April 6 and 7, 1968, a weekend, he remained home and did not leave Miami or Dade County, Florida. From April 7 - 12, 1968, he worked at Aerodex on the above described shift.

He has never left the State of Florida with the exception of going to New York City once when he was in high school.

He has never been in the State of Alabama and he has never heard of the names EDDIE WILBURN, SAMUEL LEWIS, WILLIAM PIERCE or BOB HRINKLEY. He does not know anyone from Huntsville or Athens, Alabama and he has never been in nor does he know anyone that drives an automobile with a police radio.

He has never been in Belle Glade or Okeechebee, Florida, and he does not know anyone that owns a motel, hotel, cottages or owns an airplane.

of the identity of the interviouer as a Special Agent of
the Federal Bureau of Investigation and of his rights as
contained in an exsecuted waiver of rights form. Upon
signing the form PRANCE furnished the following information:

Me was in the cattle business in Caba in 1956 and 1957 and upon leaving Caba he came to Okeochobec, Florida where he developed the Buckhead Ridge Subdivision, of which he is the sole owner. He is no longer in the cattle business and devotes all of his time to the developing of the subdivision and selling lots. He does not own any buildings or cottages on the property. For eighteen years, prior to going to Caba, he was in the cattle business in Belle Glade, Florida. While in Belle Glade he became acquainted with WILLIAM PIERCE, who also went to Caba in the 1950's to promote a middle east fiber called "Raime". He did not associate with WILLIAM PIERCE and in fact only spoke to him about a half a dozen times. He does not know what line of business WILLIAM PIERCE is in now nor does he know how he could be located.

He is not now nor has be ever been a member of the Kn Klux Klan nor is he sympathetic to their cause. He does not know the following individuals; BOB and WILLIAM BRICKLEY, BEN THOMPSON, EDDIR WILBURN nor JIN GARRISON, although he has read about JIM GARRISON in the paper. He did not do may building while in Cuba nor did he believe WILLIAM PIERCE did may building while in Cuba. He has never been to Enness City, Kauses or Enness City, Missouri, and in fact the only places he has been outside of the State of Florida are New Orleans for a cattle suction in the early 1950's, New York City, Mashington, B.C., Thomasville, Georgia and Cuba. He does not own a plane nor does he do may flying.

He did not kill MARTIN LUTHER KING nor does he know who did nor does he know who might have been involved in the murder of KING. There is a member of the local Ku Klux Klan, JOHN THOMAS BOWLES, who was capable of participating in the murder of KING. BOWLES has a strong hatred for Negroes and was recently tried in Martin County, Flored for beating up a school superintendent because of his efforts in integrating the schools. BOWLKS owns a small two passenger Sub sirplane that he keeps on Hog Island which is next to Buckhead Ridge. It is an open field without any lighting facilities. Beputy CUETIS WRIGHT, Glades County Sheriff's Office, had asked PEARCE to keep an eye on the airplane, particularly if the Klan was planning anything, so that BOWLES' whereabouts could be accounted for. He recalls that on the evening of the murder of MARTIN LUTHER KING he made it a point to check the airplane and noted that it was gone. The next morning, around seven AM, while on his way to Okeechobee for coffee he noted that the plane was there; however, when he returned approximately an hour later the plane was gone. It was either the day following the death of KING, April 5, 1968, or the next day, April 6, 1968, that the sirplane was gone and stayed gone for about two or three days. He had been told by BOWLES' girl friend, MARY ENIGHT, a barmaid at the Fin and Feather Bar in Buckhead Ridge that BOVLES had gone to Tampa to get his teeth fixed. BOWLES' AND GERALDINE, is presently seeking a divorce although he believes they are still living together. He sold BOVLES & couple of lots in Buckhead Ridge and BOVLES built a home on one and his brother-in-law, CHARLES P. GRIZZAFFE, built the Ridge Apartments on the other lot. There are about sixteen units in the apartment. GRIZZAFFE is a businession.... who lives in Tampa, Florida. BOWLES and his wife, GERALDINE, manage the apartments for GRIZZAFFE.

He has never been a member of the Ku Klux Klan and does not know anyone who is or was a member of the Klan.

There are no other BEN THOMPSONs who are fishermen in the Miami-Key West, Florida area as far as he knows, noting his father, BEN THOMPSON, SR. died in November, 1967, while residing at 4220 N. W. 23rd Avenue, Miami. His father gave up full time fishing in 1954 when he had heart trouble. Prior to that, in 1952, his father sold his beat. From 1952 to November, 1967, his father was semi-retired and only fished occasionally. When his father was much younger, he worked on a wrecking tug and at times, went to Cuba on this tug. However, his father did not own any business in Cuba. He has never been to Cuba himself and he has never had any interests in Cuba.

During the time he was a commercial fisherman, he has had a great many individual deck hands, however, to his knowledge, none of these individuals had ever served any time in a prison or penitentiary.

He has a relative named RONNY PIERCE who is about 35 years of age and who is a fisherman living in Marathon, Florida. As far as he knows, HONNY has never been in any trouble.

Photographs of JAMES KARL RAY were shown to him and he felt the photographs showing RAY by himself, with the picture of RAY with sunglasses, looked familiar, however, he could not be sure of this identification. Possibly he may have seen photographs of RAY in the newspapers or on television.

He emphatically denied being involved in this matter in any manner or under any circumstances. It is a complete mystery to him if or why his name would be used in this matter. If someone is using his name on this regard, then the identity of this individual is unknown to him.

JOHN THOMAS BOWLES, 607 Buckheed Ridge, Oksechebee, Florida, was advised of the identity of the interviewer as a Special Agent of the Federal Bureau of Investigation and of his rights as contained in unexecuted waiver of rights form. BOWLES stated that although he did not desire to sign a waiver of rights form he would be willing to answer any questions. He then furnished the following information:

He and his wife, GERALDINE, manage the Ridge Apartments in Buckhead Ridge. About four or five days a week he works as a guide for fishing parties on Lake Chuschebee. He owns a small yellow J-3 Cub airplane that he hoops on Hog Esland, which is next to Buckhead Ridge.

On April 4, 1968, he was in Tampa, Florida, at the dental lab of KUNARD H. CALLARAN located on Armenia Avenue. He had flown there early that morning from Cheechobee, Florida, for a 10:00 Am appointment. To the best of his recollection he was in the lab until about 2:00 PM. After leaving the lab he returned to Okeechobee, Florida, and that evening he went to the Fin and Feather Bar in Buckhead Ridge and it was while he was at the bar he learned that MARTIN LUTHER KING had been murdered. He made one or two trips to Tampa during the week prior to April 4, 1968, and then made one or two trips following April 4, 1968 to Tampa within the period of about & week. Each trip was for the purpose of having work done on his teeth at the Callahan Dental Lab. Prior to each trip he would telephone his brotherin-law, CHARLES GRIZZAFFR, owner of Ridge Apartments in Buckhend Ridge, who maintains an office about five miles from the Wandenberg Airport in Tampa, to have his son meet him at the airport and drive him to the dental lab. He had purchased gaseline from the airport and they should be able to furnish tickets reflecting the dates of the purchases. On occasion he would take his wife with him, and on one occasion he recalls she had gone to Tampa by car with her sister-in-law, Mrs. Charles Grizzaffe, and then returned with him by plane the following day,

He added that he is a former member of the En Klux Klan in Okeechobee, and even though he did not feel any remorse at the time of KENG's death, he did not have any participation in it, nor does he know who might have. He does not know a WILLIAM PIERCE.

He stated that the reason he is able to recall the events of April 4, 1968, is because he associates the events with the news of the death of KING. He said he is unable to recall specifically what he was doing the week before or the week after April 4, 1968, other than he knows he had made four or five trips to Tampa during that period to have his teeth fixed. He commented that his airplane holds approximately 13 gallons of gasoline and he does not attempt to fly any farther than Tampay Florida.

Referenced teletype advises the Bureau has instructed reasonable efforts be expanded to locate LESTER/EDWARD PACKETT.

On 6/12/68, Mrs. CALLIE CATHEY, 1/10 Wright Street, Sweetwater, Tennessee, advised she was formerly married to LESTER PACKETT, who is deceased, and that LESTER EDWARD PACKETT is her son. She advised she last actually saw PACKETT approximately four years ago but has not seen him since that time. She did, however, receive a birthday card from him during March, 1968 and is of the opinion that the envelope containing the birthday card was postmarked Chicago, Illinois. She further stated PACKETT telephoned her during February, 1968 indicating that he was in the State of Illinois.

On 6/14/68, MRS. NELSON CROWLEY, sister of FRANK BRICKLEY, wichita Falls, Texas advised she last saw BRICKLEY about two and one half weeks prior to 6/14/68, when he visited her in Wichita Falls. He left about two weeks ago and did not say where he was going, and she has no idea where he might be. She said he is a drifter and only occasionally stops in to see her for a few days. She said she had told BRICKLEY that the FBI had inquired of their father about him. BRICKLEY only replied that he was in no trouble and that the FBI really did not want him.

MRS. CROWLEY said BRICKLEY had been residing at an unknown address in Dallas and he had claimed that he was employed as a painter by Southwestern Life Insurance Company Dallas, but had quit that job recently. She said CHARLENE HAYDEN, employed by New York Life Insurance Company, Dallas, was formerly the girl friend of BRICKLEY and might know his whereabouts.

MRS. CROWLEY advised she will notify the FBI should she learn the present whereabouts of BRICKLEY.

MISS CHARLENE HAYDEN, Clerk, Service Department, New York Life Insurance Company, Republic National Bank Building, Dallas, advised on 6/18/68, she has known BRICKLEY since about July, 1967. She believes he had been living in Dallas about five or six months prior to that. She said she went out with him, but when she wanted to terminate their relationship, he began to make a nuisance of himself, trying to see her both at work and at home. She said she has not seen him for about a month and hopes that she will never see him again. She said she has made it perfectly clear to BRICKLEY that she does not want to see him, but if he should contact her, she will notify this office.

MISS HAYDEN said BRICKLEY is 31 years old

MYRTIS RUTH HENDRICKS, also known as JITTERBUG, 873 Mesquite Street, who requested her identity be kept confidential, furnished the following information:

She went to work on March 31, 1968, for an individual known to her as DEVILISH NICK, owner and operator of John's Restaurant located just off First Street before the underpass in Laurel, Mississippi, and worked there until April 9, 1968.

She worked as a cook and on the day after she started working for him, DEVILISH NICK had sexual relations with her. He then started her working at a place he had outside of town. On April 2, 1968, she overheard NICK say, "I got a call on the King", but did not hear any more of the conversation.

On the evening of April 3, 1968, two neatly dressed men with stocky builds came to NICK's place, where she started work at 3 p.m., and worked nights.

While going to the bathroom, she observed a rifle with a telescopic sight in NICK's office. Later, the two men took the rifle and a long box which took three men to carry out and put them in a 1964 maroon Dodge with a fake "Continental kit" on the back.

On April 4, 1968, while on duty, she overheard NICK receive a telephone call on his phone which is close to the kitchen. After this call, NICK said, "MARTIN LUTHER KING is dead". This was before the news came over the radio.

NICK had meetings every night in his office, and she was told by other employees that NICK is the head of the Ku Klux Klan in that area.

A white man known to her only as "Big WILL ADAMS' son" was in on the activity at the restaurant. FROSTENE (phonetic), a large fateNegro girl who works for NICK, and two white waitresses, who are associated with the two men who took the gun, knew of the activities of NICK.

From what she overheard, she feels that NICK had some part in the assassination of MARTIN LUTHER KING, but she has no definite proof of this.

She became so frightened, she told NICK she had a very sick relative in Abilene, Tems. She left on April 9, 1968, and came to Abilene where she met THOMAS McGEE. She has been going with McGEE for four years and he came to Abilene shortly before Christmas to look for work. She could not identify the photograph of JAMES EARL RAY as ever being at John's Restaurant or having ever seen him.

THOMAS McGEE, 873 Mesquite Street, furnished the following information, which he requested be kept strictly confidential and his identity be protected.

He worked at John's Restaurant about a year ago for a month as carhop. He was told the restaurant was a meeting place for the Ku Klux Klan (KKK), and DEVILISH NICK, the proprietor of the restaurant, was the head of the KKK in that area. He also determined that the women employees worked as prostitutes for NICK on off hours and the two white women who work as waitresses, one brunette and one blonde, live in the most expensive hotel in Laurel, Mississippi, name unknown.

NICK beat up certain employees while he was there and McGEE decided to leave. When he learned that MYRTIS RUTH HENDRICKS was working for NICK, who was making a prostitute out of her, he had her come to Abilene.

He admitted that he is on probation out of Gulfport, Mississippi, for "moonshining", and has previously furnished information to the FBI through a one-legged man who runs a barbershop next door to Kitchen's Grocery in Seminary, Mississippi. This man could vouch for his reliability.

He feels that should DEVILISH NICK know that he and MYRTIS have talked to the FBI, he would have them located and killed, and would take some action against their friends and relatives in Laurel, Mississippi. He, therefore, requested that their identities be protected and kept very confidential. He intimated that if investigation by the FBI reflects that the information on DEVILISH NICK is of any value, he would be willing to return to Laurel and obtain information for the FBI on a paid basis.

He advised he and HENDRICKS will maintain contact with the FBI.

MYRTIS RUTH HENDRICKS, also known as JITTERBUG, 873 Mesquite Street, advised that she would be unable to advise as to the location of the house at which she worked for NICK as a prostitute, as they always went there at night. She advised that this work was before she started working at the restaurant. She started working for him as a prostitute shortly before Christmas and worked a number of times, exact amount unrecalled.

She advised that the only thing she recalls about the house is that it was on the outskirts of Laurel where there are some large homes which are not too close together. There was a gaslight in the front yard and she recalled a chimney which was for a mock fireplace in the house. She advised she did not know how many rooms were in the house, but it was fairly nice inside. She could furnish no further information on the residence, except that she believed it was a one-story house and had a large room which was always kept locked, which she believed was the meeting place for the Ku Klux Klan. She knew none of the men who frequented the place. She advised she worked from about 9 p.m., to midnight.

She advised that when NICK made the statement, "I got a call on the King", she was upstairs in the restaurant going to the bathroom and this was the same time that she saw the gun in the room upstairs on April 2, 1968. She advised she thought NICK was talking to the man who lived upstairs at the restaurant, name unrecalled.

She advised that at the time she overheard NICK state, "MARTIN LUTHER KING is dead", NICK was standing in the little booth where food is served to persons at the drive-in. She advised that NICK was called to the telephone and upon his return he made the statement to someone there, whom she does not recall. She advised as she recalled, this was early in the evening, the exact time she does not recall. She advised that at the time she overheard this, she was cooking and leaning over, listening for an order.

knowing the name of the complainant, it would be extremely difficult to locate the case number for the original offence that is, the purchases on March 8 and 11, 1968. He said that this case number would have to be obtained since if anyone was arrested by the police department on that charge, it would have been listed within that case number. He said that either Detectives V. HICHEY or J. EACHARIAS, of his Command, might have handled the matter because they are the efficers he usually assigns credit eard cases to.

On 5/21/68, Detective WILLIAM MICHEY advised that he thinks he recalls the original report from the Shell Station and would make an effort to locate it. He further advised, however, that he could not recall anyone being arrested for this offense. Subsequently, on 5/22/68, Detective MICHEY advised that he was unable to locate any CB number for a fraudulent credit card purchase on the dates indicated at a Shell Station on Armitage Avenue.
