THREE THREE FIVE WILSHIRE BLVD. SHE RECALLS SEEING GALT ON SEVERAL OCCASIONS BUT HAD NEVER COLLECTED RENT FROM HIM. HE WAS A TENANT OF THE BUILDING WHEN SHE TOOK OVER AS MANAGER. SHE STATED THAT GALT DOES NOT IN ANY WAY RESEMBLE PHOTOGRAPH OF JEROME VERNON.

BERNHARDT DESCRIBED GALT AS FIVE FEET NINE INCHES, THIN FACE, HIGH CHEEK BONES, TRIANGULAR SHAPED FACE, DARK BROWN HAIR, AGE TWENTY EIGHT TO THIRTY THREE YEARS, MEDIUM BUILD, IMPRESSED HER AS "FORLORN" IN APPEARANCE. HAS NO OUTSTANDING CHARACTERISTICS WHICH WOULD APPEAL TO WOMEN.

BERNHARDT ADDED THAT SHE KNOWS NO ONE BY NAME OF GINGER OR ANITA KATZWINKEL. SHE STATED THAT APARTMENT SIX IS CURRENTLY RENTED TO ONE J. MORGAN, A FEMALE MARRIED TO AN ARMY CAPTAIN NOW IN VIETNAM.

JENNIE MORGAN, APARTMENT SIX, ONE FIVE THREE FIVE NORTH SERRANO AVE., LA, INTERVIEWED AND ADVISED THAT SHE HAS LIVED IN INSTANT APARTMENT SINCE FEBRUARY TWELVE LAST AND THAT SHE DENIES KNOWING GALT, VERNON, OR FEMALES BY NAMES GINGER AND ANITA OR ONE WHOSE LAST NAME IS KATZWINKEL. SHE WAS UNABLE TO IDENTIFY THE PHOTOGRAPH OF VERNON.

RECORDS OF LOS ANGELES POLICE DEPARTMENT AND LOS ANGELES SHERIFF'S OFFICE CONTAINED NO RECORD FOR ANITA KATZWINKEL.

WAS IN RECEIVERSHIP AND COLLECTED THE RENTS AT ONE FIVE THREE FIVE NORTH SERRANO. HIS RECORDS SHOW GALT PAID RENT IN CASH FOR THE MONTHS OF NOVEMBER AND DECEMBER NINETEEN SIXTY SEVEN, WHEN HE WENT TO COLLECT THE RENTS WHICH WERE DUE APPROXIMATELY JANUARY EIGHTEEN SIXTYEIGHT, GALT HAD LEFT THE PREMISES. HE RECEIVED A LETTER FROM GALT DATED JANUARY TWENTY ONE LAST AND POSTMARKED IN LOS ANGELES JANUARY TWENTY TWO LAST WHICH STATED "DEAR SIR, I AM WRITING TO INFORM YOU THAT I MOVED FROM THE APT. I INFORMED THE ORIGINAL MANAGER SO, I AM ALSO INCLOSING THE KEYS. I MADE A DEPOSIT ON KEYS BUT AS A LOST ONE WILL FORFIT (SIC) DEPOSIT. SINCERELY, SIGNED ERIC S. GALT". DYKEMA DESCRIBED GALT AS WHITE MALE FIVE FEET TEN INCHES TO SIX FEET, THIRTY FIVE TO FORTY YEARS, ONE SEVENTY TO ONE SEVENTY FIVE POUNDS, SLIGHT TO MEDIUM BUILD, HIS FACE, BROWN BRUSH CUT HAIR, BLUE EYES PERHAPS, PROMINENT EARS. SPOKE WITH A SOUTHERN ACCENT, NEAT IN APPEARANCE.

LETTER IS BEING SENT TO FBI LAB VIA FIRST AVAILABLE AIRPLANE AND BUREAU ADVISED WHEN WILL ARRIVE.

MAURICE HOWARD ADVISED HE SOLD THIS PROPERTY TO JEROME VERNON ON JANUARY FIFTEEN LAST WITH A NINETY DAY ESCROW. VERNON ALLEGEDLY BORROWED FIFTEEN HUNDRED DOLLARS FROM HIS WIFE, WHOM HOWARD KNEW AS BONNIE, AND HER PARENTS WHICH HE USED AS DOWN PAYMENT. ON MARCH TWENTY FIVE LAST HOWARD HAD A NINE O'CLOCK AM APPOINTMENT WITH VERNON TO DISCUSS MATTER OF FUTURE PAYMENTS ON PURCHASE OF LAUNDRY. VERNON KEPT APPOINTMENT BUT STATED HE WANTED TO HAVE HIS LAWYER (NAME NOT INDICATED) PRESENT, SO HOWARD MADE SECOND APPOINTMENT FOR FOUR O'CLOCK PM ON SAME DATE, WHICH VERNON DID NOT KEEP. SOMETIME BETWEEN NINE O'CLOCK AM AND FOUR O'CLOCK PM MARCH TWENTY FIVE LAST, VERNON WENT TO LAUNDRY, WHERE HE EMPTIED CASH REGISTER, REMOVED LAUNDRY RECORDS AND LOCKED DOOR. HOWARD HAS NOT SEEN HIM SINCE.

MORTGAGE HOLDER, LEW PUTTERMAN, AND HOWARD PRESENTLY IN LITIGATION TO DETERMINE RIGHTFUL OWNER OF LAUNDRY. HOWARD REPORTS THERMO SEAL LAUNDRY MARKING MACHINE WAS NOT IN SHOP PRIOR TO FEBRUARY ONE LAST. HOWARD REPORTED THAT VERNON ALLEGEDLY LEFT STORE WITH SEXY LOOKING TALL BLOND CAUCASIAN FEMALE WHO WAS SUPPOSED TO HAVE WORKED IN THE LAUNDRY.

BECKMAN WILL BE AVAILABLE FOR INTERVIEW APRIL TWELVE INSTANT. BALLAN NOT FAMILIAR WITH NAME GALT OR JAY VERNON. COULD NOT IDENTIFY PHOTO OF VERNON.

ED DEVINE, PACIFIC TELEPHONE NIGHT SECURITY SUPERVISOR, ADVISED THIS NUMBER DISCONNECTED ON APRIL EIGHT LAST. AT TIME OF DISCONNECT NUMBER WAS LISTED TO ABOVE GRAMERCY PLACE ADDRESS TO ANITA KATZWINKEL. BUSINESS RECORDS CONTAINING BACKGROUND UNAVAILABLE UNTIL REGULAR WORKING HOURS APRIL TWELVE.

Investigation in Little Rock determined that ERNEST SUMPTER GAULT was born [redacted] in Danville, Arkansas. He was in the Army in 1942 to 1945. This GAULT is an alcoholic, and was in the Veteran's Hospital in Memphis within the past year. His brother, HARRY, indicates that ERNEST married one NINA STARVO (PH) in 1938 or 1939 in Little Rock.

Little Rock is continuing efforts to verify this marriage, but encountering difficulty in view of Good Friday. We are continuing, however.

## SUGGESTED LEAD AT MEMPHIS:

Determine if ERNEST SUMPTER GAULT is currently in the VA Hospital at Memphis, and determine if he had any children by his wife NINA, who might be identical with suspect, ERIC STARVO GALT.
