DID NOT SHOW FOR LESSON OCTOBER TEN, SIXTYSEVEN, AND SOMETIME BETWEEN OCTOBER TEN AND FOURTEEN, LAST, MYERS RECEIVED LETTER FROM GALT ADVISING HE HAD TO LEAVE TOWN AND COULD NOT CONTINUE WITH LESSONS. MYERS HAD DESTROYED LETTER AND DOES NOT RECALL LOCATION WHERE LETTER WAS MAILED. MYERS HAD OWNED AND OPERATED CONTINENTAL DANCE STUDIOS, NEW ORLEANS, LOUISIANA, BETWEEN NINETEEN SIXTYFOUR AND OCTOBER NINETEEN SIXTYFIVE. HE RECALLS GALT HAD TAKEN DANCE LESSONS ON A YEAR'S BUDGET CONTRACT STARTING IN NINETEEN SIXTYFOUR IN NEW ORLEANS, LOUISIANA, HOWEVER, DATES NOT RECALLED AND MYERS NO LONGER HAS RECORDS OF NEW ORLEANS OPERATION SINCE IT IS NOW DEFUNCT. WIFE, JOAN MYERS, FORMER DANCE INSTRUCTOR IN NEW ORLEANS, RECALLS GALT AND STATED BELIEVES HE TOOK DANCING LESSONS IN NEW ORLEANS ON A FULL-YEAR BUDGET PLAN CONTRACT STARTING POSSIBLY IN APRIL SIXTYFOUR. SHE STATED HE LIKES TO DANCE BUT IS A "LONER." MYERS STATED EMPLOYMENT RECORDS FOR DANCE INSTRUCTORS WERE IN POSSESSION OF HIS FORMER PARTNER, LOUELLA LUTZ, WHO RESIDES IN AN UNKNOWN PLACE IN CALIFORNIA. MYERS INTERVIEW CONTINUING AS DANCE STUDIO BUSINESS REQUIRED INTERRUPTIONS, AND ATTEMPTS WILL BE MADE TO OBTAIN ADDITIONAL INFORMATION, AS WELL AS IDENTITY OF OTHER STUDENTS DURING PERIOD GALT TOOK HIS LESSONS. THIS INFORMATION TELEPHONICALLY

PROPRIETOR, TOWN MOTEL, FOUR ONE FOUR THIRD AVENUE WEST, BIRMINGHAM, ADVISED ARTIST CONCEPTION OF MEMPHIS SUSPECT SIMILAR TO PATROL FRANK C. BEEBE, WHO RESIDED TOWN MOTEL PERIOD MARCH ONE TO MARCH ELEVEN, LAST. BEEBE DISAPPEARED AFTER ISSUING TWO BAD CHECKS ON LOUISIANA BANK DATED MAY TEN AND MAY TWELVE, LAST. WHEN REGISTERING BEEBE GAVE BATON ROUTE, LOUISIANA, ADDRESS AND INDICATED REPRESENTING EBSCO COMPANY, BIRMINGHAM. EBSCO INDUSTRIES PERSONNEL RECORDS REVEAL BEEBE EMPLOYED THERE FEBRUARY TWENTYONE THROUGH NINETEEN, LAST, WHEN HE LEFT WITHOUT GIVING NOTICE. On 4/13/68 MILTON VON MAN, 3301 Overlook Drive, Nashville, Tennessee, employed at Father Ryan High School, Nashville, telephonically contacted the Nashville RA and advised as follows:

During the Spring of 1964 he was employed as an instructor at Dominican College in New Orleans, La. In April or May 1964 the Jewish Director of the Anti Defamation League in New Orleans, name unrecalled, was invited to speak to members of the faculty and administrative staff of the college regarding the KKK.

At this meeting two unknown men attended who appeared to be merchant seamen, both wearing black knit caps usually associated with members of the merchant marine in New Orleans.

The larger of the two men began "heckling" the speaker and stated he was a member of the KKK which was a Christian organization. This individual caused a great deal of trouble for the speaker, and after the meeting adjourned the speaker advised the group that this individual was known to him and that his organization had a "large file" on this person.

The younger of the two men was approximately 25 to 30 years old, 5' 10" to 6', weighing approximately 170 lbs., with sharp features. He made no remarks at the meeting and appeared to have only accompanied the larger man to the meeting. Following the speech, one of the Sisters asked the young man for his name and he wrote the name "ERIC GALT" on the slip of paper which he gave to the Sister.

He has no further information regarding GALT and reported this incident after reading the name of ERIC GALT in Nashville newspapers.
