Mrs. DORIS LADNER, 2121 - 36th Avenue North, Birmingham, Alabama, advised that her brother, MARLIN C. MYERS, and his wife JOAN own and operate the Continental Dance Studios, 7960 Crestwood Boulevard, Birmingham, Alabama. She advised that commencing on or about September 5, 1967, she has been taking dance lessons from her brother. She stated that from September 5, 1967, until approximately two months ago her brother gave dance lessons at the Friendship Club located on Graymont Avenue, Birmingham, and that these lessons were given each Tuesday evening from 7:30 p.m. to 8:30 p.m.

She stated she does recall ERIC GALT was a student in her dance class from September 12, 1967, until approximately October 3, 1967. She stated that during that period there were approximately fourteen to sixteen persons in the class and that half of them were men and the other half were women. She stated that at the beginning of the classes in September, 1967, all the students introduced themselves to each other and she does recall at this time that her brother had asked her and her sister, Mrs. WEEKS, who was also a student in the class, to circulate among the students to help them feel at ease. She stated that as a result of doing this she met ERIC GALT and did try to make him feel at ease.

She stated GALT was a very quiet and timid person who had very little to say and did not volunteer any information concerning himself when asked such questions. She stated that to the best of her knowledge he only attended approximately four lessons and that on his last appearance he did seem to converse with her more than he did at the beginning of the lessons; that he did ask her where she was living in Birmingham. She stated that when she told him she lived on the north side of Birmingham, he replied that he knew very little about Birmingham and the only area he was familiar with was the Highland Avenue

area where he resided. She stated that from this conversation she feels he is not a native of Birmingham and had not been in Birmingham for any length of time. She stated he did tell her he had taken dancing lessons in New Orleans and when he made this statement, she mentioned that her brother and his wife were from New Orleans and had taught dancing lessons in New Orleans. She stated GALT did not make any indication that he had recalled taking dancing lessons from her brother, although she was aware of this since her sister-in-law, JOAN, had previously mentioned this fact to her.

She stated that during her conversations with GALT he never indicated where he was employed, although she recalls that he either said he was living near an area where construction was going on or was working in construction.

She advised that she noticed when she was talking with him he would not look her in the eyes; that he would either look away or drop his head, and that when he would be sitting in a chair he seemed to be staring into the distance as though he had something on his mind. She further stated that in trying to make him feel more at ease she would attempt to draw him into conversation by bringing up various subject matters; however, he never seemed to respond to any of the questions she asked other than the fact he would either give a yes or no answer. She did state, however, that he was interested in sports and when asked specifically what sport he was interested in, he commented that he liked baseball.

She advised that on each occasion when she arrived for a dance lesson GALT was always there before she was and after the classes were over he always left before she did since she would usually stay around and assist her brother and saster-in-law in cleaning up the studio. She, therefore, was unable to state whether he had an automobile and GALT had never made any comment to her how he would arrive at the dance studio. She stated that when she, her brother, sister and sister-in-law would leave the dance hall, they stually went to the Plantation Barbecus and she had never observed GALT at the Plantation. She stated she has no knowledge as a where GALT would go after the dance instructions were over; that she never observed him in the area of the Friendship Club when she was latving.

Mrs. LADNER stated that during the dance instructions they would keep changing partners and therefore no one particular individual would dance with the same partner for any length of time. She stated she never observed GALT talking with any particular student in the class, and she again reiterated that GALT would stay by himself or if a group of people came around to him during one of the breaks, he would just sit there and say nothing.

She added that she never observed GALT smoking cigarettes, nor at any time did she notice any alcoholic beverages on his breath. She advised that she is certain she would be able to recognize GALT if she saw him again.

She described him as follows:

QUINTON B. DAVIS, 912 Ann Street, Ensley, Birmingham, Alabama, owner of "The Gun Rack", 1507 31st Street, S.W., Birmingham, Alabama, furnished the following information regarding a customer who had expressed an interest in buying a high-powered rifle.

He advised that during the past several months, an individual has been in The Gun Rack on two or three occasions. He stated that he recalled on one occasion, he talked with this individual and attempted to sell him a rifle. It was about noon and he was alone in The Gun Rack at the time this occurred. He stated that it was raining at the time and he recalls the individual parked his car near the front entrance to The Gun Rack. He stated that he could not recall the exact description of this car but as he recalls, the car was a small car, light in color. He stated if it was a white car, it was dirty.

He advised that he believes this individual was in The Gun Rack two or three months ago, exact date he cannot recall.

He stated when the man came into The Gun Rack, he asked him if he had a Model 264 Browning automatic, Grade 2. He informed the man he did not have a Model 264 Browning, as this was a new rifle and he had not been promised delivery by the Browning Company of Model 264 until June or July 1968. DAVIS advised that numerous gun magazines have carried stories about a Browning Model 264, but they are not available to dealers at this time.

He advised he recalls the man asked him about a Redfield rifle scope, a 3x9 Accu-range scope, and DAVIS

pointed out in a Redfield 1968 bulletin that on page 6 of this bulletin is the type scope the man made inquiry concerning.

He recalls the man asked him how long it would take for him to get the scope, as DAVIS did not have the scope in stock. DAVIS informed the man it would take two or three days to obtain the scope and have it mounted.

DAVIS advised that he exhibited to the man several different rifles but does not recall the man actually handling any of the rifles. He recalls that among the weapons that he attempted to sell this individual was a Remington Model 742 automatic, a Model 700 7 m.m. Remington Magnum. He stated that the reason he recalls the 7 m.m. Magnum is that he only had one of these guns and he had purchased it for an individual who had refused to take the gun after he had purchased it. He advised that he attempted to sell the man several other guns, including guns with caliber 30/06, .243 and .308, but the man appeared to be more interested in obtaining information regarding the amount a bullet dropped at certain distances than actually in buying a rifle. He stated that he and the man referred to a 1968 gun book and looked up various manufacturer's ammunition and the amount the bullet would drop at various distances for .243 caliber, .308 caliber, and 30/06 caliber.

He advised that in his experience in selling guns and ammunition, most of the people who are interested in ballistics are individuals who do hand reloading. He advised that at the time, he thought this individual was interested in the drop of bullets, as he might be planning to reload ammunition with varying amounts of powder. He advised that now he recalls during their conversation the man did not at any time express any interest in the muzzle velocity of the bullet but was only interested in weights of bullets and the amount of drop at various distances. From the conversation, he gained the impression the man wanted to buy a rifle that would fire a bullet with the least amount of drop, several hundred yards of distance.

He stated the man, during their conversation, did not appear to be too interested in the guns as he was listening very closely to information he furnished regarding ballistics. He stated the man stared at him during their conversation. He advised the man's eyes were light in color, blue, but with different colors, very unusual in appearance, and very noticeable. He stated the man talked very plainly, pronounced each word very clearly. He stated he could not be positive as to whether this man is a Southerner or from some other section of the country, although he does not talk like most Southerners.

He stated the man had thin, bony hands and his fingernails were manipured. He stated the man's face was thin, and although the man talked very intelligently and may have been an iducated person, he gained the impression the man was under a strain or slightly mentally disturbed. He stated the man had a very serious expression on his face, although he was polite and courisous. He advised that he believes this man may have been in his store on one occasion during the football season but he does not recall the man buying anything or his reason for being in the store.

He advised he would describe this individual as a white male, thirty years of age, 5'8" to 5'9" in height, 140 to 150 pounds, light brown hair, light complexion, dressed in sports clothes, and he does not believe the man was wearing a coat when he was in The Gun Rack.

He stated he did not observe this individual's automobile or mode of travel. He gained the impression from conversation with this individual that he had either been or was going to Long-Lewis Hardware Company, Bessemer, Alabama.

He advised he recalls that this individual was interested in the amount of drop a built would have at 200 yards and other various distances, and he was seeking information concerning the speed and weight of builtets. Mr MANASCO said he would give this matter further thought and he might be able to recall additional details concerning this matter.

He advised that he now recalls that the man who came to The Gun Rack and made inquiry concerning ballistics of various rifles did not occur on March 29, 1968, as he had previously informed SA J. T. ARNETT. He stated that on March 29, 1968, he was not at work as he took an examination for a pilots license on March 29, 1968. He stated that he was alone at The Gun Rack at the time the man came in, as the owner of The Gun Rack was out of town on business on Wednesday, March 27, 1968, and he believes that March 27, 1968, is the date that this man came to The Gun Rack.

He stated that since being interviewed by SA J. T. ARNETT on April 8, 1968, he had given this matter considerable thought, and now recalls that this individual had been in The Gun Rack three or four times during the past several months, exact time and dates he could not recall. He stated that he recalls on other occasions when this man came to The Gun Rack he did not make any inquiry of him about any guns, ammunition, or ballistics. He stated on the other occasions he had observed this man, he had come into the store and looked at the various items on display. He stated that this is not unusual, for many customers are "lookers". He stated the man did not handle the weapons on the cocasions he was in The Gun Rack. He stated that many costomers who come to The Gun Rack pick up and handle numerous weapons without making a purchase. He advised he did not recall ever seeing this individual with another person when he was at The Gun Rack. MANASCO stated that as he now recalls, the man coming in the store on March 27, 1968, stated on his arrival, "I would like to see your .243 caliber rifles". MANASCO stated that he did not have any .243 caliber rifles in stock, and he attempted to sell the man a 30/06 caliber rifle. He stated that he recalls he attempted to sell this man a Weatherby rifle, and the man indicated that the price of this rifle was too high. He stated that the man, he did not believe, however, handled any rifles while at The Gun Rack, although MANASCO believes he attempted to hand the man a rifle as he would exhibit them to him. He stated he recalls he tried to sell the man a 742 rifle, caliber 30/06. He stated that on previous occasions that this man had been in The Gun Rack, he had appeared not to be interested in purchasing a gun, but was merely interested in looking at the various weapons. He stated on March 27, 1968, however, he gained the impression that this man was "about ready to buy a gun". He stated, therefore, he attempted to sell the man a gun. He stated the man showed an interest and asked questions about the weight of bullets for the various calibers and the amount the bullet would drop at various distances. He stated he gained the impression that the man was more interested in the inches a bullet dropped at various distances than he was in muzzle velocity of the bullet and weight of the bulles.

He advised he did not recall the man asking him anything about a 6.5 millimeter rifle or ammunition. He stated he has 6.5 millimeter rifle ammunition in stock. He stated that when the man asked him about charts concerning ballistics and weapons, he gave the man a booklet entitled "Winchester-Western 1968 Sporting Arms and Ammunition". This booklet has a cover and is 47 pages in length. He pointed out that this booklet contains various articles on weapons and ballistics of various type cartridges. He stated he also gave this man a booklet entitled "Redfield '68 Scopes, Mounts, Sights". He advised that this booklet has a cover and is 31 pages in length. This booklet, he advised,

contains various articles on scopes and mounts. He advised the man was also seeking information on rifle scopes. Mr. MANASCO furnished copies of two similar booklets as the ones he had furnished the man on March 27, 1968.

He stated that on the occasions he had observed this man, he at no time was under the impression he had been drinking alcoholic beverages. He stated that ne now recalls the individual's description as follows:

He stated the man did not appear to be a strong person, but weak physically. He stated the man was polite and gave the impression of being intelligent. He stated the man's teeth were clean and straight although not perfect. He recalls that the man's fingernails had been manicured and the fingernails were even with his fingers.

JOHN MICHAEL KOPP, 1420 - 35th Street, Ensley, Birmingham, Alabama, employed as Manager of Firearms Department, LONG-LEWIS HARDWARE Wholesale and Retail Store, Bessemer, Alabama, furnished the following information:

He stated that on Friday, March 29, 1968, at about noontime, he recalls a customer making inquiry concerning a high-powered rifle. This individual was seeking information concerning ballistics of the various high-powered weapons. When the man first made inquiry concerning whether they handled high-powered rifles, he asked him if he would like to see a 30-30 and the man said he would not as a 30-30 would not be powerful enough. The man asked if he had a .243, .308 or 30/06 caliber rifle, also inquiring as to the prices of the various rifles, and he informed him he had a Winchester .243 rifle for \$127.95, a .308 for \$154.95 and a 30/06 for \$176.98. He recalls this man asking how many inches would the .308 bullet drop at 600 yards. He also wanted to know the ballistics or drop in a 30/06.

KOPP stated this individual looked at the rifles and is sure he handled the rifles in the store. However, since that time these rifles have been handled by numerous other individuals, and the previous day all of these rifles were removed from the racks and stored in another part of the building, at which time at least four other employees had handled the rifles. He stated he recalls that this individual handled a Browning rifle, opening the action of the rifle and closed it without any difficulty. He said this particular rifle had a unique manner in which the action could be opened and released and unless someone was familiar with this rifle, it would be highly unlikely that he could open and close the action without assistance or careful study of the mechanism. He stated this individual asked him if he had any 6.5 mm. ammunition that would fit a Japanese rifle.

Mr. KOPP advised that this individual asked if he had any scopes and scope mounts. He recalls the man asked how much a "tip-off" mount would cost. He said the man did not ask him any details concerning the power of scopes, nor did he state what power scope he desired. This individual asked how long it would take to have a scope mounted on a rifle and KOPP informed him it would take at least two days as he sent his rifles to Birmingham to T. K. LEE to have the scopes mounted. He said the man appeared to be shopping and pricing rather than actually interested in the immediate purchase of a rifle.

He stated the individual did not appear to be familiar with Bessemer, Alabama, as he recalls the individual asking him about other places that might have high-powered rifles at Bessemer, and he told the man that BANKS PAWN SHOP and SIMMONS PAWN SHOP might have them, at which time the man asked him where these places were located. KOPP stated these two places of business are located directly across the street from Long-Lewis Hardware Company, and he pointed out Banks Pawn Shop, directly across the street, to this man.

Mr. KOPP advised he did not know whether any other employee at Long-Lewis Hardware Company observed this individual, but that the other employee who works in the same department is LYNDEL EARL DILBECK.

He stated this unknown individual talked in a soft voice but pronounced each word very clearly and had no particular accent. During the conversation he noted that the man pronounced several words in a way which indicated to KOPP that he may have been from another section of the country. He stated he recalls on one occasion, while this man was in the store, he called to an employee in the store whose name is PAUL, and when he called this individual by the name PAUL. It appeared to startle the man and he repeated the name "PAUL" but pronounced it "PAAL."

He stated that at Long-Lewis Hardware there is a moose head trophy on display, and this individual made some comments concerning this being such a nice trophy.

JOHN MICHAEL KOPP, 1420 - 35th Street, Ensley, Birmingham, Alabama, employed as Manager of the Firearms Department, LONG-LEWIS HARDWARE Wholesale and Retail Store, Bessemer, Alabama, was shown artist's conception of an individual by SA J. T. ARNETT. Mr. KOPP advised that this artist's conception resembled an individual who had made inquiry concerning a high-powered rifle on March 29, 1968; however, in his opinion, it varies from the person's appearance in the following manner:

The hair was not combed exactly like the artist's conception, the hair appearing to be too thick. He stated the man's hair appeared to him to be combed more flat on top, straight back, thinner, and not quite as high. He said the artist's sketch of the man's eyes did not appear exactly as he recalled the person's eyes with whom he talked. The man's face appeared to be thinner than the artist's conception, but stated the artist's conception does resemble this person.

RECORD CHECKS

The following investigation was conducted by IC WILLIAM H. CUSHEN at Birmingham, Alabam, on Ipril 9, 1968.

Indices of the Birmingham Division were checked, with negative results, regarding the surnous LOWMEYER and LOWMYER.

City directories and telegraphe directories covering the Birmingham territories were negative regarding the surnames LOWMEYER and LOWMYER.

Miss JEAN BISHOP, Revenue Department, Auto License Department, Jefferson County Courthouse; Miss SYLVIA LITTLE, Beard of Registrars, Jefferson County Counthouse; Mr. D. L. WEBBER, Identification Bureau, Jefferson County Sheriff's Office; Miss YVONNE HILL, Identification Bureau, Birmingham Police Department; Miss CATHERINE McCRCMIE, City Recorders Court; and Mrs. JESSIE WILLIAMS, Merchants Credit Association, advised from their respective files they could locate no record regarding the surnames LOWMEYER or LOWMYER.

Likewise, the names of JOHN WILLIED, ERIC S. GALT, and others as they became of interest, were checked through all available sources and records without any identification located.

NEIGHBORHOOD INVESTIGATIONS

Throughout the period covered by this investigation, intensive coverage was afforded all neighborhoods where it had been determined that GALT had had any contacts.

This investigation covered a 25-block area surrounding the address 1907 - 11th Street South, Birmingham, where GALT indicated he resided when murder weapon was purchased under name HARVEY LOWMEYER. This neighborhood investigation also extended to include the address 1907 - 11th Avenue South.

All the business establishments in the Five Points South area, which is centered at the intersection of South 20th Street, 11th Avenue South, and Magnolia Avenue, were checked based on a reported taxicab trip of an individual who had been let out in that area.

All the surrounding area and blocks around GALT's rooming house, 2608 Highland Avenue, were checked, including the high-rise apartment building of the Sheraton Apartments at 2909 Highland Avenue, which address had been considered pertinent based on a cab fare picked up at that address and discharged near the rooming house of GALT. All the area around 4th Avenue and 20th Street North in downtown Birmingham was checked, based on the report of a cab driver that he had picked up a fare at that intersection.

The entire area surrounding the Continental Dance Club Studios, aka Friendship Club, on Graymont Avenue, where GALT had enrolled for dancing lessons, was checked.

The names and addresses of all individuals contacted have been made a part of the Birmingham file, but are not being set forth herein in the interest of brevity although some results of contacts are reported on the following pages.

JIMMY PHILLIPS, Standard Oil Service Station Manager, 7953 Crestwood Boulevard, residence 1204 Concord Avenue, Birmingham, furnished the following.

Until about the middle of March, 1968, PHILLIPS had been the Assistant Manager at the Standard Service Station at 2188 Highland Avenue, Birmingham. He recalled a customer at the Highland Avenue Station who drove a white Mustang and whose first name was ERIC. He described this person as a white male in his early 30's, five feet, nine to ten inches, 180 pounds, black hair, combed straight back, neat dresser. easy-going in his manner.

PHILLIPS believes this person at the time claimed he was working for an insurance company or a realty company or possibly Social Security. He made all his purchases in cash and was always alone. PHILLIPS believes this person had been observed by him smoking on occasions, but he could not recall his discussing anything except the night clubs in downtown Birmingham and "chasing women." PHILLIPS believes this man once told him that he was divorced and lived in the Highland area of Birmingham.

PHILLIPS claimed when he first observed this car, it had Georgia license plates and a trailer hitch. PHILLIPS said this man claimed he was from Atlanta and used his Mustang to pull a large boat, with the result that the clutch on the Mustang was then in bad shape.

PHILLIPS believed the last time he saw this man was in February, 1968, and he was positive he could identify him if he saw him again.

All hotels and motels, including all employees on all shifts, were contacted at the inception of this investigation and continued throughout as developments indicated. The names of all such employees interviewed are maintained in the Birmingham file.

TERRITORY OUTSIDE BIRMINGHAM

All service stations, motels and hotels in the territory of the Birmingham Office covering the northern half of the State of Alabama were contacted, which included cities of the Resident Agencies and all highways leading into Birmingham from the States of Mississippi, Tennessee, and Georgia. Highways on which investigation was conducted included U. S. Highway 78 West, U. S. Highway 78 East and I-20, U. S. Highway 31 and I-59 N.E., U. S. Highway 31 North and I-65 North, U. S. Highways 72 and 231 across the northern part of Alabama, State Highway 79 from Birmingham through Huntsville, thence Highway 431 North to Tennessee.

The identities of those individuals contacted during the above investigation have been placed in the Birmingham file.

AIRLINES

All employees of City Ticket Offices and at the Birmingham Municipal Airport of each airline were interviewed and their names maintained in the Birmingham file. As a result of this, one possible suspect whose name was similar to LOWMEYER, namely, W. J. LEHMEYER, was positively eliminated after communication with the Minneapolis Office identified him as a legitimate attorney, whose reason for being in Birmingham during a pertinent period was verified by RICHARD EVANS, Bessemer, Alabama.

TAXICABS

The trip sheets during pertinent periods of GALT's residence in Birmingham and later return to purchase the murder weapon were checked and all drivers on all shifts of each taxicab company were interviewed.

Names of each individual cab driver are recorded in the Birmingham file in this matter.

BARS AND LIQUOR STORES

All bars, liquor stores, and "joints" in the entire Birmingham area, with especial attention to the southside section of Birmingham and the downtown business district, were canvassed and employees on all shifts were interviewed for possible information. This investigation proved negative with the possible exception of one waitress in a downtown lounge, whose interview has been set forth in this report.

Likewise, all similar institutions on highways leading from Birmingham were canvassed without obtaining any positive information.

BUS STATIONS

All bus stations were checked at the inception of this investigation and throughout as developments indicated.

AUTOMOBILE INSURANCE AGENCIES

On the possibility that GALT may have insured the 1966 white Mustang after its purchase at Birmingham on August 30, 1967, all agencies dealing in automobile insurance were contacted and no record could be located of any policy having been insured to ERIC S. GALT.
