Shortly thereafter a girl called into Room 213. MENKE stated that this was a local call, and she heard a portion of it including the fact the individual in Room 213 would be in his room all evening, and that this girl would call back if she would be able to come over and see him. She mentioned Las Vegas and asked him how long it took him to get there. She stated that her girl friend made it in two days.

MENKE advised that the occupant of Room 213 also made several long distance telephone calls, and she believed that they were all to Louisville, Kentucky, however, no record of these calls were made and no calls were recorded because this individual used a telephone credit card and went directly through the telephone operator. MENKE advised that she never observed the occupant in Room 213 and observed Wanted Flyer 442-A stating she does not know this individual and has not seen anyone resembling him.

The following investigation was conducted by SAs CHARLES S. DUKE and MARTIN JOHN WEBER at St. Louis County, Missouri, on May 13, 1968:

MILLIE RIDDLE, 11930 Missouri Bottom Road, St. Louis, Missouri, advised that she is presently employed as a maid for Holiday Inn North, St. Louis County, Missouri, and has been so employed for approximately ten years. RIDDLE stated that on May 12, 1968, she and ROBERT HULL were in Room 217 of the Holiday Inn North, and that HULL was discussing with her the peculiar activities of a guest in Room 213 when they heard the occupant of Room 213 out in front of his room and she locked up and saw this individual and jumped back in surprise immediately thinking that this was the same person she had seen a number of times as MARTIM LUTHER KING's killer.

RIDDLE advised that thereafter she discussed this person's possible likeness to JAMES RAY with employees at Woliday Inn North and after carefully considering what she saw in viewing Wanted Flyer 442-A and St. Louis Police Department photograph of RAY, October 10, 1959, she feels that the individual she saw closely resembles the above photographs.

RIDDLE stated that the person she saw and that occupied Room 213 was a white male; five feet, ten inches to six feet; medium, stocky build: 170; middle 30s.

The following investigation was conducted by SAs CHARLES S. DUKE and MARTIN JOHN WEBER at St. Louis County, Missouri, on May 13, 1968:

JANET WILLIAMS, Desk Clerk, Holiday Inn North, advised that her hours are 3:00 to 11:00 p.m., and at approximately 9:00 p.m. on May 12, 1968, two white males approached the office desk and one of these men asked her if he could check out. WILLIAMS advised that she does not check people out asked this individual to go down to JACK SEDIVY, who is the regualr person who checks guests out.

WILLIAMS advised as he went down to the other end of the counter, she got a good look at the individual who she talked to and observed his profile. After the individual got finished checking out, both individuals went out of the office and got into a large car which had a Kentucky license tag. WILLIAMS could provide no further description of the car.

WILLIAMS stated that she was suspicious of this individual because of his wise-cracking and general appearance, and for this reason paid particular attention to him and watched him leave. After he left, she checked his name on the guest registration list. WILLIAMS provided the following description of the individual who checked out:

WILLIAMS viewed Wanted Flyer 442-A and stated this individual looked very much like the one who had checked out. WILLIAMS was then shown a photograph of subject taken by the St. Louis Police Department, dated October 10, 1959, and WILLIAMS immediately advised that "This is the man." She stated that the side view of RAY was identical to the individual who she saw the day before.

The following investigation was conducted by SAs CHARLES S. DUKE and MARTIN JOHN WEBER at St. Louis County, Missouri on May 13, 1968:

ROBERT LEE HULL, Bus driver, (Bellman), residing at 4726 Page, St. Louis, Missouri, and employed at the Holiday Inn Morth, North Lindberg, St. Louis County, Missouri, advised on May 13, 1968, that approximately 3:00 p.m., Saturday afternoom, May 11, 1968, a man in Room 213 called for a Bellman requesting room service.

HULL stated that when he arrived at Room 213, the door was adjar and as he stepped into the room, a man who was laying on the bed stated, "Don't get close". He said that he had that he had just come in off the road from California, and that he intended to take a couple of hours of sleep. HULL stated that he asked for his name and said he may be needing him again. HULL replied, "What for?", and the man responded by requesting to get him a pint of Old Crow, some ice, two cokes, and some hair spray.

HULL further advised that the man said, "Look, I'll show you something" and he took him outside to where a 1966-1967 Lincoln Continental was parked and said that he had somewhere around \$1,000 worth of clothing in the trunk. The man then opened the trunk and HULL advised that he saw what he considered well over \$1,000 worth of fine clothing.

HULL described the car as a Lincoln Continental, in very good condition, light green with a black convertible top, bearing Kentucky tags. It had a numerical figure 4 in the tag number, which HULL thought to be the second digit. RULL also stated that he saw in the back seat of the car a dark leather golf bag with wheels and a lot of golf clubs.

After the man closed the trunk, HULL then went to Walgreens, located at the Plaza Shopping Center, and made the purchases requested by the man.

MULL further advised that on Sunday, May 12, 1968, at about 3:00 p.m., he saw the man again at Room 213 when he again called for room service. HULL stated that the following conversation took place:

The man said, "Look here, I want you to get me something to eat. Is there someplace you can get me some sandwiches?" HULL answered by stating that he could go to the Steak and Shake or Mc Donald's. The man responded, "Is that something where you can get hamburgers?" To this HULL answered "Yes". The man stated "I want two cheeseburgers, one Coke and some ice." The man gave HULL \$5 at that time and MULL went to the Steak and Shake to make the purchases. Upon returning, the man in Room 213 gave him a \$1.70 tip.

HULL stated that he did not see the man again until late Sunday night, May 12, 1968. He said that he was in Room 217 talking with one of the maids by the name of MILLIE RIDDLE, about the man in Room 213. The door of that room was open at that time. They both heard a noise somewhat similiar to that of an electric motor and upon looking out of the doorway, they both saw the man in Room 213 by the Lincoln Continental. As the man turned toward Room 217, MILLIE jumped back in surprise or fright and told HULL that was the man who shot MARTIN LUTHER KING.

HULL described the man resembling RAY is a man who was medium built, who had brown hair, and who had a small or what appeared to be a small spot or white colored mark on

the upper lip. He was wearing light colored trousers, probably white, a black turtle neck T-shirt or a sweater with short sleeves, and tan cloth-type shoes.

FULL viewed Wanted Flyer 442-A and stated that the photograph taken in 1968 of subject RAY was very similar to the man in Room 213.

The following investigation was conducted by SAs CHARLES S. DUKE and MARTIN JOHN WEBER at St. Louis County, Missouri, on May 13, 1968:

JACK J. SEDIVY, 3328 Krem Avenue, St. Ann, Missouri, Desk Clerk for the Holiday Inn North, advised on May 13, 1968, that he saw the occupant of Room 213 come into the office with another man. He remembered JANET WILLIAMS asked the men if they were together. SEDIVY stated that he heard a remark similar to "We're not married".

SEDIVY stated that JANET sent the occupant of Room 213 down to him and he stated that he did not pay attention to the occupant of Room 213 or the man that came in with him because he was in the process of checking the occupant out. He said as he looked up he remembered seeing the man at about eye level, which made him believe that the man was probably about five feet, seven inches. SEDIVY stated that the man had black hair which was shiny; he had dark blue eyes; little bit better than medium build; had straight teeth when he smiled; and had no visible scars or marks. He described the other man that came into the room with the occupant as being approximately six feet, one inche; about 30 years old; light brown hair; smartly styled hair; 180 to 190 pounds.

Upon viewing Wanted Flyer 442-A and police photograph dated October 10, 1959, SEDIVY advised that the occupant that checked out of Room 213 looked more like the police photograph taken October 10, 1959. He stated. "I could almost swear it was him."

SEDIVY stated that after the men left the office, he saw a car pull around to the vending machines at the side of the building and then take off. He said that was the last time he saw both men and the car.

The following investigation was conducted by SAs CHARLES S. DUKE and MARTIN JOHN WERER at St. Louis County, Missouri, on May 13, 1968:

FRANK BROMMELHORST, 2445 Cheshire Drive, Florissant, Missouri, Auditor for the Holiday Inn North, advised that he is employed at the Holiday Inn North and that he had worked from 7:00 a.m. on Saturday, May 11, until 3:00 p.m. that same date. He stated that he checked a man in at about 1:38 p.m. on May 11, 1968, and assigned him Room 213. He stated that he did not remember what the man looked like nor did he see anyone else with him.

He advised that he questioned the man's signature on the check-in card because it was different from that on a credit card which he presented. The man replied that he was using his sister's-in-law credit card.

BROWNELHORST stated that he checked to see if the credit card was on a list of bad credit cards; he found out that it did not appear. He then rented the room to the man.

BRONKELHORST viewed Wanted Flyer 442-A and photograph takes at St. Louis Folice Department October 10, 1959, and stated that he could not recall whether or not the man resembled the photographs.

NATIONAL KNIGHTS OF THE KU KLUX KLAN, INC. (NKKK)

A source advised that on May 22, 1960, the National Grand Council of the Knights of the Ku Klux Klan met at Atlanta, Georgia, to discuss consolidation of the Klan's unit of effort and activities to establish a National Fund and a National Secretary and to design a new flag. The meeting was attended by representatives of the Federation of Ku Klux Klan, Alabama; Association of Arkansas Klans, Arkansas; Florida Knights of the Ku Klux Klan, Florida; Southern Knights of the Ku Klux Klan, Florida; Association of Georgia Klans, Georgia; Knights of the Klans, South Carolina; Dixie Knights of the Ku Klux Klan, Tennessee; and Kyksos Klan, Texas.

This source advised that at a consolidation meeting at Atlanta, Georgia, September 2-5, 1960, at which the North Carolina and Texas Klans were not represented, it was resolved and passed that their name be changed to National Ku Klux Klan.

A second source advised in March, 1964, that several meetings of Klan groups were held during the period 1960 to 1963 in an effort to unite the Klan groups under a single leadership.

The organization was granted a charter in DeKalb County, Georgia, November 1, 1963, under the name National Knights of the Ku Klux Klan, Inc., as a "patriotic, secret, social, and benevolent order".

A third source advised in December, 1963, that the organization had issued a statement of its program which indicated the organization to be anti-Negro, anti-Jewish, anti-Catholic, and anti-foreign born.

The third source advised in August, 1964, that the organization has a headquarters in Tucker, Georgia, and the day-to-day operations are under the direction of JAMES R. VENABLE, Chairman.

NATIONAL KNIGHTS OF THE KU KLUX KLAN, KLAVERN #14, ST. LOUIS, MISSOURI

A source advised that on October 25, 1965, at a meeting of the National States Rights Party of Missouri, a speaker identified himself as a member of, and organizer for, the Klan and requested all persons interested in joining the Klan to see him after the meeting; that on November 30, 1965, the first organizational meeting of Klavern #14 was held at 2806 North Grand Avenue, St. Louis, Missouri; that on January 14, 1966, William Lon Lockhart announced at a meeting held at El Monti Tavern, 5201 Southwest Avenue, St. Louis, Missouri, that he had been commissioned by the Grand Dragon of the State of Missouri, and was granted a charter to institute a new klavern in St. Louis, Missouri by James R. Venable, Imperial Wizard of the National Knights of the Ku Klux Klan. On August 9, 1967, source advised that the klavern was called Klavern #14 and currently holds its initiations and meetings at rented halls in St. Louis, Missouri.

On 6/27/68, Mr. WILLIAM S. GECKS. Seles Administrator, <u>National Marking Machine Co.</u>, (NATMAR, Inc.), 4026-30 Cherry St., Cincinnati, Ohio, was contacted relative to type of specific information needed concerning the laundry marks found on the ciothing related to the Alten, Illinois bank robbery on 7/13/67.

Mr. GECKS advised it would be best to have color photos of the laundry markings taken alongside a ruler or other fine measuring device. GECKS stated from the information furnished him from Chicago airtel that the markings appear to have been made by a 18 digit machine which can be coded by the user for his own specific purposes. With the use of color photos. GECKS may be able to identify the size of the type used by the machine and other details which would possibly identify the model of the machine used to make the mackings. NATMAN can then furnish a list of laundries or dry cleaners in a specific area that are utilizing NATHAR machines that could possibly have made these markings. WILLIAR, who usually goes by the name PAT GLSON or PAT WILLIAR, worked for a short time as cocktail waitress at French Quarter, Ocean City, Maryland, and then moved to Baltimore, Maryland, where she resided on Park Avenue for a short period and is currently residing on Lake Drive with an unknown woman. She is not known to be employed.

Her father, STANLEY OLSON, will probably know her whereabouts and can be reached at Baltimore telephone number 636-3758, his place of employment.

SHORTLY AFTER THE DEATH OF JOHN F. KENNEDY, MARTIN LUTHER KING. JR .. BECAME PROMINENT AND RAY STATED ON SEVERAL OCCASIONS THAT SOMEBODY WAS GOING TO KILL KING. THE STORY WENT ON TO REFLECT THAT DURING THIS PERLOD AN INDIVIDUAL CAME INTO THE MISSOURI STATE PENITENTIARY, AT JEFFERSON CITY FROM VICKSBURG. MISS., AND WHO. UPON LEARNING OF JAMES EARL RAY'S FEELINGS TOWARD KILLING KING, ADVISED HIM OF THE KK BUSINESSMEN ASSOCIATION OF THE SOUTH AND OF THE FACT THAT PEOPLE IN FIVE STATES WERE PUTTING UP MONEY FOR KING'S ASSASSINATION. THE STORY FURTHER POINTED OUT THAT RAY INFORMED HIM THAT HE INTENDED TO HAVE EVERY-THING SET WHEN HE KILLED KING AND THAT RAY. THROUGH MAPS. LEARNED OF KING'S MOVEMENTS SO HE COULD LATER STALK HIM TO THE POINT OF ASSASSINATION. THE STORY FURTHER POINTED OUT THAT RAY ADVISED HE WOULD LEAVE A FALSE GUN AND FALSE TRAIL IMMEDIATELY FOLLOWING THE MURDER. RAY WAS SUPPOSED TO END PAGE SIX

GO TO VICKSBURG FOLLOWING THE MURDER, CONTACT THE MAN FROM VICKSBURG, MISS., WHO HAD THE HOUSEBOAT, AND THIS MAN WAS TO TAKE HIM EITHER TO NEW ORLEANS OR CANADA VIA THE MISSISSIPPI RIVER.

AT THE CONCLUSION OF THE INTERVIEW, CURTIS STATED HE WOULDNOT TESTIFY TO ANY OF THE ABOVE. HE DID ADVISE IN STRICTEST CONFIDENCE THAT THE NAME OF THE INDIVIDUAL ON THE HOUSEBOAT IN VICKSBURG, MISS., WAS (FNU) WILLETT, ALSO KNOWN AS MISSISSIPPT WHO SERVED TIME IN THE MISSOURI STATE PENITENTIARY.

THE STORY ALSO MENTIONED A MAN FROM NEW CRLEANS WHO COULD OBTAIN ANY KIND OF IDENTIFICATION AND CURTIS LATER IDENTIFIED THIS MAN AS JOE COIN, WHICH INFORMATION HAS PREVIOUSLY BEEN SET OUT IN AN INTERVIEW WITH CURTIS.

THROUGHOUT THE INTERVIEW WITH CURTIS, AND WHILE READING CURTIS' STORY, HE CONTINUED TO EMPHASIZE THE FACT THAT HE WOULD NOT TESTIFY AGAINST RAY AS HE FEARED FOR HIS LIFE.

HE INDICATED THAT ANY STATE PRISON HE WAS SENT TO WOULD PROBABLY HAVE INDIVIDUALS WHO WOULD KILL HIM AS A RESULT OF PREVIOUS INFORMATION HE FURNISHED THE PRESS AND TV MEDIA AND IT IS FELT HE WAS USING THIS AS AN EXCUSE AS TO WHY HE END PAGE SEVEN

DID NOT WANT TO BE SENT TO A STATE PRISON ON HIS CURRENT LIFE SENTENCE, HE STATED HE WOULD NOT ALLOW HIS STORY TO

BE XEROXED NOR WOULD HE WRITE IT OVER AGAIN OR ALLOW THE PAGES TO LEAVE HIS CELL. HE DID STATE HE WOULD TRANSCRIBE HIS STORY OVER A DICTATING MACHINE AND WOULD REDRAW CERTAIN MAPS HE PRODUCED FOR HIS STORY.

HE THEN PRESENTED CRUDE SKETCHES OF THE FED. PENITENTIARY AT LEVENWORTH, THE MISSOURI STATE PEN, IN ADDITION TO THE ABOVE MENTIONED MAP CONCERNING THE TOWNS WHERE KING MADE NUMEROUS SPEECHES.

UACB, CURTIS WILL BE ALLOWED TO DICTATE HIS STORY ON A DICTATING MACHINE IN THE PRESENCE OF SA THOMAS R. HENRY. JR.

DUE TO THE UNRELIABILITY OF CURTIS, NO LEAD FOR AN EXTENSIVE INVESTIGATION IS BEING SET FORTH FOR JACKSON IN CONNECTION WITH IDENTIFYING (FAU) WILLETT; AKA MISSISSIPPI UACB.

RE RAYMOND CURTIS' INTERVIEW IN COUNTY JAIL AT DALTON, GA.

Enclosed herewith for Little Rock and Memphis is one copy of referenced teletype.

PAUL J. DENNIS, Vice-President, Vicksburg Mid River Service, Inc. advised on 7/5/68, that (FNU) WILLETT owned a houseboat known as the "Nell Willie" a dieselpowered ship capable of travel on the Mississippi. (FNU) WILLETT was described as an elderly man who was crippled and used a came. He and his wife, whose name is believed to be NELL, took vacation trips on his houseboat approximately twice a year, securing the services of a Mississippi River pilot to operate the boat for them. (FNU) WILLETT is believed to have died approximately two years ago. He is believed to have been a resident of the State of Arkansas and to have docked his houseboat at the Greenville, Miss. Yacht Club.

WILLIE SMITH, a Negro male employee of the Greenville, Miss. Yacht Club, advised on 7/5/68, that the correct name of the houseboat is the "Nell Willis" and that it was owned by a (FNU) WXLLIS, who died about two or three years ago. NELL WILLIS / wife of (FNU) WILLIS, is still living and

Raymond Curtis submitted a letter to Mr. Charles

Sets forth the essentials:
"Mr. Charles L. Sanders

"Dear Mr. Sanders:

"I thank you for your answer to my letter. I think that details I give you in this letter will be of help to you.

"Well, Sir, I have written a story. No one but myself has read it but me. At this time I know that it will have to be re-wrote for I am not a writing it as bad as it is.

"It all about the crime I did and about a crime I did in 1954 with James Earl Ray and about the 13 years of prison pal and everything we talk about. About thing and about James Earl Ray wanted the job of killing Martin Luther King, Jr. We talk of killing King for three years. And we talked to the man from Mississippi that knew all about the KK businessman association that was to put up the money to kill King. I also know the men from Mississippi.

# JAMES EARL RAY; MARTIN LUTHER KING, JR. - VICTIM

"In that three year we made maps just had to find the right place to kill King. Well I have made the maps over myself. They are with the story also.

"And just where we would go after we killed King so yes when we talk about it I was to be in on it. But I was not. The story has it all in it. All the big thing and the little one also. And what Ray like and what he did not like. This story could get me killed. I know that. That is why I won't send the story by mail. I know that this is getting to be a long letter. But when you read this if you want the story O.K. If not just let me know, O.K. That way I won't talk to men about it.

"Mr. Sanders there are men in five states that is behind the King killing and they don't know what I know. But James Earl Ray did not. Now that they have Ray Tenn. will trial him if they get him back.

"Well, they want me to testify. Well, I just don't know yet what I will do."

"You see, me and Ray were pal. I could tell what I have to the news. That no much. Or I could not say everything. And I did not tell the FBI. Well, this is not a book. I am just trying to tell you what you ask of me in your letter."

"If you have a man or have someone down this way, if you will have them stop by the jail I will let them read the story and you can go from there. O.K.

"I thank you again.

"I will be looking to hear from you soon,

"I am still in the Dalton County Jail."

On July 3, 1968, CURTIS was interviewed at the Whitfield County Jail, Dalton, Georgia, and furnished the following information:

RAYMOND CURTIS was contacted at the Whitfield County Jail and advised of the identities of Special Agents THOMAS R. HENRY, JR. and ALBERT D. MILLARD. He was furnished a rights and waiver of rights form which he read, indicated he understood, but refused to sign. He was advised that he was being interviewed concerning statements he made in a letter he had mailed to Mr. SANDERS of Ebony Magazine.

CURTIS stated he was merely trying to sell a story to Ebony for approximately \$5,000 to help his mother pay off a mortgage on her home. She had obtained this mortgage as a result of paying attorney's fees for the defense of CURTIS at a previous trial.

CURTIS stated that he and JAMES EARL RAY participated in a burglary in Joliet, Illinois, in October or November, 1954. It was pointed out to CURTIS that certain statements made by him in his letter to Ebony Magazine could possibly involve him in a conspiracy with JAMES EARL RAY in connection with the murder of Dr. MARTIN LUTHER KING, JR. CURTIS then stated he wished to go on record as to the statements made in his letter to Mr. SANDERS. He categorically denied the following statements which were in his letter to Ebony Magazine:

- 1) That he and JAMES EARL RAY participated in a crime in 1954;
- 2) That RAY wanted the job of killing KING;
- 3) That he and RAY talked about killing KING for three years;
- 4) That he and RAY talked to the man from Mississippi that knew all about the KK Businessmen's Association which Association was to put up the money to kill KING;
- 5) That he knew the men from Mississippi;
- 6) That for three years he and RAY made maps just to find the right place to kill KING and that he made the maps over himself:
- 7) That he and RAY knew just where they would go after the killing of KING:
- 8) That he was to be in on the killing of KING;
- 9) That there are men in five states who are behind the killing of KING and these men do not know what he (CURTIS) knows.

During this interview CURTIS drew two maps setting out how he thought RAY would stalk KING. This map indicated the following towns where he said KING made most of his speeches: Atlanta, Georgia; Little Rock, Arkansas; Birmingham, Mobile, and Selma, Alabama; Jackson, Vicksburg, and Marks, Mississippi.

CURTIS further advised that there was a man living on a houseboat in Vicksburg, Mississippi, on the Mississippi River whose name he would not divulge who was to take RAY down the River on his boat to New Orleans after the killing. CURTIS further advised that in the past he had pulled several burglaries and armed robberies in towns along the Mississippi River and while police were looking for him on the highway he would be on a boat down the Mississippi. He added that he had written a story concerning the KING killing which was currently being typed and this was the story he mentioned in the letter to Ebnny Magazine and which he intended to sell to Ebony.
