He advised he has been receiving hundreds of calls concerning the campaign and in many cases he does not know to whom he is talking, so he requests the persons to contact his campaign headquarters by mail in order for the persons to receive answers to their inquiries.

On December 15, 1967, a telephone call was placed from Orange, Texas, telephone number 886-9976, to Enka-Candler, North Carolina, telephone 667-4670.

The following investigation was conducted by Special Agent ROBERT S. MOORE at Enka-Candler, North Carolina:

On May 6, 1968, Miss CARRIE JACKSON, Route 1, Candler, North Carolina, who has telephone number 667-4670 on the Enka-Candler Exchange, advised that she knows no one in Orange, Texas, and does not recall having received a telephone call from anyone in Orange, Texas, on or about December 15, 1967. She advised that she has an unlisted telephone, that very few people know her telephone number and that she and her elderly mother are the only persons who use her telephone.

She advised that she does not know how a call could have been made to her telephone without her being aware of it.

Miss JACKSON was shown a photograph of JAMES EARL RAY and advised that she knows no one by this name or anyone who resembles RAY.

The following investigation was conducted by Special Agent CHARLES S. MILLER at Roxboro, North Carolina:

On May 7, 1968, REVIS CARVER, PEARLIE CARVER, and JANIE BLAYLOCK, employees of the Thomas and Oakley Drugstore, Main Street, Roxboro, North Carolina, where pay telephone 599-9083 is installed, were interviewed concerning the receipt of a long distance call from Houston, Texas, on December 15, 1967.

They advised that the drugstore also has a listed regular telephone number 599-3712 which is the telephone normally used to call employees at the store.

On 5/4/68, ARIAN BRODHEAD, manager of the Hamilton House Apartments, 7140 Gaston Avenue, advised V. MAI TEDDER has the apartment number 103 and telephone DA 8-5533. TEDDER is a woman over 40, and spends little time at the apartment. BRODHEAD has never seen TEDDER although TEDDER has been a resident more than three years, and during the time BRODHEAD has been manager, more than a year. TEDDER has talked to her on the phone, and pays her rent regularly. She spends most of her time on a ranch in Oklahoma, believed to be the "Biffo" Ranch (phonetic). BRODHEAD stated when TEDDER is gone her (TEDDER's) nephew stays at the apartment. She described him as approximately 22 years of age, 5' 10", slight build, dark hair. BRODHEAD could furnish no information as to the occupation, relatives, current whereabouts, or the name of the nephew. She described TEDDER as obviously wealthy.

Attempts were made to contact someone at 7140 Gaston Avenue, Apartment 103, from 5/4 to 5/14/68, without success.

On 5/7/68, MRS. BIRDIE SUE BELCHER, Credit Bureau Service, advised her organization has no record of a V. MAI TEDDER.

On 5/8/68, MRS. FRANCYS WALLS, 7140 Gaston Avenue, Apartment 104, advised she lives just across the hall from a MRS. TEDDER and TEDDER had been living in the apartment across the hall regularly until the fall of 1967. She has not been living at that apartment since then except for irregular visits. She allegedly got married to a NED (LNU). WALLS did not know where TEDDER was living or whether she was employed or by whom. She advised a young man stays at the apartment and seems to keep irregular hours. She does not know this person's name as he keeps to himself and she does not know what kind of car he drives or where he works. To her knowledge,

he has no friends in the apartment building. She believes this person is TEDDER's nephew.

On 5/14/68, JERRY WYATT, 7140 Gaston, Apartment 103, was contacted and advised he is MRS. V. MAI TEDDER's nephew and he works at LTV Industries at Grand Prairie, Texas. He advised he does not know how to reach MRS. TEDDER, whether she is married or unmarried at this time, whether she is working or not. He advised he does not ask her her business and she does not ask him his. He advised he had been staying at the apartment during December, 1967, and did not recall whether or not MRS. TEDDER might have been visiting at the apartment during that month. He advised he does not know anyone in Alpine, Texas, and does not remember receiving a call from anyone there. He advised TEDDER is the sister of Deputy JOE TEDDER, Kaufman County Sheriff's Office, Kaufman, Texas, and that perhaps that person might know more about the activities of MRS. TEDDER.

WYATT was shown identification order #4182 and advised he knew no one that was possibly identical to the individual pictured.

On 5/15/68, Deputy JOE TEDDER telephonically advised his sister had married a NED BIFFLE who owns the Biffle Ranch outside of Allen, Oklahoma, telephone Area Code 405 FE 2-3516. He advised MRS. TEDDER could be reached at that location. He stated he did not believe MRS. TEDDER was involved in anything illegal or associated with subject RAY.

A call was placed from Houston, Texas, to Bakersfield, California, number 805-323-2660, on 12/16/67.

Above number was disconnected on 2/15/68, and was formerly listed to C. E. HUGHETT, 3209 Dartmouth, Bakersfield.

On 5/16/68, Mrs. DON HUGHETT, 431 Highland, Oildale, California, advised that during December, 1967, 3209 Dartmouth, was occupied by FRANCINE METROVICH and that her brother-in-law C. E. HUGHETT was staying with FRANCINE during 1967, and allowed her to obtain a telephone in his name.

Mrs. HUGHETT indicated that C. E. HUGHETT was actually living with METROVICH out of wedlock and that METROVICH's character was very questionable.

Attempts to contact METROVICH, 3209 Dartmouth, Bakersfield, California, on 5/16/68, were negative.

On 5/16/68, C. E. HUGHETT, telephone number 325-2950 advised that he dated FRANCINE METROVICH during the latter part of 1967, and allowed her to obtain a telephone in his name. He said he knows nothing specific re any particular telephone calls from Houston, Texas, but that he believes there were several long distance calls charged this telephone number 323-2660 during the latter part of 1967. He added that he received a telephone bill of over \$100 during late 1967 or early 1968, and that METROVICH has never paid this bill resulting with problems with the telephone company.

On 5/17/68, FRANCINE DOYLE, aka Francine Metrovich, 3209 Dartmouth, Bakersfield, California, said she could recall only one long distance telephone call during mid-December, 1967. WILLIAM CARL HENDERSON, Route 5, Box 311,

following information:

HENDERSON advised that he currently works out of  
Iron Workers, Local Number 469, Jackson, Mississippi. He  
advised he is currently employed in Vicksburg, Mississippi.  
HENDERSON further advised that he has lived at his current  
address for the past 18 years.

HENDERSON stated that on or about December 16,  
1967, he received a telephone call from SYLVIA SNOWDEN,  
white female, who resides in Houston, Texas. HENDERSON  
stated that SNOWDEN mentioned the fact that she was calling  
from a pay phone. HENDERSON went on to say that SNOWDEN  
lived with him for sometime up until October, 1967, at  
which time she left for Houston. HENDERSON said he was  
not married to SNOWDEN.

HENDERSON advised that SNOWDEN told him she was  
pregnant by him. He added that he knows SNOWDEN to be a  
compulsive liar. He further advised that he knows SNOWDEN  
to be living in Houston with a JIMMY (Last Name Unknown)  
(LNU), white male. HENDERSON stated that he knows JIMMY LNU  
to be a pipe welder working out of a local union in Houston,

advised that he knows both SNOWDEN and WILKINSON to be originally from Meridian, Mississippi, and to be prostitutes who work as barmaids. HENDERSON went on to say that JIMMY LNU, SYLVIA SNOWDEN, and GLENDA WILKINSON stayed at his residence either the day of or immediately after the slaying of KING and he knew them to have arrived from Memphis, Tennessee. He described JIMMY LNU as a white male, 5'9" to 5'10", 160 pounds to 170 pounds, approximately 24 years of age, brown hair, medium build, with eyes close together - oddness about the eyes, and a very neat dresser.

He added that JIMMY LNU was somewhat quiet and seemed to observe a lot. He stated that after staying with him for a couple of days, the trio left for Larose, Louisiana, where WILKINSON is employed as a barmaid. HENDERSON said he thought both SNOWDEN and JIMMY LNU went on to Houston. HENDERSON advised that it was his impression that JIMMY LNU was originally from Louisiana, but had been in Houston for some time. He further advised that he thought JIMMY LNU to be in some sort of trouble and perhaps out on bond for "shooting up a place" in Louisiana.

HENDERSON advised that he knew SYLVIA SNOWDEN could be reached at telephone number 453-2874 in Houston. He also said that he knew her to have worked at one time at both the ElRanch Lounge on Raymond Road, Jackson, Mississippi, and the Capri Lounge, Cooper Road, Jackson, Mississippi.

HENDERSON stated that he had seen pictures of JAMES EARL RAY in the newspaper, and that JIMMY LNU did not resemble the pictures he had seen in the paper. HENDERSON could provide no further information at this time.
