ReSFlet to Bureau 2/17/70, regarding a portion of a letter that MARIE MARTIN DENINNO, 11075 Oxnard St., Hollywood, Calif., directed to R. DENINNO, FBI # 821 464 D, Soledad # B12713, State Prison, Soledad, Calif.

A review of the Memphis files concerning this matter revealed that MARIE MARTIN, aka Marie Deninno, was interviewed on numerous occasions by Agents of the Los Angeles Division in connection with her association with JAMES EARL RAY during the period RAY resided at the St. Francis Hotel in Los Angeles and during the period that RAY made a trip to New Orleans, La., in December 1967 accompanied by MARTIN's cousin, CHARLES STEIN.

During these interviews, it was determined that RAY traded a console television set to MARIE MARTIN in exchange for a portable television set. It was also ascertained that RAY did leave a set of barbells for safekeeping with MARTIN, and these barbells are currently in possession of the Los Angeles FBI Office.

A review of Memphis sub file in this matter concerning evidence submitted to the Bureau failed to reveal any information to indicate that the console television set formerly owned by RAY and the barbells in possession of the

Therefore, MARTIN's story regarding fingerprints obtained from these weights and TV set is a complete fabrication.

UAC by the Bureau, the Los Angeles Division is not being requested to reinterview MARTIN concerning any book that MARTIN contemplates writing concerning her association with JAMES EARL RAY.

Information copies of this airtel have been designated for Los Angeles and San Francisco in order that these divisions may be aware of the Memphis Division's evaluation of MARTIN's letter to DENINNO.

JR., supposedly on Page 136 of this book, the author

having used their names as references in order to gain employment as a waiter. The names of the references in this book supposedly were CHARLES and MARIE DENINNO. The Police Constable pointed out to Sgt. NOBLE that he believed the DENINNOs mentioned in this book were possibly related to his source and that there might be some significance which would aid in developing past background re JAMES EARL RAY. The Police Constable's source is unavailable but the Police Constable is attempting to locate him for additional details.

It is believed that MARIE DENINNO referred to in referenced airtel is MARIE MARTIN, aka MARIE DENINNO, who was an associate of the subject JAMES EARL RAY at Los Angeles during late 1967 and early 1968. At that time, MARIE MARTIN was a cocktail waitress at the Sultan Room, a bar in the St. Francis Hotel in Los Angeles. She knew the subject as ERIC GALT, and it was at MARIE MARTIN's suggestion that the subject and MARTIN's cousin, CHARLES STEIN, traveled from Los Angeles to New Orleans for the purpose of bringing the children of another cousin, RITA STEIN, back to Los Angeles during December, 1967.

For your information, CHARLES STEIN, RITA STEIN, and MARIE MARTIN have all been interviewed on several occasions regarding their knowledge of the subject, and it is not believed likely that they are now in possession of any worthwhile information which they have not previously furnished.

For the information of WFO, subject JAMES EARL RAY is now being represented by J. B. STONER of the National States Rights Party; RICHARD J. RYAN, a Memphis, Tennessee, attorney; and BERNARD FENSTERWALD, JR. An article appearing in a Memphis newspaper indicated that FENSTERWALD is from Washington, D.C. and heads a private group called "The Committee to Investigate Assassinations." According to the article, FENSTERWALD worked for the Senate Judiciary Committee from 1957 until 1968.

Assistant Attorney General CLYDE MASON, Memphis, Tennessee, the state prosecutor assigned to the JAMES EARL RAY case, has asked that we furnish him any information available concerning FENSTERWALD and his political linkings.

For the information of Birmingham, the subject has not exhausted all possibilities of appeal from his present sentence. However, if subject's appeals are successful, it will only mean that he will be given an opportunity to stand trial for KING's murder.

Since the subject is receiving free, or presumably free, legal assistance, it is anticipated that these appeals may continue for several years or longer.

Should the Department be agreeable to dismissing the Federal warrant now outstanding at Birmingham, Memphis has no objection as it sees little likelihood of RAY's being acquitted on state charges even if he is ever allowed to stand trial on these charges.

Re your airtel 6/5/70 captioned as above.

Bernard Fensterwald, Jr., was the subject of applicant-type investigations in 1949 and 1959, which developed the following information which you may orally furnish to Assistant Attorney General Clyde Mason. Fensterwald was born [redacted] in Nashville, Tennessee, graduating from Harvard University in 1942 with a Bachelor of Science degree and thereafter attending Harvard Law School, Harvard University, where he was awarded a Bachelor of Laws degree in 1949. The names of his mother and sister appeared on a list of delegates and members in 1942 of the Southern Conference for Human Welfare, which has been cited by the House Committee on Un-American Activities. In 1956, while employed by the State Department, Fensterwald and his mother traveled to the Soviet Union. In addition to his employment by the State Department, Fensterwald was also employed as chief counsel of the U.S. Senate Committee on the Judiciary; Subcommittee on Administrative Practice and Procedure (the Long Committee). He has also been employed on the staffs of a number of Senate committees.

For your own information and guidance, our contacts with Fensterwald have made it clearly evident that he was unscrupulous, untrustworthy and anti-FBI and frequently endeavored to draw the FBI into conflicts around the country by his requests of various telephone companies and other sources who might have information of wiretaps and other technical surveillances by the FBI. In January, 1966, in connection with hearings scheduled to be held in San Francisco, Fensterwald indicated that ex-Agent William Turner would be one of the witnesses he intended to call in connection with the extent of FBI wiretapping. As you are aware, Turner is extremely anti-FBI

Dear Sir,

I was advised by the local police department that I should write to you to find out about petitioning the court to reopen a case that has been closed on the basis of further information (information involving material evidence which was disposed of but of which I have certain knowledge). I am referring to the case of James Earl Ray in the assassination of Martin Luther King, Jr. The assassination was definitely a conspiracy on the part of some Nazi or Nazis from the evidence I received, meaning other than Mr. James Earl Ray. The local district attorney's office and the local police department said I might need an attorney to file such a petition. I would like the name of an attorney in Memphis (other than Richard J. Ryan, to whom I have already written) if this is necessary. If your office can handle the matter, I would appreciate that information also. Thank you.

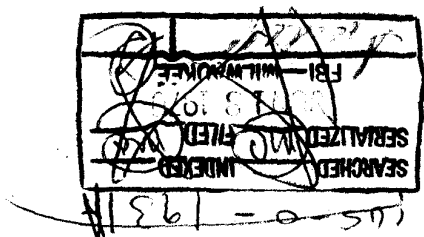

Dear Mr. Hoover,

In regards to the assasssination of Martin Luther King, Jr., in Memphis, Tennessee, in April of 1968, I would like to draw your attention to the fact that there may be a "package" yet wandering around or parked someplace in the Kenosha area addressed to me care of Dell Horscope in New York City. I received the package in a Dell envelope, but this I almost immediately threw away. The "package" was an old brown wrapper envelope (about the usual 8"x12") containing a letter from some old man in Canada (Toronto-Montreal area, I believe) who wanted to know his "future". He gave a birthdate which I cannot recall off-hand but which involved five planets in the sign of Taurus. I also found in the "package" some newspapers, the Canadian Sun front page for one day in 1941, on which date a photo appeared of an unidentifiable flyer (face covered) and a short comment under the picture about the flight of Rudolf Hess to Scotland. Also included were some of the same newspaper's want ads. These were not marked in any way so I made nothing much of them other than that this was an answer to my "feeler" to some television news reporter (I forget which one), meaning my statements: "I like the American Nazi Party". Apparently some Nazi (or Nazis) heard about it and decided to let me hold some evidence on a future political assassination. I immediately answered the letter and tore it up and put it in the garbage (a milk carton with old scalloped potatoes or something). I duly noted that there was a news leak in the Kenosha post office as the address I wrote to was broadcast by the local networks. You realize that I do not like being under surveillance when I have committed no crime whatsoever, and I am finding it difficult to remain "tactful" in this letter to you. What I choose to do about mail that comes to me is my business and no one else's. This is a free country and I consider that an invasion of privacy. If it were not for the fact that James Earl Ray has admitted in public that there was a conspiracy, I would not be telling the U.S. authorities anything at all, that's how angry I am. To get back to the "package" - I slipped it in among some old stuff I had around the house (in a closet off the bathroom at 5700 19th Ave, Kenosha - the package came to 1902 17th Ave. as that is the address Dell had for me at the time - I had sold two articles to them). My parents can verify the existence of the package and also the fact that it came in early June, so that James Earl Ray could not possibly have mailed it himself, from the very dates of his work in Chicago (Winnetka). You might check with Dell to see if anyone remembers the package - what also came with it was the ~~same advertisement for~~ a Chicago Baptist Church - doubtless mailed in Chicago, but timed to arrive with the package so that I would know that some Negro minister or other was going to be murdered. I had not the faintest idea who the intended victim would be, nor any other details. I wrote back because I was being so harassed and was so sick at the

time I needed the Nazi Party. As I recall, I did the usual horoscope and mentioned that on the basis of a stellium in Taurus the individual could be expected to live a very long life. I definitely did not approve of your giving out publicity photos of James Earl Ray - that wasn't conducive to a long life, which are the odds on a racial murder, which was what I suspected.

You have to realize that since my parents had opened the thing and ran over to drag me to their house to see it, that I had to answer (and wanted to) so that perhaps the organization would give some indication of the victim and so on, so that I would know the specific crime. Quite bluntly, I wanted that assassin as a future husband or friend whoever he was - I assumed the source of the "deal" was George Lincoln Rockwell and I trusted his judgment on that score. He was bound to have a good man lined up for the job. As I saw it, I was merely to keep the material as future evidence to support the assassin in case he got into deep water. I had no idea such a prominent man as Martin Luther King was involved, and I did rather go into a state of shock over it, especially when the assassination of Robert Kennedy confirmed the tip-off I received in January or February (prior to the 8th) about "two white papers".

As I recall, after Rockwell was murdered, I was so upset I decided to take a chance that if I threw the "package" out, someone might rescue it and turn it over to local authorities to keep - I have my pride and I would not approach any authorities on the Nazi Party personally. But Rockwell was dead, and I wanted that assassin back in the country as company for me. I duly noted that while apparently there was plenty of "heat" all over the country and abroad, there was very little information given out in Wisconsin. When will authorities learn that lack of information is as much of a dead give-away as "heat", and I already suspected the material was being used or suppressed someplace along the line? I have been patient long enough. I have already written to one of James Earl Ray's lawyers about the package and stated specifically that he could not have mailed the tipoffs to me (in 1966 I had received a Baptist Church advertisement from Chicago through Dell) himself. You realize also that he and his American cohorts (if there were any) could not have collected and packaged that stuff themselves - someone had to have been saving those old newspapers and possibly that old hand-written note (it, too, was rather old, in distinctive black ink and hand-writing - stylized, you might say).

I am sorry I didn't keep the stuff, but I had a real mad on with all that stuff about the Communists (read Witness some time - I didn't like it), although it was a nice temporary "cover". That's why I don't feel like suing over the allusions to me and my family. So - the package came in early June, I answered, the note was destroyed immediately and the package tossed out in September 1967 (first week of Sept) just before I moved (I was evicted). I'm still thinking of suing ABC for the use of my name for advertising purposes without my interest or permission - specifically the Storer Broadcasting Company. They started in in 1966, as far as when I first noticed it.

Oh, I might mention that the Britisher who came by Global knew about both assassinations and was merely sent around to see me to let me know about the Kennedy business in advance. He was about six feet tall, sandy-gray hair and moustach (resembling that of a Schnauzer) well-dressed (light colored suit - maybe grey or blue, but not very light- the weather in early February was very warm that day here in Kenosha). He was extremely healthy and alert - he tapped at the back door, the entrance to the apartment above, and raced around the house to my porch and stood there - then he tapped at my door - I was sitting quietly on the couch listening - it was mid-morning, the sun was shining, there was no traffic whatsoever on 22nd Ave, which is normally a very busy streets many hours of the day. I opened the door, he enchanted me with his British accent, saying that he was an insurance agent for the lady upstairs. Then he asked for "Mrs. Schwartz". As I recall, his exact words were, "Is there a Mrs. Schwartz here?" and gritted his teeth (I looked like such a mess - I had been so sick). I said "Why don't you try the lady upstairs?" and he left. As he walked away, he held the top of his head looked backsort of, and waved a white cardboard twice. Then I just sat around. I immediately arranged to leave town, first informing my permanent mission in New York and later informing them of my departure date (April 3, the first day my brother had open for me to leave for a rest). I lost my cool - I said out loud "Lee Harvey Oswald, you <sup>might have at least</sup> should have tried for just one bullet". I suspect somebody heard it, and the harassment has continued. I am planning to leave this state for Knoxville, Tennessee, in the near future - I want to keep an eye on the possible retrial of James Earl Ray. But actually, I had no idea that "they" would have the nerve to try for another Kennedy, I was suspecting political murders and that's all. At the time I assumed it was merely somebody in the know who was tipping me off that possibly Kennedy was due to get it someplace - I assumed that if I heard it it must be common knowledge, because I am usually the last one to hear anything at all.

I would have loved to get in touch with the Nazi assassin, to let him know what was going on, to attempt to call him off (which would not possibly have been very smart- you know how the Nazis are when they have something set up - they are apt to be extremely unappreciative of objections from mere women, and you saw what happened to Rockwell). As it was I had tossed out the letter, and I assumed the assassin would be long gone anyway, in case I might tip off the authorities and they might go to that address. But I could not take the chance of writing to any of the Nazis now that Rockwell was dead - he was the only one I would have trusted in something so big. And I couldn't write to him either at the time I received it - I assumed he knew of it, and you will note that Patler murdered him as he came out of a laundromat (the noise on the networks was that I am "schizophrenic", and you know what the books say about that - I'm not, but I had a good old-fashioned case of delirium there from abscessed teeth for a while - it lasted well into <sup>early</sup> 1968 - I had my teeth fixed in June, 1967, but then I had very bad colds and tonsilitis in early 1968). That may have had something to do with the fact I was writing to the USSR for a while, and Patler perhaps thought I talked about that "package" to them.

If he was trying to fix it, Patler can go fly a kite. The first the Soviets heard was my letter about the Britisher, and even then they didn't know what or how much I knew or anything. Since it was Federenko who made me suspicious that another Kennedy might just get it, they sure couldn't do much but swallow their words about that one. I try very tactfully not to mention it to them, but in a way I feel I have them pinned down, so to speak. I really don't want to get old Federenko in trouble, so I pretend I didn't even notice anything. Which I think is brighter than the comments of that jackass Eugene McCarthy. Some Irish have the tact of a pack of apes. I felt I had to tell that lawyer Ryan to be tactful in fishing around Kenosha for that "missing package". If it is around, I'm hoping he subpoenas it as evidence, since the defense has a right to any material available to the prosecution. Now, I subtly made it available to the authorities, if anyone was on the ball. I have to give the defense their chances, which was my intention all along. If the FBI had access to it, I hope it turns up. I will advise him to check with your agency here, too.

I am not part of any conspiracy other than my and Rockwell's attempts to find me a Nazi husband. I am known to enjoy battling with the Irish (more fun making up), so I guess that was the best he could come up with - must be pretty nice, too, that James Earl Ray. I'm sorry the Nazis didn't understand my interest in the USSR - very sorry. I don't feel much like talking to them since they cremated Rockwell - I don't like cremations. Oh, that line about the bleach was Rockwell's attempt to cover up the "package", but I just forced myself to read about it later, just this fall - I may have heard it on television, though.

I may be way out of line in talking to the FBI about this, as I don't know what kind of a retrial Mr. Ray's lawyers are working on - possibly a state trial again. Myself, I would think conspiracy trials have to be held in federal courts if the case involves a variety of states and also people from a foreign country. (The "package" was mailed in Canada). When I threw the stuff out it was not yet evidence of anything but perhaps criticism of my religious writings and perhaps a hint that I should join some Negro church myself - so I now practice black magic instead. Would you believe it, I even bought a copy of Mein Kampf (please don't tell the Nazis, but I am not overly impressed thus far - I'm only reading it in memory of Rockwell, anyway). I don't even want to discuss the Communists, I get a headache just thinking about them. Some time when this Nazi business is taken care of.

I'm rather teed off at that lousy Arab, but if that Britisher knew about it, and he wasn't an official foreign source (you know what I mean, I'm sure), I think some effort should be made to get him a life sentence in the hopes he'll talk (I read he lost his cool in court - he may just do it again). I'll still bet it started from some Arab guerrilla "plot" and the guy was planted, but the Communists wouldn't tell anyone - and with my name being used and my address to put me up as a target again (I know what Witness was put out for - anybody in the US government willing to apologize to three generations

of Pestkas and Sutki 'czs. The latter were royalis in (e you hadn't heqrd. The former never discussed it. I'm waiting for an apology, not for warm wishes from the President - it is a little too latefor that. But I like a good argument too much to care to see Nixon drop dead. No conspiracies hatching around here, and by now, with all the network heat, I doubt if I ever will hear anything again.

Please don't send any ~~more~~ of your agents out to see me here in Kenosha - the neighbors are too nosey, and strangers stick out like sore thumbs. Maybe in Tennessee, I don't know. I sure didn't like the man who was so snarly in Kenosha in 1967 when I called to ask the address of the Communist Party in Kenosha (if there was one, which I guess there isn't). I also don't like doling out information and then not receiving any in return. I would have loved to have heard about the prints on the material I got, but then I know you people never tell anything anyway, so we're both possibly out in the cold. The German Nazis put out a nice front about the "package" - it proves my word is good about it - I really would hate to drag my parents into this. If it's around their prints are on it, too. Mine are. Doll's are (or were). And someone else's.

Oh, for your information, there was abother one like the Galt of Memphis here in Kenosha in 1966 - the Vis. Employment office sent me over to St. Catherine's to work as a potwasher and there was some temporary help there - a "Jim" who vaguely resembled James Earl Ray (he grabbed my stomach to see if I was pregnant and I wanted to kill him - but I quit at the height of the rush instead) and an Al who made a point of his "sore feet". "Jim" made a point of being from "Canada". I didn't like either of them. Am I getting through to you about what was going on? They did a nice job on the addressing of the package - it was made to look like my own handwriting on the outside, vaguely - but ~~ø~~ you see I have never been to Canada in my life and likely never will, of course. I am not interested in "election-swinging" - I am not a part of such goings on - I will not tolerate an attempt on the part of the USA and Canada to "frame" me in to keep me quiet, is that clear? I have been very busy spreading the word, and I will not shut up about it. I'm healthy now, I'm not sick. I want to see James Earl Ray's case handled right and I want to find a nice job and I never want to hear about it again. I am not on speaking terms with whoever was at the bottom of it - I don't know. I took a real mental and emotional beating from that Democrat I was married to after that Jack Kennedy business, and no men are ever around me any more - I'm tired of prejudice against my face and nationality and I'm tired of being used. I see someone has "cooled" the networks lately - too late. for that, too - nothing more to be milked from me, and this time I'd like to see justice served properly, instead of having to read about some Jew covering up the facts by murdering an "assassin". It won't do any good for anyone to try to shut me up - information is good any time a person chooses to use it, and now I have given you some information. All I've seen from my letters to Nixon was a batch of oddly marked photos - sorry, they are quite secure at the moment. Nice rigging, but I'm still an ESP-ist, with "help".



Now that I'm wise to that, no more photos from machine in U.S.A. So much for that.

It's too bad I couldn't come forward before Ray's original trial, I realize it is difficult to reopen a case, but evidence is evidence, and information is information, you know. I would hate to think the FBI is not up to its usual "old college tries" in this matter. Try the garbage collectors, though from one character's comment that he was "Pete the Porter", I have my suspicions about the "package". I don't expect to have to ~~publish~~ publish a book about it to get the truth out. Well, don't broadcast away any more, hmm? You wouldn't want to get a witness murdered, now would you? In any case, I'm feeling very lively. And very alive. I shall expect some response to this letter, and I don't mean my arrest, either. I also don't expect any more "dates" to appear in the news columns, nor "allusions" - really, Douglas MacLean's fondness for "allusions" is extremely unpopular with me. That's the trouble with the USA - it's such a lying, blabbermouth country. When a person does tell the truth, all she sees is more bilge in the press. I don't like it. I'd like to see a response worthy of its salt - a retrial for James Earl Ray and more consideration about that Arab. Thank you for your patience.

P. S. All my arrangements to leave town are being made. I want to get a US passport here where I am now, so I may have to delay until August, and I will be low on cash anyway. I am on state aid here and I am planning to take part of a check as the local social worker said I should, to go job-hunting. I am trying in Kenosha for a temporary job, but the situation is very poor.

P.P.S. To finish describing the Canadian or Britisher: blue eyes, average oval face (pointed chin), good teeth, average body frame not thin for over 6 feet, but not as broad-shouldered for his height, say, as Mr. Ray. His clothes looked like money or at least a decent income. He was between 35 and 45, closer to the latter figure, which was what surprised me about his age. (Unless he was <sup>he was</sup> prematurely gray). The way he hot-footed it away, he could be anyplace by now. Since I mentioned the incident in a letter to the USSR the next day or so and I assured the Kenosha post office was still leading my private business, I would think you'd know about it and be doing something about it. What's the U.S. govt's stance this time?

On 7/16/70, BILLY D. HODGES (protect identity), racial informant - PROB, was contacted and stated that NEUMAN BRITTON, his wife SALLY, and a couple of their daughters went to Atlanta, Georgia, from 7/2/70 to 7/13/70 to help J. B. STONER with his campaign and parade on the 4th of July. After helping STONER with his campaign, they returned to Arkansas through the State of Alabama and Nashville, Tennessee. SALLY BRITTON bragged to him that during the parade in Atlanta, Georgia on 7/4/70, they had 18 guns in the car. NEUMAN BRITTON was armed with a .38 caliber revolver and J. B. STONER always had one hand on a shotgun during the parade.

NEUMAN BRITTON was scheduled to fly to Norfolk, Virginia, on 7/24/70 to make a speech before an NSRP group in that city.

On 7/18/70, HODGES was again contacted and furnished the following information:

He saw NEUMAN ROY BRITTON and SALLY ANN BRITTON on the evening of 7/17/70. At that time NEUMAN BRITTON told him their plans had been changed and that he and SALLY were driving to Jacksonville, Florida, on 7/22/70 in the station wagon. HODGES stated this means a 1966 Chrysler station wagon, red in color, Arkansas license BTE 841. According to BRITTON, they planned to stay approximately one week in Jacksonville, Florida, and then may travel to Norfolk, Virginia, for a speaking engagement.

Informant said that during his conversations with the BRITTONs, he is of the impression they are hurting for money and NEUMAN BRITTON told him he was currently working full time for the National States Rights Party (NSRP).

Regarding the J. B. STONER parade in Atlanta, Georgia, on 7/4/70, informant advised as follows:

NEUMAN and SALLY BRITTON bragged to him that the brother of JAMES EARL RAY rode in the parade with them in the same car as J. B. STONER, NEUMAN and SALLY BRITTON, MARY ANN BRITTON and PAT HARRINGTON. (It is to be noted that MARY ANN BRITTON is the daughter of NEUMAN BRITTON and PAT HARRINGTON is the daughter by a previous marriage of SALLY BRITTON.)

NEUMAN BRITTON made the first speech at Atlanta, Georgia, on 7/4/70 and J. B. STONER made the rest of the speeches. SALLY ANN BRITTON told the informant that there were very few police officers on the street, with the exception of a few colored patrolmen and they had no protection whatever. During the parade they had 18 guns in the car, all of which belonged to J. B. STONER. NEUMAN BRITTON carried a .38 caliber revolver in his pocket during the parade and STONER had his hand on a shotgun at all times.

While they were in Georgia helping J. B. STONER with his campaign, they had a meeting at Griffin, Georgia, on 7/11/70. According to BRITTON, three carloads of "niggers" came to the meeting and a bunch of klan members went out with shotguns and ran them off.

PAT HARRINGTON and MARY ANN BRITTON are currently in Savannah, Georgia, where they are helping ROY WAKE, the Illinois NSRP state organizer from Chicago, Illinois, to distribute material promoting STONER's campaign. Informant said according to SALLY ANN BRITTON, PAT HARRINGTON and WAKE are going to get married and WAKE is going to leave Chicago and take up residence in Arkansas where he can help with the NSRP.

PAT HARRINGTON, MARY ANN BRITTON and ROY WAKE are supposed to meet SALLY and NEUMAN BRITTON in Jacksonville, Florida, on 7/23-24/70 and HARRINGTON and WAKE will probably be married at that time.

SALLY BRITTON told informant that she and NEUMAN BRITTON were pictured in the July issue of Jet Magazine, a Negro publication. She also stated that she and NEUMAN and several others were pictured in a newspaper, the name of which he could not recall.

Regarding the meeting in Decatur, Arkansas, on the weekend of 6/26-28/70, informant stated that BRITTON told him that the persons attending the meeting were BUD REESE of Oklahoma, ART LOGAN of Oklahoma, and LOGAN's brother-in-law, name unrecalled; ARNOLD MURRAY of Gravette, Arkansas, and ROY and MADGE, father and step-mother of NEUMAN BRITTON. BRITTON told him not too many people were there but they had a "powerful meeting."

For the information of Savannah, the meeting held at Decatur, Arkansas, on 6/26-28/70 was carried in local newspapers as the annual convention of the First Covenant Church. Informant stated he knew it was to be listed as an annual convention but he attended the convention last year and knows that it is just a meeting where they verbalize the NSRP hatred.

On 7/31/70, GEORGE BEN EDMONDSON, a former Top Ten Fugitive, who is presently residing and working in Pittsburgh, Pennsylvania, under the assumed name of ALEX BORMANN, personally appeared at the Pittsburgh Office at which time he furnished the following information:

EDMONDSON advised that he is presently residing with his wife JINETTE and his young son at Brighton Terrace, Apartment 403, 721 Brighton Road, Pittsburgh, Pa. 15233, after having recently moved to Pittsburgh from Montreal, Canada, where he had been living and working since his release from the Missouri State Prison (MSP), Jefferson City, Missouri, on \$5,000 bond pending an appeal with the Missouri Supreme Court on his armed robbery sentence. EDMONDSON stated that since his release from MSP he has been living and working under the assumed name of ALEX BORMANN. He stated he is employed as a project engineer by Rust Associates, Ltd., Montreal Canada, a Division of Litton Industries and was recently transferred to Rust Engineering, Pittsburgh, Pa., for a new work assignment. EDMONDSON stated that officials of Rust Associates, Ltd., and Rust Engineering, Pittsburgh are cognizant of his present status and his background as a former Top Ten Fugitive.

EDMONDSON advised that his purpose in contacting FBI, Pittsburgh at this time was because he was greatly disturbed over some recent developments that have come to his attention which could result in his identity being exposed, thereby jeopardizing his employment and all that he has accomplished since his release from prison.

EDMONDSON stated that he recently learned that a book entitled, "I Slew a Dreamer," written by WILLIAM BRADFORD HUIE, published by Delacorte Press, New York City, is being sold throughout the United States and Canada. He stated that this book is a story about JAMES EARL RAY and the events leading up to the murder of MARTIN LUTHER KING. He stated that upon reading this book, he determined that his name and some of his aliases, including ALEX BORMANN, are frequently mentioned in several chapters of the book with regard to the author's suspicions that he, EDMONDSON may have been involved with and influenced JAMES EARL RAY in the plot to murder KING, while both he and JAMES EARL RAY were serving prison sentences together in the MSP.

EDMONDSON stated he is fearful that notoriety of this book will lead to his subsequent exposure by some news media tracing him to Pittsburgh. He stated he has already received one anonymous telephone call at his place of employment wherein the caller suggested he go to a bookstore and read, "I Slew a Dreamer" which he would find very interesting.

EDMONDSON stated that he immediately notified his attorney, JAMES A. DUNN, Carthage, Missouri, of the contents of the book and mailed him a copy to read. He stated that he has also brought this book to the attention of his superiors at Rust Engineering, Pittsburgh. He stated that if he should be exposed he will consider filing a damage suit for slander against the author and publisher of the book. He stated that insofar as the author's suspicions, that he was involved with JAMES EARL RAY in the murder of KING are concerned, they are not true and FBI records would substantiate him on this as he was extensively interviewed along these lines by the FBI after his apprehension as a Top Ten Fugitive.

EDMONDSON stated that he was merely bringing the above mentioned developments to the attention of the FBI for informational purposes. He stated he is awaiting instructions from his attorney as to what action he should take with regard to his problems.

The above information is being forward to the Bureau for informational purposes only.

On Sunday, September 6, 1970, an individual who identified himself as J. M. BISHOP, a writer, telephonically contacted the Clerk on duty, requesting that I contact him at 6:00 PM, September 6, 1970, at the Downtowner Motor Inn, Memphis.

I contacted JIM BISHOP telephonically the evening of 9/6/70. He stated that he is preparing a book on the death of MARTIN LUTHER KING and that he had been conducting a number of interviews in Memphis. He stated that about all he needed from the FBI was an introduction to the doctor who either accompanied Dr. KING in the ambulance to the hospital or who first attended KING on arrival at the hospital.

JIM BISHOP also commented about an organization known as "The Invaders" in Memphis and asked if I knew about the Invaders.

I pointed out to JIM BISHOP that the prosecution of this case was handled completely by the office of Attorney General PHIL M. CANALE and that attorneys for JAMES EARL RAY are still filing post-sentence motions. I further pointed out to JIM BISHOP that for the reasons stated, it would be improper for me to make any comments about the case in question.

JIM BISHOP stated he did not agree with my position but that he would have to accept my answers.
