"DUKE" WAS A WHITE MALE, APPROXIMATELY 6', 180 LBS., DARK HAIR, WALKED WITH A LIMP, DROVE A LARGE DARK CAR WITH A GWINNETT COUNTY TAG. "DUKE"

ARNOLD RAY GODFREY, AKA RAY GODFREY, INTERVIEWED AND DENIED ALL KNOWLEDGE OF ANY ASSASSINATION PLOT REGARDING MARTIN LUTHER KING, JR., WAS NOT FAMILIAR WITH NAMES CLAUDE AND LEON POWELL, BUT AFTER OBSERVING THEIR PICTURES KNEW THEM TO BE FREQUENT VISITORS TO PETE'S PLACE. GODFREY ADVISED HE WAS EMPLOYED AS A BARTENDER AT PETE'S PLACE. HE DID NOT TALK WITH EITHER OF THE POWELLS REGARDING THE ASSASSINATION OF MARTIN LUTHER KING, JR., NOR DID HE INTRODUCE ANYONE TO THEM REGARDING THE ASSASSINATION OF MARTIN LUTHER KING, JR. POWELL ADVISED A COUPLE OF DAYS AFTER THE INITIAL CONVERSATION WITH GODFREY WHILE THEY WERE IN PETE'S BAR A WHITE MALE ENTERED THE BAR INQUIRING ABOUT THE POWELLS. AFTER LOCATING THEM, HE STATED HE CAME TO TALK TO THEM CONCERNING A MATTER THAT HAD PREVIOUSLY BEEN DISCUSSED AFTER THEY ACKNOWLEDGED IN THE AFFIRMATIVE THAT THEY KNEW WHY HE WAS THERE. THE WHITE MALE, WHOM POWELL IDENTIFIED AS RALPH, THEN ASKED IF THEY WERE READY TO GO THROUGH WITH IT. POWELL STATED THIS WHITE MALE NEVER MENTIONED THE KILLING OF KING OR DISCUSSED HOW THE KILLING WOULD TAKE PLACE BUT ONLY DISPLAYED A SMALL BRIEFCASE WHICH CONTAINED A LARGE AMOUNT OF MONEY. ONE QUESTION ON THE POLYGRAPH EXAMINATION WAS "DID RALPH SAY HE HAD

TWENTY-FIVE THOUSAND DOLLARS IN THE BRIEFCASE?" HOWEVER, POWELL STATED RALPH NEVER INDICATED THE EXACT AMOUNT, ONLY STATING HE HAD "TWENTY-FIVE." POWELL, WHEN QUESTIONED AS TO WHETHER HE MEANT TWENTY-FIVE HUNDRED OR TWENTY-FIVE THOUSAND, STATED RALPH NEVER DID STATE THE AMOUNT BUT HE REALIZED THAT THAT MUCH MONEY IN THAT SIZE BRIEFCASE WOULD HAVE TO BE AT LEAST TWENTY-FIVE THOUSAND DOLLARS. RALPH ALSO MADE STATEMENT THAT THERE WOULD BE "FIFTY MORE" WHEN MARTIN LUTHER KING WAS BURIED. HOWEVER, WHEN HE QUESTIONED THEM AS TO WHETHER OR NOT THEY WOULD GO THROUGH WITH IT, CLAUDE POWELL STATED THEY WOULD HAVE TO THINK ABOUT IT AT WHICH TIME RALPH DEPARTED THE BAR STATING THAT IF THEY HAD NOT MADE UP THEIR MINDS BY THAT TIME HE COULD NOT DO BUSINESS WITH THEM.

POWELL WAS AFFORDED FOUR SEPARATE EXAMINATIONS, THE FIRST BEING A CARD TEST WHERE POWELL VIEWED THREE DIFFERENT CARDS OF DIFFERENT COLORS BUT WAS ADVISED TO DELIBERATELY LIE TO THE COLOR OF TWO OF THESE CARDS. IT WAS NOTED THE RESULTS OF THIS EXAMINATION INDICATED NO SIGNIFICANT REACTION TO THESE QUESTIONS AND THIS TEST WAS INCONCLUSIVE.

EXAMINATIONS TWO, THREE AND FOUR, ALL CONTAINING RELEVANT, IRRELEVANT AND CONTROL QUESTIONS, THE RELEVANT QUESTIONS CONCERNING STATEMENTS MADE BY GODFREY AND CONTACT BY RALPH, WERE ALSO INCONCLUSIVE IN THAT POWELL DID NOT REACT SIGNIFICANTLY TO ANY ONE OF THESE QUESTIONS. POWELL DID REACT TO TWO QUESTIONS CONCERNING GODFREY, PARTICULARLY THE QUESTIONS "DID GODFREY EVER ASK YOU IF YOU WERE INTERESTED IN MAKING BIG MONEY?" AND "DID GODFREY TELL YOU THE BIG MONEY WAS TO KILL MARTIN LUTHER KING?" THE REACTION INDICATED ON THE CHART WAS NOT SIGNIFICANTLY STRONG ENOUGH TO DRAW A CONCLUSION AS TO DECEPTION AND IT IS POSSIBLE THIS REACTION COULD BE ATTRIBUTABLE TO POWELL'S CHANGING HIS STORY FROM THE ORIGINAL INTERVIEW OF GODFREY MAKING THE STATEMENT CONCERNING FIFTY THOUSAND DOLLARS TO NOW STATING "BIG MONEY."

DURING THE POLYGRAPH EXAMINATION, POWELL APPEARED TO HAVE DIFFICULTY BREATHING AND THE UPPER PNEUMOGRAPH HAD TO BE CONTINUALLY ADJUSTED BY THE EXAMINER. POWELL DID NOT APPEAR OVERLY NERVOUS, DID NOT DISPLAY ANY OUTWARD SIGN OF EMOTION, BUT DID STATE ALL DURING THE POLYGRAPH THAT HE WAS VERY NERVOUS CONCERNING THIS WHOLE MATTER AND THAT HE HAD A HARD TIME BREATHING PROPERLY,

PARTICULARLY AS THE POLYGRAPH EXAMINATION PROGRESSED. WHEN QUESTIONED CONCERNING RESPONSES INDICATED ON THE CHART, POWELL WOULD ONLY STATE THAT HE WAS TELLING THE TRUTH AND THAT HE TOLD ALL THAT HE KNEW AND COULD RECALL CONCERNING THIS INCIDENT. POWELL INDICATED HE HAD A HIGH SCHOOL EQUIVALENCY DEGREE, HOWEVER, HE APPEARED TO BE OF LIMITED INTELLIGENCE AND APPEARED TO BE MUCH OLDER THAN FORTY YEARS OF AGE. DURING QUESTIONING, HE ADMITTED TO DOING A LOT OF BEER DRINKING, HOWEVER, DENIED DRINKING ANYTHING DURING THE DAY OF THE EXAMINATION.

A REVIEW OF THREE CHARTS REFLECTS POWELL RESPONDED GENERALLY IN THE SAME MANNER TO ALL QUESTIONS ASKED WITH NO SIGNIFICANT RESPONSE TO ANY INDIVIDUAL QUESTION WHEREBY A CONCLUSION COULD BE DRAWN AS TO HIS BEING TRUTHFUL OR UNTRUTHFUL. THEREFORE, THESE POLYGRAPH EXAMINATIONS WERE DETERMINED TO BE INCONCLUSIVE.

Re memo of SA DARRELL L. HAMAR dated 12/1/75.

On 1/5/76, ROY ALLEN RICHARDSON, Belfast, Tennessee, furnished the following information:

He does not remember the date or even the year, but sometime prior to the time that MARTIN LUTHER KING, JR. was killed, he (RICHARDSON) had flown to Memphis in a private plane for tryst with a young Memphis State college student, whom he declined to identify.

He, at one time, owned two different private airplanes and had access to a third one and does not recall which plane he may have taken to Memphis on this occasion. In all of his flights to Memphis, and there were many of them, he always utilized the airport located on the island in the Mississippi River.

One reason he cannot recall any more details is that during this particular period, he drank exceptionally heavily and used all sorts of drugs.

As best he can recall, on the occasion in question he checked into the Downtowner Motel.

While waiting for his girl friend, he realized that he could hear voices in an adjoining room. As best he could tell, there were two men in this room, one apparently known as FRANK, and the other referred to as JOHN J. He does not know what they were talking about, but got the impression that they were discussing the possible elimination or murder of a person.

He cannot hope to remember the exact conversation but remembers that the one identified as JOHN J. made some comment to the effect that "the money situation is no problem. That's been taken care of."

The individual referred to as FRANK commented to the effect that the money or part of it had been put in the right place.

He believes it was FRANK who said, "RAY has part of his money already."

FRANK (LNU) during the conversation, referred to a female as JANICE ANN or ANN and that she and RAY were getting their money but they did not know where it was coming from.

JOHN J., on one occasion, referred to "this damn black troublemaker" and another time indicated that "by the time this is done I will be Governor of the State."

At no time was the name JAMES EARL RAY mentioned nor did he hear the name MARTIN LUTHER KING mentioned.

He thought nothing more about it at the time, and it was only after he was in prison or maybe even after he got out that this incident reoccurred to him and began to think that possibly it had something to do with MARTIN LUTHER KING.

He does know, however, that he left the room after overhearing this conversation, and as he went out of his room, a man exited the room next to him from which he had heard the voices. He recognized this man as JOHN J. HOOKER.

He has never personally met HOOKER or had any business dealings with him in any way whatsoever, but readily recognized him from having seen HOOKER in the news media many, many times.

HOOKER looked at RICHARDSON for a long time and seemed to recognize him, although there was no reason for him to. HOOKER, in speaking through the open door, said to someone inside that he was going to the bar to get him another drink. HOOKER had a glass in his hand.

RICHARDSON also went to the bar and noticed that HOOKER sat watching him for a long period of time.

He had had no contact with HOOKER since that time.

Sometime later, date unknown, RICHARDSON received an anonymous telephone call from someone who said in effect that he should just forget everything he saw or heard while he was in Memphis. He has no idea who made this call or whether they were referring to this conversation or not.



He reiterated that at this time he was running around with many different women much to the chagrin of his wife and that he was forever getting calls from unknown individuals relating to his exploits.

RICHARDSON said he is certain that this incident occurred before he was ever involved in the robbery of the bank in Belfast, but he cannot recall whether or not he was under investigation by the FBI on the stolen car problem at this time, again, because he drank so much he could not remember well.

It was pointed out to RICHARDSON that this writer had been in contact with him on many, many occasions since this happened and was asked why he had not mentioned this earlier.

RICHARDSON stammered a bit and when forced for an answer, said that he did not think much about it until recent months and knew that he had not seen nor heard anything of any evidentiary value and because of this thought it would be foolish for him to say anything. He said, however, that the matter has weighed on his conscious and he wanted to make it known for whatever it might be worth.

He said that except for DENNIS BATES, the only other person that he ever told about this was his attorney in Lewisburg, HAYWOOD WHITAKER. He claims to have told WHITAKER several months ago.

RICHARDSON was asked if he had any objection to the FBI talking to WHITAKER on the premise that RICHARDSON might have remembered some information and given it to WHITAKER but has since forgotten it.

RICHARDSON did not voice any particular objection to this, but did not seem to be pleased with the prospect of it.

It will be noted that this Agent has investigated ROY ALLEN RICHARDSON at great length in a car theft ring and investigated and prosecuted him for robbery of the bank in Belfast. Up until the time RICHARDSON was convicted of bank robbery, he was totally uncooperative, but subsequent to that time went through a period of apparent sole searching and seemed desirous of telling everything that he knows.

At no time did he ever indicate that he had any information of this sort in his possession.

Recently, RICHARDSON has undergone severe financial reverses based, he says, on his ill health.

Throughout recent years, RICHARDSON has been frequently hospitalized and showed outward signs of being ill.

On 1/5/76, RICHARDSON outwardly was a "picture of health" and said that he was feeling better than he had for a long time. His reaction to and demeanor before this Agent was somewhat different from what it has been in recent years. Where he had previously exhibited his air of cooperation, on 1/5/76 he appeared somewhat reluctant to furnish details.

It is the interviewing Agent's opinion that if the incident did, in fact, occur, RICHARDSON had no knowledge at the time that it was related in any way to MARTIN LUTHER KING and that his subsequent connections with the KING murder is purely a move on his part to gain release from his parole.

Every possible effort was made to pin RICHARDSON down as to a date this incident occurred in the hope that it could be verified, at least as to his residence at the Downtowner Motel. RICHARDSON steadfastly maintained he could not remember the date and had no records to search to determine this date and that even his white records were destroyed or he did not know where they were.

He claimed that he traveled to Memphis on an average of once a month during this time, which would make it virtually impossible to determine the date in question, and because of this no specific leads are being set forth.

CLAUDE POWELL, JR., was located at the Scottish Inn Motel, Interstate Highway 20 at Holiday Hill Road, Room 211. POWELL was advised of the identities of the interviewing Agents and at the outset of the interview, was asked if he had been in contact with any member of his family or in particular, his brother, LEON POWELL. POWELL denied being in contact with any member of his family, including LEON POWELL, since his departure from Atlanta, Georgia, on December 31, 1975. He was then interviewed as follows:

POWELL was asked if he had ever been offered a large sum of money to commit a murder, and he immediately volunteered that he had been offered \$25,000 shortly before the actual assassination of MARTIN LUTHER KING to murder MARTIN LUTHER KING. He recalled the circumstances of that offer as follows:

Approximately three to four weeks prior to the murder of MARTIN LUTHER KING, he and his brother, LEON POWELL, were seated in a booth in Pete's Bar on Moreland Avenue in Atlanta, Georgia. A friend of his brother, RAY GODFREY, a musician and Atlanta City employee, joined them at their booth and engaged in conversation with LEON. He paid no particular attention to what LEON and RAY were talking about. GODFREY left the booth, and, in approximately 10 to 15 minutes, an individual previously unknown to him, came to their booth and seated himself opposite from LEON and him.

As this unknown person sat down, he placed an expensive-looking black brief case on the table. He described the unknown person as being a white male, approximately 5'8" in height, medium build, approximately 150 pounds, approximately 30 years of age. POWELL explained that the unknown person appeared to him to be out of place in such an establishment as Pete's Bar, in view of his dress, which did not fit into the crowd that frequented Pete's Bar.

The unknown person impressed him as being a well educated person, who appeared to be a professional type such as a lawyer. He said the unknown person was clean cut, and very calm and cool in his manner. He stated the unknown person may have introduced himself, but he does not recall any names. The unknown person asked LEON and him if they wanted to pull a job. He does not know the exact wording, but he questioned the unknown person concerning the nature of the job, and how much money it paid. The unknown person told him and LEON that he wanted them to do away with someone and when POWELL questioned the unknown person further, he was told that it was someone important. The unknown person then told him and LEON that he wanted them to kill MARTIN LUTHER KING, and would pay them \$25,000 now and \$25,000 when the job was done. The unknown person then opened his brief case which was full of wrapped currency; some of the bills he noticed were in \$100 denominations. He stated that he was shocked by the statements of the unknown person, and initially assumed that it was some sort of prank or possibly a law enforcement officer trying to trick him. After the unknown person made the offer, he ignored any further conversation, whereupon the unknown person closed his brief case and departed.

He has never had any further contact, nor did he ever ascertain the identity of the unknown person, or means or reason for the offered payment to kill MARTIN LUTHER KING. He related that he had gained the bad reputation of being a hoodlum because of his past prison record, participation in several fights, and habit of carrying a shotgun in his vehicle, which he frequently loaned to the bartender at Pete's Bar whenever trouble occurred. He denied ever receiving such an offer prior to this incident, and further denied affiliation with any group which advocated racial hatred. He admitted that he had made statements while drunk to the effect that he had no aversion to killing blacks, although he had never seriously considered doing so.

POWELL stated he was shocked and dismayed to learn, approximately three to four weeks later, that MARTIN LUTHER KING had been murdered. He advised that he did not

go to any law enforcement officers, and tell them of the above contact with the unknown person, because he felt he might become a suspect in the murder of MARTIN LUTHER KING.

POWELL was then requested to assist the FBI by providing an artist conception of the unknown person who contacted him at Pete's Bar by the use of a facial identification catalogue. It was explained to POWELL that a sketch would be made from a combination of features that he selected from photographs displayed in the catalogue. Each category in the catalogue was thoroughly explained and photographs in these categories were shown to POWELL. POWELL then stated that he would be unable to assist in this regard because he had only talked with the unknown person for approximately five minutes, and that he would not recognize him even if he was brought into his motel room at that moment.
