As you recall, during a recent telephone conversation, you were advised that Ben D. Gibbens, Investigator, Criminal Division, Louisiana Department of Justice, informed the United States Attorney that a previously reliable informant of his claims to have been present during a meeting at which several men discussed the murder of Martin Luther King. The informant advised Gibbens that he can identify two of the men who were present at the meeting and that one of those "put up a considerable amount of money" to have King murdered. The informants said he saw the money change hands. He can identify the man who gave the money but not the man to whom the money was given. The meeting in question, according to the informant, occurred in Memphis, Tennessee, prior to King's death. The informant was himself in jail in Memphis, Tennessee, when King was murdered.

The informant also advised Gibbens that while in Chicago he worked for a "gangster" who offered him money to kill a Chicago man named "Giacanno". That individual was in fact later killed by persons unknown to the informant. The informant surmised that the "gangster" hired others to complete the assassination plot when the informant refused.

The informant also advised Gibbens that he knows who was responsible for the death of a man named "Murphy" whose body was found in the trunk of an automobile on Cicero Avenue in the Chicago area. The informant told Gibbens that Murphy's head looked like it had been mashed in a vise.

The informant also claims to have knowledge of those responsible for the theft of varying amounts of plutonium and mercury in the Oklahoma area.

Following the United States Attorney's telephone conversation with you, Gibbens met with the informant who advised that he would not be interviewed locally but would only discuss these matters with Justice Department investigators from Washington. Gibbens did not seek to obtain more detailed information from the informant, but advises that the informant asserts that he can supply more detailed information to Justice Department investigators.

The informant is an inmate in a Louisiana jail who is presently facing a sentence of life imprisonment. He claims to have been convicted at a trial where perjury was suborned by state law enforcement officials. Gibbens advises that the informant, in exchange for his cooperation, only requests that the matter be looked into by Justice officials. The informant specifically requests that two witnesses, whose testimony he claims was perjured, be interviewed.

Whether this information is valuable or accurate is something that neither Gibbens nor the United States Attorney can assess. Gibbens does not feel that he is in a position to evaluate the accuracy or reliability of the information. He simply requests that the United States Attorney relate these sketchy details to you in the event that someone in the Justice Department might be interested in interviewing his informant. Gibbens would be willing to be present during an interview between Justice investigators and his informant. The informant has indicated that he will discuss the matter with Justice investigators only in Gibbens' presence.

Should anyone decide to pursue this matter further, they can contact Gibbens or the United States Attorney. As indicated on the telephone, the United States Attorney has no idea who the informant is or where he is presently located. The United States Attorney's and Mr. Gibbens' interest in this matter is in seeing that this report is conveyed to the U. S. Department of Justice.

The informant said he saw the money change hands. He can identify the man who gave the money but not the man to whom the money was given. The meeting in question, according to the informant, occurred in Memphis, Tennessee, prior to King's death. The informant was himself in jail in Memphis, Tennessee, when King was murdered.

The informant also advised Gibbens that while in Chicago he worked for a "gangster" who offered him money to kill a Chicago man named "Giacanno". That individual was in fact later killed by persons unknown to the informant. The informant surmised that the "gangster" hired others to complete the assassination plot when the informant refused.

The informant also advised Gibbens that he knows who was responsible for the death of a man named "Murphy" whose body was found in the trunk of an automobile on Cicero Avenue in the Chicago area. The informant told Gibbens that Murphy's head looked like it had been mashed in a vise.

The informant also claims to have knowledge of those responsible for the theft of varying amounts of plutonium and mercury in the Oklahoma area.

Following the United States Attorney's telephone conversation with you, Gibbens met with the informant who advised that he would not be interviewed locally but would only discuss these matters with Justice Department investigators from Washington. Gibbens did not seek to obtain more detailed information from the informant, but advises that the informant asserts that he can supply more detailed information to Justice Department investigators.


The informant is an inmate in a Louisiana jail who is presently facing a sentence of life imprisonment. He claims to have been convicted at a trial where perjury was suborned by state law enforcement officials. Gibbens advises that the informant, in exchange for his cooperation, only requests that the matter be looked into by Justice officials. The informant specifically requests that two witnesses, whose testimony he claims was perjured, be interviewed.


Whether this information is valuable or accurate is something that neither Gibbens nor the United States Attorney can assess. Gibbens does not feel that he is in a position to evaluate the accuracy or reliability of the information. He simply requests that the United States Attorney relate these sketchy details to you in the event that someone in the Justice Department might be interested in interviewing his informant. Gibbens would be willing to be present during an interview between Justice investigators and his informant. The informant has indicated that he will discuss the matter with Justice investigators only in Gibbens' presence.

Should anyone decide to pursue this matter further, they can contact Gibbens or the United States Attorney. As indicated on the telephone, the United States Attorney has no idea who the informant is or where he is presently located. The United States Attorney's and Mr. Gibbens' interest in this matter is in seeing that this report is conveyed to the U. S. Department of Justice.

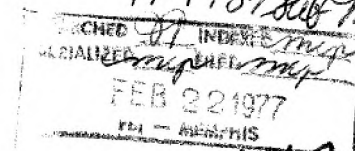

Tyson, Deputy Director, Executive Office for United States Attorneys, Department of Justice, Washington, D. C. This memorandum advised that the FBI was furnishing a copy of this letter for information and no further investigation was being conducted concerning this matter unless specifically requested by the Department.

Reference is also made to the memorandum dated February 3, 1977, from Mr. Michael E. Shaheen, Jr., Counsel, Office of Professional Responsibility, to the Civil Rights Division, Criminal Division, and the FBI which furnished a copy of this same letter dated January 20, 1977.

It is noted in this letter that the informant advised that he would not be interviewed locally but would only discuss these matters with Justice Department investigators from Washington. In addition, the informant, in exchange for his cooperation, requests certain action concerning his local conviction.

Accordingly, no investigation is being conducted by the FBI concerning this matter unless specifically requested by the Department.

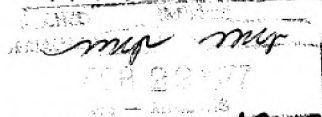

By letter dated February 3, 1977, directed to Mr. Joseph A. Marion (Jr.), c/o United States Embassy, 100 Wellington Street, Ottawa, Ontario, R. R. L. Ostrum, Inspector, Officer in Charge, General Section, Federal Policing Branch, Royal Canadian Mounted Police (RCMP), Ottawa, Canada, requested that Mr. Terry Lafferty, Assistant District Attorney General, be contacted to determine the present status of matters before the courts in respect to James Earl Ray. Inspector Ostrum made reference to exhibits being held by the RCMP relating to this matter.

On February 24, 1977, Mr. Terry Lafferty, Assistant District Attorney General, 15th Judicial Circuit, State of Tennessee, Memphis, Tennessee, advised there is currently no litigation pending in the various courts in the State of Tennessee involving James Earl Ray. Mr. Lafferty stated he would direct John Carlisle, Chief Investigator, on the District Attorney General's Staff to discuss the disposal of exhibits being maintained by the RCMP with Mr. Hugh W. Stanton, Jr., District Attorney General, 15th Judicial Circuit, Memphis.

On February 28, 1977, John Carlisle, Chief Investigator, 15th Judicial Circuit, State of Tennessee, Memphis, Tennessee, advised that Mr. Hugh Stanton, Jr., was out of the City of Memphis but would return to his office on the morning of March 2, 1977, at which time he will discuss this matter with Mr. Stanton.

On March 2, 1977, Hugh W. Stanton, Jr., District Attorney General, 15th Judicial Circuit, State of Tennessee, advised that James Earl Ray has exhausted all of his legal remedies in the Tennessee State courts and, therefore, there is no pending litigation involving him. Mr. Stanton is of the opinion that exhibits maintained by the RCMP should be retained at this time, pointing out that the House Select Committee on Assassinations created by the United States House of Representatives in 1976 might desire to examine these exhibits in the future.

The former Birmingham PCI who furnished the information in referenced Birmingham communication of 12/15/76, contacted the Birmingham Office telephonically from time to time regarding captioned matter.

On 3/3/77, he telephonically contacted Birmingham wondering if, "LIBERTO" had been investigated in New Orleans in the past. He was told that investigation regarding a family of LIBERTOS had been conducted back in 1968. Source mentioned that the LIBERTO in New Orleans has a brother in the produce business in Memphis, Tennessee, and also expressed the thought that "No one can convince me that it (the KING assassination) was not a conspiracy."

Source advised he received two recent telephone calls, the last on 2/28/77, from a Mr. EVANS, a deputy chief of the House of Representatives Committee on Assassinations. EVANS told him that if they get their appropriation, EVANS will want to talk to the source about this matter, and the source told EVANS that he would, but would not discuss it on the telephone.

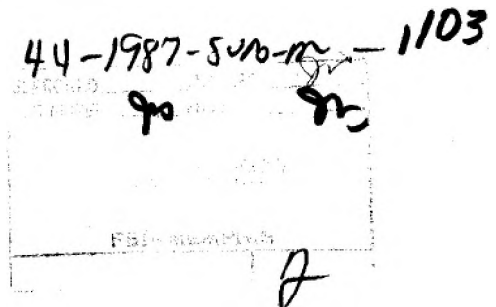

On January 27, 1977, ALLEN RAY HALL, an inmate of North Carolina Central Prison, wrote a letter to Mr. DAN RINZEL, United States Department of Justice, Civil Rights Division, making certain allegations regarding the assassination of Dr. MARTIN LUTHER KING. On February 4, 1977, ALLEN RAY HALL was interviewed at the New Hanover County Jail, Wilmington, North Carolina, by Special Agents of the FBI and furnished the following information:

During a period of racial unrest in Wilmington, North Carolina, in 1971, ALLEN RAY HALL testified as a state witness against a group of defendants known as the "Wilmington Ten" in which the subjects were convicted and sentenced to varying prison terms. HALL has now recanted his testimony in that trial in 1972 and has been reinterviewed on several occasions by Special Agents of the FBI in which he has given conflicting stories as to his participation in the racial unrest in Wilmington, North Carolina, as well as allegations against law enforcement officers who interviewed him at the time of the "Wilmington Ten" trial.

During the interview on February 4, 1977, HALL stated that during the period of racial unrest in Wilmington, North Carolina, in 1971, he had been interviewed by Special Agent BILL WALDEN, Bureau of Alcohol, Tobacco and Firearms. He stated that at the time of his conversation with WALDEN, they also discussed the murder of Dr. MARTIN LUTHER KING and WALDEN drew him a map indicating how Dr. KING was killed and where everyone was standing at the time of Dr. KING's assassination.

HALL stated that he was later confined at Central Prison, Raleigh, North Carolina, awaiting trial at Wilmington, North Carolina. He stated that while at Central Prison, he was interviewed on several occasions by North Carolina Central Prison Superintendent of Transportation, STEPHEN ALBERT BERRY, and HALL alleged that BERRY apparently found out about the sketch which had been given to him by Special Agent BILL WALDEN of the Bureau of Alcohol, Tobacco and Firearms Division, and that BERRY came to his cell at Central Prison and requested that HALL give him the sketch. HALL stated he told BERRY he did not have the sketch and then BERRY searched his cell and found it. According to HALL, BERRY then stated that JAMES EARL RAY had been gotten out of the country, and the same method could be used to get him (HALL) out of the country. From this statement, HALL alleged that he assumed BERRY had some knowledge of the KING murder, and believed that BERRY might be somehow involved in the murder.

HALL further stated that, during an interview on February 9, 1977, that North Carolina Central Prison Superintendent of Transportation, STEPHEN ALBERT BERRY, told him that he, BERRY, was a member of the Ku Klux Klan and they, BERRY and other prison officials, would help him the same way "they" helped JAMES EARL RAY when he killed MARTIN LUTHER KING.

STEPHEN ALBERT BERRY on interview on February 8, 1977, stated his job at Central Prison is to review all grievances filed by the inmates at Central Prison. BERRY stated that HALL's most recent incarceration at Central Prison was on December 7, 1976. BERRY stated that he estimates HALL has filed between ten and fifteen grievances since the above date which referred to alleged threats or mistreatment against him, and these grievances have been investigated and have failed to substantiate that HALL was ever threatened or mistreated. BERRY stated HALL has accused him of being a member of the Ku Klux Klan and also alleged that BERRY said that when Dr. KING was killed, they did not get the right man and that it would be the same way with him; they would have him killed and put the blame on a white inmate at Central Prison.

HALL's most recent allegation at North Central Prison is that attempts are being made on his life by putting razor blades in his prison food.

Ray To Talk About King Murder

Representatives from the House select committee probing the assassination of Dr. Martin Luther King will take preliminary depositions from convicted assassin James Earl Ray in prison next week, Ray's attorney said Tuesday night.

Jack Kershaw, retained as Ray's attorney three weeks ago, said the deputy chief legal counsel for the assassinations panel and two court reporters will take statements from Ray at Brushy Mountain State Prison in Petros.

Ray is serving a 99-year sentence

for the April 4, 1968 slaying of the civil rights leader as he spoke from a balcony in Memphis.

Kershaw, however, said Ray will not testify before the select panel merely to support his original guilty plea made before a Memphis jury.

"Like Mr. Ray just said, he wouldn't go before them just to prove he was guilty," Kershaw said while viewing a CBS television program in which Ray was interviewed.

The attorney said he has new evidence from two sources which will aid the assassinations probe. However, he declined to reveal the information. Kershaw said he will corroborate Ray's statements after the depositions are taken next week and will then read FBI files on King which "are relevant to the case." The attorney said he will demand a public hearing when Ray appears before the committee.

Meanwhile, the attorney said, a lot of questions concerning the assassination remain unanswered. A major "piece of the puzzle," he said, concerns the Latin named Raoul who Ray said was his contact before King was slain.

"He (Ray) was contacted by a man in Canada, he called him Raoul, a small man who he said smoked a lot of cigarettes," Kershaw said.

A pair of trousers fitting a "small man" were found in the boarding house room from which the fatal shot was allegedly fired, Kershaw explained. In addition, he said the white Mustang allegedly used as a getaway car by Ray contained an

ashtray filled with cigarette butts.

"And Ray doesn't smoke," Kershaw said.

Transcripts from the murder trial showed ballistic experts could not match the bullet which killed the civil rights leader, Kershaw pointed out.

"People keep asking why Ray hasn't told his story before," the attorney said. "He hasn't had a forum before. He tried to tell it the next day (after pleading guilty) but the trial judge wouldn't let him.

"At that time the establishment was looking for a victim. Right then Ray was victimized.

"It will be my contention that he never plotted together, never breathed together, to murder King. He was a victim of a conspiracy just like King was."

Kershaw, who said he was first contacted by letter from Ray when the prisoner was attempting to be freed from solitary confinement at Brushy Mountain, said "a day or two after I was retained (U.S.) Atty. Gen. (Griffin) Bell evidenced his interest in the case. I sent Mr. Bell a mailgram saying Ray would be happy to take the witness stand."

Bell, however, has not contacted the Nashville attorney.

Is Kershaw optimistic about obtaining a new trial for Ray after he was denied by appellate courts including the U.S. Supreme Court?

"Optimistic might be too strong a word. It's possible and even

probable," responded the 63-year-old attorney.

Meanwhile, Kershaw said he plans to talk with U.S. Rep. Henry Gonzales, D-Tex., former chairman of the select panel investigating the assassinations of King and President John F. Kennedy.

"Mr. Gonzales has a lot of explaining to do. He said some organization that was more powerful than the U.S. government was behind the assassination. There had to be some sort of conspiracy," Kershaw said.

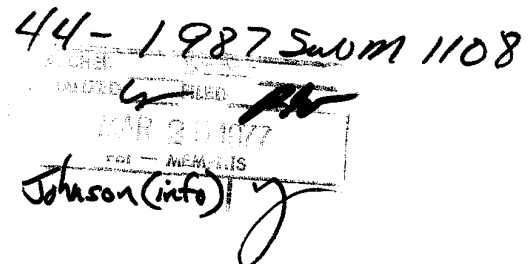

On January 28, 1977, Dr. EUGENE V. GRACE, Eye Surgeon, 911 North Broad Street, Durham, North Carolina, who also operates Moore Publishing Company, 907 North Broad Street, reported receipt of a telephone contact on January 27, 1977, from OTIS MOORE, Lomas Verdes Number 40, San Juan, Puerto Rico, telephone number 780-4533, offering GRACE an opportunity to publish a book by MOORE. MOORE identified himself as a retired United States Army Master Sergeant. He stated in his book, he identified the assassin of MARTIN LUTHER KING and implied this assassin had first sought to hire MOORE for the assassination. MOORE, during his telephone call, claimed to have previously reported this information to the Federal Bureau of Investigation (FBI) and said KELLEY had assigned him a file number. MOORE stated he was in contact with other prospective publishers. He also claimed correspondence with United States Senators FRANK CHURCH and EDWARD KENNEDY. During his call, MOORE said he felt his life was in danger.

GRACE indicated there was a possibility he would be back in contact with OTIS MOORE about January 30, 1977, concerning publication of the book referred to by MOORE.

On March 17, 1977, Dr. GRACE advised he had not had any contact with OTIS MOORE during the latter part of January or early February, as previously proposed. However, since GRACE had returned to Durham, North Carolina, in mid-February, 1977, MOORE had contacted GRACE's residence at Durham, North Carolina, on two occasions. During one of these calls during the latter part of February, 1977, MOORE told GRACE's wife he was staying in Alexandria, Virginia, and was trying to arrange for an appearance before the United States House Committee conducting investigation into the death of

MARTIN LUTHER KING. He indicated his intention to stay in the Washington area until someone heard his story. He left a telephone number for GRACE to reach him in Alexandria, but later when GRACE called this number, he determined that the number was to a pay telephone and that MOORE was not available there. During the other telephone contact at about the same time, MOORE stated that he was currently preparing the manuscript for his book. GRACE indicated a desire to see this manuscript when it was completed. Since that call, GRACE has written to MOORE in Puerto Rico to indicate again an interest in seeing the completed manuscript. MOORE, in his conversations, again indicated he had corresponded with Senator FRANK CHURCH and Senator EDWARD KENNEDY. GRACE stated since that time he has had no additional contact with MOORE, and noted that he had never had any personal contact with MOORE, nor had MOORE indicated any intention of visiting GRACE in Durham, North Carolina.

On March 20, 1977, M. G. (Gene) Snyder, United States Representative, 4th Congressional District, Kentucky, appearing on WHAS-TV "News Conference", taped March 18, 1977, at Louisville, Kentucky, revealed that he believed investigation by the House Select Committee on Assassinations (HSCA) would be productive in light of some recent revelations even though he did not initially vote for funding of same. Snyder indicated that he had changed his mind in light of some recent information which he carefully explained so as to not "drop somebody in" or "say anything wrong about somebody, that shouldn't be said."

Snyder indicated that he had received a letter a few weeks ago from a "citizen" whom Snyder described as being retired after many years from a responsible police department and that this "citizen", not further described, claimed to have been approached by three (3) "FBI officers" and three (3) or four (4) "prominent people at that time in that police department." Snyder noted that this unnamed "citizen" received this "offer" on two (2) separate occasions in his automobile where he had a tape recorder secreted. Tapes were made of the "offer" on both occasions, however, one tape was subsequently stolen. Snyder noted that the other tape was retained by the "citizen" and has been furnished to HSCA by the unnamed "citizen" when the latter reportedly traveled to Washington, D. C., at his own expense in order to bring the above information to the attention of said committee.

Snyder has spoken with the unnamed "citizen" personally and in Snyder's opinion, the "citizen" appears to be responsible. Snyder believed that the above "lead" and other leads should be "checked out" and that because of same, United States Representative Samuel L. Devine (Ohio), Ranking Minority Member of HSCA, now intends to vote for continuation of HSCA funding.

Snyder revealed that the letter written by unnamed "citizen" was received in the "regular United States Mail" and that the basic allegation is that the unnamed "citizen", who is a retired policeman, was approached by "members of the FBI and unnamed police department" and encouraged to assassinate Martin Luther King, Jr. When asked why Snyder received the letter, Snyder replied, "Time will have to tell." Snyder added that he "didn't want to go into that."

Snyder further revealed that the unnamed "citizen" had been to Washington and that the HSCA now has possession of the above mentioned tape recording which is being "washed down" to eliminate background noises such as a running automobile engine. Snyder has listened to the tape recording himself and describes same as having "some pretty inaudible sections" which are being worked on at the present. Snyder noted that the tape purports to deal with instant subject matter. Snyder indicated that he could not attest to the authenticity of the tape recording since he did not consider himself to be an electronics expert but noted same must be determined.

Snyder declined to answer interrogatories as to whether the letter came from his Congressional District or Louisville, Kentucky, noting he did not think he ought to place the unnamed "citizen" in jeopardy in the event the allegation is true, or people mentioned therein in jeopardy if the allegation is false. Snyder believed that the HSCA will have to decide when the names of individuals allegedly involved are to be released and made public.

Snyder declined any further comment on the matter, noting that if allegations were in fact true, the unnamed

"citizen" furnishing the basis for same would be in jeopardy from "FBI and others named" in the letter, and if allegation was not true, "responsible persons" would likewise be in jeopardy. Snyder assumed that the HSCA would give the individuals named in the letter an opportunity to express themselves at the appropriate time.

Snyder gives panel allegation of plot to assassinate King

U.S. Rep. Gene Snyder, R-4th District, said yesterday that he has turned over to the House Assassinations Committee an allegation that FBI agents and police plotted to kill Dr. Martin Luther King Jr.

Snyder said that in late February he received a letter from "a former policeman" who claims he was twice offered \$500,000 to kill King.

Snyder made his comments yesterday while taping a WHAS-TV News Conference program, which will be broadcast at 12:30 p.m. tomorrow on WHAS television and radio.

Snyder would not reveal the name of the former policeman making the charge, or the names of three FBI agents and several policeman who allegedly were involved in the plot. Snyder also declined to name the police force that the man worked on for more than 20 years.

Snyder made no connection between the offer allegedly made to the policeman and the actual killing of King.

"I have always had confidence in the major law enforcement agencies of this country, and I had to assume that what they determined (about the slaying) was accurate," Snyder said. "Now I think this is something that needs to be investigated."

Richard A. Sprague, the Philadelphia attorney who is chief counsel for the assassinations committee, last night confirmed that Snyder had turned over material containing the allegation, but refused to answer questions about it.

"The matter you refer to has been referred to the committee and is under investigation," he said by telephone from Philadelphia.

King was slain in Memphis, Tenn., in 1968, and James Earl Ray was convicted of killing him. The House committee last fall began investigating the assassinations of King and President John Kennedy. The committee's funding expires March 31.

Snyder, who voted against the committee initially, told The Courier-Journal in an interview last night that he will vote to continue funds for its investigation solely on the basis of the allegation brought to him.

Snyder said he had no explanation for why the policeman brought the charges to him, rather than directly to the committee. The policeman asked Snyder to put him in touch with the committee, the congressman said.

He said the former policeman had attempted to turn a tape recording of the \$500,000 offer over to Ray's attorneys, but finally was asked by one of the attorneys' investigators "where he planned to hide if he tried to do anything with the tape."

Asked if he believes the man's allegation, Snyder said, "I don't know. But I think charges such as this need to be investigated."

Snyder said he has discussed the charges with U.S. Rep. Samuel L. Devine of Ohio, the ranking minority member on the committee. He said Devine, a former FBI agent, checked into the man's background and found him to be "a solid citizen." Devine could not be reached last night.

Snyder told WHAS, "I have talked to him (the policeman) personally and in my opinion he appears to be a responsible citizen. . . ."

He told the television station, "He (the former officer) was approached to assassinate Martin Luther King. He names three FBI officers, he names three or four prominent people at that time in the police department. He indicates that the offer was made on two occasions in his automobile where he had a tape recorder, that he taped those items. One of them (the tapes) was stolen, the other he still has."

Snyder said the man went to Washington and either appeared before the committee or was interviewed by its staff. Snyder said the committee has the tape. Asked if he has a copy of the tape, . . .

"Involved in this conspiracy were agents of the Federal Bureau of Investigation, agents (blank), (blank) and (blank) and others that I did not know," the letter said, as Snyder read it, citing but not naming several other officers.

Snyder said he could not divulge the names or the identity of the man who contacted him.

"What I'm saying," Snyder said, "is, those blanks need to be protected if there's nothing to this. And if it is an accurate allegation that he's made, then the author of the letter needs to be protected. The committee is investigating it."

SNYDER SAID the man "indicates further in the letter that after he retired he contacted (a man) who, he says, is James Earl Ray's attorney . . ."

Ray is serving a life term in prison in connection with the assassination of the late civil rights worker who was slain in Memphis, Tenn., in 1968.

Snyder said the former policeman claimed he was offered \$500,000 on two occasions to kill King.

Richard A. Sprague, the Philadelphia lawyer who is chief counsel for the assassinations committee, confirmed Snyder had turned over material containing the allegation, and that it "is under investigation."

The former policeman, Snyder said, tried to turn over a tape recording of the alleged \$500,000 offer to Ray's lawyers, but one of their investigators finally asked "where he planned to hide if he tried to do anything with the tape."

SNYDER SAID he has discussed the allegation with Rep. Samuel L. Devine of Ohio, the ranking minority member of the committee. Devine, a former FBI agent, checked into the man's background and found him to be a "solid citizen," Snyder said.

Snyder said the man told him the offers for him to kill King were made in his automobile, where he had a tape recorder. Snyder quoted the man as saying he had two tapes, one of which was either stolen or lost. The other tape has been turned over to the committee, Snyder said.

"Most of it was inaudible to me," he said. "I could make out a little. I made out enough to believe and ascertain that a discussion was being had about King and money, but I didn't even listen to all of it."

SNYDER SAID he wants the allegation to be thoroughly investigated "and this guy ought to be protected from any problems. If it is inaccurate, then those people who he names need to be protected. He names three alleged FBI agents, four or five members, prominent members at the time, of a police department."

The man has been interviewed by the committee's investigative staff, Snyder said.

Snyder said he received the letter from the man on Feb. 28.

"I don't know if it is valid," he said. "It is up to the committee to investigate it."

Assassination proposal told

LOUISVILLE, Ky. (AP) — U.S. Rep. Gene Snyder, R-Ky., says he has referred to the House Assassination Committee a retired police officer who claims FBI agents propositioned him to kill Dr. Martin Luther King Jr.

In statements broadcast Friday on WHAS-TV, Snyder said the former officer, whom he declined to name, has a tape recording of a purported conversation between himself and FBI agents in which an alleged suggestion was made to murder King.

According to Snyder, the former policeman "names three FBI officers (and) three or four prominent people at that time in the police department (and) indicates that the offer was made on two occasions in his automobile where he had a tape recorder."

Snyder, who represents Kentucky's 4th District, declined to name dates and the city where the purported offers were

made.

Snyder also declined to specify whether the former officer was from Kentucky. He said the man contacted him by letter recently and that he later met the man and listened to one tape recording.

Part of the tape was inaudible, Snyder said, but he was able to discern that the subject was King's assassination.

"I have talked to him and in my opinion he appears to be a responsible citizen and I think these kinds of leads need to be checked out," Snyder said.

Snyder said Assassinations Committee now has the tape recording and is investigating the matter.

King was assassinated in Memphis, Tenn., in 1968. The Assassinations Committee recently said it had new information on King's murder, but has not produced any evidence of involvement by anyone other than the convicted killer, James Earl Ray.

Snyder says man revealed police plots to kill King

LOUISVILLE, Ky. (AP) —
Rep. Gene Snyder, R-Ky., said
Saturday the House Assassina-
tions Committee is in-
vestigating an allegation from
a "logical, rational" man who
claims several members of a
police department and FBI
agents plotted to kill Dr. Mar-
tin Luther King Jr.

Snyder said he met the man
"face to face" and that "he ap-
peared to be rational, a logical
kind of man."

Snyder said he received a let-
ter from the man and listened
to a tape recording the man
said he made of the alleged as-
sassination plot. He refused to
say whether the man or the po-
lice department involved were
in Kentucky.

Asked why the man contacted
him and let him listen to a
copy of the tape recording, Snyder
said "he may have just
been looking for someone with
nerve, a fighter."

Snyder read part of the letter
and used the word "blank"
where the man had used
names.

"I retired from (blank) police
department in (blank) after
serving (blank) years," the let-
ter said. "While I was in the
police department I was in-
nocently involved in a con-
spiracy to assassinate Dr. Mar-
tin Luther King.

"Involved in this conspiracy
were agents of the Federal Bu-
reau of Investigation, agents
(blank), (blank) and (blank)
and others that I did not
know," Snyder said, continuing
to read the letter. "Members of
the (blank) police department,
chief of detectives, captain

(blank), lieutenant (blank), of-
ficer (blank), lieutenant
(blank) of the homicide bureau
and president of the FOP ser-
geant (blank)."

FOB stands for Fraternal Or-
der of Police, a collective bar-
gaining organization for police
officers.

Snyder said he could not di-
vulge the names listed in the
letter or the identity of the man
who contacted him.

"What I'm saying," Snyder
said, "is those blanks need to
be protected if there's nothing
to this. And if it is an accurate
allegation that he's made, then
the author of the letter needs to
be protected. The committee is
investigating it."

Snyder said the man "in-
dicates further in the letter that
after he retired he contacted
who he says is James Earl
Ray's attorney..."

Ray is serving a life term in
prison in connection with the
assassination of the late civil
rights worker who was slain in
Memphis, Tenn., in 1968.

Snyder said the former po-
liceman claimed he was offered
\$500,000 on two occasions to kill
King.

Richard A. Sprague, the
Philadelphia attorney who is
chief counsel for the assassina-
tions committee, confirmed
Snyder had turned over mate-
rial containing the allegation.

"The matter you refer to has
been referred to the committee
and is under investigation,"
Sprague said.

Snyder said he would vote to
continue funds for the com-
mittee's continued existence
solely on the basis of the al-
legation brought to him.
