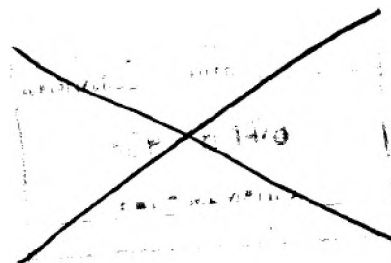

She advised she was a senior in high school in 1968 and received a 1965 white Mustang from her father as a graduation present. JONES stated she was in Memphis, Tennessee, with her mother visiting her maternal grandfather, who was in a Baptist hospital after suffering a heart attack, at the time of the KING murder. She and her mother flew from Kansas City to Memphis on an unrecalled airline and stayed three or four days. She recalled there were curfew restrictions while they were in Memphis. She advised that her father, who was a flight engineer on a C-124 and stationed at Richard's Gabour Air Force Base, remained in Kansas City with her two brothers, [REDACTED] and [REDACTED] who were ages [REDACTED] and [REDACTED].

JONES stated she definitely did not travel to Memphis in the Mustang and she never made any trips in it with her father. She stated the car was in very poor condition and could not make it to Memphis.

She recalled that while they were in Memphis her mother called Kansas City at least twice and talked to her father.

Further, she stated she has not seen her father in five years but that he calls her frequently. She advised she received a call last Saturday morning at which time he sounded sober. On this occasion they had a general conversation. JONES advised he called her again on Thursday night and was obviously intoxicated. On this occasion her father told her the Federal Bureau of Investigation (FBI) was going to put him in jail for the murder of KING. In addition, he told her the FBI had given him a polygraph test. He told her she would be contacted by the FBI and that she was to tell the FBI nothing.

times he calls her and she feels he definitely has mental problems. She knew of no psychiatric treatment, but she felt he needed it badly.

She stated her mother, BETTY L. (Mrs. KEITH W.D.) WADE, resides at 233 Smith Street, Barleson, Texas, and has telephone 817-295-2200. Her two brothers live in the same area. JONES advised that her father has a sister, LEIDA MC GAHEY, 2002 East Eighth Street, Columbus, Mississippi, telephone 601-327-1141, who usually knows his whereabouts.

JONES advised her father never indicates where he is calling from and has moved around a great deal since his divorce four and one-half years ago at Ft. Worth, Texas. She stated he was arrested around that time at Brownsville, Texas, while intoxicated in a bar and after making threats to kill his wife. She advised the police found a rifle in his car.

Further, she stated her father was congenial when sober, but when he drank he was mean and often hit his wife. She advised that although he was bigoted she is sure he did not kill KING and that he was not in Memphis at the time KING was murdered.

Synopsis: DEBRA ANN JONES, Belvidere, Illinois, daughter of BURGESS AUDIE WILSON, advised she and her mother were in Memphis during the KING assassination and her father remained in Kansas City, Missouri. Her mother called her father in Kansas City at least twice from Memphis. WILSON was arrested in Brownsville, Texas, about four and one-half years ago and allegedly had a rifle in his car. She said he definitely has mental problems, is intoxicated most of the time and feels he badly needs psychiatric treatment.

WILSON allegedly defaulted on a \$1,000.00 note at the Kyle State Bank, Kyle, Texas, and in a security agreement and financing statement filed with the Hayes County District Clerk's Office, WILSON indicated that the \$1,000.00 note was obtained to purchase cattle.

By teletype, dated August 24, 1978, Jackson Division requested San Antonio to re-interview WILSON regarding a discrepancy in the registration number of the Bonanza Aircraft he claimed he owned at the time of KING's death. This interview was not conducted based on telephonic instructions received from ASAC, Memphis Division, on August 24, 1978.

Synopsis: NCIC inquiry revealed BURGESS AUDIE WILSON, JR., born [redacted], in Mississippi, Social Security Account Number (SSAN) [redacted] wanted by New Braunfels, Texas, Police Department as Probation Violator as of 8/18/78. WILSON presently on probation out of Comal County District Court, Texas, for theft over \$200.00 and under \$10,000.00. WILSON previously treated at McKenna Memorial Hospital, New Braunfels, Texas, and Veterans Administration (VA) Hospital, San Antonio, Texas. No record located for treatment of mental disorders. Results of record reviews of both hospitals, Comal County District Court Clerk's Office, Comal County Probation Office, Comal County Sheriff's Office, and interview of ex-wife set forth.

DETAILS:

AT SAN ANTONIO, TEXAS

On August 18, 1978, inquiry of the National Crime Information Center (NCIC) revealed that BURGESS AUDIE WILSON, JR., born [redacted], in Mississippi, Social Security Account Number (SSAN) [redacted], Texas Drivers License Number 77911315, was wanted by the New Braunfels, Texas, Police Department as a Probation Violator, date of warrant April 18, 1978.

The following investigation was conducted by Special Clerk DAVID A. WALL:

AT SAN ANTONIO, TEXAS

A review of the records, Identification Bureau, Bexar County Jail, San Antonio, Texas, on August 18, 1978, indicated that BURGESS AUDIE WILSON, JR., white male, born [redacted] height 5'11", hair black, eyes brown, was booked into the Bexar County Jail on June 19, 1972 on Contempt of Court charges out of State District Court 57 (case number F248-084). WILSON served twelve days and was released on June 30, 1972.

The following investigation was conducted by Special Clerk CARMEN J. HINES:

AT SAN ANTONIO, TEXAS

On August 21, 1978, a review of court records, Bexar County 57th District Court, San Antonio, Texas, revealed WILSON was incarcerated for Contempt of Court growing out of a civil suit entitled "Allison-Kaufmann Company, a California corporation, v. North Star Diamond Corporation (case number F248-084) of which WILSON was listed as the owner. This civil suit involved a fraud case and WILSON was incarcerated following his refusal to furnish the court with an inventory of merchandise in his possession belonging to Allison-Kaufmann Company. This incarceration did not involve any action growing out of child support.

The following investigation was conducted by Special Agent WAYNE SMITH:

AT SAN MARCOS, TEXAS

On August 19, 1978, JO ANN CHILDRESS, 113 Mill, San Marcos, Texas, advised that she met BURGESS AUDIE WILSON, JR., also known as Bill Wilson, at Sadler, Texas, in September, 1977, and they were married in November of 1977. They separated February 15, 1978 and the divorce was finalized on April 26, 1978. On August 12, 1978, she received a telephonic message from WILSON indicating that he was in the state of Tennessee and was involved in an automobile accident. WILSON stated that as a result of this accident both of his legs were amputated. CHILDRESS advised that WILSON is a "very convincing liar and a con-man". He has never mentioned the death of MARTIN LUTHER KING and has never displayed any hatred or dislike for members of the black race.

According to CHILDRESS, she believes that WILSON was in the United States Army during 1968, and WILSON has stated that he was a Prisoner Of War (POW) during the Vietnam conflict. She is aware that WILSON visited the Veterans Administration (VA) Hospital in San Antonio, Texas on several occasions, but she possesses no knowledge of him suffering from any psychiatric problems. By previous marriage, WILSON has three children, two sons and one daughter, locations not known by CHILDRESS.

CHILDRESS advised that it is her personal opinion that WILSON is sick and she is not in a position to provide any information regarding his whereabouts in 1968 other than the fact that he did mention that he once resided in Memphis, Tennessee.

Further review of the record indicated that no
compensation was being received from the VA by WILSON and
that he had received no treatment at that facility for
mental disorders. In June, 1976, his claim folder was located
in the Wichita VA Center.

On June 27, 1976, WILSON was admitted as an in-patient to the VA hospital in San Antonio for insect bites. Initial diagnosis indicated Cellulitis of the right knee, Lymphangitis and Lymphadenitis; inflammation of lymph glands and multiple pus nodules on all extremities and neck. Additional diagnosis included chronic obstructive pulmonary disease; mild cardio infarction and a questionable cerebral vascular attack at age 30.

On June 29, 1976, WILSON went on pass from the hospital to visit his son who had been involved in a motorcycle accident in Dallas, Texas. WILSON did not return to the hospital.

On August 4, 1976, WILSON was treated as an out-patient for lime burn on his left foot. He was seen and released. On August 6, 1976, he telephonically contacted the hospital to report that his foot was healing properly.

On December 11, 1976, he was again treated as an out-patient for a swollen left elbow. He returned on December 14, 1976, for additional treatment. On December 21, 1976, WILSON failed to keep an appointment at the VA hospital for additional treatment and has not been treated subsequent to that time.

The following investigation was conducted by
SA THOMAS E. MOODY, IV at New Braunfels, Texas:

On August 22, 1978, HAZEL KUHN, Clerk, District Clerk's Office, Comal County District Court, New Braunfels, Texas, made available for review the records of the Comal County District Court. She noted that on the day BURGESS WILSON was scheduled to appear in Comal County District Court in connection with his divorce proceedings set forth hereinafter, he was admitted to the McKenna Memorial Hospital for an "alleged" rattlesnake bite. His attorney, IRVIN BOARNET of New Braunfels, withdrew from the case following this incident.

A review of the Comal County District Court records revealed that on September 3, 1974, WILSON was indicted by a Comal County Grand Jury for Theft Over \$200, a color television set being the property of DOROTHY E. WIMBERLY, under Cause Number 7520, in the 22nd Judicial District Court. An arrest warrant was served on WILSON on September 20, 1974, in Baxter County, Arkansas (Mountain Home). WILSON waived extradition and restitution was made. The charge was formally dismissed on March 30, 1976.

On February 7, 1975, an information was filed in Comal County District Court charging WILSON with Theft By Check. A capias was issued on February 7, 1975. WILSON, also known as WILLIAM WILSON, Highway 5, Mountain Home, Arkansas, was doing business as Ozark Jewelry and Watch Repair, (501) 425-8636. The charge was subsequently dismissed on December 22, 1977.

On August 7, 1974, WILSON was indicted by the Grand Jury in Comal County for Theft of Over \$200 and Under \$10,000 from ALBERT J. CRAUSE, Apartment 18, 1786 Austin Highway, San Antonio, Texas, under Cause Number 7712. WILSON pled guilty to this charge on March 11, 1976, at which time the following other charges were pending against him:

PATRICIA WILSON, 103 Catherine Drive, Starkville, Mississippi.

As a result of WILSON's guilty plea, he was placed
on 8 years probation by the 22nd Judicial District Court,
Comal County, beginning March 25, 1976. He was to report
weekly to the Probation Officer and pay \$2500 restitution
and \$62.50 for court costs.

On June 8, 1976, the 22nd Judicial District Court
issued a warrant for WILSON's arrest for violation probation.

On April 22, 1974, BETTY LOU WILSON filed a petition for divorce in Comal County District Court seeking to dissolve her marriage to BURGESS A. WILSON. The petition listed a son, MARK ANTHONY WILSON, born [redacted], at Memphis, Tennessee. In the petition BETTY LOU WILSON listed her address as 1505 West Canyon Lake Drive, Startzville, Texas, and BURGESS WILSON's address as 101-B Wonderland Shopping Center, Timex Center, San Antonio, Texas. The petition indicated that they were married on February 25, 1967, and separated on March 28, 1974.

In a cross petition filed by BURGESS WILSON on May 21, 1974, he indicated that they were originally married on December 13, 1948, and divorced on August 28, 1966, in Memphis, Tennessee. They were remarried on February 28, 1967, and separated on March 28, 1974.

The cross petition indicated that the son, MARK ANTHONY WILSON, was residing with WILSON's daughter, DEBORAH ANN JONES. A degree of divorce was entered on June 27, 1974, granting custody of MARK ANTHONY WILSON to BETTY LOU WILSON and requiring BURGESS A. WILSON to pay child support. A motion for Contempt was filed on August 19, 1974, as WILSON was in arrears in child support payments. The court has been unable, until this time, to locate WILSON for the purpose of serving the necessary papers.

ALLEN stated that he did not believe WILSON to be capable of violence and noted that WILSON experiences illusions of grandeur and is capable of telling "wild stories" when drinking.

The following day the pain disappeared and the electro-cardiogram was normal. His past medical history listed alcoholism and heart attack, the last "heart attack" being in 1963 in Memphis, Tennessee.

On May 24, 1974, WILSON left the hospital via taxi against medical advice at 3:20 p.m.

It was noted in the medical records that WILSON has upper dentures.

Sir: I respectfully report that about 10 months ago while in a laundromat on Taraval St. near 43rd Ave. I had a conversation with a female who upon learning that I was with the Police Department asked if I knew Insp. Robert Casciani and upon my confirming that I did told me of a case that he handled for her in 1960 involving the theft of her coin collection and the suspect involved.

She identified the suspect as an individual named Raoul stating that he was the son of the ex Prime Minister of Cuba before Bautista took over as Dictator. She claimed to have knowledge of Raoul having heavy involvement in gun running in Georgia and Alabama and a direct connection and involvement with the assassinations of President Kennedy and Martin Luther King. She claimed to have some of this knowledge partially through psychic powers she possessed, but had not ever tried to pass this information to the FBI. The information that she gave me at the time seemed to be somewhat logical but there was so much information I asked her if she would be agreeable to talk to the FBI and she reluctantly agreed. My general impression of the woman at the time was that she was probably a mental case.

I contacted Agent Ellie Kirkwood, FBI, San Francisco, in the next day or so and passed the information to him asking if the FBI would be interested in an interview and seeing if he would identify Raoul. I also contacted retired Insp. Casciani to see if he could recall the case. Casciani did remember the case and the woman and stated that in his opinion she was not fully competent. Kirkwood made some inquiries but was unable to ID the subject, Raoul, and under the circumstances no further action ensued.

During the first part of the week of Aug. 14th when the congressional committee started to question James Earl Ray and the name of the yet unidentified Raoul was mentioned, Kirkwood and I discussed the woman's information and he brought it to his supervisors who expressed a heavy interest in pursuing an immediate interview. I was requested on Thursday afternoon to make contact with her and see if she was agreeable to be interviewed by the FBI. I was successful in making the contact and building up a rapport with her and arranged a meeting on Friday evening with Agent Chuck Teevan who has been assigned the case.

I find that after having spending two evenings of about 3 hours each with this person, that she is very intelligent, fairly logical and more than likely fully competent as far as I can determine. She holds a full time job as an interior decorator, part time manages a 39 unit apartment house and part time bookkeeper for 3 businesses.

The information that she gives on the involvement of Raoul in the gun running and the assassinations however is primarily based on psychic powers she claims to have possessed during an approximate period of about 10 years and which she states she lost these powers around 1965.

DORI JEAN BREHAUT, 3421 Taroval Street, San Francisco, California was interviewed and provided the following information. Present during the interview was Inspector HAROLD M. SUSLOW, San Francisco Police Department who had made the initial contact with BREHAUT and who had advised concerning BREHAUT that she would be reluctant to provide any information without the Inspector's presence during the interview.

BREHAUT stated that during 1960 to October, 1961, she was employed at 323 Geary Street, with Lufthansa Airlines in the reservations and sales department. At that time, she was one of the few native Americans employed with Lufthansa Airlines. It was during this period of employment that she attracted the attention of a Cuban born male named RAOUL DEL LOPEZ CASTILLIO. CASTILLIO entered the Lufthansa office where BREHAUT was employed during May, 1960 and represented himself to her as a credit card salesman for Hilton Carte Blanche credit card. She indicated that she believed that CASTILLIO actually was employed with Hilton Carte Blanche but that he used this position as a ruse to make her acquaintance. BREHAUT during their initial contact declined to purchase a credit card. CASTILLIO however, purchased the credit card for her at his own expense. CASTILLIO never approached any other female employee at the Lufthansa Office and after that initial contact continued to contact her at her place of employment. BREHAUT stated that his infatuation on CASTILLIO's part continued for the next three or four months and he was a frequent visitor to her place of employment as well as her residence which was an apartment at 2160 Van Ness Avenue, San Francisco. BREHAUT stated that this relationship was platonic.

BREHAUT was unable to provide the names of any of her associates who would recall CASTILLIO other than her former employer CORNELIUS CASE KLEIN, who was intensely jealous of CASTILLIO. BREHAUT indicated that she subsequently has had an affair with KLEIN and would advise against contacting this individual. She indicated that KLEIN is probably still employed with Lufthansa.

BREHAUT stated that CASTILLIO was the son of the former prime minister to Cuba prior to BATISTA's Prime Ministership. During her conversations with CASTILLIO, he indicated a strong dislike for JOHN F. KENNEDY, then President of the United States because of the mishandling of the Cuban Bay of Pigs fiasco. CASTILLIO would speak of exiled Cuban's desires to liberate their native land. During these conversations, CASTILLIO mentioned (First Name Unknown) ALVAREZ (phonetic), a former attorney in Atlanta, Georgia who was active in Cuban affairs in this country.

In August of 1960, CASTILLIO left San Francisco and BREHAUT did not hear from him for several days until he telephoned her. He indicated during this telephonic contact that he was in Reno, Nevada and asked if everything was all right. He additionally indicated that he had left her telephone number as a contact point for himself and that she might be receiving telephone calls from men who are gathering guns for an arsenal in Benicia, California. BREHAUT indicated that she became extremely upset at hearing this but that CASTILLIO advised her not to worry about it. She stated that she never did receive any telephone calls concerning weapons nor did she have any further contact with CASTILLIO. DORI JEAN BREHAUT, 3421 Taroal Street, San Francisco, California was interviewed and provided the following information. Present during the interview was Inspector HAROLD M. SUSLOW, San Francisco Police Department who had made the initial contact with BREHAUT and who had advised concerning BREHAUT that she would be reluctant to provide any information without the Inspector's presence during the interview.

CASTILLIO never approached any other female employee at the Lufthansa Office and after that initial contact continued to contact her at her place of employment. BREHAUT stated that his infatuation on CASTILLIO's part continued for the next three or four months and he was a frequent visitor to her place of employment as well as her residence which was an apartment at 2160 Van Ness Avenue, San Francisco. BREHAUT stated that this relationship was platonic.

BREHAUT was unable to provide the names of any of her associates who would recall CASTILLIO other than her former employer CORNELIUS CASE KLEIN, who was intensely jealous of CASTILLIO.
