BOB SORRELL, Route 1, Box 260, (Beaumont Colony), Kountze, Texas, was contacted at his residence where he was advised of the identity of Special Agent RUSSELL E. KALIHER, JR. who identified himself as a Special Agent of the Federal Bureau of Investigation. He was advised that any information he furnished could possibly be used in a court of law. SORRELL was observed to be a white male, age 46, who exhibited no physical or mental impairments which would prevent his testifying in a court of law. SORRELL advised he preferred not to furnish a signed statement but did furnish the following oral information:

SORRELL became personally acquainted with BILL WILSON, through his, SORRELL's attendance at the Hollywood Baptist Church in Memphis, Tennessee, which was pastored by Brother WILSON, father of BILL WILSON. SORRELL had no other association with BILL WILSON except through contact at church. SORRELL attended that church as a youngster and continued until approximately 1958, when his family moved from the neighborhood and his attendance stopped.

He, SORRELL, had no other contact with BILL WILSON until after 1967 when SORRELL became employed at Hagler Aero Service, Charles W. Baker Airport, Millington, Tennessee, telephone number 872-2261. SORRELL was employed part-time at Hagler until October or November, 1967 when he became a full-time employee functioning as a lineman.

SORRELL recalled that sometime after becomeing a full-time employee that BILL WILSON flew into the airport, exact date unrecalled, in a twin Beechcraft (D-18) believed to be red and white in color with possibly a blue stripe. SORRELL recalled that he, SORRELL, refueled this airplane, but he cannot recall the time of day that WILSON arrived at the airport. As best recalled by SORRELL, WILSON was wearing civilian clothing and paid cash for the fuel purchase. SORRELL and WILSON had little conversation other than a routine greeting. As best recalled by SORRELL, WILSON stayed overnight and left the following day, time unknown. SORRELL does not know how WILSON was transported from and to the airport.

Vithin two or three months, MILSON made a second visit to Hagler in the same aircraft where he received gas, paid each and laid over for two or three days. Again, SORRELL has no idea as to the transportation from and to the airport. SOFRELL has no information as to where he came in from or his destination upon departure from the airport. SORRELL could supply no information about a 1965 white Mustang and did not know that WILSON had a daughter, DEBORAN.

SORRELL has not seen nor heard from WILSON since WILSON's last visit to Hagler.

SORRELL terminated his employment at Hagler in October, 1976. SORRELL cannot recall the exact time of arrival or departure of WILSON, but does believe that both visits occurred in either 1968 or 1989. SORRELL advised that fuel receipts are broken down by single engine or multi-engine aircraft and are maintained on a monthly basis. He said that a CLENN MITCHELL, Maintenance Supervisor, Magler Aero Service, could assist if a review of the gas receipts became necessary to determine the exact date of arrival of VILSON.

SOFRELL had no information as to how WILSON came into possession of the aircraft and does not know whether it was leased or owned by him. In recalling the two visits by WILSON, SOFRELL has a "gut feeling" that someone may have been with him on each occasion, but this is just a feeling on his part and he can supply no information to confirm this feeling. SOFRELL had no information about an airport in Olatha. Kansas, where WILSON allegedly landed after departure from Memphis.

As further background information, SORRELL recalled that during his attendance at the hollywood Baptist Church he got the impression that WILSON was in and out of trouble although he does not know the type. We may have received this information from one of WILSON's sisters, names unrecalled. Through contact with WILSON at church, WILSON impressed CORRELL as the type of guy who always had a 'big deal', "kind of a con man personality". Again, and it may have been one of WILSON's sisters who mentioned it. SORRELL got the impression that WILSON had been arrested and received time for an unknown offense. SORRULL advised that contact with WILSON's sisters was always at church. He again stated that he has a "gut feeling" that one

of them may have been at the airport on one of the two occasions of WILSON's arrival.

SORRELL did not know for certain that VILSON served in the U.S. Air Force, but recalled that VILSON were a uniform to church on occasions. SORRELL was not aware that VILSON was employed at Prudential Insurance Company, but does recall his marriage to BETTY LOU (Maiden name unknown), because PETTY lived in the same neighborhood. SORRELL had no information about VILSON's cleaning business or time spent in the Tennessee Mational Guard or that WILSON ever left the Memphis area.

Synopsis:

On August 18, 1978, BURGESS AUDIE WILSON turned himself over to FBI Agents of the Jackson, Mississippi, Office. WILSON alleged that he murdered MARTIN LUTHER KING, JR. At the time of KING's death, WILSON resided at 13125 Herrick Avenue, Grandview, Missouri. During the same period of time, WILSON owned a jewelry store in Belton. Missouri, called Wilburs Jewelry Store. As a result of doing business as a jeweler, he met MITCH ZAMMAR who he alleges gave him a Japanese Sniper Rifle with which he killed KING. ZAMMAR admitted knowing who WILSON was, however, he said he does not know anything about WILSON's involvement with the assassination of KING. ZAMMAR only met WILSON once as a result of selling WILSON a diamond ring. ZAMMAR said that he had five brothers who are now all deceased. He said that his brother, JIM, had a scar on his face as a result of an injury sustained as a infant. WILSON also alleges that a LOU CREWS of Crews Jewelry Store, Grandview, Missouri, engineered the assassination of KING. CREWS died of cancer on August 22, 1978, before he could be interviewed. According to FAA records, WILSON purchased a Bonanza Airplane #4434L from FISHER Sales and Services on June 6, 1968. DON FISHER, of Fisher Sales and Services, purchased this plane on May 27, 1968, from a CORNIE C. MILLER, 9618 Sagamore, Kansas City, Missouri. WILSON alleges he used this plane to fly from Kansas City to Memphis. FISHER said that prior to the time that WILSON purchased the plane from him, WILSON rented the plane from him on numerous occasions. FISHER said that MILLER, the previous owner, never rented the plane to anyone while he was the owner.

MILLER indicated he never rented or leased the plane to anyone while he was the owner of Bonanza Plane #4434L. WILSON also alleges that he drove to the airport in a Thunderbird owned by him, however, the records of the Johnson County Bank, Kansas, show that the car was not purchased until October 9, 1968. WILSON has been described as a con man and a heavy drinker.

Investigation was initiated on August 21, 1978, upon receipt of an immediate teletype from Memphis, indicating that BURGESS AUDIE WILSON surrendered to FBI Agents of the Jackson Office. WILSON, at that time, alleged that he assassinated MARTIN LUTHER KING, JR.

After being advised of the identity of the interviewing Agent, DON FISHER, Fisher Sales and Services, State Line Airport, Leawood, Kansas, telephone 681-2496, provided the following information:

FISHER purchased State Line Airport in 1964. He remembered the sale of a Model G #56 Bonanza to WILSON. He said he does not remember the exact date, however. He said he remembers the sale of the plane to WILSON because FISHER originally purchased the plane from C. C. MILLER, a retired executive for Western Auto Supply Co. FISHER indicated that MILLER based the plane at State Line Airport from the time MILLER purchased the plane until FISHER bought it from him. FISHER indicated that all the records pertaining to the sale of the aircraft to WILSON were destroyed in a fire at the airport last year.

FISHER thinks that WILSON financed the plane with the Johnson County Bank in Kansas and thinks that WILSON had a partner named LOU CREWS, who owns Crews Jewelers, Grandview, Missouri.

FISHER indicated that he thinks WILSON was a Shriner and also that WILSON drank a lot. FISHER said he thinks WILSON was a jeweler in Grandview, Missouri. He could not recall whether he owned the jewelry store or if he worked for another company.

FISHER indicated that the airport keeps no records of landings or takeoffs.

FISHER said that if he cannot be contacted at State Line Airport, he will be at the Lake of the Ozarks, telephone 314/873-5166.

EDWARD BUSH, person in charge of airglane loans, Johnson County Bank, Kansas, telephone 362-7000, after being advised of the identity of interviewing Agent, provided the following information:

BUSH said he searched his files regarding the financing of a Bonanza plane purchased from a DON FISHER. BUSH indicated that a BURGESS AUDIE WILSON did finance a plane purchased from FISHER in 1968. He indicated that his records show that a Credit Bureau check was made on June 5, 1968. He also indicated that the bill of sale was dated June 6, 1968.

BUSH said that WILSON's applicant for the loan listed his residence as 13125 Herrick, Grandview, Missouri. It listed his employment as owner of Wilbur Wholesale Jewelry, telephone 331-2500. BUSH indicated that there was no date on the application.

BUSH indicated that WILSON signed a security agreement on June 6, 1968, along with LOU CREWS. He said on June 6, 1968, the plane was registered listing both TREWS and WILSON as partners. The address of the registration of the plane was 553 North Scott, Belton, Missouri.

BUSH said that CREWS' application showed his residence as Hickman Mills Drive, Old 71 Highway. His employment was listed as Chipper Manufacturing. BUSH also indicated that there was no date on the application, nor was there an address or telephone number for Clipper Manufacturing,

BUSH indicated that there is a letter in the file dated November 22, 1968, stating that WILSON and CREWS transferred all rights in the Bonanza #4434L back to DON FISHER.

WADE said she could positively state that
WILSON was in Grandview, Missouri at the time Dr. MARTIN LUTHER KING, JR. was shot.

WADE advised that WILSON has had serious mental problems for years, but he declines to seek treatment. She said WILSON has made threatening and harassing telephone calls to her on numerous occasions over the past five years, and her son, MARK WILSON, had his father arrested at Clebanne, Texas, two years ago as a result of one of these calls and due to non-child support. WADE described her ex-husband as a liar and con-artist with serious mental problems. She said he cannot differentiate between the truth and fantasy, and that he lives in a dream world most of the time. She felt he needs medical attention.

WILSON confirmed that his sister, DEBORAH ANN, was given a Mustang by their father, but stated the vehicle remained at Grandview and was never driven to Memphis, Tennessee. WILSON confirmed that his father did drive the vehicle on occasion, but it was primarily driven by DEBORAH ANN. WILSON siad he recalled the vehicle to be light blue in color and a 1965 model.

WILSON said when he got out of the military service in January, 1976, he went to San Antonio, Texas. He said his father was living at New Braunfels, Texas, at that time and was placed on probation there for some kind of criminal offense. WILSON said that after his father was placed on probation, and because of his known alcohol addiction, he went to New Braunfels and picked up his father and took him back to San Antonio, Texas, where he was placed in the Atcoholic Rehabilitation Clinic for three or four days to try to get him "dried out". At this time his father's mental state was not rational. He said after his father was released from the clinic, he took him home. WILSON said his father stayed with him for several weeks but was asked to leave after it was discovered he was drinking alcohol during the day and had made numerous long distance telephone calls to his ex-wives and girl friends.

WILSON said his father has been known to make threats and has physically and verbally abused his wife and children for many years; however, he has never known him to be violent with anyone else. WILSON said he has never heard his father make any statement that he killed Dr. MARTIN LUTHER KING, and was of the opinion that he would not be capable of such an act.

WILSON said he last saw his father at San Marcos, Texas, in January, 1978, when he and MARK had dinner with their father. WILSON said his father seemed to be doing alright at this time, he seemed happy and there was no indication of any problems.

MARK ANTHONY WILSON, 514 Southeast Gardens, Apartment Number 132, Burleson, Texas, furnished the following information:

He is the son of BURGESS AUDIE WILSON. He said his father is a very sick man and may even be insane. He was advised of his father's allegation that he killed MARTIN LUTKER KING, and WILSON said his father could not have done it, because to the best of his recollection, BURGESS WILSON was at home in Grandview, Missouri, at the time of the KING killing. WILSON said his father was babysitting with him and his brother, STEPHEN WILSON, at the time and he thinks his mother and sister were in Memphis, Tennessee, visiting his grandmother.

WILSON confirmed that his sister had a white 1965 Mustang vehicle at that time. He said BURGESS WILSON would drive the vehicle on occasion primarily to instruct DEDORAH ANN to drive. He did not recall the father ever making any trip to Memphis, Tennessee, in the Mustang.

WILSON described his father as a habitual liar who always wanted to be someone important. He said his father is an alcoholic who thinks the whole world is crazy and he is the only sane person.

WILSON confirmed his father was a private pilot and said he used to own a Bonanza aircraft when they lived at Grandview, Missouri.

He said he has never heard his father make any allegation that he killed Dr. MARTIN LUTHER KING, JR.

MARK WILSON, 514 Southeast Gardens, Burleson, Texas, was telephonically contacted and advised of the identity of SA GERALD LEWIS GUARY as a Special Agent of the FBI. He was advised he was being recontacted regarding the statement of BURGESS AUDIE WILSON, his father, that he had killed Reverend PARTIM LUTTER KING. It was explained to MARK WILSON that his father claimed that he had shot Reverend KING with a Japanese sniper rifle. In addition, his father indicated during interview that he flew a Bonanza Beechcraft from Grandview, Texas to Memphis and then returned to Grandview by plane after shooting Doctor KING. MARK WILSON advised the following information:

He personally had no knowledge of any of his father's firearms as he had no interest in guns. He, therefore, could not verify whether his father ever owned a Japanese sniper rifle.

His dad, BURGERS AUDIE WILSON, was definitely at home in Grandview, Texas taking care of himself and his brother, STEPHYN, at the time Doctor KTIG was killed in Memphis, Tennessee. He recalled his father flew a plane, Bonanza Beechcraft, usually on weekends from a small air field near town. He believed his dad owned the plane; however, he is not positive. He recalled that his mother and sister had flown to Memphis by commercial airliner to see their grandparents and were in Memphis at the time Doctor KING was killed.

Mrs. BETTY LOU WADE, 233 Smith Road, Burleson, Texas, was contacted telephonically and advised of the identity of SA GERALD LEMIS GEARY as a Special Agent of the FBI. She was advised that she was being recontacted regarding the statements of BURGESS AUDIE WILSON, her former husband, that he had killed Reverend MARTIN LUTHER KING. It was explained to Mrs. WADE that BURGESS WILSON had claimed that he had killed Reverend KING with a Japanese sminor rifle. Mrs. WADE advised that she had no recollection of her husband having a Japanese rifle. She stated she separated from FURGESS WILSON in 1974 which would mean if he actually had owned such a weapon, he most probably obtained it after that time period. She stated she is certain that she would have been aware if he had purchased or obtained the weapon while they were living together.

STEPH-M UNITE CIRCL, 3117 Mivragston, Fort Worth, Texas, was contacted tolephonically and advised of the identity of SA GMMALD LEWES GEARY as a Special Agent of the FBI. He was adviced that he was being recontacted regarding his father's statement (BURGESS AUDIE WILSON) that he had killed Asvarend HIRTH LUMBEL KING. It was explained to VILSON that his mather claimed that he had shot Reverend HIRS with a Japanese saider wifes which he had later given to GERSTON. CTAPHEN MAKES WILSON advised the following information:

The WILSONs were a closely-knit family, and were very conscious of cash other's activities. He is positive his father obtained the Japanese rifle from an unknown source after he was in the military service, which would have been after 1970. He recalled his ded showing it to him when he came home on additary leave. STEPHEN never fired the weapon because he was afraid that it would not function properly, and secondly, because they never had any amountain for the rifle. He personally never bnew of his dad using the weapon. His Jad had the stock of the weapon worked on by a friend who was a furniture refinisher in Canyon Lake, Texas, but that has the only work ever done on the rifle. The gun was of Japanese manufacturer, as it had Japanese printing on its various parts.

WILSON's dad gave the gun to him while he was in the service, and he hocked the rifle at a pawn shop in San Antonio sometime in the early 1970's, date unrecalled. He has no receipt or bill of lading for the rifle.

Mr. WILLIAM DON GLADDEN, age 46, white male, keute 3, Box 205-N-3 (Braderhark Drive), Gulf Paul Estates, Ocean Springs, Mississippi (telephone number 875-3518), was contacted at the Seanons and Reasons Gift Shop located at 2446 Highway 90 Dast, Ocean Springs, Mississippi (telephone number 875-2531). Mr. GLADDEN furnished the following information:

He is employed as the manager of the Social Security Administration Office in Gulfport, Mississippi (telephone unaber 896-3221), but also is owner of the above noted gift shop along with his wife, ALICE A. GLAVEEN. GLADDEN advised that he and his wife opened the gift shop in Ocean Springs on July 3, 1978.

Co or about July 26, 1978, a man came to the gift shop and identified himself as "Bill" WILSON. He talked with GLADDEN's wife stating that he was getting ready to open a watch repair business in the Edgewater Shopping Mail in Bilani, bassissippi, and nonted to use the GLADDEN's gift shop as a pickup power for watches to be repaired. Has, GLADDEN discussed the matter with her husband and he and WILSON agreed approximately four or five days later to permit WILSON to rent repair shop space in the rear of GLADDEN's gift shop.

According to GLADDEN, neither he nor his wife had ever met WILSON before but he was a friendly outgoing individual whenthey came to trust. He was a very good worker and always was the first one to open the store in the morning. WILSON paid his own money for a lot of radio ads for his watch repair business. WILSON had some of his own jewelry and watch repair equipment but after moving into GLADDEN's gift shop, spent several thousand dollars of his own money for additional equipment. GLADDEN advised that the only investment he (GLADDEN) had in the watch repair effort was that he agreed to go in half with WILSON on an \$800 sign for the store.

always trying to "drum up now business". According to GLADDEN, all signs were that BILL WILSON was going to stay with the gift shop as a watch repairmen on a permenent basis. After a few days, WILSON advised Mr. and Ers. GLADDEN that he had changed his mind about opening up a watch and jewelry repair business in the Edgewater Mall, Biloxi, Mississippi.

GLADDEN advised that neither he nor his wife ever visited the MILSON residence in Ocean Springs but it was their understanding that WILSON resided in Apartment No. 9 at the Twin Pines Motel on Highway 90 in Ocean Springs for several days after first arriving in town. Later WILSON advised the GLADDENs that he had moved to a residence located at Route 6, Box 387. Ocean Springs (telephone number 875-9542). GLADDEN advised that this residence apparently is located on the Vancleove Road north of the Ocean Springs Hospital. WILSON told the GLADDENs that the house is owned by an unidentified friend who was letting him live there in exchange for keeping the bouse in good repair.

GLADDEN advised that WILSON is an excellent pilot. GLADDEN and his son flew with WILSON in a rented plane and according to GLADDEN, WILSON appeared to know everything about flying the plane and could handle it well in rough weather. GLADDEN did not know the extent of WILSON's education but described him as being an "extremely intelligent man". WILSON would come and go in the shop every day and had numerous advertising fliers priored up which he apparently hand delivered in various businesses around the Ocean Springs area.

GLADDEN advised that semetime after WILSON began working at his watch repair business in Ocean Springs, he became aware that WILSON had a drinking problem. The drinking problem, however, did not affect WILSON's work because he would come into the shop early every morning and do all of the watch repairs that were waiting for him and then he would leave for the day. GLADDEN advised that one salesman (identity unrecalled) who apparently had some contact with WILSON stated that WILSON told him that he had a drinking problem but was trying to work hard at the watch repair business in order to defeat this problem.

On August 17, 1978, at around 11:45 p.m. WILSON telephoned ALICE CLADDEN at the GLADDEN residence in Ocean Springs. He asked to speak to WILLIAM D. GLADDEN who at that time was askeep. GLADDEN answered the phone and WILSON teld him that he had to seekim and his wife immediately about a matter which would not wait until the morning. WILSON refused to come to the GLADDEN residence and stated that they should meet at the gift shop to discuss a matter of "national urgency". GLADDEN stated that he become worried at WILSON's insistence so besides his wife, he took his 18 year old son along and met WILSON at the gift shop at 12:15 a.m. on August 18, 1978.

WILSON arrived at the gift shop at the appointed time driving his old model blue Chevrolet with a white top and unrecalled Louisiana license tags. He had been drinking because his breath smalled of alcehol and his eyes were extremely red; however, he did not talk like an intoxicated person. He appeared very depressed according to CLADDEN.

WILSON opered the conversation by saying, "I am the mystery man." When questioned by GLADDEN as to what he meant by this remark WILSON said, "I am the man that murdered Martin Luther King," GLADDEN advised that WILSON then talked with him for the next hour and 15 minutes about how he had grown up in Granada, Mississippi, where his father was a Baptist preacher. WILSON described how his father's church was open for local blacks to worship in and they were treated like neighbors. When the racial unrest was running rampent in the State of Mississippi in 1967 some "northern" blacks came to the church escorted by FBI Agents. WILSON's father welcomed them to the church only if they were not there "for thouble". However, according to WILSON, they did come for trouble and his father subsequently died of a heart attack as a result of the racial unrest.

WILSON then stated again that, "I am the one that pulled the trigger." He stated that the KING killing was a conspiracy and that he was the logical one to pull the trigger. WILSON told the GLADDENs that he had been with the Government (not further described) and had been involved in undeclared wars (not further described). WILSON also said that he knew MARTIN LUTHER KING's father and brother and grew up right next door to KING's cousin and knew the entire family.

(WILSON did not furnish the name of KING's cousin to the GLADDENs.)

GLADDEN advised that WILSON told him that he had purchased a white Mustang for his daughter and that it was similar to a vehicle which GLADDEN had purchased for his daughter in Ocean Springs. WILSON told GLADDEN that his daughter had driven the white Mustang to Memphis. Termessee, just prior to the KING assassination. WILSON was supposed to be in Kensas City, Missouri, at the time of the assassination and had alibis to prove it when actually he too was in Memphis.

WILSON told GLADDEN that JAMES EARL RAY was the "fall guy". He said that RAY only saw him twice but WILSON knew who RAY was. RAY was semposed to have gotten away clean. WILSON said that he was sumprised that RAY has brought it all back up again incometh as he (RAY) is probably due for parole in about two years.

WILSON told GLADDEN, "You won't see me anymore after tonight." He wanted the GLADDENs to have his watch repair equipment. WILSON again insisted to the GLADDENS that the KING assassination was a "group conspiracy". WILSON stated that he would only deal with the "Sheriff of Memphis, Tennessee, whom WILSON used to fly with". WILSON also said that he felt the Government (not further described) wanted the KING killing to happen and he (WILSON) knew it needed to be done and did not expect to get much time for it.

WILSON told GLADDEN that he was not sorry he did the KING killing since the "niggers are better off". Later in their conversation WILSON did say he was sorry that he had pulled the trigger.

WILSON told the GLADDENs that the Sheriff of Memphis had talked to him on the telephone and had agreed to meet WILSON in the Gulfport, Mississippi, Holiday Inu the morning of August 18, 1978. WILSON speculated that he would probably be allowed to have a television set in his cell and would probably be allowed to repair watches or give instruction in watch repair while in prison.

WILSON also told the GLADDENs that he fired the shot that killed MARTIN LUTHER KING not from 50 yards but from about 50 feet away and he saw the bullet hit. WILSON said that, "I shot the shit out of him and saw it fly." WILSON never mentioned the type of gun he used nor did he tell the GLADDENs the location from which he allegedly fired the shot.

At one point during their conversation, WILSON looked at GLADDEN's son who apparently appeared disturbed by WILSON's revelations. WILSON told GLADDEN's son that he could tell he did not approve of what he had done but that he had better keep his nose out of it.

WILSON, who apparently had served in the U.S. Air Force, indicated that he had worked in some type of investigative work while in the military service.

WILSON kept bringing up the fact that he was going to meet with the Sheriff of Hemphis, Tennessee, the morning of August 18, 1978, and even offered to furnish GLAPDEN this individual's name and telephone number if he wanted it for verification. GLADDEN declined.

WILSON said that he had gone through 10 years of hell because he killed KING. He said that it had ruined 26 years of a good marriage and now his conscience was bothering him more than ever in the last few years.

WILSON referred to a sketch of the KING murder suspect which apparently had been recently shown on television and told GLADDEN that the sketch was almost an exact likeness of him (WILSON).

WILSON said that he has a sister in Fulton, Mississippi, who telephoned him in Ocean Springs after the sketch was shown on television saying that the sketch looked exactly like him. According to WILSON he called his sister and other members of his family to let them know he was turning himself in.

GLADDEN advised that at the end of their convergation, WILSON left the gift shop and drove east on Highway 90. GLADDEN feels sure that WILSON probably drove to the Augular's Inn Tavern which is located a short distance from the gift shop and was apparently frequented by WILSON.

GLADDER advised that shortly before noon on August 18, 1978, he was telephonically contacted by WILSON who said that he was now at home and that he had been to the Holiday Inn in Culfport, Mississippi, accompanied by "the father" (not further identified). The sheriff of Memphis, Tennessee, had not shown up; however, there were individuals there believed by WILSON to be FBI Agents. He believed he had been betrayed and was now ready to "blow anyone's head off who comes to my house except the father", About three hours after this conversation WILSON walked into GLADDEN's gift shop. He was close and neat and told GLADDEN that he apparently had been in touch with the FBI and that the I'm was not going to do anything to him. According to GLADDEN, WILSON indicated that he had worked out some "bargain" with the FBI and now WIISON wanted to live a normal routine life. He asked GLADDEN if he could continue working in the watch repair business. GLADDEN advised WILSON that he and his wife were seriously contemplating selling the business and they would make no decision about retaining him.

Outside the possibility that WILSON had a drinking problem, GLADDEN observed nothing unusual about the person and did not consider him to be "the typical psychopath". GLADDEN stated that in his job as manager of the Social Security Office he deals with a lot of people who have mental problems. He does not fit WILSON into any of the categories of mental imparities that he has observed. He recalled that he has heard a lot about WILSON's past life but nothing about his activities within the past 10 years. He recalled WILSON saying he had been married five times, twice to the same woman. WILSON said that he had been on the Mississippi Coast only for about three months even though he grew up in the State of Mississippi.
