On 4/20/68 Mrs. EVELYN ARNOLD, Williams Drive, Stoughton, Wisconsin, telephone 873-3487 telephonically contacted this office to advise that on 4/15/68 she was taking a friend to O'Hare Field and had parked her car across the roadway from the International Building on the upper ramp and when coming out of the International Building she noticed a man on the far side of the car who appeared to be trying to get into the car. When he looked up and saw her coming toward the car he ran across the roadway and entered one of the buildings.

She described him as a white male, 5'11", about 33, had a crook in the bridge of his nose, dark hair, rather long with normal sideburns and the hair was combed straight back. Slender build, complexion was on the pale side. He was well dressed wearing dark trousers with light colored windbreaker and was good looking. She stated that she called to advise that when she saw the picture of ERIC GALT in the paper this individual appeared somewhat similar and thought she should contact the FBI.

On 4/20/68 Mr. and Mrs. FRED ROACH, 3759 North 28th Street, Milwaukee, telephone 444-4237, advised that she and her husband after leaving work at 12:15 AM this date stopped at a tavern called Hoppies at 40th and Fond du Lac. While waiting at the bar they observed three middle-aged men who were attempting to engage an older gentleman in conversation regarding civil rights and disorders. One of the three men said that he had a machine gun and that he was going to use it. She said that this individual had been drinking but that she and her husband felt that he was not inebriated. He appeared to be well dressed and upon checking the photograph of GALT felt that he closely resembled GALT. She said that the description was similar to that of GALT.

She subsequently called the Milwaukee Office and advised that she observed 1960 picture of JAMES EARL RAY and said she felt that one of the remaining three men who was not talking, closely resembled the picture of RAY. She said that the only exception was that this man had longer brown hair which was wavy.

At 12:01 PM, 12/20/68, JAMES W. BAKER, Reporter, Associated Press, address 621 North 14th Street, Milwaukee, Office Phone 271-0158, telephonically called the office concerning captioned case, stating that he saw an individual resembling GALT,

DAL'S BAKER stated that on 4/18/68 between 4 and 5 PM he was visiting the hamburger place, believed known as Dews on the northeast corner of 12th and Wisconsin Avenue and was sitting on a stool at the time. He said an individual, who was obviously drunk, was sitting in the booth behind him who resembled the photograph of GALT a few days ago in the "Milwaukee Journal" and who resembled RAY in the "Milwaukee Sentinel" Saturday issue of 4/20/68 (the right side photograph).

BAKER described this individual as being in his late 30s or early 40s, 5'9", about 160 pounds, sport plaid jacket, medium dark brown - tan trousers (unkempt), white shirt and tie who talked with a southern "hillbilly" accent. He said this individual had just eaten and in conversation with him stated that he had been in town only three weeks and needed help to get to some unknown place. BAKER suggested he take a cab and he didn't say anything but he did ask directions to the nearest bar and was directed to the Avalanche Bar on Wells Street between 12th and 16th, exact address unknown.

BAKER said that unknown subject also spoke with one of the waitresses and said two waitresses that were presently at the time were BONNIE (LNU) and SANDY (LNU).

On 4/20/68 Mr. DANIEL S. KELLY, 2533 North Wall Avenue, Milwaukee, Wisconsin, telephonically furnished the following information to the FBI, Milwaukee. Mr. KELLY stated that he and his wife were recently in Florida, having arrived there 3/28/68 from the West Coast. They checked into the Sun Castle Club, 1380 South Ocean Blvd., Pompano, Florida which Mr. KELLY stated was operated by an ex-FBI Agent, ERNEST CASTLE. He said that upon his arrival he was roomed by a bellboy of the Club and subsequently requested this bellboy to furnish him with three or four copies of various newspapers. He stated that two or three days later he attempted to locate the bellboy to reimburse him for the papers and found out that he had left the employ of the Club. He stated that inquiry revealed that this bellboy, whom he knew only by the first name of EARL, had told others at the Club that he was leaving to accept an offer to work as an electrician someplace in Tennessee for \$500 a week. Mr. KELLY stated that this salary sounded absurd and that upon subsequently checking photographs of JAMES EARL RAY he and his wife felt that this individual closely resembled RAY, both in looks and general description. At about 6 p.m. on 4/4/68, while standing on the second floor balcony outside Room 306 of the Lorraine Motel, 406 Mulberry Street, Memphis, Tennessee, Dr. MARTIN LUTHER KING, JR. was struck in the right side of the face by a single bullet fired from a 30-06 rifle. The bullet severed KING's spinal cord and death was almost instantaneous.

This investigation, predicated upon a specific request from the Attorney General of the United States, disclosed that the fatal shot had been fired from the bathroom of a cheap rooming house located at 422½ South Main Street, Memphis, which bathroom was located at the rear of the rooming house, and had a window overlooking the Lorraine Motel.

At about 3 p.m. on 4/4/68, an individual using the name JOHN WILLARD had rented Room 5-B in the rooming house at 422½ South Main Street and had paid one week's rent. After hearing the rifle shot at about 6 p.m. on that same day, other tenants in the rooming house observed a man presumably identical with WILLARD, fleeing from the rooming house carrying a large package which was subsequently abandoned by him on the sidewalk in front of the Canipe Amusement Co., 424 South Main Street, Memphis. A neighborhood investigation in the vicinity of 424 South Main Street disclosed that the subject had fled from the scene in a white Mustang.

Investigation at Memphis disclosed that an individual had purchased a set of binoculars at the York Arms Company in Memphis on 4/4/68. These binoculars were among the material abandoned with the rifle and recovered in Memphis. Also recovered was a brown and green herringbone bedspread. The items abandoned in Memphis were all wrapped in this bedspread. The blue bag which was inside the bedspread contained numerous items, among which were the binoculars and a set of underwear consisting of a T-shirt and shorts. The T-shirt and shorts are those on which appears the laundry mark which has been a matter of interest in this case.

A search of motel records in the Memphis area disclosed that an individual using the name ERIC S. GALT had spent the night of 4/3/68 at the Rebel Motel, Memphis, Tennessee, and was driving a 1966 white Mustang bearing Alabama License 1-38993. Investigation at Birmingham disclosed that this automobile had been purchased by ERIC S. GALT on August 30, 1968, from a private person in response to a newspaper ad. He paid a total of \$1995 cash. While in Birmingham he furnished the address of 2608 South Highland Avenue, Birmingham. This is also the address which appeared on a driver's license issued to him by the State of Alabama. The driver's license identifying data listed his birth date as [redacted] his height as 5'11", his weight as 170 and his eyes blue and hair brown.

The automobile in question, the white Mustang bearing the Alabama tags mentioned above, was recovered in Atlanta on 4/11/68 and determined to have been abandoned there prior to 9 a.m. on 4/5/68.

In connection with the evidence submitted by Atlanta, Birmingham, and Memphis, identifiable latent prints were recovered. It was on the basis of these latents that identification was made of JAMES EARL RAY. In handling future leads, all offices should be particularly interested in securing an identifying number, military, police, or FBI, in connection with suspects so that the necessary check can be made through the Identification Division.

On 4/17/68, AUSA R. MACEY TAYLOR, Birmingham, authorized the filing of a complaint charging ERIC STARVO GALT with a conspiracy to violate Section 241, Title 18, U. S. Code, and

On 4/22/68, LESTER BLIFFERT, Apartment 101, (no phone) 505 North 26th Street, Milwaukee, Wisconsin, appeared at the Milwaukee Office and advised he observed a man enter the apartment building in which he lives and manages on the night of 4/17/68, who is a "dead ringer" for the photograph (with eyes open) of ERIC STARVO GALT, whose photograph appeared in the Milwaukee SENTINEL that date.

He stated there have been some unusual incidents in the apartment building and that something is wrong but he does not know exactly what. He related the following:

Apartment No. 108 is occupied by MARGARET LARSEN, a white female, age 40, 4" 11", who has been employed by the Towne Hotel, Milwaukee, for many years and who has held the position of manager of the hotel for the past year. She has resided in the apartment building since August 1, 1963, and formerly lived at 620 North 17th Street. She has shared the apartment with her son JOHN PETERS, who is now about 20 and who has worked for the post office in the past carrying mail. 723

About a week and a half to two weeks ago and he believes prior to the KING murder, he observed LARSEN bring a white male into her apartment one afternoon about 4:00 p.m. This white male is not identical to the one whom he described as a "dead ringer" for GALT. She has never had male visitors previously. Since that time he has observed this man on other occasions, and he believes that the man is staying in her apartment but does not go out during daytime.
