Ray Reportedly Wanted 'Bounty'

From Press Dispatches

Dalton, Ga. - A prison friend of James Earl Ray said Tuesday that when Ray heard there was a "million dollar bounty" on the Rev. Martin Luther King, jr., he smiled and said: "I'll collect it."

Ray, a 40 year old fugitive from the Missouri state prison, is sought by the FBI in connection with the assassination of King in Memphis Apr. 4.

The prison friend, Raymond Curtis, 40, who is in the Dalton jail awaiting appeal on a murder sentence, said word of a million dollar kitty supposedly being raised by a Ku Klux Klan "businessmen's association" was circulated about a week after the assassi-

nation of President John F. Kennedy in November, 1963.

Curtis, who was in Missouri state prison with Ray at the time, said Ray's reaction to the Kennedy assassination was: "Well, somebody made a pretty penny on that."

No Evidence of Bounty

There is no evidence that a \$1 million bounty was ever started for the death of King, nor any evidence of such a klan "businessmen's association."

Curtis, who has been interviewed by the FBI in the King case, said he had known Ray in the Kansas City jail, in federal prison at Leavenworth, Kan., and in the state prison at Jefferson City, Mo.

He described Ray as likable, addicted to drugs, a "loner"

and a man concerned only with money.

Curtis said Ray never mentioned racial matters. "He never made no statements of any kind in a group," Curtis said.

Was "Mastermind"

According to Curtis, Ray could not "make a long conversation unless he was planning something."

"If he was planning something, you could bet they'd be thorough plans," Curtis said, adding that Ray had masterminded things "that would be small things outside, but were pretty big jobs in prison." He mentioned the theft of such things as eggs and drugs and cigarettes.

He said Ray told him that if he ever wanted to kill someone, he would buy a gun under a false name, and have everything ready for an escape. "He used to talk a lot about escaping to New Zealand, Brazil and Argentina," Curtis said.

In other developments in the King case:

Harold Swenson, warden at the Missouri state prison, said Ray's brother, John was visited in the prison a day before James escaped last year. An FBI complaint filed on Apr. 17 accused Eric Starvo Galt, whom the FBI has since identified as James Earl Ray, of conspiring with "an individual whom he alleged to be his brother," to violate King's civil rights.

A report that the FBI was still looking for Eric Starvo Galt in Florida was based on the use of old information, law officers in Tallahassee said Tuesday. An FBI alert distributed in Florida Monday disregarded the announcement last week that Galt and Ray "were one and the same person," an FBI agent said.

Re memo of SA J. RICHARD NICHOLS, 4/20/68.

On 4/20/68, SA's RALPH D. PERRIGO and DONALD E. REILLY interviewed BONNIE SPARZA, who was employed as a waitress at Dal's Hamburger Stand on the corner of 13th and Wisconsin Avenue, concerning information of re memo. Mrs. SPARZA stated she did not recall incidents reported in re memo nor did she recall seeing anyone resembling JAMES EARL RAY. Photographs of RAY were displayed to Mrs. SPARZA; however, she stated she still could not recall this man being in her establishment.

On 4/23/68, SANDRA PEKRUN, 1727 West Kilbourn, and ALICE HOLMES, the proprietors of Dal's Hamburger Stand, were both interviewed at the Hamburger Stand and advised that the photograph of JAMES EARL RAY appeared familiar to them, and that a man resembling RAY had been in the restaurant several times within the last year. They stated they could not say when this man was last seen. They stated he had a crewcut the last time they recalled seeing him, and the only picture of RAY he resembled was the one at the Missouri Penitentiary in 1960 when RAY had a crewcut. HOLMES and PEKRUN were asked to immediately notify the Milwaukee Office of the FBI should this man return to their establishment, which they agreed to do.

No further investigation is being conducted in this matter.

On 4/22/68, at approximately 5 p.m., Detective DANIEL SCHRAMM, Menomonee Falls, Wisconsin, Police Department, telephonically contacted the Milwaukee Office of the FBI and furnished the following information:

He stated that on that date he received a call from his mother, EVELYN SCHRAMM, who is the operator of Schramm's Tavern, W164N9067 Water Street, Menomonee Falls. She stated that some of her customers had told her that one of her roomers looks very similar to the person being sought for the murder of MARTIN LUTHER KING. She stated he moved in about a week ago and used the name JOHN BECKWITH. She further advised he is unemployed and has told her he works as a welder, long distance trucker, and construction worker. He also told her he comes from Appleton, Wisconsin. She described BECKWITH as a white male, 5'11" to 6', 35-40 years old, 170 lbs., with medium length hair, graying at the temples. BECKWITH was driving a 1964 white, two-door bearing 1968 Wisconsin Plates E30134. Detective SCHRAMM said he checked his plates and determined they are listed to a JOHN BECKWITH of 630 Elm Street, Waupaca, Wisconsin. SCHRAMM further advised he contacted the Waupaca Sheriff's Office on the same date where he learned that JOHN DAVID BECKWITH, date of birth [redacted] has lived in that area for many years, has no record, but is considered very odd. He stated he further contacted the Appleton Police Department where he determined the only record they have of JOHN BECKWITH is an attempted suicide on 2/23/64.

In view of the above information, the writer does not consider further investigation warranted in this matter as it is felt BECKWITH has been adequately eliminated by Detective SCHRAMM.

She stated that the incidents recorded in re memo appear to have concerned a close friend of hers by the name of WILLIAM HUGHES. She stated that HUGHES formerly worked for her and is presently employed nights by the Randolph Hotel at Fourth and Wisconsin. She stated that HUGHES has been coming to dinner at her home every evening, and she has, on occasion, lent him the key to the front door of her apartment building. She stated that no other man has visited her home in the last few months other than WILLIAM HUGHES.

On the same date, WILLIAM HUGHES, 755 North 25th Street, was contacted by the same Agents and was immediately eliminated for consideration in this matter by his physical appearance.

Recontact with LESTER BLIFFERT, Apartment 101, 505 North 26th Street, determined that BLIFFERT was not absolutely sure that he had seen two different people at the LARSON residence. He stated that he had seen the face of only one of the men and therefore, could not be sure that the two individuals he saw at separate times were not one and the same person.

No further investigation is contemplated in this matter.

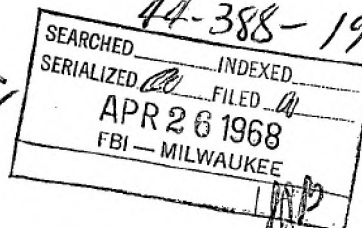

I talked to him and he advised he had the woman in his office to whom SA WILLIAM DORAN had talked at the ~~Antlers~~ Hotel on the previous day. He requested an Agent to talk to DYRELL DENISS. He was advised that we were not planning to talk to her again as she had given her information previously. He stated she wanted to talk to an Agent.

I talked to a woman identifying herself as DYRELL DENISS and she advised she simply wanted to establish a place to live in Milwaukee as her 17-year-old son was here. She requested that the newspapers be advised to stop bothering her. I specifically advised her that the FBI did not have any control over what the newspapers did. She again requested that they be told we didn't have any further reason to talk to her.

Mr. LUBINOW again got on the phone and asked if we were going to talk to her. He was advised we had already talked to her and Mr. LEAVITT had already stated the FBI's position in the matter. He stated he would call Mr. LEAVITT again and hung up.

At 12:30 p.m., 4/26/68, TOM LUEBENOW, Milwaukee JOURNAL newspaper reporter, was telephonically contacted at his office. LUEBENOW stated he had certain information concerning the assassination of KING and wanted to know "what's in it for me" if such information were furnished to the FBI. LUEBENOW was advised that the FBI had no comment on the KING case but if he had information to furnish to the FBI, we would be willing to accept such information. LUEBENOW stated that since that is the attitude of the FBI there is a waitress whose last name is ELLER working in the Royal Hotel, 5th and Michigan Streets, who has some information pertinent to the KING case.

Investigation conducted by the writer identified ELLERS as Mrs. HERBERT (LOIS) EHELER, 3236 West National Avenue, telephone No. 383-5967. Mrs. EHELER is employed as a waitress at the Royal Hotel Coffee Shop.

On 4/26/68, Mrs. EHELER furnished the following information:

She stated that a couple of days ago, she was speaking with MARY ANN WICKS, the switchboard operator of the Royal Hotel and that she mentioned to WICK that she recalled a customer in the coffee shop during March that resembled the wanted poster of RAY that she had seen published in the Milwaukee JOURNAL. She stated that WICK told her that if she thought this was the man who killed KING, she should furnish such information to the FBI.

She stated that she told her husband about this and he told her to forget it since she undoubtedly sees many a bum at the Royal Hotel that may or may not be wanted by the FBI. Mrs. EHELER further stated that WICK told DAVE LEUSKI, the hotel manager, who in turn telephoned this information to the Milwaukee JOURNAL.

She said as a result of this she has been pestered by a reporter named TOM (LNU) who came to the coffee shop shortly after she arrived at 2:00 p.m. and told her he was putting her name in the newspaper.

Mrs. EHELER stated that the man whom she felt resembled the wanted poster of RAY was a guest at the hotel on March 26 - 28, 1968. She described him as a white male, 35 years of age, 5' 8", 175 pounds, dish-water blond hair worn long and bushy. She stated this individual was dressed in clean work clothes which she described as faded denim. Subject had a southern accent and always visited the coffee shop alone. She said even though he ordered substantial meals at the coffee shop, he never ate after being served the food and had complained to Mrs. EHELER that he was broke. She stated that one time he told her he was in Milwaukee looking for a job and that he was originally from Chicago.

On 4/26/68, MARY ANN WICK, switchboard operator of the Royal Hotel, stated that to the best of her knowledge, RAY has never been in the Royal Hotel.

Based upon the above information, no further investigation is being conducted at the Royal Hotel concerning the individual observed by Mrs. EHELER.

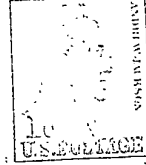
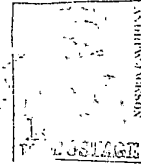

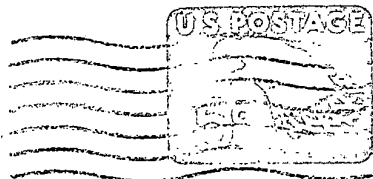
