

said she was extremely reluctant to discuss the above information with anyone and had almost decided to forget about it because of the possible consequences of divulging this information. advised that as mentioned previously, she did not hear the entire conversation, but received the distinct impression that the individual calling from Union Grove, Wisconsin, was referring to JAMES EARL RAY. She said he was very excited during the conversation and mentioned several times he needed a lot of money to get out of the country and reiterated several times that he would talk unless he received it. She said the individual in North Carolina spoke very quietly and did not say very much, only acknowledging with a "Ya" or a gutteral sound.

advised that after the call, the individual flashed her back to obtain the charges and ashed her at that time, "Operator, would you tell me one thing? Just why do operators have to listen in on conversations/" To this remark said she did not know what he was talking about and asked him if he wished to speak to her supervisor. She said it was impossible for this individual to know if she had listened in on the conversation. She also recalled that during his conversation with the man in North Carolina, he mentioned that he did not want to talk too much because of nosey operators.

described the caller as a white male with an intelligent sounding voice, speaking with a southern accent. She guessed the individual would be in his late 30's or early 40's and stated he did not sound intoxicated or mentally unbalanced. She noted the individuals whom he talked to in North Carolina sounded like "hillbillies."

individual then told her it was a nonpublished number and requested that she recall the second number, 754-4930, in order to obtain RUBY ANDERSON's number. She called this number and, with the individual on the line, asked for RUBY ANDERSON's number. A male voice informed that he was not sure if he should give out the number, at which point the individual calling from Union Grove told the individual in North Carolina to furnish the operator with the number. The male in North Carolina said, "Hey ROBERT, is that you," at which the individual replied, "Yes." The male in North Carolina then said, "I don't know if (uncle?) wants me to give out that number." The operator said thanks at this point and disconnected, but the individual told her he wanted her to call back and insisted she obtain the number. called back and spoke to the same individual and after some discussion obtained a number, which she subsequently called, but which was a wrong number.

She advised the individual in Union Grove of the fact she was unable to obtain the number, but he again insisted she call the previously mentioned individual for the number. She did this, but the individual in North Carolina hung up advising that he had given her the only number he had.

At the outset of the interview. requested the information furnished be kept in the strictest confidence as she was fearful of her life and her position with the telephone company should she become identified as the source of this information. She then furnished the following information:

On 6/11/68, she was working as a long-distance operator for the , and received a call from Union Grove, Wisconsin, to place a long-distance call. The caller, whom she believed was a white male with a southern accent, told her he wished to call number 704-758-2908. She placed a call for the individual and he talked less than three minutes, after which he flashed her back to obtain the charges. The individual paid 95 cents, which was 5 cents too much, and was that he did so. The individual then told told by her to credit it to him because he was going to place several noted that she initially dialed the more calls. ( above number wrong and the individual made several funny remarks concerning the fact that she had probably been out late the night before.)



United States officials, headed by Asst. Atty. Gen. Fred M. Vinson, jr., chief of the justice department's criminal division, beat their self-imposed deadline for handing in the petition by one day.

But parts of the petition, which was at least an inch thick when it was handed in to the foregin office by United States Consul General Jack Herfurt, apparently had been readied in advance of Ray's arrest last Saturday at London airport as he tried to board a plane for Brussels.

The petition contained a summary of some of the evidence against Ray in King's murder at a Memphis motel Apr. 4. It also contained information on his escape from the Missouri state prison. while serving an armed robbery charge.

The United States government is seeking extradition on both counts and must satisfy a British judge that both would also be crimes under British as well as United States law.

The petition also contains fingerprints and other material to identify Ray as the man ngw being held under guard in London's Wandsworth prisen. Officially he is being held here as Ramon George Sneyd, triveling under a Canadian passment issued in that name and darged with passport oftenses as well as carrying a waded gun.

Galt said he was in the Memphis area two years ago and that he traveled regularly to Florida for skin diving in the summer.

Ray, however, was in the Missouri state prison until he escaped in April, 1967 with more than 12 years remaining of a 20 year sentence.

Canadian police also were searching for three persons who allegedly were connected with Ray while he was in Toronto.

The three are a fat man who came to one of Ray's rooming houses with an envelope for Ray; a husky, fair haired man with whom Ray drank beer several times in a sleazy tavern, and a woman who, one source said, applied for one of Ray's phony birth certificates and said she was his aunt.

# Ray in Tighter Prison; Slaying Writ Names Him Lisbon earlier. board of education, and Ray

London, England - James Earl Ray, the escaped convict accused of slaying the Rev. Martin Luther King, jr., was transferred under police guard Tuesday to Wandsworth prison where security has been tightened since one of Brita in's "great train robbers" went over the walls four years ago.

Wandsworth is considered a safer place for Ray than Brixton prison where the suspect had been held since his arrest Saturday.

American authorities Monday took the first formal step toward extradition of Ray by obtaining a provisional British warrant charging him with the murder of King.

Tuesday, Gov. Buford Ellington signed "all necessary papers" required for Tennessee's formal request that Ray beareturned from London to Memphis to stand trial for my der in the Apr. 4 super sla ing.

#### Substitute Unlikely

Some legal experts suggested that the British government might speed up the process by deporting Ray as an undesirable alien, But other lawyers said there was a strong tradition against using this procedure as a substitute for extradition.

Ray, 40, made a two minute appearance Monday in Bow Street court on charges of carrying a forged passport and a loaded gun, the charges on which he was arrested at London airport Saturday under the name of Ramon George Sneyd.

There was still some mystery about Ray's earlier movements. London airport officials first said he had been arrested upon flying in from Lis-bod. Later they said he was outward bound for Brussets.

#### Aliases Pose Mystery

RCMP sources note that Ray used the loopholes known to espionage agents and other underworld figures to enter and leave the country. Ray had money. He had also been in Canada a year ago. He lived in Montreal for a while last July, signing an apartment lease under the alias of Eric S. Galt, a name he also used in Los Angeles.

The real Galt, Eric St. Vincent Galt, is a warehouse foreman in Toronto.

One mystery confronting the police is how it happened that the three men whose mes Ray used as aliases all within a few blocks e ch other. They are Gal Paul Bridgman, a consultar teacher with the Toronto

board of education, and Ray mond George Sneyd, a con-stable of the Toronto po ce

Ramon George Sneyd.

All three men - Galt. Bridgman and Sneyd - bear Ray thad lived in Toronto certain resemblances to Ray, for a nonth before flying to police say. All have dark hair as does Ray. They are about Ray's height — 5 feet 10 inches. Ray is reported to weigh 174 pounds, Galt weighs 172 and Bridgman 190.

#### Have Similar Scars

Ray first was sought under (RCMP) spokesman. He noted the name Eric Starvo Galt. Eric St. Vincent Galt has a signature which looks like Eric Starvo Galt. He uses the middle initials St. V., but with small zeros instead of periods.

Galt and Ray have similar scars, in the middle of the forehead and on the palm of the right hand.

"I don't know what to think," Galt said. "It's a bit more than coincidence. The weight is right, the height range is right and the identification marks are there.

"I've wondered where bur piths might have crossed, but I ust don't know."

Galt said he was relieved that Ray had been arrested.

Gh. Fred M. Vinson, ir., is expected to make formal application to Britain's home secretary for extradition as soon as he receives the necessary documentation from the United States

The home secretary, James Callaghan, will forward the application to the chief magistrate at Bow Street court who will consider whether the documentary evidence submitted by Vinson would be substantial for extradition. The application is expected to reach the court on Tuesday.

Ray will then have 15 days to apply for a writ of habeas corpus.

Under British law and the 1935 treaty of extradition between Britain and the United States, the home secretary cannot surrender Ray to United States authorities before 15 days have passed.

Security measures so tight that even lawyers submitted to frisking, were in effect when Ray was brought into court Monday. No one except the police and legal officers had seen Ray since his arrest Saturday when he tired to board a plane for Brussels.

#### False Passport

Under the name Sneyd, Ray was charged with using a false passport with that name and carrying an unlicensed, loaded gun. There was no mention in court of the name Ray or of the American charges against him.

Ray is sought on an American federal warrant chirging that he took part in a conspiracy to deprive King of he civil rights. He is also charged by a mennessee court with first degree murder in the slaying of King in Memphis Apr. 14.

My's identity was unc vered after Canadian authorities spent a month searching through as many as 400,000

passport photos. The word was passed to the FBI and to authorities in Europe.

In Lisbon May 8

Riv arrived in Lisbon Portugal, on May 8. He stayed in the Hotel Portugal until May 17, paying just over \$2 a day for his room on the first floor. Staff members at the hotel recall that he was generally out of his room 15 or 16 hours a day.

# British Grant Kay a S Pressing for Extradition

Earl Ray made a two minute appearance in Bow Street court Monday. London's chief magistrate ordered the accused killer of the Rev. Martin ther king, jr., held without bail for another court appearance June 18.

While United States officials swiftly gathered documents to present a formal request Wednesday or Thursday for Ray's extradition to the United States, both American and British officials declared a news blackout on the enigma of the much traveled fugitive.

Ray's arrest at London airport Saturday came about through the co-operation of the federal bureau of investigation, the royal Canadian mounted police, Scotland Yard and authorities in Portugal.

The project that put police on Ray's trail was initiated by the FBI in Washington shortly after King's slaying in Memphis, Tenn., on Apr. 4.

#### Search Begun Apr. 5

It involved going through every photo of every passport issued since Apr. 5.

The FBI had no luck on its efforts. But since it was known that Ray once visited Canada, the FBI asked Canadian officials to institute a similar search.

Early last month, a Canadian passport form bearing Ray's photograph, but under the name Ramon George Sneyd was turned up. The hunt focused on Toronto.

Police there had no trouble locating the real Sneyd. He is a 35 year old metropolitan policeman who spells his first name Raymond instead of Ramon. He knew nothing about any passport application.

#### Month Spent in Canada

Police discovered that Ray had lived in Toronto for a month, after arriving in the city Apr. 8.

The following day, he turned in the return half of his ticket and obtained a flight to Lisbon, Portugal, instead. He is believed to have left for Portugal the same day.

In Lisbon he obtained a second Canadian passport from the Canadian embassy on May 16. He then dropped out of sight.

After the fraudulent passport was uncovered a few days ago, Pontuguese and litish immigration officials, police and airline personnel were instructed to be on the lookout for a person using the Ganadian passport under the name of Sneyd.

Authorities spotted him promptly. While his passport was being examined, he was searched and a loaded pistol was found in a hip pocket.

#### Complaints to Canada

There have been past complaints to the Canadian government that foreigners have been able to obtain Canadian passports too easily.

A person applying for a Canadian passport must have someone, usually a professional man, sign a declaration that he has known him for two years, or else the applicant must swear an affidavit before a notary public.

Miss Lillian Spencer, the office manager of the travel firm, said the man identified as Ray told her that he had been born in Toronto, had moved away and then had returned. She said he told her that he did not have a birth certificate and that, as a recent returnee, he could not find a guarantor who would vouch for having known him two years.

They stated that ROBERT had traveled extensively over the U. S. and the family never knew where he was or when he would next appear in Caldwell Co., N. ### Ray Counsel Von't Fight Extradition

Atlanta, Ga. -AP- The attorney who tentatively has agreed to defend James Earl Ray says he does not plan to fight extradition — which would return the accused assassin of the Rev. Martin Luther King to this country.

Arthur J. Hanes, former FBI agent and former mayor of Birmingham, Ala., made the comment here as he boarded a plaen for Washington Tuesday to check on passport arrangements for his trip to England, where Ray is being held.

Hanes was asked if he planned to request a change of venue once Ray was returned to Memphis for trial.

"No sir, I will not," Hanes said. "I feel that the people of Memphis and the people of Tennessee are fair minded and just — like most Americans."

Hanes said he had no personal knowledge of the prisoner.

"I've never heard of Ray, and I've never heard of any of the aliases used," he said. "This man, whoever he may be is unknown to me. I don't know who's in jail in London, and I'm not so sure that a wbd ly in this country knows as of now."

# **British Court Sets June 27** For Ray Extradition Case

Los Angeles Times Special extradition proceedings against James Earl Ray, accused in the slaving of the Rev. Martin Luther King, jr., were set for June 27 by a British court Tuesday in a preliminary hearing.

The only unexpected event during the brief, 10 minute session in Bow Street magistrates court was a denial by Ray's defense counsel, "on behalf of my client," of a British newspaper headline that said Ray had been "interviewed" by a United States official.

The denial does nothing for Ray's case. If anything, it helps the case against him for he might have tried to claim improper interference in British law by a foreign official if it were true.

So the incident was surprising and even puzzling. A possible explanation was that Ray, who gets newspapers in prison, wanted it known that he had not been "talking."

#### **Does Not Speak**

The 40 year old prisoner appeared in court under the same heavy police guard as on his first hearing June 10.

He did not speak at any point and showed no emotion when the British lawyer representing the United States, Nigel Graham Maw, read the two extradition counts. The first said:

"James Earl Ray, hereinafter called the defendant, suspected and accused of the commission of the crime of murcir, to wit, on Apr. 4, 1968 in Shelby county, state feloniously, willfully, deliber-complain of the headline (but ately, premeditatedly and of not the story) in the London

London, England - Formal and murder Martin Luther King, jr. within the jurisdiction of the United States."

> The second count dealt with robbery with violence and a deadly weapon in 1960 for which Ray was sentenced to 20 years. He is wanted for escaping from a Missouri prison last year.

#### **British Case Told**

Chief Magistrate Frank Milton dealt initially with the British case of passport and gun violation charges against the prisoner who is charged here in the name of Ramon George Sneyd. Ray was arrested on those charges June 8 at London airport as he sought to board a plane for Brussels. Two days later he was remanded in custody until Tuesday.

The magistrate continued the remand until June 27, and he agreed with the prosecution request that extradition Presumably, there will be no further action on the British charges, except for keeping Ray in custody on them until completion of the American

Extradition was then taken up while Ray, between escorts, continued to stand facing the magistrate. A human wall of nine plainclothes officers stood behind him facing the audience of 50 correspondents and 25 in the public gallery, all of whom had been searched before they were ad-

The United States authorities must establish, to the satisfaction of the chief magistrate, that there is prima facie (self-evident) evidence that Ray murdered King. Mere suspicion that the escaped felon committed the assassination is not enough.

However, there is an alternative to extradition under the 1870 act. This is the device of "disguised extradition."

It means using the powers given to the home secretary to deport any alien. A deportation order that expressly required an alien to leave Britain and go to the United States would be illegal. But there may be a way of getting around this.

In 1917 it was held lawful for the home secretary to bequire an alien to leave Britian on a particular ship or plane, even if the sole object was to give effect to a request from a

#### Could Agree to Return

Ray could uncomplicate the issue by agreeing to return voluntarily to the United States. Wandsworth prison, where he is now held, is probably grimmer than most American jails. But the comparative comforts of the jails are hardly likely to induce him to return home and face trial for murder.

The formal hearing on the extradition warrants would normally be set in a week or 10 days, but Ray's court appointed counsel could request another week to study the evidence submitted by the United States.

Then, if extradition is ordered, Ray will have 15 days to appeal.

Asked by his counsel, "Did you kill Dr. Martin Luther King?" Ray replied quickly and in a matter of fact tone: "No, sir."

The British counsel for Ray, Roger Frisby, announced his plan to save Ray from extradition: He will contend that the assassination of King was a political crime.

#### **Political Crimes Excluded**

"The whole burden of my case is that Dr. King is a political figure," Frisby told the court. The extradition age must be tween the United States and Britain does not cover political crimes.
