If you decide to answer questions now without a lawyer present, you will still have the right to stop answering at any time. You also have the right to stop answering at any time until you talk to a lawyer.

I understand and know what I am doing. No promises or threats have been made to me and no pressure or coercion of any kind has been used against me.
