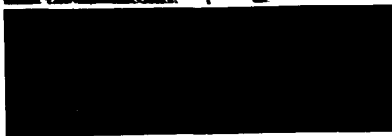

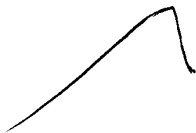

On 4/22/68, ROBINA DEANS, Marking Machine Operator, Naval Air Station Laundry, Bldg V-57, NF NAS advised the code number 20R-3 could not have come from any of the three Textile Marking Machines on the premises. She advised the codes used in that laundry never include a dash in any part of the code. She also advised the three machines always print <sup>the</sup> ~~in~~ <sub>entire</sub> code in large type only.

Deans explained the code used by the NAS Laundry is as follows:

- (a) Color of tape distinguishes one lot from another
- (b) One lot = 40 bundles
- (c) The first number or numbers in the code designates the # of the lot
- (d) The letter designates the week # of the year.
- (e) The last number or numbers designate the bundle # in the lot. (never higher than 40).

He was shown a photograph of a T-shirt and pair of shorts bearing the marking 02B-6 and stated that the machine that produced this marking is a much newer model than is used by his laundry. He stated he did not know any laundry which uses such a marking device.
