VOLUNTARY APPEARANCE; ADVICE OF RIGHTS
YOUR RIGHTS

Before we ask you any questions, you must understand your rights. You have the right to remain silent. Anything you say can be used against you in court. You have the right to talk to a lawyer for advice before we ask you any questions, and to have him with you during questioning. You have this right to the advice and presence of a lawyer even if you cannot afford to hire one. We have no way of giving you a lawyer, but one will be appointed for you, if you wish, if and when you go to court. If you wish to answer questions now without a lawyer present, you have the right to stop answering questions at any time. You also have the right to stop answering at any time until you talk to a lawyer.

WAIVER

I, Jack C. Nam have come to the New York Office of the Federal Bureau of Investigation (FBI) of my own choice to talk with Special Agents of the FBI about a crime which they are investigating. I know that I am not under arrest and that I can leave this office if I wish to do so.

Prior to any questioning, I was furnished the above statement of my rights at 3:55 P on 4/6/68 at La Guardia Airport

 by Special Agent James J. Reilly of the FBI. I have (read) (had read to me) this statement of my rights. I understand what my rights are. I am willing to answer questions and make a statement. Gentlemen:

I believe it to be of interest to you to know of a plan ~~apocals~~ to take Ray from the authorities upon his arrival in the U.S. The people involved have expressed themselves as being undaunted if he is surrounded by 100 Federal Marshals or F.B.I. personnel. They anticipate a large protective force but will not be stopped and expect to lose several in the attempt but there will be martyrs. They have anticipated his surprise return and have placed watchers at every conceivable airport including his forse landing areas.

Because of possible reprisals I must abstain from signing this note to you. I am deeply concerned and hope that no one is hurt.
