RACIAL MATTERS

At approx. 9:27pm this date an individual who wished to remain anonymous advised that he has reason to believe that ~~CHRISTIAN CAPPEL~~ aka CY is responsible for the murder of KING. He stated CAPPEL drives a cab for Four Way Cab Co. in the Bronx. in approx. 29 years of age.

The male caller stated CAPPEL owns two .30-06 caliber rifles; however he stated one of the guns is missing. In addition, he stated CAPPEL presently has \$15,000.00 secreted in a locker at Grand Central Station in NYC.

He stated he could give no further details at this time but would try to call back later. He stated he could not account for the whereabouts of CAPPEL during 4/4/68.

The caller concluded by saying that CAPPEL has a prior record with the FBI.

ROHER TOLD MTPD ARTISTS CONCEPTION IS PRECISE LIKENESS OF PAUL ADAM HARMON WHITE MALE THIRTY THREE FIVE FEET SEVEN INCHES ONE FIFTY POUNDS SLIGHT BUILD SANDY BLOND HAIR RECEDING AT TOP. HARMON ORIGINALLY FROM PENSACOLA FLA. LIVES IN APARTMENT TWO A SAME BUILDING AS ROHER AND SHARES APARTMENT WITH ONE KEITH ILES, WHITE MALE TWENTY THREE FIVE FEET TEN INCHES ONE SEVENTY LBS. MUSKY BUILD. HARMON AND ILES ARE SOCIAL WORKERS FOR DIFFERENT NYC AGENCIES. BOTH ARE HOMOSEXUALS WITH HARMON

THE AGGRESSOR. ILES CAME TO NYC FROM TALLAHASSEE FLORIDA.

ROHER STATED NEVER HEARD HARMON REFER TO KING NOR EXPRESS HATRED OF NEGROES BUT DESCRIBED HIM AS MORBIDLY INTERESTED IN MURDERS AND POSSIBLY PSYCHOTIC. ILES IS DESCRIBED AS HATING ALL NEGROES AND FEARFUL BECAUSE OF BEATINGS GIVEN HIM. ROHER TOLD MTPD HE ONCE SAW GRAY SUITCASE IN HARMON'S POSSESSION WHICH HARMON SAID HE HAD QUOTE USED WHEN IN JUVENILE COURT UNQUOTE. SUITCASE CONTAINED TWO PAIR HANDCUFFS PLUS BALL POINT TYPE PEN WHICH HARMON SAID WAS CAPABLE FIRING SOME TYPE BULLETS OR PROJECTILES. ROHER TOLD MTPD SUITCASE CONTAINED NO OTHER TYPE WEAPON.

ROHER IS PORTRAIT ARTIST AND FEELS HAIR LINE, NOSE AND JAW DETAIL IN ARTISTS CONCEPTION ARE REPLICAS OF HARMON'S.
