At 2:15 PM, 4/10/68, I telephonically contacted the Memphis Office and in the absence of the SAC and Inspector Sullivan, who were out to lunch, I talked to SA Joe Hester who is the case agent. In order to get a general rundown on this case, I asked SA Hester to give me a briefing on what had happened and there follows the narrative which he supplied:

As reported in the newspapers, the subject fired from a bathroom window, located at the rear of the rooming house where he had rented a room that day. He had a cardboard rifle box which was a Browning Box and which had been supplied to him by the gun shop in Birmingham from whom he had purchased the rifle. They had supplied him with a Browning box although the rifle was a Remington because the telescopic site which they had mounted for him prevented it going into the Remington box. According to Hester, the subject, after firing the shot, placed the rifle in this cardboard box, wrapped the box in a bedspread (which did not come from the rooming house and which he must have brought in with him), picked up a small suitcase in which he had a T shirt, undershorts, a pair of socks and toilet articles consisting of a toothbrush, some Bryll Hair Cream, a razor, some blades and a pair of binoculars. He then left the rooming house, which faced on the next street over from that where KING was staying.

According to Hester, there were a large number of police and sheriff's personnel in the area because of KING's presence and the shot from the back of the house attracted their attention to the street on which KING's motel was located. The Memphis Office believes that the subject on reaching the street, saw a large number of armed police officers on the move and fearing that what he carried might attract attention to him he discarded what he carried. As the subject passed

a small store with a recessed doorway he discarded what he was carrying and did so with such force that they hit the entrance to the store creating a considerable noise. This attracted the attention of the store owner and two Negro youths who were in the store. At this point they observed a white car pulling away from the curb rapidly with a screech of tires and this car has been described by both of the teenagers as a white Mustang.

Hester related that the Bureau has found latent fingerprints on the rifle and on the binoculars which match and they believe they must be fingertip impressions since the Bureau has indicated they can eliminate a suspect if they have his fingerprint card.

The rifle was purchased at a gunshop in Birmingham as we have been previously advised and the binoculars were bought in Memphis approximately 2 hours prior to the murder.

Memphis has checked all motels for any guests arriving in a white Mustang. One such individual so developed is ERIC STARVO GALT. The background thus far developed on him reflects he arrived in Birmingham in early September and left December 1. He paid \$1,995.00 cash for a white Mustang which he bought through a newspaper ad. He obtained a driver's license while in Birmingham, rented a safety deposit box but had no bank account at the bank and closely resembles the composite of the subject. He also furnished employment information that he was with the INGALLS (phonetic) SHIPBUILDING CO. in Pascagoula (phonetic) but a check at this shipyard was negative.

According to Hester, the lead on the laundry marks and underwear is still considered the very best lead the Bureau has at the present time.

Mr. ROBERT CONRAD, victim's attorney, 60 East 42nd Street, NYC, contacted the NYO and advised that the victim, who resides at 75 Willow Street, Brooklyn, NY, had received threatening telephone calls from her estranged husband from several Washington, D. C. hotels. Members of the victim's family have also received threatening telephone calls from the subject.

The subject and victim have been estranged since 3/8/68, when the victim assaulted by the subject. The victim, through her attorney, has filed for a divorce decree and has secured a warrant for the subject from Family Court, New York County.

This matter was discussed with AUSA STEPHEN E. KAUFMAN, SDNY, and he declined prosecution as it was his opinion that this matter could be better handled by the State Courts, where it currently is, and that this was

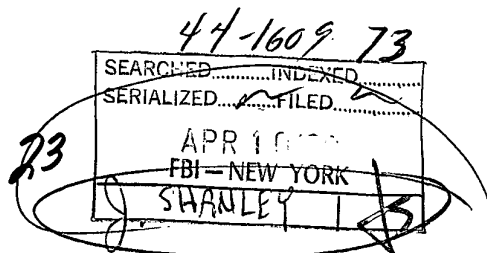

For the information of offices not previously advised, the following is set forth:

Search of premises believed occupied by Unsub who assassinated Dr. MARTIN LUTHER KING on 4/4/68, disclosed suitcase in which was located tee-shirt and undershorts bearing laundry mark on red tape with black lettering believed to be thermo-seal type, manufactured by Textile Marking Machine Co., Inc., Syracuse, N. Y. The tape is  $\frac{1}{4}$ " wide and  $1 \frac{1}{16}$ " long and bears letters and numbers 02B-6.

Experts at Textile Marking Machine Co. advise type on this machine is unusual in that the first two characters are 15 point type and the last three characters are 18 point type, with the middle character, the letter B, probably being narrow rather than regular type. The usual machine carries 15 point type for the first three characters and 18 point type for the last two characters.

Textile Marking Machine experts also stated this machine is defective in that it is producing a tape 1 1/16" long instead of 1 1/8" long and is not projecting the tape far enough resulting in cutting off a portion of the first letter. The code used in the Northeast part of the U. S. is as follows:

The first letter O stands for lot number; the first number 2 indicates the day of the week, two being Tuesday; the second letter indicates the first letter of the store name, this is the letter B; the last number is the bundle number, this is 6. Color coding of the tag may designate various things such as a different month or the identity of a store in a chain. Experts also state the use of this system on laundry items is unusual in that the system is normally used on garments being dry cleaned.

The Bureau has instructed that all textile machines using this type tape be located and machines using this code be identified.
