to 7 various officers as of yesterday,
Good Thursday, 11-th of April, 1968

Coon Amen,
Harlem, New York.

Good Friday 12-th of
April, 1968

"TO WHOM IT MAY CONCERN:

"Please pass on to all the authorities wherever possible - to discontinue the search of a white man, as the killer of Martin Lucifer King, because the smart killer is right now in his own family. He is one of his own Civil Rights Urinators and a negro, not a white. I was among them myself in 1965, there were many young nuts, such as was I, and also many whites. However, God opened my eyes in Alabama, when I witnessed the behavior of our marchers under King's leadership. He was a devil's minister, taking all the money he could from the jews, and was doing his work under their leadership and demand. Those were communist jews.

"While marching in Alabama in 1965-it was in spring-we were instructed by King's advisers-red-rat-jews to do the following:

"A group of our negroes forced their way into a nice restaurant; on a given signal, all the negroes grabbed the sugar bawls off the tables, stood up and urinated into them, amid laughter, replaced the bals on the tables-MLK laughed approvingly.

"This is the reason why I, and many others, turned against him, and it was God's will that he was shot by one of his own disciples, a negro, not a white. Please stop all your sham broadcastings and grateful homage for that killed Martin Lucifer King - he was against our best President LBJ - for the nut hippie Bobby Kennedy, who hates the President because he was not appointed as Vice Pres. when his brother JFK was murdered the same way as was MLK. Senate should prohibit all marches at least for the duration of this war, and specially in our Capital. Now the white people are to be more against us for the crazy revolts, murders and damages.

On 4/15/68, Chief of Police C. L. GUNN, Meridian, Mississippi, Police Department, made available a carbon copy of a typed letter dated 4/12/68, and signed "COON AMEN". He stated that he received this letter at the Meridian PD on this date and is the only person who handled it. He added that he has no idea who sent this letter, that he knows no one in New York City, and was making it available for whatever assistance it might be in this investigation. He added that the letter and the envelope is all the information he has concerning this matter.

"I am mailing the Police drawing of suspected killer of Dr.K. which appeared on page 2 in yesterday's Daily News, as a white man, who actually is a negro, but a brown one, made white with cream etc. - however, I made it with a crayon darker so they may find him in Atlanta in the King's family.

"You must understand that I cannot reveal my real name and address, although I actually do live in Harlen. Please do not hesitate to use my information, because it is God's truth.

"I am mailing 7 Of these letters to various places - why 7? Because yesterday was Good Thursday, the last supper of Jesus Christ, as a reminder of HIS seven words on the Cross:

'Into Your Hands I command my soul!'

"May your Easter be blessed!

"Sincerely,

"Coon Amen, 23 years old"

The Identification Division is requested to process this letter for latent fingerprints and compare any prints located with prints developed in this investigation. Any prints developed should be compared with those contained in the single fingerprint section.

Enclosed for Memphis is a copy of New York letter to Bureau, dated 4/12/68, which states that three (3) rolls of film taken by Columbia Broadcasting System (CBS), Staff Cameraman REGGIE SMITH at Spelman College of the funeral of Dr. MARTIN LUTHER KING were obtained from ROBERT ROCKS of CBS and forwarded to the Bureau.

On 4/16/68, the film was returned to ROCKS and a receipt obtained.

ROCKS stated that the film was loaned to the FBI to be reproduced but not to be made available to CBS competition or other news media and that if the film is needed for court then a subpoena duces tecum would have to be issued.

The film was duplicated and copies kept at the Bureau.

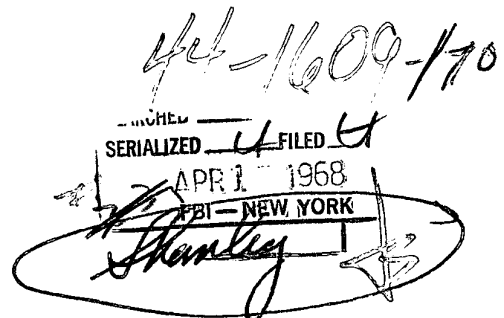

ATTORNEY GENERAL RAMSEY CLARK ANNOUNCED TODAY THAT ERIC STARVO GALT IS BEING SOUGHT BY THE FBI AS A FUGITIVE ON A FEDERAL CHARGE ARISING FROM THE FATAL SHOOTING OF THE REVEREND DR. MARTIN LUTHER KING, JR., IN MEMPHIS, TENNESSEE, ON APRIL 4, 1968.

DIRECTOR J. EDGAR HOOVER STATED THAT A FEDERAL COMPLAINT WAS FILED BY THE FBI IN BIRMINGHAM, ALABAMA, TODAY CHARGING GALT WITH CONSPIRING TO VIOLATE THE CIVIL RIGHTS OF DR. KING IN VIOLATION OF TITLE 18, SECTION 241, OF THE UNITED STATES CODE.

THE FBI COMPLAINT CHARGES THAT "ON OR ABOUT MARCH 29, 1968, AT BIRMINGHAM, ALABAMA,...ERIC STARVO GALT AND AN INDIVIDUAL WHOM HE ALLEGED TO BE HIS BROTHER, ENTERED INTO A CONSPIRACY WHICH CONTINUED UNTIL ON OR ABOUT APRIL 5, 1968, TO INJURE, OPPRESS, THREATEN, OR INTIMIDATE MARTIN LUTHER KING, JR.,...IN THE FREE EXERCISE OR ENJOYMENT OF A RIGHT SECURED TO HIM BY THE CONSTITUTION OR LAWS OF THE UNITED STATES; NAMELY, THE RIGHT TO FREELY TRAVEL FROM STATE TO STATE. IN FURTHERANCE OF THIS CONSPIRACY, ERIC STARVO GALT DID, ON OR ABOUT MARCH 30, 1968, PURCHASE A RIFLE AT BIRMINGHAM, ALABAMA...."

PAGE THREE

ACCORDING TO MR. HOOVER, A 30.06 RIFLE EQUIPPED WITH A TELESCOPIC SIGHT WAS FOUND NEAR A ROOMING HOUSE ON SOUTH MAIN STREET IN MEMPHIS IMMEDIATELY AFTER THE FATAL SHOOTING OF DR. KING OCCURRED. THE ROOMING HOUSE OVERLOOKS THE LORRAINE HOTEL AND MOTEL WHERE DR. KING WAS STAYING.

MR. HOOVER SAID THAT FBI AGENTS DETERMINED THAT THE 30.06 RIFLE HAD BEEN PURCHASED FROM A GUN DEALER IN BIRMINGHAM, ALABAMA, ON MARCH 30, 1968. THE TELESCOPIC SIGHT ALSO WAS PURCHASED FROM THIS DEALER.

THE FBI DIRECTOR SAID THAT GALT, WHO HAS USED THE NAMES OF JOHN WILLARD AND HARVEY LOWMYER IN THE PAST, IS THE OWNER OF A 1966 WHITE MUSTANG BEARING ALABAMA LICENSE PLATES WHICH WAS LOCATED ABANDONED IN ATLANTA, GEORGIA, ON APRIL 11, 1968. INVESTIGATION DISCLOSED THAT GALT PURCHASED THIS CAR FROM A PRIVATE CITIZEN IN BIRMINGHAM ON AUGUST 30, 1967. THE MUSTANG'S ODOMETER SHOWED THAT IT HAD BEEN DRIVEN MORE THAN 19,000 MILES BETWEEN LATE AUGUST, 1967, AND EARLY APRIL, 1968.

PAGE FOUR

ACCORDING TO MR. HOOVER, GALT'S TRAVELS IN THE MUSTANG INCLUDED TRIPS TO LOS ANGELES, CALIFORNIA; NEW ORLEANS, LOUISIANA; BIRMINGHAM, ALABAMA; AND MEXICO, AS WELL AS TO MEMPHIS, TENNESSEE, AND ATLANTA, GEORGIA. GALT WAS REPORTED TO HAVE BEEN IN MEMPHIS ON APRIL 3 AND 4, 1968, AND TO HAVE DEPARTED FROM THERE FOR ATLANTA.

INTENSIVE INVESTIGATION BY THE FBI HAS DISCLOSED THAT GALT HAS CLAIMED TO HAVE BEEN EMPLOYED AS A COOK ON MISSISSIPPI RIVER VESSELS AND AS A MERCHANT SEAMAN. HE IS SAID TO BE AN AVID DANCER AND TOOK DANCING LESSONS IN NEW ORLEANS IN 1964 AND 1965; IN BIRMINGHAM DURING SEPTEMBER AND OCTOBER, 1967; AND IN LONG BEACH, CALIFORNIA, FROM DECEMBER, 1967, TO FEBRUARY, 1968.

GALT LEFT LOS ANGELES ON DECEMBER 15, 1967, AND DROVE HIS WHITE MUSTANG TO NEW ORELANS, WHERE HE CLAIMED HE CONTACTED EITHER AN ENGINEERING OR A CONTRACTING FIRM. HE LEFT NEW ORLEANS ON DECEMBER 19TH AND ARRIVED BACK IN LOS ANGELES ON DECEMBER 21, 1967.

WHILE IN THE LOS ANGELES AREA EARLY THIS YEAR, GALT TOOK A COURSE AT A SCHOOL OF BARTENDING AND WAS GRADUATED ON MARCH 2, 1968.

THE FUGITIVE IS DESCRIBED AS A WHITE MALE. HE IS APPROXIMATELY 5 FEET 8 INCHES TO 5 FEET 11 INCHES TALL AND WEIGHS BETWEEN 160 AND 175 POUNDS. HE IS SAID TO BE A NEAT DRESSER AND HAS A MEDIUM BUILD.

PAGE FIVE

GALT HAS BROWN HAIR, WHICH HE WEARS IN A "BRUSH" CUT. HE REPORTEDLY HAS BLUE EYES; HIS NOSE IS STRAIGHT AND NARROW; HIS TEETH ARE STRAIGHT AND CLEAN; AND HE HAS GIVEN HIS DATE OF BIRTH AS JULY 20, 1931.

THE FUGITIVE IS SAID TO HAVE A NERVOUS HABIT OF OCCASIONALLY PULLING AT AN EAR LOBE WITH HIS HAND. HIS LEFT EAR PROTRUDES FARTHER FROM HIS HEAD THAN HIS RIGHT EAR.

ACCORDING TO MR. HOOVER, PERSONS WHO HAVE MET GALT DESCRIBE HIM AS A "LONER" AND STATE HIS LANGUAGE AND ^{DICTION}~~DICTATION~~ HAVE A "RURAL" QUALITY AND SUGGEST THAT HE PROBABLY DOES NOT HAVE A HIGH DEGREE OF EDUCATION. HE IS SAID TO DRINK ALCOHOLIC BEVERAGES AND HAS A PREFERENCE FOR VODKA AND BEER. HE IS A FAN OF WESTERN AND COUNTRY MUSIC.

KING CASE AGAINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FOR WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI'S IDENTIFICATION DIVISION LED TO THE DETERMINATION THAT GALT AND RAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI STATE PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967. HE HAD BEEN RECEIVED AT THAT INSTITUTION ON MARCH 17, 1960, TO SERVE A 20-YEAR SENTENCE FOLLOWING CONVICTION IN ST. LOUIS FOR ARMED ROBBERY AND FOR OPERATING A MOTOR VEHICLE WITHOUT PERMISSION OF THE OWNER.

HE HAS SERVED TERMS IN THE LOS ANGELES COUNTY JAIL IN 1949; IN STATE PRISONS AT JOLIET AND PONTIAC, ILLINOIS, IN 1952-54; AND IN THE FEDERAL PENITENTIARY AT LEAVENWORTH, KANSAS, IN 1955-58.

RAY WAS AN ENLISTED MAN IN THE UNITED STATES ARMY FROM FEBRUARY, 1946, TO DECEMBER, 1948, AT WHICH TIME HE WAS GIVEN A GENERAL DISCHARGE DUE TO INEPTNESS AND LACK OF ADAPTABILITY FOR MILITARY SERVICE.
