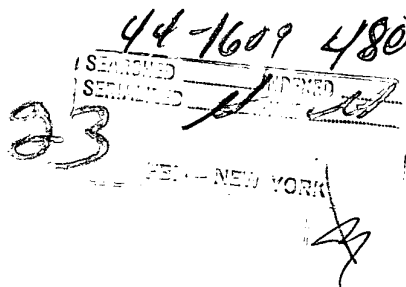
On 5/2/68, at 3:30 PM, Inspector CARL JOHNSON, Seaport Section, INS, 20 West Broadway, telephone number 264-5886, telephonically advised that he had a call from a Mr. ALIANI of "Air Canada" JFK to the affect that he, ALIANI, had received a telegram from "Air Canada" agency in Port of Spain, Trinidad, that a person named GALT had made a reservation on "Air Canada" flight number ~~679~~ ⁷⁸⁹ from JFK to Toronto on 5/3/68 at 5:40 PM. The message did not indicate whether the passenger was male or female. There was no description furnished, no age given, no address given and there was no indication given as to how the passenger would travel from the Port of Spain to NYC.

Mr. JOHNSON said that the above information was given by him to ED KNORTZ, INS, JFK, telephone number 264-5818 and to BARNEY TRIFF, an INS Investigator at the New York Office of INS, telephone number 264-5922. The above information was given to SA JOHN SHANLEY of Section 23.

Mr Johnson said that Mr. Aliani can be reached at tel. #935-2318. Johnson did not know where this # was located.
