Mrs. LEE MABER, Office Manager, Dale Carnegie and Associates, Inc., International Exporters, 1475 Franklin Ave., Garden City, NY, advised that above organization has 74 domestic and 20 overseas franchises. Each franchise covers a designated area and each franchise holder has agreements with as many sponsors as he desires. Sponsors are promoters who establish and promote the schools and arrange for lecturers. The sponsors submit rosters of students to the franchise holder, who in turn submits copies of student rosters to international office.

Mrs. MABER stated that students throughout the US and overseas amount to over 90,000 per year. Student rosters submitted to international office are not alphabetized and to cover pertinent period, approximately 140,000 names would have to be checked to determine if subject, under true name or aliases, had been enrolled. It is estimated that it would take approximately 15 agent days work to check aforementioned records.

ANDERSON was issued Card #2207-1386-1DC. ANDERSON reported this card was lost by teletype to DC dated 3/30/68.

DC issued a duplicate credit card to ANDERSON with same number except that the final series of numbers and letters (1DC) has an additional lower case letter d under the numeral 1 in this series which indicates that this is a duplicate credit card. If a charge is received by DC without the lower case letter d under the figure 1 in the final series, DC will not pay this charge. To date no such charge has been received.
