William Bradford Hule has written a third article for "Look" magazine. The article appears in the issue dated April 15, 1969, but this issue was circulated on April 1, 1969. A review of the article reveals that James Earl Ray allegedly registered at the Travelodge Motel, Five Points, Birmingham, Alabama, on March 29, 1968; at a motel near Florence, Alabama, on April 1, 1968; and at a motel near Corinth, Mississippi, on April 2, 1968. It is to be noted that Ray, using the name Harvey Lowmyer, negotiated the purchase of a rifle at the Aeromarine Supply Company, Birmingham, Alabama, on March 29 and 50, 1968. Cn April 3, 1968, he was registered at the Rebel Motel in Memphis, Tennessee.

In an effort to establish whether or not Ray was in contact with any individuals immediately prior to the assassination, appropriate investigation should be conducted by the Birmingham and Jackson Offices. It should be understood that there is to be no indication made whatsoever that the following investigation has any connection whatsoever with the case involving James Earl Ray.

Birmingham and Jackson Cffices should make inquiries of the motels in or near the cities indicated above to determine the identities of individuals registered during the period March 29 to April 3, 1968. Efforts should be made to identify all individuals listed, as well as

obtaining descriptions and registrations for the automobiles of such persons. A review of such records might indicate whether any one individual might have accompanied Ray or been in contact with him during this period. Pertinent or questionable registration records should be obtained if possible for examination by the FBI Laboratory.

Memphis should insure that the Bureau is kept currently advised of pertinent developments in this case, particularly all aspects of court action since the death of Judge Battle on March 31, 1969.

Referenced Bureau airtel reflects that one WILLIAM BRADFORD HULE has written a third article for "Look" magazine and in this article indicates that JAMES EARL RAY allegedly registered at various motels in Alabama and Mississippi during the period March 29, 1968, to April 2, 1968. One of the motels allegedly registered at during this period was a motel located near Corinth, Mississippi. The Bureau instructed that appropriate investigation be conducted to establish whether or not RAY was in contact with any individual immediately prior to the assassination and instructed that in this investigation there is to be no indication made whatsoever that the investigation has any connection with the case involving JAMES EARL RAY.

The Jackson Office conducted appropriate investigation and identified individuals registered at various motels in the Corinth, Mississippi, area for the period March 29, through April 3, 1968. The indices of the Oklahoma City Office are negative regarding individuals listed above. In the event it is deemed necessary to interview an individual to determine if there is a possibility of association with JAMES EARL RAY, such interview should not be conducted in any manner to indicate this investigation has any connection with the JAMES EARL RAY case. It is suggested a suitable pretext be used in order to ascertain the reason for the individual's presence in the Corinth, Mississippi, area and specifically at the motel where they are known to have been registered.





JUDGED on its success in escape? shedding new light on the murders of President Kennedy and that Ray himself hight give to Martin Luther King Jr. the any of these questions must be House Assassination Commitee has been an expensive turkey from the start. But it has provided some good theatre and some interesting copy for news media during an otherwise dull Washington summer.

As an entertainment production, the inquiry probably peaked this week with the performance of James Earl Ray, who once confessed to the murder of Dr. King but later changed his mind. 🦡

There is nothing new about this. But the committee did liven up its own proceedings by hauling in Ray and letting him repeat his recantation and his latest version of the crime for the cameras.

There is overwhelming proof that Ray bought the murder weapon. Witnesses have placed him at the rooming house from which the fatal shot was fired. His fingerprints were found on the rifle after the slaying. A reasonable person might entertain some small doubt that Ray actually pulled the trigger. But there is no doubt whatever that he took part in the killing, at least as an accomplice. So any protestation that Ray is "innocent" has to be treated as a bad taste joke.

But there remain a lot of important, unanswered questions surrounding the King assassination?

Did Ray act alone? Was he a hired killer? Who, if anyone, gave him money and other assistance making good his initial

Unfortunately, any answer treated as perfectly worthless unless it is corroborated by other witnesses. As the Rev. Jesse Jackson pointed out in a recent

interview, Ray is an habitual liar. And he has a good motive for lying now.

Many civil rights leaders are emotionally committed to the possibility that the FBI may have been involved. This theory is not supported by a single fact or piece of believable evidence. But black leaders remember that the late FBI Director J. Edgar Hoover disliked King and did a number of things to besmirch his reputation. In their minds, it follows that Hoover may have stooped to murder.

If Ray could convince respectable black leaders that he is innocent and that the FBI may have had a role in the murder, he would acquire some powerful allies in his effort to switch the blame for the crime.

But Ray's problem is that there are no facts and no evidence to support his latest yersion of the King murder...

Ray's case is also hurt by the fact that his lawyer, Mark Lane, has a vested interest in the matter that goes beyond the guilt or innocence of his client. Lane has made a fortune peddling various conspiracy theories about the King and Kennedy murders. Anything he says or does has to be judged in that light.

So far, the assassination probe has cost \$2 million. Taxpayers: haven't gotten anything much for their money. white the thinks that a beat age
