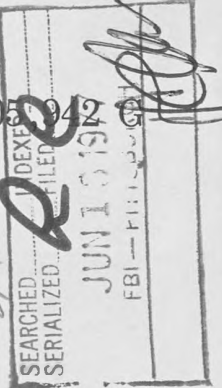

### CRIMINAL RECORD

Ray has been convicted of murder, burglary, robbery, forging U. S. Postal money orders, armed robbery, operating motor vehicle without owner's consent.

### CAUTION

RAY, AT TIME OF ESCAPE, WAS SERVING A NINETY-NINE-YEAR SENTENCE FOLLOWING HIS CONVICTION FOR 1ST DEGREE MURDER WHEREIN A FIREARM WAS USED. CONSIDER ARMED AND EXTREMELY DANGEROUS.

A Federal warrant was issued on June 11, 1977, at Knoxville, Tennessee, charging Ray with conspiracy to violate the Unlawful Flight Statute (Title 18, U. S. Code, Section 371, and Title 18, U. S. Code, Section 1073.)
