



This item was laundered on approximately 12/19/67 for which there was a charge of 60 cents. From the price OSOKOW concluded that it was definitely not shirts. He stated that the item had been forwarded to him for laundering from JACK STEIN of Jack's Cleaners, 307 South 23rd Street, Philadelphia, Pa., LO 8-6272.
