Re Bureau tel to all continental offices, 4/9/68, requesting immediate checks of logical laundries for red cloth laundry tags manufactured by Thermo Seal marking machine bearing "02B-6" or "D2B-6."

In the course of contacting all laundries in the Philadelphia telephone directory, JACK OSOKOW, Manager, Barclay Laundry, 253 South 10th Street, Philadelphia, MA 7-0884, advised SA EDWARD A. SMITH that he utilizes the Thermo Seal quarter inch tape and a check of his records reflects that marking number D2B-6 was listed to (FNU) NEWBAUR. This item was laundered on approximately 12/19/67 for which there was a charge of 60 cents. From the price OSOKOW concluded that it was definitely not shirts. He stated that the item had been forwarded to him for laundering from JACK STEIN of Jack's Cleaners, 307 South 23rd Street, Philadelphia, Pa., LO 8-6272.

JACK STEIN was immediately interviewed and advised that (FNU) NEWBAUER was a customer of his who resided some where on Spruce Street and drove a green or blue Volkswagen. He recalled NEWBAUER generally brought sheets, shirts, and dry cleaning to his establishment but does not recall ever observing Thermo Seal red tags at his shop. He described NEWBAUER as a white male, 33-35, 5'10", slim build, dark hair.

Inquiry of Postal Carrier #359, DOMENIC GAGLIARDI, reflected that one FRED NEIBAUER resided at 2213 Spruce

Street. GAGLIARDI advised that he has never observed this individual but that NEIBAUER's niece, SANDY, had sent him a postal card from the Fontainebleu Hotel, Miami Beach, on 4/9/68.

A pretext inquiry of WILLIAM TOBIN, first floor resident, 2213 Spruce, failed to reflect any information concerning NEIBAUER or his employment.

Philadelphia indices contain no identifiable information on FRED NEIBAUER or variations of that name.

Philadelphia Credit Bureau, Inc., reflects that one FRED NEIBAUER of 2318 Spruce Street, formerly resided at 1052 Kingsley, Rydal, Pa., and listed his occupation as a teacher, place not given.

DON POWELL, Security Officer, Bell Telephone Company of Pennsylvania, advised SA EDWARD A. SMITH that their records contained a listing for FRED NEIBAUER, 2213 Spruce Street, telephone LO 7-4756. Additional information was not immediately available.

IC BRIAN F. MC LAUGHLIN checked records of the Board of Education which reflected that FRED E. NEIBAUER, Social Security Number [REDACTED] was a teacher at the West Philadelphia High School. No additional information was immediately available. 

LAUNDRY TAG MARKING PROCEDURE

JACK OSOKOW, Manager, Barclay Laundry, 253 South 10th Street, was recontacted by SA EDWARD A. SMITH and advised that there were many Thermo Seal marking machines utilized by major laundries in the Philadelphia area. He stated that each of the users may utilize their own particular coding system and in his case D2B-6 indicated that D represented the fourth week, 2B the lot number, and 6 the customer number. He stated this code system has a one-time use and is utilized for inventory control and location of

lost laundry articles. He advised that there are 10 plain colors utilized in Thermo Seal machines plus three striped colors and that under the present system it would be possible to re-use the same number after a 72-week cycle. He stated that it is probable that in laundries throughout the United States there could be several instances of this exact code number coming up on red Thermo Seal tape. He further advised that there were no restrictions on utilization of any specific code on this machine.

Fred Neibauer, 3rd floor front, has resided at this address since June 1966. He formerly resided at 2218 Spruce Street and is a teacher with the Philadelphia Board of Education at \$120 a week. He maintains an account with the Fidelity Philadelphia Trust Company. He possesses an excellent reputation in the building.

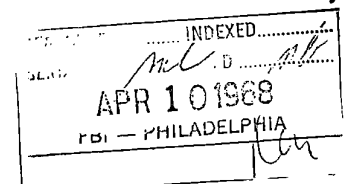
LOUISE WHITEHEAD, 2nd floor rear, has resided at this address since 2/67.

In addition to the above, Miss MARTIN advised that one DONALD NORRIS had occupied the apartment on the first floor rear since 10/25/67 and he was dropped from the list on 3/25/68. NORRIS was an art teacher with the Philadelphia Board of Education but had gotten into a fight or an argument with the elderly Mr. TOBIN and became so infuriated that he took an ax and did considerable damage to his apartment. He then left the area and they have been unable to locate him since. This occurred in December 1967 and inquiry at the Board of Education reflects he no longer was employed there.

NORRIS is described as a white male about 27-28 years old, 5'9", sandy hair and a thin build.

A review of the operators file in Harrisburg reflects NEIBAUER was issued operators license [REDACTED] for the period June 1967-1969. His birth date was listed as 7/28/43 and he must wear glasses when driving.

Mr. Donald Bakoff, Assistant Personnel Director, Board of Education, Phila., Pa. advised IC Brian McLaughlin that his records reflect Fred E. Neibauer who was born on 7/28/43 began teaching the public school system on 9/1/66 and is currently a teacher at West Philadelphia High School. He graduated from Abington High School in 1961, Penn State University in 1965 and then doing graduate work at Temple University. As of June 1966 his address has been listed as 2213 Spruce Street. There is no indication he has changed addresses. He has been present for every school day since March 7, 1968. His Social Security number is [REDACTED]

On 4/10/68, Mr. ARIS HARRIS, Manager, American Dry Cleaners, 1702 Allen Street, Allentown, Pa., advised that the Thermo Seal Marking Machine is ordinarily used by large commercial laundries to mark the garments of regular customers. Mr. HARRIS advised that the Thermo Seal cloth tag is permanently affixed to the garment and may be used for the life of the garment. He stated that the Thermo Seal tag is used most prevalently by industrial plants, clothing rental companies, and institutions such as nursing homes.

On 4/10/68, Mr. GORDON CHAMBERLAIN, Operations Department, Allen Laundry, Inc., 12th and Allen Streets, Allentown, Pa., advised that he is familiar with the Thermo Seal Laundry Tag but is unaware of its use in the Allentown, Bethlehem, and Easton, Pa., area. Mr. CHAMBERLAIN advised that his company had recently purchased a smaller laundry that used the Thermo Seal tag and made available an example of the tag for inspection. Mr. CHAMBERLAIN advised that the tag is no longer in use by his company, and the tag that was used is dissimilar to the tag in question.

Mr. CHAMBERLAIN advised that the Thermo Seal tag is ordinarily used by large institutions, such as mental hospitals or nursing homes, to identify an individual patient's garments. He advised that the ordinary neighborhood laundry would probably not use the Thermo Seal tag due to the expense involved. He stated that even large laundries would confine the use of the Thermo Seal tag to garments such as shirts, as it would be economically unfeasible to mark undergarments with the Thermo Seal tag due to the large amount of time involved in marking the garment.

Mr. CHAMBERLAIN advised that the primary advantage of the Thermo Seal tag is that it can withstand numerous launderings of the garment. It is applied by heat and can only be removed

by the application of heat of equal temperature. He stated that it would probably be used by an institution where people are kept for a longer period of time than six (6) months, as it would be unfeasible to mark the garment for a shorter period of time. He stated such institutions would probably be nursing homes, mental hospitals, or prisons. He further advised that some institutions probably have their own Thermo Seal Machines. Tags from these machines would be coded to a particular customer, patient, or inmate.

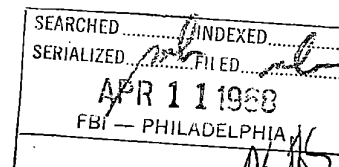
