

Referenced memo was a report by CG 7116-R (PROB). This report stated J. B. of SCLC had been in and out of Chicago.

By airtel dated 3/26/69 the Bureau instructed Philadelphia to interview Reverend Jack B for information in his possession regarding his statement in the "New York Times" on 3/18/69 that a letter was turned over to the Memphis Police on approximately 4/3/68 which contained information that MARTIN LUTHER KING was to be assassinated while in Memphis.

Informants of the Philadelphia Division advised that B was in a mental hospital in New York City.

The New York Office is currently checking out this information.

The Bureau has advised that B is not to be interviewed before determining complete background concerning

According to informant this is the second floor of a two story building. A state liquor store is on the first floor and there are approximately four apartments on the second floor. Everyone residing in the apartments on the second floor is connected in some way with SCLC.

It is to be noted that Bernell Server, girl friend of BEVEL, and BEVEL have been interviewed by agents at this address.

PH 897-R and T who is a former staff member for Philadelphia Branch SCLC, went to the address to talk to B They had been instructed to invite B to speak at a meeting of "The Resistance" to be held May 1 in downtown Philadelphia. The second purpose for their visit was to determine if they could help in any plans being made by SCLC in connection with the recent arrest of R A Charleston, S.C.

Report (LNU), who is currently residing on the second floor of Philadelphia, advised that BEVEL was in New York and has been in New York for three weeks. He also stated that it would be impossible for informant and Total to contact him at this time.

With regard to activity of SCLC in Charleston, S.C., Research stated that no plans have been made by SCLC in Philadelphia and that he did not know what was being done nationally.

Informant advised that after he and Total left Barrers, Total made the statement that SCLC was "apparently falling apart in Philadelphia."

The above is furnished for information and was not put into an LHM because it would immediately identify an informant of continuing value.




