This is the case involving the murder of MARTIN LUTHER KING, JR. on 4/4/68, at Memphis, Tennessee.

The Bureau has instructed:

- (1) NO INDICATION TO BE GIVEN THAT THESE LEADS ARE IN CONJUNCTION WITH MURKIN CASE.
- (2) THIS CASE MUST BE GIVEN TOP PRIORITY AND ALL LEADS MUST BE COVERED BY TELETYPE TO THOROUGHLY RESOLVE.

The pertinent dates in this investigation are 3/29 - 30/68 when suspect purchased murder weapon at Birmingham, Alabama, and 4/4/68 at 6 P.M., which is time of shooting in Memphis, Tennessee. If suspect cannot be eliminated by dates, efforts should be made to obtain photographs and send to Memphis and Birmingham.

Fingerprints of UNSUB are also available and it may be necessary to send fingerprints to Bureau for elimination purposes.

RE: HARVEY LOWMEYER OR LOWMYER

It has been determined that a rifle abandoned near scene of the crime was purchased by individual using the name HARVEY LOWMEYER or LOWMYER, who is generally described as a white male, age 36, height - 5'8", weight - 150 to 160 lbs., hair black or dark brown.

The Bureau has instructed that in view of the unusual nature of the names, LOWMEYER or LOWMYER, that all Offices should immediately conduct certain checks on the surnames LOWMEYER or LOWMYER, not confining the check to HARVEY LOWMEYER or LOWMYER.

The checks directed to be made which have not been handled through Richmond Headquarters are as follows:

- (1) All City Directories
- (2) Voter Registration Records
- (3) Credit and Criminal Records

Any individuals identified from these checks as bearing the surname LOWMEYER or LOWMYER should be immediately checked out covering the pertinent period.

RE: ERIC STARVO GALT

The Bureau has advised that investigation has established that an individual using the name ERIC STARVO GALT was in Memphis Tennessee, on 4/4/68, reportedly driving a 1966 white Mustang with 1968 Alabama license 1-38993. The Bureau has further indicated that this individual is considered a prime suspect in this murder. The 1966 Mustang has been located in Atlanta, Georgia.

Concerning this name and individual, the Bureau has instructed considerable investigation be conducted which is set out below excluding investigation that has been and is being handled in Headquarters City:

Immediately check all City Directories, all financial institutions, conduct credit and criminal checks and contact other logical sources to obtain any information whatsoever resuspect, GALT.

Concerning the contacting of financial institutions, the following banks and their branches are being handled at Headquarters City:

The Bank of Virginia
First and Merchants National Bank
State Planters Bank of Commerce and Trusts

Senior RAs should assure expeditious handling of above contacts and immediately check out any individuals identified from these contacts for the pertinent periods.

Senior RAs will parcel out the leads necessary to handle thi matter. Each SRA will correlate within their territories and return all results at one time and not piecemeal.

At 9:10 p.m., 4/10/68, Corporal J. E. O'CONMER, Fairfax County, Va., Police Dept., advised SA O. M. SMASAL he had learned the following from RUBY DANSBY, 9100 Richmond Highway, Ft. Belvoir, Va., who operates The Belvoir Grill, at this address, telephone 781-5841; that earlier in the evening, a man had been in The Belvoir Grill and he appeared to be a "dead ringer" of the individual whose composite picture she had seem of the subject wanted for the murder of MARTIN LUTHER KING, Jr. O'CONMER stated that DANSBY had described this man as a white male, 5'7" to 5'8", sandy graying hair, thin line mustache, wearing a brown pin-strip suit and a red-blue plaid flannel shirt. She said that the man had no luggage and as far as she could ascertain, he was on foot. In conversation with this individual, DANSBY said he told her he was from Knoxville and was hitchbiking to Fla.

The Washington Field Office telephonically advised the Alexandria, Virginia Resident Agency on April 11, 1968 that they had received a telephone call from a MR. JAMES G.L.HOWARD 7115 Leesville Boulevard in Springfield, Virginia on the night of April 10, 1968 advising that he observed x max the driver of a green Volkswagen bearing North Carolina license BY-7044 who resembled the artist's sketch of the assassin of MARTIN LUTHER KING. He advised that this individual was observed in the vicinity of Gallows Road and Route 50 in Fairfax, Virginia.

The license number was determined to be registered to a JOHN LEWIS CAMPHANE of 10027 Mosby Woods Drive in Fairfax, Virginia according to the records of the Division of Motor Vehicles located at Charlotte, North Carolina.

Special Agent ROLAND M. COCKER conducted the following investigation on April 11, 1968: MR. and MRS. BERNARD SEXTON, apartment 321 at 10027 Mosby Woods Drive advised that JOHN LEWES and PENELOPE CHAMPAGNE reside in apartment 322 at this address and are closely acquainted with the SEXTONS. They both advised that MR. and MRS. CHAMPAGNE have resided here since September 1967 and he is a student at American University working towards his Master's Degree and they know that neither MR. or MRS. CHAMPAGNE have left the area during their residence here. When shown the artist's conception of the assassin, MR. and MRS. SEXTON advised that they did not think there was any resemblance. They commented that MR. CHAMPAGNE has a conspicuous facial scar extending from his lip caused from an accident a number of years ago.

MR. JOHN LEWIS CHAMPAGNE and his wife were thereafter interviewed and advised that they have resided in this apartment since September, 1967 and have not been out of the State since. CHAMPAGNE was born July 15, 1939 at Springfield, Massachusetts, received an honorable discharge from the U.S. Army as a Captain, Serial Number 05322368 after serving from January 3, 1964 through August, 1967. He was employed with the Defense Intelligence Agency at Arlington Hall, Arlington, Virginia from SEARCHED INDEXED TO SEPTEMBLE THE THROUGH ABSTRACTION OF THE SEMALUTE SE

Through observation and interview, CHAMPAGNE is described as a white male, $6^{\circ}1\frac{1}{2}^{\circ}$, left weight 195 pounds, brown eyes and hair, 3" scar from/corner of lip.

Enclosed to Memphis are nine copies of investigative insert reflecting investigation conducted in Dallas, Texas. Also enclosed for Memphis is a Xerox copy concerning passengers who boarded American Airlines flight 296 at 1:20 PM, 3/28/68, in Dallas. It is noted Mr. G. AHRENS, apparently identical with GRANT AHRENS, was a coach passenger and accordingly it appears passengers who sat in the immediate vicinity of him were also coach passengers. Coach passengers are listed on the enclosed beginning with the name of Mr. ANRENS, those above being first class passengers.

Investigation disclosed no names of military persons appear on the enclosed list, however, two persons were on "stand-by" and did hoard the flight in Dallas. Both were destined for Louisville. One was Sgt. (illegible possibly REYNOLDS or REVNORES), the other one FARRIS, rank and service not indicated. It is further observed that the female Captain in the Afghanistan Army is not identifiable from the list enclosed. Agent was informed that the numbers to the immediate rights of the names of the individuals on the list are identifying information in a computer at the Briar Cliff Computer System, New York City. Such information will show in most cases the full data concerning reservations made by the respective persons, including contact telephone numbers and/or addresses.

It is being left to the discretion of Memphis whether this investigative lead is worthy of being pursued further in this regard.

It is suggested with respect to military personnel, that Louisville Office might check records of airlines out of Louisville to Richmond, Virginia, following the arrival of American Airlines flight 296 on 3/28/68, in an effort to identify the Airman who reportedly sat next to AHRENS. It is further suggested that Louisville at Fort Enox, Kentucky, might successfully identify the female Afghanistan Army Captain, perhaps more easily than through information from the airlines.

Memphis note 71 persons reportedly boarded the plane at Memphis.

Dallas Office will not pursue this matter further unless advised by Kemphis.







Police departments in Virginia were asked by the FBI to be on the lookout last night for a man who admitted that he had slain civil rights leader Dr. Martin Luther King Jr.

Police said that the white man bore a tatoo on his upper right arm that said: "Born to Lose."

The man had told someone in Whiteville, N.C. about midnight Monday that he had slain. King and was going to Washington to surrender himself to federal authorities, police said. They added that the man was thought to be hitchhiking along either U.S. 1 or Interstate 95.

In an all - unit broadcast, the man was described as being about 25, with blue eyes, black hair, mediumdark complexion and about 5 feet 10 inches tall.

He was wearing a white shirt with yellow stripes and dungarees when last seen, ponce said.

Enclosed for the FBI Laboratory are two 3" by 5" cards containing six Thermo Seal pieces of marking tape.

On 4/11/68, Mr. JOSEPH A. YOUNG, Manager, Bonnie Bright Laundry (formerly known as Farlington Laundry), 3800 South Four Mile Run Drive, Arlington, Va., advised SA JOHN W. PFAFF, JR. that his company has used white Thermo Seal marking tape exclusively for over two years. Mr. YOUNG made available six samples of Thermo Seal marking tape which were affixed to two 3" by 5" cards.

Mr. YOUNG noted the machine is capable of making six characters at one time and that the first four characters on this machine are slightly smaller than the last four characters. His company uses a coding system consisting of four alphabetic letters, a dash and one number. According to Mr. YOUNG, there is no standard coding process and each individual laundry is free to employ its own individual coding system.

For the information of San Juan, the following is furnished:

Search of premises believed occupied by UNSUB who assassinated Dr. MARTIN LUTHER KING on 4/4/68, disclosed suitcase in which was located tee-shirt and undershorts bearing laundry mark on red tape with black lettering believed to be Thermo-Seal type, manufactured by Textile Marking Machine Co., Inc., Syracuse, N.Y. The tape is ½" wide and 1 1/16" long and bears letters and numbers 62B-6.

Experts at Textile Marking Machine Company advise type on this machine is unusual in that the first two characters are 15 point type and the last three characters are eighteen point type, with the middle character, the letter B, probably being narrow rather than regular type. The usual machine carries 15 point type for the first three characters and 18 point type for the last two characters.

Textile Marking Machine experts also stated this machine is defective in that it is producing a tape 1 1/16" long instead of 1 1/8" long and is not projecting the tape far enough resulting in cutting off a portion of the first letter. The code used in the Northeast part of the U. S. is as follows:

The first letter 0 stands for lot number; the first number 2 indicates the day of the week, two being Tuesday; the second letter indicates the first letter of the store name, this is the letter B; the last number is the bundle number, this is 6. Color coding of the tag may designate various things such as a different month or the identity of a store in a chain. Experts also state the use of this system on laundry items is unusual in that the system is normally used on garments being dry cleaned.

The Bureau has instructed that all textile machines using this type tape be located and machines using this code be identified.
