On 4/26/68 Mr. R. DAWSON, Manager, Bonnie Brae Cleaners, 1344 Main Street, Lynchburg, Va., advised his laundry is marked with a Thermo-Seal tape utilizing 2 letters and 3 numbers, hence the code number 20R-3 does not correspond with any used by him.

On 4/26/68 Mr. JAMES E. SMITH, Smith's One-Hour Cleaners, 2300 Fort Avenue, Lynchburg, Va., advised his laundry uses Thermo-Seal tapes and the code number 20R-3 would be included in numbers utilized. He stated this number, on red, yellow, blue, pink or white tape, possibly was used about four months ago. However, when the taped tickets are made up, one is put on the garment, the other on the laundry slip, and no record is kept. He could furnish no information as to the identity of the customer who had this number about ~~four~~ months ago.

Mr. SMITH furnished samples of tapes printed on his Thermo-Seal machine.

**THE CRIMES:** Ray escaped from the Missouri State Penitentiary, Jefferson City, Missouri, on April 23, 1967, while serving a 20-year sentence for armed robbery and operating a motor vehicle without the owner's permission. He subsequently allegedly conspired, under the alias Eric Starvo Galt, to violate the civil rights of Dr. Martin Luther King, Jr., shot to death on the balcony of a Memphis, Tennessee, motel on April 4, 1968.

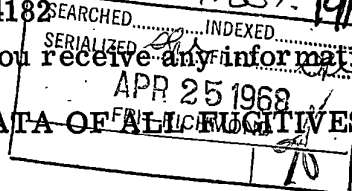
**THE CRIMINAL:** A 40-year-old white native of Illinois, who is known as a "loner" and "drifter" and has taken elaborate steps to establish a false identity, Ray has an extensive criminal record, including convictions for burglary, robbery and forging U. S. Postal Money Orders. Outstanding characteristics include a straight narrow nose, straight and even teeth, a noticeably protruding left ear and a nervous habit of tugging at an ear lobe. He has taken dancing lessons, attended bartending school, enrolled in a correspondence course in locksmithing and traveled widely in a 1966 Mustang recovered in Atlanta, Georgia, a week after Dr. King's murder. Ray likes western and country music, drinks vodka and beer and has worked as a baker, laborer and color matcher.

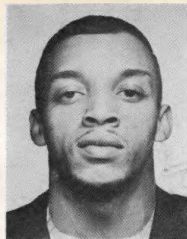
**PROCESS:** A Federal warrant issued at Jefferson City, Missouri, on July 20, 1967, charges Ray with unlawful interstate flight to avoid confinement for robbery. Another Federal warrant, issued at Birmingham, Alabama, on April 17, 1968, charges Ray, as Eric Starvo Galt, with conspiring to interfere with a Constitutional Right of a citizen.

She advised she had little or no recollection of the individual from whom she received the weapon. She stated a review of the passengers as listed on the manifest for that flight did not refresh her memory in identifying this individual. The published wanted flyer of JAMES EARL RAY was exhibited to Miss STUMLER and she advised she recalled having seen photo on television but could not connect it with passenger bringing weapon on plane.

DIANE MOSELEY, 532 Cleveland Avenue, Apt. 12-C, Hapeville, Georgia, advised on 4/23/68, that she was on duty in the tourist section of DAL Flight 725 on 4/1/68, with SYLVIA PAGE. She advised that her duties required her to remain in the rear section of the plane while the passengers boarded and that she does not recall a passenger bringing a weapon case on the plane. She also advised SYLVIA PAGE was in the rear of the plane and would not have been in a position to observe this. Miss MOSELEY advised based on the limited description available, she could not recall the individual described in referenced airtel.

The published wanted flyer of JAMES EARL RAY was exhibited to Miss MOSELEY who advised she was unable to identify him.

In view of information furnished by Miss MOSELEY it appears as though Stewardess SYLVIA PAGE would not have been in a position to observe incident or identify individual, and in view of her unavailability, she will not be interviewed.
