Clark Repeats View King's Slayer Alone

ATLANTA (P) — Atty. Gen. Ramsey Clark said Saturday that there is no significant evidence that the assassination of Dr. Martin Luther King "goes beyond the single actor" who fired the fatal shot.

Clark made the statement during a news conference here in reply to a question concerning the reports of a possible conspiracy of southern businessmen.

"We could make a long, long list — as long as the imagination of man runneth — of people who could possibly be involved in this," Clark said, "but there's no significant evidence that it goes beyond the single factor."

The attorney general did not mention the man sought in connection with the slaying, James Earl Ray, by name, and did not elaborate on the investigation except to say that he still feels confident an arrest will be made soon.

I was hopeful an arrest would be obtained before now," he said. "The individual being sought is in a very difficult situation and it will be difficult for him to avoid arrest."

Clark was in Atlanta to speak at a Emory University Law Day luncheon.

Asked if he thought the slaying of King would result in effective gun legislation, Clark said it is "incredible that it has taken this long" to obtain such legislation. However, he said he would not "describe a direct casual relationship" between the slaying and the legislation.

"I hope to see action on this legislation in the Senate next week" be said.

Riots can and must be prevented, Clark said. "April of 1968 showed this," he said. "For each riot that happened one was prevented. The conduct of the police is the determining factor. Police have the only related opportunity to snuff out a right before it occurs.

"Unless we garrison our cities we must rely on the police," he said.

The police can provide America with the "few years we need to rebuild our cities and ourselves," Clark said. "When we come through this trying period we shall have to go on living together on this soil forever. Nothing else is possible."

LAUE, 8231 Chauncey Court, Fairfax County, Virginia, advised he was a guest at the Lorraine Motel, in Room 308, in Memphis, Tennessee, from April 1, 1968, through April 5, 1968, in connection with his duties as Acting Director, Program Evaluation and Development, with Community Relations Services, U. S. Department of Justice, Washington, D. C.

On April 4, 1968, according to LAUE, at approximately 6:00 p.m., he was in his room at the Lorraine Motel and heard what appeared to be a loud report of a firecracker from the direction of the motel court. Upon opening his door, he noted the prostrate form of Dr. KING lying on the motel balcony.

LAUE further stated he immediately went to Dr. KING's aid and upon arriving, he noticed upon viewing the body, a three inch in diameter wound between the right ear and jaw of Dr. KING, and there was much blood around the body.

LAUE further stated he immediately returned to his room and obtained a towel and returned to Dr. KING and placed the towel under Dr. KING's head in an effort to absorb the blood. He then attempted to find a pulse beat of Dr. KING.

LAUE further stated he noticed no one leaving the scene and could furnish no further pertinent information, except that he recalls the following individuals were present upon his first arriving at the prostrate form of Dr. KING:
