Re Bureau airtel to all offices dated 5/9/68.

Dr. GEOFFREY T. MANN, Chief Medical Examiner, state of Va., Richmond, Va., has advised that to date there is only one (1) unidentified deceased in the Richmond territory of Va., that could possibly be identical with subject RAY. He advised that this body was discovered burned to death in a fire in Alexandria, Va., on 5/1/68, and that although the unidentified deceased appears to be that of a male Negro, the conclusion could not be positive.

Dr. MANN advised that a dental chart of the unidentified deceased is available and that a positive identification or elimination could be made if the dental charts for subject RAY could be made available.

The Bureau is requested to furnish Richmond with dental charts for subject RAY, suitable for identification or elimination purposes, if such charts are available. Richmond will upon receipt of RAY's dental charts, have a comparison made with unknown deceased mentioned above, to determine if identical.

Richmond, Va., advised that he had recently seen several
photographs of JAMES EARL RAY in Newsweek magazine and that
two of these photographs very much resembled an individual
he had recently seen in his restaurant. The photographs which
MC BRIDE thought resembled this individual were both taken
in approximately 1959. MC BRIDE examined a photograph of
RAY taken in Jan. or Feb., 1968 and stated this did not
resemble the individual whom he had referred to as having
been in his restaurant.

HUBERT SMITH, Manager, Milner Hotel, 10 W. Main
St., Richmond, examined the most current photograph of RAY
as well as the photographs which had been in Newsweek
Magazine and stated that none of these photographs were at
all familiar to him.

LLOYD WILLIAMS, Clerk Dispatcher, Employers Overload
Co., 15 W. Main St., Richmond, examined the most recent
photograph of JAMES EARL RAY as well as the photographs
of RAY which appeared in Newsweek Magazine and stated he
was sure he had never seen this individual before.

The Bureau has further advised for information and investigative assistance, that subject JAMES EARL RAY has been known to consort with prostitutes and "street bums." A photograph of RAY was obtained from a prostitute in Mexico, which is the photograph publicized of RAY, showing him wearing sunglasses.

The Bureau has instructed that the above should be borne in mind in our daily contact with informants, officers of vice squads, and prostitutes, in covering leads in connection with this and other cases.

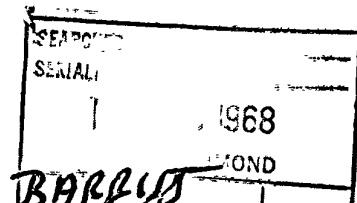

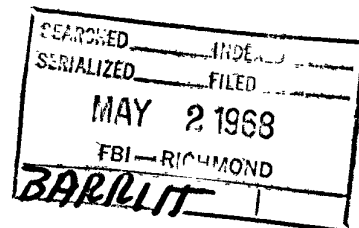
