As the result of a search in the Anonymous Letter File, the writings on Q338 through Q340 have been identified with other material submitted to the Laboratory attributed to Robert P. Anderson, and which have been included in Bureau file 62-111085. (LA file 9-3759; SA file 55-67; CG 9-3944). Nothing of significance was noted between the writings on Q338, Q339 and Q340 when compared with the various writings which have been received in the MURKIN case.

On 5/20/68 MARY KASSOUF, 5015 Lansing Drive, Austin, Texas, advised that on the evening of April 20, 1968, she observed three white male individuals, all of whom were wearing brown colored khaki uniforms, at the Kentucky Fried Chicken outlet at 2320 S. Congress, Austin. She advised that she thought one of the men met the description of JAMES EARL RAY as it was set out in the local newspaper. She stated, however, that she had not seen the photograph of RAY until this date, and that she could not now be sure the person she observed was RAY## as the person at the chicken shack had a different shaped head. She said the person she saw had a short "bowl haircut" similar to the haircut of RAY as it was portrayed in the 1960 photograph appearing on the Wanted Flyer.

KASSOUF repeatedly changed the subject of conversation and among other things mentioned that she had been in two different Veterans Administration hospitals for a mental condition.



Each Special Agent in Charge and Legal Attache is instructed to promptly remind their established cooperative news sources, in a discreet and tactful manner, of the existence of substantial reward money for information leading to the arrest and conviction of the killer of Dr. Martin Luther King. This money now totals at least \$100,000. The FBI should not, however, be publicized as the source of this reminder.

While the Bureau's continuing policy is to encourage the public to furnish information to law enforcement authorities as a matter of good citizenship, without expectation of financial reward, it is fully recognized that monetary rewards are often necessary to motivate some individuals. The knowledge of the existence of the substantial rewards available in the Murkin case could possibly prove of value in the solution of this major investigation.




