Remarks:

As the result of a search in the Anonymous Letter File, the writings on Q338 through Q340 have been identified with other material submitted to the Laboratory attributed to Robert P. Anderson, and which have been included in Bureau file 62-111085. (LA file 9-3759; SA file 55-67; CG 9-3944). Nothing of significance was noted between the writings on Q338, Q339 and Q340 when compared with the various writings which have been received in the MURKIN case.

In view of the incoherent nature of the material submitted, a copy of which has been enclosed for San Antonio, and the past mental history of Anderson, no additional examinations are being made.

The material submitted is returned to San Antonio.

Mr. CANTU noted, however, that he has a brother, a truck driver, who frequently telephones them, as he passes through north Texas on his hauls, to relay family news, etc. Mr. and Mrs. CANTU stated that photographs, names, aliases, and description of JAMES EARL RAY were unfamiliar.

## AT SAN JUAN, TEXAS

On 5/14/68, MARIA G. GARZA, P. O. Box 634, North San Antonio Road, advised that her telephone number, 512-787-4545 (Pharr, Texas, exchange), is unlisted and has been furnished only to members of her family and some friends. She stated she could not recall receiving a long distance telephone call in 12/67. She noted that photographs, names and aliases of JAMES EARL RAY were unfamiliar to her.

## AT MC ALLEN, TEXAS

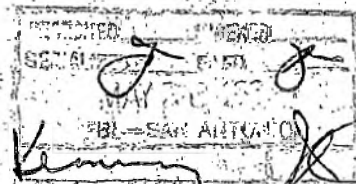

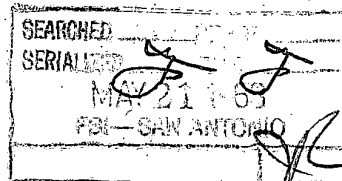

On 5/20/68 MARY KASSOUF, 5015 Lansing Drive, Austin, Texas, advised that on the evening of April 20, 1968, she observed three white male individuals, all of whom were wearing brown colored khaki uniforms, at the Kentucky Fried Chicken outlet at 2320 S. Congress, Austin. She advised that she thought one of the men met the description of JAMES EARL RAY as it was set out in the local newspaper. She stated, however, that she had not seen the photograph of RAY until this date, and that she could not now be sure the person she observed was RAY as the person at the chicken shack had a different shaped head. She said the person she saw had a short "bowl haircut" similar to the haircut of RAY as it was portrayed in the 1960 photograph appearing on the Wanted Flyer.

KASSOUF repeatedly changed the subject of conversation and among other things mentioned that she had been in two different Veterans Administration hospitals for a mental condition.

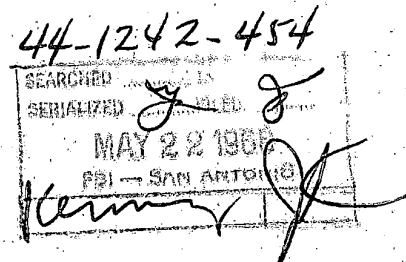

PUBLICITY ON REWARDS OFFERED

*CO* Each Special Agent in Charge and Legal Attache is instructed to promptly remind their established cooperative news sources, in a discreet and tactful manner, of the existence of substantial reward money for information leading to the arrest and conviction of the killer of Dr. Martin Luther King. This money now totals at least \$100,000. The FBI should not, however, be publicized as the source of this reminder.

While the Bureau's continuing policy is to encourage the public to furnish information to law enforcement authorities as a matter of good citizenship, without expectation of financial reward, it is fully recognized that monetary rewards are often necessary to motivate some individuals. The knowledge of the existence of the substantial rewards available in the Murkin case could possibly prove of value in the solution of this major investigation.

Highway 90 and Interstate Highway 10 over which subject and CHARLES STEIN allegedly traveled 12/15-17/67. Subject reportedly made eight long distance telephone calls while in Texas.

Set forth by Field Division are some of the telephone calls made from the San Antonio Division, 12/15-17/67, which were obtained from available Southwestern Bell Telephone Company records. The various Field Divisions will determine from the subscriber or person receiving the call the identity of the caller. If the caller was JAMES EARL RAY, aka, obtain all available information. Further, determine if the subscriber or the person receiving the call has any knowledge of JAMES EARL RAY.

Unless information is developed during the course of the investigation requested above which pertains to the San Antonio Division, it is not necessary to advise the San Antonio Division of the results.

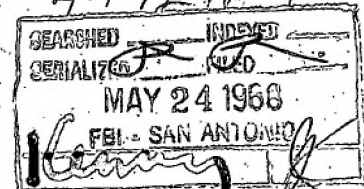
