IN THE COURSE OF HIS JEWELRY BUSINESS, HE MET A WHITE MALE ITALIAN WHO WAS IN HIS LATE SIXTIES AND WAS APPROXIMATELY 5 WEET S INCHES TALL, WEIGHED APPROXIMATELY 250 POUNDS, AND WHO OPERATED A JEWELRY TRADE SHOP ON WALMUT STREET.
