At approximately 11:20 pm this date, an anonymous male caller advised that a person resembling ERIC STARVO GALT was in THE LANTERN, 1322 3rd., Chula Vista, phone 427-4200.

Complainant advised that he had observed this individual for approximately one and a half to two hours previous to this call and that this individual was boasting how he had "knocked of that god dammed King mother f\_k n nigger." Complainant stated that this individual had a hillbilly accent.

Complainant stated that the individual was driving a 1964 or 1965 Black Ford, similar in appearance to the SDPD detective cars and that it contained shortwave radio equipment and had an antenna in the middle of the roof. Complainant also advised that the car bore Calif. license UNT 891. Complainant stated the the individual was carrying a gun on his belt.

Complainant had no other information to furnish and he stated that he preferred to remain anonymous.

ASAC BROWN advised at 11:25 pm.

Subsequent contact with FBI Sacramento, SPC Larry Long, revealed that Calif. license UNT 891 was registered to a 1967 Rambler station wagon belonging to WILLIAM E. or BARBARA DELONG, 2462 Lorna Lane, Carlsbad, Calif.

No occupation was shown for POOLE.

Mr. CHARLES R. POOLE, Apartment 1, 856 Seventeenth Street, San Diego, California, who is employed as a desk clerk at the Park Manor Hotel, directly across the street from the San Diego FBI Office, and who is well known to a number of the Agents assigned at San Diego, made available his 1959 Chevrolet, bearing California license plate KMS-347 and it was noted that both license plates were intact. The color of this automobile is dark brown in color.

Mr. POOLE advised that it would be impossible for his automobile to have been seen in the vicinity of Charlotte, North Carolina on 4/22/68.

At approximately 7:12 p.m., 4/22/68, a Mrs. WILLIAMS, giving telephone number 422-3727, telephonically contacted the San Diego Office and advised that approximately one week and a half previously, a male cousin of a neighbor and another male individual named JIMMY RAY BUNDY visited this neighbor. The cousin was driving a car with a North Carolina license.

JIMMY RAY BUNDY left rather unexpectedly hitchhiking on his way back south. Mrs. WILLIAMS and her husband thought that BUNDY bore a striking resemblance to ERIC STARVO GALT and that his actions while at the neighbor's home were most circumspect. Mrs. WILLIAMS further advised that BUNDY had a peculiar reluctance to converse.

Mrs. WILLIAMS was recontacted by SA ARNOLD W. O'BRIEN and she advised that the neighbor, Mrs. MARJORIE GREGG resides directly across from her place at 138 Quail Drive, Chula Vista, California. The cousin of Mrs. GREGG is driving a 1957 Chevrolet bearing North Carolina license plate HJ7057.

Mrs. WILLIAMS advised that she determined that JIMMY RAY BUNDY was taken to Alpine, California by Mrs. GREGG several days ago where he was let out to hitchhike back to North Carolina. He was immediately picked up by an automobile bearing an orange license plate.

The following investigation was conducted by  
SA ARNOLD W. O'BRIEN and CHARLES W. BONE:

Mr. MILTON GRAY MANNING, temporarily residing at 138 Quail Drive, Chula Vista, California, advised that he is the cousin of MARJORIE GREGG who is the owner of the residence at 138 Quail Drive.

On approximately 4/9/68, MANNING and a friend named JIMMY RAY BUNDY left Greenville, North Carolina in his 1957 Chevrolet bearing North Carolina license plate HJ7057 en route to California.

According to MANNING, he and BUNDY have been in California for approximately 1½ weeks, however JIMMY RAY BUNDY departed from Alpine, California, hitchhiking enroute to Greenville, North Carolina or Portsmouth, Virginia.

According to MANNING, JIMMY RAY BUNDY was employed for his father, JIM BUNDY who operates his own real estate company at Portsmouth, Virginia. JIMMY RAY BUNDY came to Greenville, North Carolina to visit his mother, Mrs. IDA SAWYER, who lives in the Village Grove section of Greenville, North Carolina. BUNDY's mother is presently married to RUDELL SAWYER of the Village Grove Section, Greenville, North Carolina and believes that the telephone number is listed under his stepfather's name.

While in Greenville, JIMMY RAY BUNDY decided to come to California with MANNING for the purpose of obtaining employment.

Employment was not obtained by BUNDY, therefore, he decided to return to the southern states.

Mrs. MARJORIE GREGG, cousin of MILTON GRAY MANNING verified the information furnished by MANNING and advised that she took JIMMY RAY BUNDY to Alpine, California on the morning of 4/19/68 for the purpose of his obtaining a ride to either Greenville, North Carolina or Portsmouth, Virginia. Mrs. GREGG advised that JIMMY RAY BUNDY obtained a ride almost immediately in an out of state automobile bearing orange license plates.

Mrs. GREGG advised that she has known JIMMY RAY BUNDY and his family for many years and upon being shown a

photograph of JAMES EARL RAY she stated that there was no resemblance between RAY and JIMMY RAY BUNDY.

MANNING also was displayed photograph of RAY and he likewise stated there was no resemblance between the two. MANNING and GREGG described JIMMY RAY BUNDY as follows:

DAVID M. KREPCHIN, Manager, San Diego Branch, M. Rosenblatt and Son, Incorporated, Naval Architects and Marine Engineers, 707 Broadway, San Diego, California, advised as follows:

JOHN DONALDSON WILLARD has been employed at M. Rosenblatt and Son as an electrical design draftsman since June, 1967. He provided a personal record on WILLARD which disclosed that he had served in the United States Navy from August 18, 1943 to April 1, 1963, leaving the Navy as a Senior Chief Electrician's Mate, Navy Serial Number 866-62-02. He was described as follows:

KREPCHIN advised that WILLARD had been sent from M. Rosenblatt and Company on March 25, 1968 to work for the M. Rosenblatt and Son representative at Lockheed Shipbuilding and Construction Company, 2929 Sixteenth Avenue, Southwest, Seattle, Washington, to report for work on March 26, 1968. KREPCHIN advised that he had received word that WILLARD had reported for work as scheduled, and was certain that he had worked from March 26 to March 29, 1968, but could not personally vouch for this attendance at work, and did not know whether WILLARD was present at work after March 29, 1968. His supervisor at the Seattle Company was to be Mr. RICHARD CUNNINGHAM, the M. Rosenblatt and Son representative at the Lockheed Shipbuilding and Construction Company.

WILLARD's personnel record also disclosed that he had a secret clearance to work on classified contracts, ~~the clearance granted by the Defense Industrial Security~~ Clearance Office in Columbus, Ohio, ~~on~~ October 18, 1967.

According to a Form DD48 dated July 31, 1967, WILLARD attended schools in Kansas City, Kansas from September, 1931 through May, 1943, and had served in the Navy from August, 1943 to April, 1963. Former addresses for WILLARD after his leaving the service were listed as:

4601 Cottage Hill Road, Mobile, Alabama,  
April 1963 through December, 1964;

Route 1, Box 132A, Theodore, Alabama,  
December, 1964 through April, 1967;

8117 Brampton Street, Spring Valley,  
California, June 1, 1967 through date of

He was shown to have been an electrical designer for R.S. BERNEY, 1412 Dauph, Mobile, Alabama from June, 1964 to April, 1967 and an electronics coordinator at Alabama Drydock and Shipbuilding Company, Mobile, Alabama from July, 1963 to March, 1964. The only arrest listed for WILLARD was on October, 1956 at which time he had been arrested for excessive speed and accident, no location of arrest given and on February, 1952, at Oakland, California, he had been arrested on a drunk and disturbing the peace charge. No disposition was shown. Personal references are listed as JACK M. WELCH, 1412 Dauph, Mobile, Alabama and E.H. GOULD, 5661 Cottage Hill Road, Mobile, Alabama.

WILLARD maintained excellent remarks in his personnel record and was considered conscientious and a steady person.

KREPCHIN stated that he had never known WILLARD to be in any kind of trouble and considered him an excellent employee.

KREPCHIN furnished a photograph of WILLARD which had been taken in 1967.

KING CASE AGAINST THE FINGERPRINTS OF THE OVER 53,000 PERSONS FOR WHOM "WANTED NOTICES" HAVE BEEN POSTED IN THE FILES OF THE FBI'S IDENTIFICATION <sup>DIVISION</sup> ~~DIVISION~~ LED TO THE DETERMINATION THAT GALT AND RAY ARE IDENTICAL.

MR. HOOVER SAID THAT RAY, WHO IS 40 YEARS OF AGE, WAS REPORTED MISSING FROM THE MISSOURI <sup>STATE</sup> ~~STAVE~~ PENITENTIARY AT JEFFERSON CITY, MISSOURI, SINCE APRIL 23, 1967. HE HAD BEEN RECEIVED AT THAT INSTITUTION ON MARCH 17, 1960, TO SERVE A 20-YEAR SENTENCE FOLLOWING CONVICTION IN ST. LOUIS FOR ARMED ROBBERY AND FOR OPERATING A MOTOR VEHICLE WITHOUT PERMISSION OF THE OWNER.

HE HAS SERVED TERMS IN THE LOS ANGELES COUNTY JAIL IN 1949; IN STATE PRISONS AT JOLIET AND PONTIAC, ILLINOIS, IN 1952-54; AND IN THE FEDERAL PENITENTIARY AT LEAVENWORTH, KANSAS, IN 1955-58.

RAY WAS AN ENLISTED MAN IN THE UNITED STATES ARMY FROM FEBRUARY, 1946, TO DECEMBER, 1948, AT WHICH TIME HE WAS GIVEN A GENERAL DISCHARGE DUE TO INEPTNESS AND LACK OF ADAPTABILITY FOR MILITARY SERVICE. WHILE IN THE ARMY, HE RECEIVED A THREE-MONTH SENTENCE AT HARD LABOR FOR BEING DRUNK AND BREAKING ARREST. <sup>639-18</sup> <sup>136-158\*</sup>

MR. HOOVER SAID THAT DURING HIS CRIMINAL CAREER, RAY HAS ALSO USED THE NAMES OF JAMES MC BRIDE, JAMES WALTON, W. C. HERRON AND JAMES O'CONNER. HE IS A WHITE MALE; CLAIMS TO HAVE

BEEN BORN [REDACTED] IN ILLINOIS; IS APPROXIMATELY 5 FEET 10 INCHES TALL AND WEIGHS ABOUT 163 TO 174 POUNDS. HE HAS BLUE EYES AND BROWN HAIR. THERE IS A SMALL SCAR ON THE CENTER OF HIS FOREHEAD AND A SCAR ON THE PALM OF HIS RIGHT HAND.

RAY HAS CLAIMED THAT HE ATTENDED SCHOOL THROUGH THE 10TH GRADE IN ALTON, ILLINOIS. HE HAS HAD THE REPUTATION OF BEING A "DRIFTER" SINCE LEAVING SCHOOL. HIS VOCATIONAL EXPERIENCE INCLUDES WORKING AS A BAKER, LABORER AND COLOR MATCHER.

IN CONNECTION WITH HIS ESCAPE FROM THE MISSOURI STATE PENITENTIARY, AN FBI COMPLAINT WAS FILED IN JEFFERSON CITY, MISSOURI, ON JULY 20, 1967, CHARGING RAY WITH UNLAWFULLY FLEEING FROM THE STATE OF MISSOURI TO AVOID CONFINEMENT. HE HAS BEEN A FEDERAL FUGITIVE SINCE THEN.

# Link To Slaying Sought

OCEANSIDE - Police detectives continued their investigation Monday to determine if a man found dead in an Oceanside motel March 5 may have been connected with the accused slayer of Dr. Martin Luther King.

"So far we have been unable to see any connection between the two individuals," said Detective Sgt. Roy Smith, assigned to investigate the case by Police Chief Ward Ratcliff.

Smith said police have determined that Robert Melvin Owens, later identified as Earl Jack Norman, Jr., was hospitalized in San Diego two weeks prior to his death.

According to the detective, Norman was treated at Scripps Memorial Hospital Feb. 20 and transferred, in a coma, to University Hospital in San Diego the following day.

Smith said that Norman was found in a parked car at Ardath Road and Interstate 5 on the morning of Feb. 20.

The victim later told investigators he had been "bombed" in Tijuana.

Norman was released from the hospital on Feb. 24, according to the OPD.

Friday the FBI in Washington said that "Eric Stavro Galt" who was sought in the murder of Dr. King was in fact James Earl Ray, who escaped from the Missouri State Penitentiary almost a year ago.

The bureau also stated that Ray and an ex-convict named James Owens were convicted of robbing a St. Louis supermarket.

Norman is known to have used the name Owens during much of his life. However, the FBI records gives his identity as Norman throughout.

Norman also served time in the Missouri State Penitentiary.

He was sentenced there on a first degree robbery charge in September 1953, for a term of five years.

# Galt Escaped Con, Says FBI

WASHINGTON (AP) — The FBI today identified Erick Starvo Galt, wanted for the killing of Dr. Martin Luther King Jr., as James Earl Ray, 40, an escapee from the Missouri State Penitentiary.

The FBI said he was identified through "a systematic and exhaustive search of latent fingerprints" uncovered in the King case against the fingerprints of the more than 53,000 persons for whom wanted notices are on file in the bureau's identification division.

Ray was reported missing from the Missouri State Penitentiary at Jefferson City April 23, 1967. He was serving a 20-year sentence for an armed robbery in St. Louis and operating a motor vehicle without the owner's permission.

Ray, who had been at the prison since March 17, 1960, spent some time in September 1966 in the maximum security ward at the state hospital in Fulton, Mo.

The man known as Galt was charged Wednesday with the first-degree murder of King April 4 in Memphis, Tenn. He also is charged in a federal warrant with conspiracy and murder in the King assassination.

A drifter since he left school in the 10th grade at Alton, Ill., Ray served as an enlisted man in the Army from February 1946

to December 1948 when he was given a general discharge for ineptness and lack of adaptability, the FBI said. During his Army career he received a three-month sentence at hard labor for being drunk and "breaking" arrest.

The FBI said Ray has an arrest record dating at least to 1949, when he was convicted for burglary in Los Angeles. He also was convicted in 1952 for armed robbery in Chicago and in 1955 for forging U.S. postal

money orders in Missouri.

He has served terms in a Los Angeles County jail, state prisons at Joliet and Pontiac, Ill., and a federal penitentiary at Leavenworth, Kan.

The FBI said Ray has used the names of James McBride, James Walton, W. C. Herron and James O'Conner.

Ray claims to have been born March 10, 1928 in Illinois—but the FBI did not say where. He is about 5-feet-10, weighs 163 to 174 pounds, has blue eyes and brown hair
