On 4/5/68 M. B. SUMMERS, 1101A West Margaret, Pasco, Wash., Tel. 547 7106, informed as follows:

SUMMERS is in his 70's and is retired; he previously operated a furniture storage business at Pasco, Washington. About 2-3 years ago a Republic Van Line Truck which operates out of Baltimore and Los Angeles drove into his place. The driver, a Negro, who probably owned the tractor, the box being owned by Republic Van Lines, was accompanied by a Negro helper. During the course of loading or unloading some furniture the driver whose name SUMMER's recalls as JOHN BROWN, the helper and SUMMERS got into a brief discussion concerning Dr. Martin Luther King, Jr. Summers recalls that BROWN made a comment that in Brown's opinion Dr. King wouldn't live long; that someone would get him. SUMMERS stated that BROWN was Negro, Male, about 60 years of age, quite tall. He does not recall anything concerning the helper except he was a Negro male. SUMMERS believes BROWN stated he was from the state of Tennessee. SUMMERS stated that no further detailed discussion was had, BROWN did not appear to have any animosity toward Dr. King and mentioned no one who would "get him" but just stated his opinion.

The Bureau by teletype April 8, 1968, has advised that under no circumstances should anyone be told that this investigation is in connection with the murder of MARTIN LUTHER KING, JR.

It has been determined that a rifle abandoned near the scene of the crime was purchased by an individual using the name HARVEY LOWMEYER or LOWMYER. LOWMEYER or LOWMYER is generally described as a white male American, 36, 5'8", 150 - 160 pounds, black or dark brown hair. In view of the unusual nature of the names LOWMEYER or LOWMYER, all offices are instructed to immediately check all city directories, all telephone directories covering the territory, all driver's license records, all automobile registration records, all voter registration records, and credit and criminal records on the surnames of LOWMEYER or LOWMYER. In view of the unusual nature of the names, the check should not be confined to HARVEY LOWMEYER or LOWMYER, but should include similar names. Any individual identified as bearing these surnames should be immediately checked out covering the pertinent period.

The Bureau has instructed that this matter be handled immediately and given top priority. The Senior Resident Agents are being held responsible to initiate and complete the checks outlined in the territories covered by them. The Senior Resident Agent at Olympia should arrange for the checks of the driver's license records and the automobile registration records. These checks should be commenced at once, continued expeditiously until done, and the results of the checks made available immediately to the office. The checks in the Seattle Headquarters City will be under the supervision of SA VERNON P. COYNE.

For the information of all Agents, the pertinent periods in the investigation are March 29-30, 1968 in Birmingham, Alabama and April 4, 1968, in Memphis, Tenn. In event any data is developed regarding suspects, if the whereabouts of the suspect on the dates above can be established, he can thus be eliminated. If this cannot be done, efforts should be made to secure photographs of the suspects in question and forward photos to Memphis and Birmingham for possible elimination. Pertinent descriptive data should be included with the photos. If unable to eliminate on the basis of established alibis in the pertinent period, offices should make efforts to make available fingerprints of the suspect in question and submit them to the Bureau for elimination.

SUBJECT: ASSASSINATION OF REV. DR. MARTIN LUTHER KING
RACIAL MATTER

HERBERT A. FORRESTER, 3110 C Portage Bay Pl. E., Seattle, a former U of W mathematics professor and Boeing engineer, telephonically contacted this office tonight as follows:

A sketch of KING's murderer appearing in tonight's Times bears a strong resemblance to a friend of FORRESTER's, JOHN FORBES NASH, who he went to Princeton University with as a classmate in grad school.

NASH has a doctorate in math, is regarded as a fine mind on the subject, but has been declared legally insane, a man possessed with paranoid psychofrenia. He has the idea he is continually "enslaved", and seeks "freedom" from this.

The last FORRESTER heard from NASH was last week from West Virginia, and he believes he is fully capable of the act of murder.

SA KEIL advised; SA NORTON handled and found FORRESTER to be under the apparent influence of drugs.

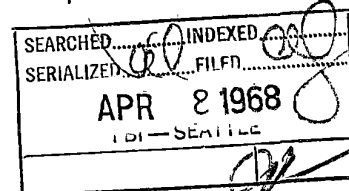

On April 7, 1968, HERBERT A. FORRESTER, 3110 C. Portage Bay East, Seattle, Washington, former Assistant Professor, Department of Mathematics, University of Washington, advised he had seen a picture in the April 6th edition of the "Seattle Post Intelligencer" drawn by a staff artist of a Memphis newspaper of the suspected killer of Dr. MARTIN LUTHER KING. FORRESTER said that this drawing bore a marked resemblance to JOHN FORBES NASH, whom he had met while doing graduate work in mathematics at Princeton University during the approximate years 1950 - 1954. According to FORRESTER, the mouth and eyes in the drawing were very similar to those of NASH and a comment in the newspaper that the suspected killer of MARTIN LUTHER KING had a "silly smile" on his face, reminded him of NASH who had that type of expression when NASH was about to do something irrational. HERBERT A. FORRESTER related that approximately ten days ago, he had received a postcard from NASH which was postmarked Roanoke, Virginia. He said that in the past months, he had received two or three other communications from NASH, all postmarked Roanoke, Virginia, and all of which he had thrown away. He related that he did not keep any of these letters or postcards since they contained "psychotic babblings" pertaining to religion, politics, and lately to the fact that NASH considered himself enslaved and was seeking a way out of his enslavement.

By way of background, FORRESTER said that JOHN FORBES NASH was considered one of, if not the foremost, mathematician in the United States and that his theories and works are widely recognized in scientific circles throughout the world. He related that after finishing graduate study at Princeton University, NASH was subsidized by the "Institute for Advanced Study at Princeton" and he believed that NASH is now, or has been, given grants to continue his studies by both Harvard and the Massachusetts Institute of Technology. According to FORRESTER in approximately 1958, NASH suffered a mental breakdown and was institutionalized. He said that he believed NASH was admitted at various times since then to mental institutions in New Jersey, Massachusetts, 371-8

and Switzerland. FORRESTER stated he does not know NASH'S present address or employment and very little background concerning him other than the fact that NASH had been married, is now divorced or separated, and has two sons. He stated the last time he saw NASH was about two years ago when NASH made a trip to the State of Washington and visited him at his residence. He described JOHN FORBES NASH as a white male American, age 40, height 6'1", weighing 170 pounds, with a very prominent nose with a "chisel tip". FORRESTER said that his relationship with NASH was an intellectual one and arose from their mutual interest in mathematics and that their conversations dealt mostly with mathematical theories and not personalities.

Mr. FORRESTER said that he did not know whether NASH would be capable of committing murder and further had no way of knowing whether NASH was proficient with firearms, however, he said that because of the marked resemblance of the photograph to NASH, the fact that NASH had a history of mental instability, and the fact that NASH was in the southeastern part of the United States approximately a week to ten days before the murder, he felt that it was his duty to inform this Bureau.

HERBERT A. FORRESTER said that he had been an Assistant Professor of Mathematics at the University of Washington until 1961, at which time he left to obtain employment with The Boeing Company. He was released from employment at Boeing in 1963 and is presently unemployed doing private research.

Indices of the Seattle Office failed to contain the names of JOHN FORBES NASH or HERBERT A. FORRESTER.

A teletype has been sent to the Bureau concerning the above information.

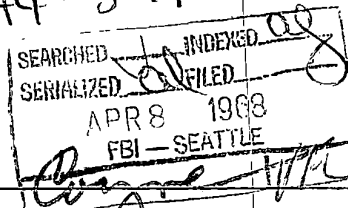

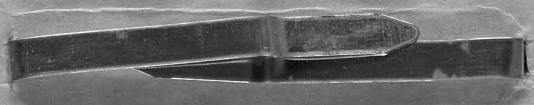
