





On 4/8/68, Mr. JACK HAGEDORN, City Counselman, Grayville, Ill., telephonically contacted the writer and advised that EARL MODE of Rural Route 1, Grayville, Ill., had contacted him and advised he had information to furnish the authorities of possible interest concerning the murder of KING. MODE requested that the interviewing agent be accompanied by Mr. BERNARD STERM, City Counselman and HAGEDORN.

Accompanied by Mr. STERM and HAGEDORN, EARL MODE was contacted at his home, Rural Route 1, Grayville, Ill.

MODE related that at approximately noon to 1 PM on Saturday, 4/6/68, he met CARL HARVEY whom he has known for approximately one year in Grayville, Ill.

HARVEY inquired if MODEL had beard not KING being killed and advised that he had been in Memphis on Thursday. He stated he had experienced trouble in getting out of Memphis as three Negroes had tried to turn his car over while he was stoped for a traffic signal. HARVEY allegedly split the head of one NEgro with a tire iron and the other two retreated. When MODE began to ask about HARVEY's activities in Memphis, HARVEY shut up and would not say anything else.

HARVEY was described by MODE as follows:

White, Male, 6', 180-190 lbs., eyes believed to be blue, Hair sandy, worn long in front, age 27-29, characteristics long nose, friendly, frequently wears dark suit with white shirt and dark tie.

HARVEY frequently exhibits a large roll of money although he is unemployed and has no visible means of support.

He is believed to have been in Memphis, Tenn. approximately two - three weeks ago about the time KING was there previously.

When questioned as to any statements previous concerning Negroes or civil rights activities HARVEY on one occasion had remarked "they'll get
