

AND HAD BEEN IN GROUPS WHERE RAY WAS TALKING ON SEVERAL OCCASIONS.

BROWN RECALLS THAT RAY MADE STATEMENT THAT HE WAS GLAD WHEN JOHN F.

KENNEDY WAS KILLED AND MADE SIMILAR STATEMENT AT THIS TIME TO THE

EFFECT "THAT IS ONE NIGGER-LOYING S.O.B. THAT GOT SHOT." BROWN

STATED THAT RAY DISLIKED NEGROES AND THAT DURING TIME MARTIN LUTHER KING WAS LEADING DEMONSTRATIONS AND MARCHES HE WOULD BECOME AGGRAVATED AND UPSET WHEN READING THIS INFORMATION IN NEWSPAPERS TO THE POINT THAT HE WOULD CURSE KING AND THE NEGROES. BROWN STATED THAT RAY MADE STATEMENT THAT KENNEDY WAS RUNNING THE COUNTRY AND ESPECIALLY IN THE RACIAL FIELD AND THAT KING COULD GET THE FEDERAL GOVERNMENT TO DO ANYTHING HE WANTED THEM TO. BROWN SAID HE HAD HEARD PRISON RUMORS THAT RAY WAS SUPPOSED TO HAVE KILLED THREE NEGROES WHILE IN THE MSP.

BROWN ADVISED THAT SOMETIME DURING THE FALL. NINETEEN SIXTYTHREE, RAY MADE STATEMENT THAT HE WAS GOING TO GET MARTIN LUTHER
KING WHEN HE GOT OUT. BROWN SAID HE HEADO RAY SAY SOMETHING ABOUT
COOLEY (PHONETIC) OR COOLEY'S ORGANIZATION WOULD PAY TEN THOUSAND
DOLLARS TO HAVE KING DEAD. BROWN SAID HE COULD FURNISH NO INFORMATION
CONCERNING THIS ORGANIZATION AND RAY DID NOT MENTION IT AGAIN IN HIS
PRESENCE. BROWN SAID THAT RAY SEEMED TO HAVE A SUFFICIENT SUPPLY OF
MONEY AND THAT HE ALLEGEDLY GOT A CHECK OR MONEY REGULARLY FROM
SOURCE OUTSIDE PRISON. HE STATED THAT RAY DID DRINK AND HE
HAD DETECTED ALCOHOL ON HIS BREATH ON DIFFERENT OCCASIONS, POINTING DITT
THAT CONVICTS MADE WHISKEY IN PRISON AND SOME OF THE GUARDS WOULD

SELL WHISKEY TO CONVICTS. BROWN SAID THERE WERE NARCOTICS PASSED
AROUND IN PRISON AND GUARDS WOULD BRING NARCOTICS AND SOME OF IT WAS
BROUGHT IN BY VISITORS. HE SAID HE HAD NO PERSONAL KNOWLEDGE THAT
RAY USED NARCOTICS. HE ALSO WAS UNABLE TO NAME ANY SPECIFIC GUARD
WHO SOLD CONTRABAND.

BROWN SAID THAT RAY WAS NOT OVERLY FRIENDLY, HOWEVER, IN GROUP'S HE WOULD TALK. HE NEVER DISCUSSED HIS PAST LIFE IN BROWN'S PRESENCE AND BROWN HAS NO IDEA WHERE RAY IS FROM. BROWN SAID HE HAS NOT SEEN RAY SINCE HE LEFT PRISON AND NOTED THAT RAY HAD TALKED ABOUT TUNNFLING OUT OF PRISON AND GOING TO VIRGINIA AND HIDING IN A CAVE. BROWN SAID THAT RAY MADE STATEMENT THAT HE HAD A LARGE SUPPLY OF GUNS BEFORE HE WAS IN PRISON AND THE ONLY FROEIGN COUNTRY HE EVER HEARD RAY MENTION WAS LIBERIA, AFRICA AND RAY STATED HE HAD A BROTHER-IN-LAW WORKING THERE AND THAT HE WAS MAKING LARGE SUMS OF MONEY.

DHNNY VALENTI (PHONETIC). VALENTI IS BELIEVED TO BE FROM BATON
ROUTE, LOVISIANA AND BROWN BELIEVES HE IS STILL IN MSP. VALENTI


